# **CHARGED FOR CARNAL KNOWLEDGE**

SAN **IGNACIO** TOWN, Cayo, Thursday, January 22, 2009:

Although the crime was allegedly committed way down south in Punta Gorda Town, two men were this week arrested and charged for engaging in a sexual relationship with a female under the age of 16.

The men arrested and charged are Ismael Correa, 48, Belizean construction worker who initially gave his address to the police as Placencia Village, but

later told the court that he resides on St. Vincent Street in Dangriga Town.

The other accused is **David Molina Jr., 23**, also a Belizean construction worker residing in the village of El Progresso (formerly 7 miles, Pine Ridge Road) in the Cayo District.

The incident began unfolding during the late evening hours on Friday, January 16 when the girls did not return home from school. Their mothers visited the San Ignacio police station at different times with each filing separate missing person reports.

Investigation revealed that the female students arrived in San Ignacio on Friday afternoon from

the high school they attend in Benque Viejo Town, where they reportedly met the accused Correa and Molina and agreed to accompany them for a ride to Spanish Lookout. On the way however, they reportedly began bar hopping and when the night was closing in, one of the girls reportedly called her mother telling her that she was with some friends in Belmopan.

A few bottles of Vodka were reportedly purchased and the trip went on for over 170 miles, ending in the southernmost municipality of Punta Gorda. Upon arriving in Punta Gorda, two hotel rooms were reportedly obtained where both men is alleged to have engaged in sexual relationships with the girls.

The girls were reportedly given a few dollars and were reportedly told to get on the first bus, the next day, out of Punta Gorda for the return trip to San Ignacio.

The Attorney General's response to the Honorable Chief Justice's address during last Monday's ceremonial opening of the Supreme Court, should serve as an eye opener for many.

For one, it is a first in Belize's post-independence history in this kind of setting. One of the relics of the colonial era has always been the fear of repercussions associated with the slightest criticism of the justice system.

Admittedly deviating from the text of his prepared address, Attorney General and Minister of Foreign Affairs and Foreign Trade, the **Honorable Wilfred "Sedi" Elrington,** minced no words in laying the cards on the table.


His eye opening revelation has created some reaction within the justice system. This has reportedly prompted the call for an emergency meeting this Friday with a view towards analyzing some of the points brought up by the learned Attorney General in his address.

We refer specifically to the Attorney General's pronouncement of the public perception of an erosion in the confidence of the justice system particularly when he mentioned the view that in some quarters there is the feeling that the court is dispensing more injustice than justice, and this could be attributed to the reason why an increasing number of persons are resorting to settling old beef outside of the justice system. This could most likely also be attributed to the high murder rate for which the Honorable Chief Justice

expressed concern during his presentation.

Without ruffling feathers, the Attorney General could have stuck to the text of his prepared address thereby continuing business as usual and the nation would have probably proceeded into yet another year of escalating violent crimes.

We trust that with this development and with Friday's meeting of Magistrates and Judges, the learned Chief Justice would have commenced a real soul searching exercise for the purposes of regaining and maintaining the public confidence in the judiciary being one of the pillars on which our democracy rests.

The Congress in Mexico has agreed to debate the issue of reinstating capital punishment for some crimes.

The move follows a surge in murders and kidnappings in the country, many linked to drug cartels and organised crime.

Mexico abolished capital punishment in 2005, but recent surveys suggest that 70% of Mexicans are in favour of the death penalty.

The campaign to reinstate judicial executions has, unusually, been led by Mexico's Green Party. Hundreds of posters, carrying the Green Party logo, and demanding capital punishment for murderers and kidnappers have appeared all over Mexico City.

No date has been set for the forums, which will bring together crime experts, academics and human rights campaigners.

The chances that the Mexican constitution will actually be amended currently appear remote. The government, church and human rights groups all strongly oppose reinstating capital punishment.

Mexico has long been a powerful voice in international forums calling for the abolition of capital punishment and has not carried out an execution since 1961. ## **Carnal Knowledge Charge Against Corporal Grinage Withdrawn**

#### SAN IGNACIO TOWN, Cayo District, Thursday, January 22, 2009:

Latest information reaching us indicate that after no less than nine adjournments, the unlawful carnal case against police corporal Joel Grinage #536 was withdrawn, reportedly for want of prosecution.

Corporal Grinage was initially arrested and charged for the crime on February 20, 2008 and after the fourth adjournment, the complainant, accompanied by her parents, visited the office of the **Director of Public Prosecutions** (DPP) on June 12, 2008 where she informed that the statement she gave to the police was not true and that it was only given at the urging of the investigating corporal.

On that visit to the DPP's office the child's father reportedly expressed the desire not to proceed with the matter as the child was preparing to commence high school and he would not want the

matter to affect her school work.

The parents were advised to visit the San Ignacio police station and give a statement to that effect.

Notwithstanding the directive, it took five subsequent adjournments over the next five months for the charge to be finally withdrawn against corporal Grinage.

In addition to carnal knowledge, Corporal Grinage was likewise facing a charge for extortion. Although this charge has not been formally withdrawn against the corporal, there are strong indication of the lack of interest to proceed with it.

By all indications, the interdiction against Corporal Joel Grinage has been lifted and he is currently on active duty at the Dangriga police station in the Stann Creek District.

## Colombian Judge Sentences Ex-Mayor **To 28 Years In Rare Conviction For Ordering Reporter Killed**

sentenced a former mayor to 28 years in prison for ordering the April 2003 killing of a journalist who had repeatedly denounced the politician as corrupt.

Julio Cesar Ardila was among three men convicted in the murder of Jose Emeterio Rivas of the local radio station "Calor Estereo," who was shot to death in the steamy refinery city of Barrancabermeja on Colombia's main river, the Magdalena.

The sentence, handed down by judge Nelly Vallejo in the regional capital of Bucaramanga on January 13, only came to light Thursday after the InterAmerican Press Association's (IAPA) president, Enrique Santos, publicized it.

Santos, co-publisher of Bogota's El Tiempo newspaper, noted that it is rare in Colombia for the mastermind of a journalist's killing to be brought to justice.

In the past 15 years, 57 journalists have been killed in Colombia while exercising their profession, according to the IAPA, with more than 70 percent of those killings going unpunished.

Ardila, Barrancabermeja's mayor from 2000-2003, was arrested last year.

Rivas had accused him not just of corruption but also of ties to

the city as they rid it of alleged guerrilla sympathizers. The key witness was a demobilized paramilitary gunman, Rayner Enrique Brokate, who said

he was present when Ardila and the two other convicted men agreed to pay militia leaders about \$68,000 to kill the reporter.

The judge's sentence, which was obtained by The Associated Press, did not indicate whether the money was paid.

A day before he was killed, Rivas called Ardila "a plunderer" in a television appearance, according to the sentence.

# The High Cost Of Living - A Major **Concern For Caribbean Youth**

The prevailing high cost of living has been cited as one of the top five issues affecting Caribbean youth.

National Research Coordinator, Shelly Carter in divulging preliminary research findings told participants of the Regional Planning Workshop organized by the CARICOM Commission on Youth Development (CCYD) that high cost of living, crime and violence, limited access to education, increasing rate of unemployment and a lack of Caribbean cultural identity were the top five critical issues identified by Caribbean Youth in a study on Youth Dreams' and Aspirations.

Ms Carter's presentation was one of five on research being conducted by the CARICOM Commission on Youth Development (CCYD) which seeks to fulfill its mandate from the CARICOM Heads of Government to "provide a provide a comprehensive analysis of challenges and opportunities for youth in the CARICOM Single Market and Economy (CSME); and to make recommendations on how to improve their well-being and empowerment."

Ms Carter said the research findings had indicated that high food prices and high tuition costs had severely limited the earning and spending power of Caribbean families and youth and had made it increasingly difficult for them to meet basic needs.



Linked to that, she said, were the challenges of unemployment and under-employment as a direct consequence of global economic recession, Caribbean contracting economies and subsequent limited avenues for job creation.

As a result, it was noted that a number of highly qualified youth were forced to settle for relatively low paying jobs, within their country.

In addition, she explained that crime and violence which seemingly plague several Caribbean countries had engendered a spirit of fear and despair among youth to the extent

to realize any dream and aspiration." The relevance of education outputs to private sector needs was

also brought into critical focus. The findings indicated that youth perceived a dissonance between education provided at secondary and tertiary levels and the demands of the Caribbean job market.

Also of significance were issues related to Caribbean identity. The findings revealed that many Caribbean youth were not knowledgeable of national or Caribbean history, failed to identify with things Caribbean and demonstrated apathy toward the Caribbean Community and its flagship programme, the Single Market and Economy.

Participants agreed that the findings on the Youth Dreams and Aspirations research did not augur very well for the promotion of the ideals of the CSME and recommended that national youth organizations, NGOs and CBOs be trained to sensitize young people in their communities to the practical implications of CSME and to develop concrete knowledge through and skills the implementation of cross-border entrepreneurial development projects.

The Commission's report is to be presented to a special meeting of the Council for Human and Social Development in April prior to its submission to the 30th Meeting of the Conference of Heads of Government.



## Another Decrease In The Cost Of Butane Gas

**BELMOPAN CITY, Cavo** District, Tuesday, January 20, 2009:

Another reduction in the acquisition cost of butane gas has been passed on consumers.

A release from the Ministry of Finance today informed that effective, Wednesday, January 22, the price of butane gas will go down by four dollars countrywide.

The new retail price, excluding delivery cost, for a one hundred pound cylinder of butane will cost \$86 in Belize City, \$87 in Corozal and Orange Walk; \$88 in Belmopan and San Ignacio; \$89 in Benque; \$90 in Dangriga and \$91 in Punta Gorda.

The Ministry informs that as prices decrease, these savings will be passed on to consumers.

All human beings are born with equal and inalienable rights and fundamental freedoms. The United Nations is committed to upholding, promoting and protecting the human rights of every individual. This commitment stems from the United Nation's Charter which affirms the faith of the peoples of the world in fundamental human rights and in the dignity and worth of the human person.

In the Universal Declaration of Human Rights, the United Nations has stated in clear and simple terms, the rights which belong equally to every person.

These rights belong to you.

They are your rights. Familiarize yourself with them. Help to promote and defend them for yourself as well as for your fellow human beings.

#### Adopted and proclaimed by the General Assembly resolution 217 A (III) of 10 December 1948.

### Preamble

Whereas recognition of the inherent dignity and of the equal and inalienable rights of all members of the human family is the foundation of freedom, justice and peace in the world,

Whereas disregard and contempt for human rights has resulted in barbarous acts which outrage the conscience of, and the advent of a world in which human beings shall enjoy freedom of speech and belief and freedom from fear and want has been proclaimed as the highest aspiration of the common people, the equal rights of men and women and have determined to promote social progress and better standards of life in larger freedom,

Whereas Member States have pledged themselves to achieve, in cooperation with the United Nations, the promotion of universal respect for and observance of human rights and fundamental freedoms,

Whereas a common understanding of these rights and freedoms is of the greatest importance for the full realization of this pledge,

Now, therefore,

The General Assembly

Proclaims Universal this Declaration of Human Rights as a common standard of achievement for all peoples and all nations, to the end that every individual and every organ of society, keeping this Declaration constantly in mind, shall strive by teaching and education to promote respect for these rights and freedoms and by progressive measures, national and international, to secure their universal and effective recognition and observance, both among the peoples of Member States themselves and among the peoples of territories under their jurisdiction.

#### Article 1

All human beings are born free and equal in dignity and rights. They are endowed with reason and conscience and should act towards one another in a spirit of brotherhood.

## Article 2

Everyone is entitled to all the rights and freedoms set forth in this Declaration, without distinction of any kind, such as race, colour, sex, language, religion, political or other opinion, national or social origin, property, birth or other status. Furthermore, no distinction shall be made on the basis of the political, jurisdictional or international status of the country or territory to which a person belongs, whether it be independent, trust, non-self-governing or under any other limitation of sovereignty.

## Article -

Everyone has the right to life, liberty and security of person.

## *Ar*ticle 4

No one shall be held in slavery or servitude; slavery and the slave trade shall be prohibited in all their forms.

## Article 5

No one shall be subjected to torture or to cruel, inhumane or degrading treatment or punishment.

## Article 6

Everyone has the right to recognition everywhere as a person before the law.

## Article 7

All are equal before the law and are entitled without and discrimination to equal protection of the law. All are entitled to equal protection against any discrimination in violation of this Declaration and against any incitement of such discrimination.

## Article 8

Everyone has the right to an effective remedy by the competent national tribunals for acts violating the fundamental rights granted him by the constitution or by law.

## Article 9

(1) Everyone charged with a penal offence has the right to be presumed innocent until proved guilty according to law in a public trial at which he has all the guarantees necessary for his defence.

(2) No one shall be held guilty of any penal offence on account of any act of omission.

# **Ceremonial Opening Of The Supreme Court**

The 2009 legal year of the Belize Supreme Court was officially declared opened by the Chief Justice of Belize, **Hon. Dr. Abdulai Conteh** at a ceremonial session held at the Supreme Court in Belize City, Monday, January 19, 2209

The session commenced with a mass attended by judges, members of the Bar Association, Magistrates, Commissioners and other legal practitioners at the Saint John's Anglican Cathedral followed by a gathering inside the Chief Justice's Chambers.

The Chief Justice gave a situational report outlining many issues over the past legal year including financial constraints, case load, and the insufficiency in the number of judges. He also mentioned his dissatisfaction in the unfortunate pattern of the criminal justice system where cases are increasingly ending in nolle prosequi status. "In the course of

2008, the Director of Public Prosecution office; I'm sorry to say, lodged not less than eighty-three nolle prosequi." said the Chief Justice.

Murder was the leading charge dealt with in the Supreme Court followed by attempted murder.

There were sixty-three murder cases, twenty-nine attempted murder cases, three robberies, eighteen rapes, twenty-seven carnal knowledge and sixteen unlawful carnal knowledge cases. Two hundred and fourteen divorce petitions were also filed.

Speaking on the adjournment, Attorney General of Belize, **Hon. Wilfred Elrington**, spoke on the progress of the Attorney General's Ministry since taking office and also on the assistance given to the other various departments that fall under that Ministry.

The Attorney General also indicated that there appears to be a lack of confidence in the system of justice as it appears now safer to commit murder than to steal. He highlighted the long delays in delivery judgments. He said that the time had come for judges to be held accountable for their actions or inactions.

#### Article 10

Everyone is entitled in full equality to a fair and public hearing by an independent and impartial tribunal, in the determination of his rights and obligations and of any crimainal charge against him.

## Article 11

(1) Everyone charged with a penal offence has the right to be presumed innocent until proved guilty according to law in a public trial at which he has all the guarantees necessary for his defence.

(2) No one shall be held guilty of any penal offence on account of any act or ommssion which did not constitute a penal offence, under national or internationa law, at the time when it was committed. Nor shall a heavier penalty be imposed than the one that was applicable at the time the penal offence was committed.

## Article 12

No one shall be subjected to arbitrary interference with his privacy, family, home or correspondence, nor to attacks upon his honor and reputation. Everyone had the right to the protection of the law against such interference or attacks.



(1) Everyone has the right to freedom of movement and residence within the borders of each state.

(2) Everyone has the right to leave any country, including his own, and return to his country.

## Article 14

(1) Everyone has the right to seek and enjoy in other countries asylum from persecution.

(2) This right may not be invoked in

#### dissolution.

(2) Marriage shall be entered into only with the free and full consent of the intending spouses.

(3) The family is the natural and fundamental group unit of society and is entitled to protection by society and the State.

## Article 17

(1) Everyone has the right to own property alone as well as in association with others.

(2) No one shall be arbitrarily deprived of his property.

### Article 18

Everyone has the right to freedom of thought, conscience and religion; this right includes freedom to change his religion or belief, and freedom, either alone or in community with others and in public or private, to manifest his religion or belief in teaching, practice, worship and observance.

## Article 19

Everyone has the right to freedom of opinion and expression; this right includes freedom to hold opinions without interference and to seek, receive and impart information and ideas through any media and regardless of frontiers.

#### Article 20

(1) Everyone has the right to freedom of peaceful assembly and association.

(2) No one may be compelled to belong to an association.

## Article 21

(1) Everyone has the right to take part in the government of his country, directly or through freely chosen representatives.

(2) Everyone has the right to equal access to public service in his country.

#### Article 2-

(1) Everyone has the right to work, to free choice of employment, to just and favorable conditions of work and to protection against unemployment.

(2) Everyone, without any discrimination, has the right to equal pay for equal work.

(3) Everyone who works has the right to just and favorable remuneration ensuring for himself and his family an existence worthy of human dignity, and supplemented, if necessary, by other means of social protection.

#### Article 24

Everyone has the right to rest and leisure, including reasonable limitation of working hours and periodic holidays with pay.

### Article 25

(1) Everyone has the right to a standard of living adequate for health and well being of himself and of his family, including food, clothing, housing and medical care and necessary social services, and the right to security in the event of unemployment, sickness, disability, widowhood, old age or other lack of livelihood in circumstances beyond his control.

(2) Motherhood and childhood are entitled to special care and assistance. All children, whether born in or out of wedlock, shall enjoy the same social protection.

## Article 26

(1) Everyone has the right to education. Education shall be free, at least in the elementary and fundamental stages. Elementary education shall be compulsory. Technical and professional education shall be made generally available and higher education shall be equally accessible to all on the basis of merit.

(2) Everyone has the right to the protection of the moral and material interests resulting from any scientific, literary or artistic production of which he is the author.

## Article 28

Everyone is entitled to a social and international order in which the rights and freedoms set forth in this Declaration can be fully realized.

## Article 29

(1) Everyone has duties to the community in which alone the free and full development of his personality is possible.

(2) In the exercise of his rights and freedoms, everyone shall be subject only to such limitations as are determined by law solely for the purpose of securing due recognition and respect for the rights and freedoms of others and of meeting the just requirements of morality, public order and the general welfare in a democratic society.

(3) These rights and freedoms may in no case be exercised contrary to the purposes and principles of the United Nations.

## Article -0

Nothing in this Declaration may be interpreted as implying for any State, group or person any right to engage in any activity or to perform any act aimed at the destruction of any of the rights and freedoms set forth herein.

## Article 22

Everyone, as a member of society, has the right to social security and is entitled to realization, through national effort and international cooperation and in accordance with the organization and resources of each State, of the economic, social and cultural rights indispensable for his dignity and the free development of his personality.

(2) Education shall be directed to the full development of the human personality and to the strengthening of respect for human rights and fundamental freedoms. It shall promote understanding, tolerance and friendship among all nations, racial or religious groups, and shall further the activities of the United Nations for the maintenance of peace.

(3) Parents have a prior right to choose the kind of education that shall be given to their children.

## Article 27

(1) Everyone has the right freely to participate in the cultural life of the community, to enjoy the arts and to share in scientific advancement and

US Priests 'In \$800,000 Theft'

Two Roman Catholic priests have been accused of stealing \$800,000 from the collection plate of their church in the US state of Florida.

They allegedly planned to spend the money on property, holidays, gambling and to meet the expenses of mistresses.

One of the priests, **Fr John Skehan** has admitted the charges, but his colleague **Fr Francis Guinan** denies them. US law - the statute of limitations - prevents the priests being charged with thefts that occurred before 2001. But the auditors say that up to \$8m might have disappeared over a period of 20 years. It could be the biggest embezzlement case to affect the Catholic Church in the United States.

One of the priests - Fr John Skehan - abandoned his not-guilty plea just before his trial began, and admitted stealing \$800,000 given by parishioners at St Vincent Ferrer Church in West Palm Beach. The priests allegedly hid the money in the church ceiling and opened offshore accounts. Fr Skehan - who is 81 and has been given the honorific title **"Monsignor"** served at the church for 40 years.

He admitted spending stolen money on expensive houses and gambling in Las Vegas. Police reports claimed that he used more than \$100,000 to pay the expenses of an alleged lover, and almost \$300,000 on rare coins.

'Well-supported' Fr Skehan's colleague at St Vincent Ferrer Church, Fr Francis Guinan, has been accused of using his share of the embezzled money to support a mistress and take her on expensive holidays. The authorities claim Fr Guinan had an "intimate" relationship with a former church book-keeper and spent much of the money on her. Fr Guinan - who is 66 - denies the charges and will go on trial next month. Fr Guinan's lawyer, Richard Barlow, said "just because both priests worked at the same church and one pleads guilty, it doesn't mean my guy is

The lawyer acting for Fr Skehan, Scott Richardson, said "Fr Skehan accepted responsibility for his actions by virtue of his guilty plea", adding, "he has the support of many people, many of whom will speak on his behalf". He could be sent to jail for as long as 31 years.

Both priests were originally from Ireland. Fr Skehan comes from Johnstown in County Kilkenny and Fr Guinan from Birr in County Offaly. Fr Skehan was arrested at Palm Beach International Airport in

September 2006 on his return from Ireland. Both the priests left the United States after the Church received a tip-off in a letter, and began an investigation into the accounts at St Vincent's, and what they called **"alleged improprieties"**.

# **Housing Grants For The Needy**

#### RADISSON FORT GEORGE HOTEL, Belize City, Monday, January 19, 2009:

A release from the Government Press Office informs that on Monday, January 19, 2009, the Ministry of Housing called a press conference at the Radisson Fort George Hotel in Belize City to present the procedures that will be undertaken for the management of a US\$10 Million grant donated by the Government and people of the Bolivarian Republic of Venezuela.

Chief Executive Officer in the Ministry of Housing, **Rosalie Gentle**, informed those in attendance that the grant will be disbursed as followed, BZ \$1.5 Million for the rehabilitation of homes that were damaged due to the Tropical Depression 16. The remaining BZ\$18.5 Million will be expended through the Ministry of Housing for home improvement and the reconstruction of new homes.


CEO Gently informed that for this purpose the country will be divided into four regions; Northern, Western, Southern and Central regions encompassing all 31 electoral constituencies across the country. District (Rural North, Rural South and Rural Central) all other three regions basically comprises the electoral constituencies in those regions.

Each of the four regions, according to CEO Gentle, will be managed by a six member oversight committee which will include a representative each from the Ministry of Housing; the Ministry of Works, Ministry of Human Development (Social Worker), the Chamber of Commerce, the National Trade Union Congress of Belize and two Area Representatives. They will primarily oversee the vetting and approval of application forms as well as the monitoring and the signing-off of all approved grants.

CEO Gentle further informed that in order to qualify for a home improvement grant, applicants should own a house and not earn more than BZ\$15,000 per annum. Furthermore, applicants seeking the construction of a new house should not own a house and not BZ\$10,000 for repairs of homes per applicant and not more than BZ\$30,000 for the construction of a new house.

Also present at the press conference were National Emergency Management Minister, Hon. Melvin Hulse, and Works Minister, Hon. Anthony "Boots" Martinez who both briefly addressed the conference.
