# SUSPECT IN FATAL TRAFFIC ACCIDENT WALKED OUT OF THE POLICE STATION

**SAN IGNACIO TOWN, Cayo District, Friday, June 12, 2009:**

The senior police command in San Ignacio is investigating the circumstance in which an injured prisoner is reported to have just **"disappeared"** from inside the police station.

The escapee is reported to have been the driver of a vehicle which was involved in a head-on collision in San Ignacio Town resulting in the instant death of a taxi driver from the western village of San Jose Succotz.

San Ignacio police reports that it was shortly after 7:30 pm on Friday, June 12, when they responded to the scene of a

Upon arrival police came upon

a Maroon, Mazda car with license plates CY-D- 3252 and a black Dodge Dakota pick-up truck bearing San Ignacio/Santa Elena license plates C00781 both extensively damaged and on the right side of the road when traveling towards Benque Viejo Town.

Preliminary investigation revealed that Edwin Ivan Valencia, 28, Belizean Taxi Driver, residing in San Jose Succotz was driving his Mazda car from San Ignacio towards his

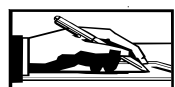

# Editorial



## Respect Is Mutual

A dark cloud is beginning to form over our heads as we are getting that uneasy feeling that the monster known as police brutality is again rearing its ugly head in our community.

Fortunately however, the silver lining behind this dark cloud is that the Officer Commanding this western police formation appears ever ready to lend a keen ear and to take corrective action whenever any such report comes to his attention.

Police brutality is an indication of an advanced stage of indiscipline which begins in subtle ways like those policemen, who in contravention of good order and discipline, are increasingly seen disrespecting the uniform they wear by walking the streets without their regulation head dress. These violators of the police code of discipline sometimes feel like it is cool to be walking the streets without their caps but the display of indiscipline stands out like a garbage man at a party for anyone who is familiar with the disciplinary code within uniform services.

Indiscipline begins in these subtle ways and it inevitably evolves into disregard for the established Judges Rule as it pertains to the use of justifiable force and harm. This advanced stage of indiscipline is first perpetuated against those outside the fraternity ultimately moving inwards. This quite possibly could have been the case a few weeks ago when an armed, drunken, on duty policeman in uniform came within inches from blowing off the head of a fellow policeman. This same policeman is at the center of another accusation of police brutality that same weekend.

The question we ask, where was the commander of this policeman's relief. Why was this policeman not sent home when he was found to be drunk on the job? If he was not sent home or at the very least, why was he not relieved of the 9 mm regulation pistol that he was carrying whist drunk on duty?

The policeman, victim in this incident, walked for many days with a black and blue mark below the right eye where he was poked with the loaded cocked pistol.

In this case the offending policeman is said to not be known for such behavior. However, this same policeman recently went through the traumatic experience of the loss of two brothers,

victims of murder by bandits suspected to be Guatemalans from across the border. At the risk of being accused of attempting to justify the actions of this policeman we ask: where is the support system for those within the department with this kind of baggage? Why are these individuals deployed, with a police gun, at the frontline in contact with the community?

In the final analysis, we would be remiss not draw attention to the fact that policemen are human being with feeling like all of us, given that they are supposed to be trained to exercise restraint under pressure, the cardinal rule nonetheless applies: *respect is mutual and if we want the police to treat us with respect then we should likewise treat them with respect.*

## Dis Da Bull Crap

Former policeman **Jose Zetina**, who was convicted of murder and was serving a life sentence, is freed of the conviction, and sentence, by the Court of Appeals. Relying on the laws of Belize, I suppose, they told Zetina that although he brutally murdered his young, pregnant common-law wife, in the presence of their young son, he was not guilty of murder.

Said our court story, ***"Jose Zetina's crime was remarkable for the unspeakable cruelty with which he butchered his young common-law wife. He stabbed her seven times in the head, jaw and chest. He also cut off her left arm. The entire savagery was committed in the presence of the couple's one-year-old son."***

But our laws excuse you, they told the murderer, because she provoked you by making you jealous, and it was out of jealousy that you killed her.

Therefore, jealousy makes it not murder, but only manslaughter, and we'll give you 20 years, not life. The court didn't tell Zetina, but we all know that with good behaviour, he could be out of prison in 12-15 years.

So ladies, remember this: don't make your boyfriend/husband jealous. He could stab you up, shoot you up, chop you up, or strangle you to death. He can kill you savagely, like an animal, and you know what? It can't be murder. The best he'll get is manslaughter, and the worst he'll spend is maybe a little over 10 years in jail, for taking your life.

So, ladies, I repeat — remember: don't do anything to make your boyfriend or husband jealous. The provocation to him could be a deadly mistake for you.

That was the unmistakable message handed to you from the judges at the Appeals Court, based on our laws that jealousy is an acceptable mitigating circumstance for a man to kill a woman. Our laws, we now know, don't require the man to

have self-control; nor to remember that life is sacred, because you can't say you're sorry, and you can't give it back; nor to remember that if the woman wants another man, that is her right.

Like I said, **this is bull crap.** This *"stchupidness"* is what the Attorney General needs to be looking to rectify. There are a lot of similarly worthless, stupid laws that need to be removed, or amended, in our law books, but just because they mainly affect

the poor, as usual, nobody in authority cares a damn. Sometimes, I wonder why we need an Attorney General. Isn't it his duty to look at these things, with a view to making better laws for all our people?

Well, we men are "covered." Women, are you going to take this foolishness sitting down?

\*\*\*\*\*

One more thing. Why in the name of common sense do we have to have a trial for criminals caught in the act? Police hear about a break-in in progress at a business, and hasten to the scene. They search the building and hiding in the attic they find two thieves.

I mean, the *"attic dwellers"*

can't claim to be family members, workers or anyone else who would have a right to be in the building, but just forgot to go home.

Besides, when you look at them, why, it's those same two rascals who have a record as long as your arm for *"crookery"* — career criminals by any description or criteria.

Courts cost money — we have to pay the magistrate, the police, the court officials, the electricity, etc. So why isn't there a law that criminals caught "with their pants down" forfeit their right to a trial — they are simply taken to court, the facts read out, and the sentence declared.

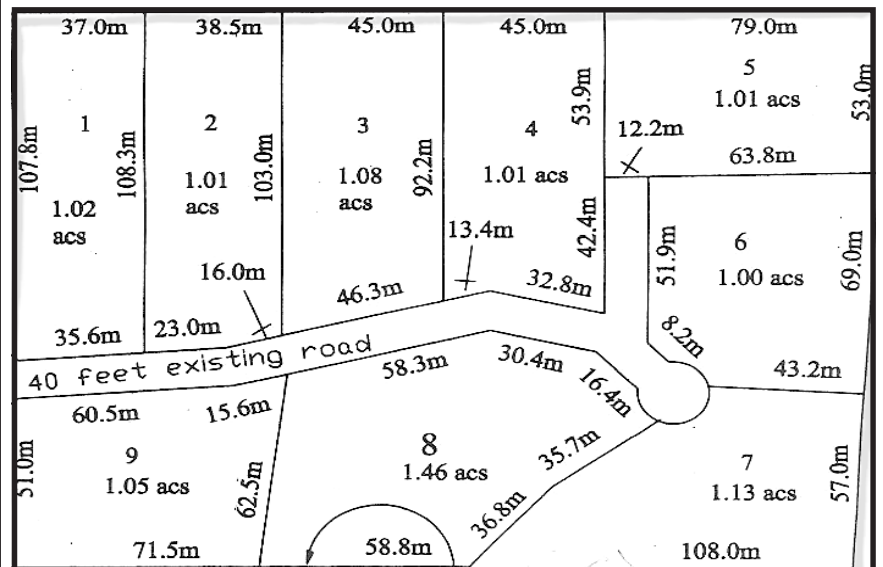

colleagues from San Ignacio Town, detained him and escorted him over to the nearby San Ignacio police station where the report was lodged.

In supporting the allegation, the merchants handed over four worthless cheques, in the total

sum of \$1,104, two of which were redeemed at Shoppers Choice Store on Hudson Street and the other two at Westside Store on Burns Avenue.

The accused carries a British passport in the name of **Kent Charles Leyton**, 47. Also in his possession was an Atlantic Bank

cheque book with several unused cheques. He was formally arrested and charged with 4 counts of obtaining property by deception. He is scheduled to appear in San Ignacio Magistrate Court on Friday, June, 19.

In the meantime, the police is advising the public in

general and the business community in particular to exercise extreme care when honoring personal, as well as company, cheques presented by persons with whom they are unable to make contact in the event that such instruments are declared unredeemable.

# SUSPECT IN FATAL TRAFFIC ACCIDENT WALKED OUT OF THE POLICE STATION

home village along with fellow villager Eddy Panti in the front passenger seat when the Dodge Dakota, traveling in the opposite direction – from Benque Viejo towards San Ignacio, when a driver’s worse nightmare reportedly occurred. The Dakota reportedly overtook a vehicle traveling in the same direction and in the process emerged directly in the path of the approaching Mazda car resulting in a head on collision.

Reports indicate that the Dodge Dakota was driven by Manuel Sanchez, 22, Belizean, laborer of a Guadalupe Street address in San Ignacio who was accompanied by Abner Ortega, 19, and his 18 year old brother, Ernan, both Belizean laborers from Santa Familia Village.

All five injured persons were rushed to the San Ignacio Town Hospital where, the driver of the Mazda, Edwin Valencia, was officially pronounced dead by the medical officer on duty while the passenger in the Mazda car,

Eddy Panti, was stabilized and rushed to the Karl Heusner Memorial Hospital in Belize City where is condition is said to be improving.

The driver of the Dodge Dakota, Manuel Sanchez and two Ortega brothers who were traveling with him, were treated at the San Ignacio Hospital for various bodily bumps and bruises and later released. The Ortega brothers proceeded to their home in Santa Familia village while Sanchez was released into police custody where a sample for the testing of alcohol in is system was obtained.

With due consideration for his medical condition, the injured Manuel Sanchez, was not confined to the regular holding cell but was instead allowed to remain rather loosely in the statement recording section inside the police station where he remained all of Friday night while the process was underway to formally charge him for manslaughter by negligence and

a possible drunk driving charge depending on the outcome of the test for alcohol in his system at the time of the accident. However, it was not until around 6:00 am on Sunday morning when police became aware that he was not inside the station and that he was gone.

While the search for Sanchez continues, his mother and his wife were detained as investigators were contemplating pressing charges for harboring a fugitive against them but after being held for several hours, they were released without charges, Up to press

time this Thursday night the accused remains at large while there is mounting suspicion that he might have fled to a neighboring Central American country.

The body of Ewdin Ivan Valencia was subsequently transported to the morgue at the Karl Heusner Memorial Hospital in Belize City where Forensic Specialist, **Dr. Mario Estradabran** conducted the legally required post mortem examination on Monday, June 15 certifying the cause of death as acute lung failure due to chest trauma resulting from road traffic accident. Valencia was laid to rests on Tuesday, June 16 in the village of San Jose Succotz.
