Liberty And The Pursuit Of Happiness

It's a wonderful feeling to be back after taking a break for some travels, rest, relaxation and spending quality time with family and friends.

After being away from the office for a couple of weeks and upon returning, we realized that our working and living environment could do well with some remodeling and so we took the first week off to change a few things around in order to spice up the working and living environment.

We are now ready and reconditioned to continue serving you with renewed vigor.

We are therefore plunging right into the mix of things and we start of off by expressing a heartfelt thank you to all those many persons who expressed genuine appreciation to see us back in town.

We were somewhat disheartened however to have returned to a wave of accusations of brutal and other less subtle, but nonetheless serious forms of abusive behavior on the part of a few elements of the local constabulary.

The case that stands out among others is the alleged beating of taxi driver, **Bernard "Banner" Anderson,** further details of which is contained elsewhere in this edition of the newspaper.

On a rather personal note, there was the case of a close relative of ours who was arrested and charged for handling stolen goods despite the fact that the arresting officer in his report provided no connection to the accused and the reported stolen goods but when the arresting officer brought this discrepancy to the attention of his immediate supervisor, the alleged response was: "You go ahead and charge his r - - s. Let him deal with that in court".

A request was consequently made for a revision of the facts and when the matter was brought before the court the prosecution informed that there was no evidence against one of the three accused and he requested that the charge be withdrawn against the accused but only after the accused had spent over 24 hours in a prison cell and was deprived of a full day's pay.

This was indeed a troubling experience as it leaves us to seriously wonder how many innocent persons have either been shipped off to prison or released on bail with having to take time out to appear in court on the many adjournment dates until the matter reaches its natural conclusion with the case being eventually struck out for want of prosecution.

This kind of abusive behavior, in our humble opinion, flourishes when those who should legally provide the check and balance against such abuses are ignorant to the important role they play within the community as officers of the court.

We are specifically referring to those untrained Justices of the Peace who, oftentimes because of political patronage, wake up one morning with the JP title suffixed to their names and without fully understanding their role.

We have said it before and we will say it again. Among their many duties and functions, a Justice of the Peace stands as a check and balance against the abuse of authority by those charged with enforcing the law.

By law, before effecting an arrest, a policeman, of whatever rank, must first swear to an information and complaint, then obtain a warrant of arrest before proceeding to deprive any citizen of his constitutional right to "*liberty and the pursuit of happiness*" as is enshrined at section (e) of the preamble of the Constitution of the Sovereign Nation of Belize.

What does swearing to an information and complaint mean? It means, Mr. Justice of the Peace, that a policeman must provide you with the facts of the charge and the basis on which they intend to deprive any citizen of their constitutional right to freedom.

This ignorance to the law is not only confined to new Justices of the Peace but it likewise exists among some "senior" ones. In fact when this procedure was recently brought to the attention of a "senior" JP his response was "NO, NO, NO, I cannot ask the police to show me any statement they have against anyone. Those



statements are confidential police matters and if the police begin to show us these statements the information could be leaked to the accused."

What this "senior" JP obviously does not realize is that in putting forward a defense, every accused person must, by law, be given full disclosure, before proceeding to trial. That disclosure, Mr. Justice of the Peace includes every bit of documentary evidence and statements that the prosecution intends to use against the accused. However, by the time this is done, the accused would have either been remanded to jail or would have been subjected to the inconvenience of having to take time off to attend those many adjournments.

Mr. Justice of the Peace, please be informed that you are under no obligation to sign any arrest warrant for any policeman if you are not fully satisfied that the information and complaint presented to you warrants the depriving of that individual's right to freedom.

We will venture to say that very, very, very few are the Justices of the Peace, if any who have ever requested to review the evidence against an accused person before signing a warrant of arrest. In fact, we would even venture to say that there are some Justices of the Peace who irresponsibly hasten to sign their names to arrest warrants without even as much as reading the paper on which they affix their signature. The saying therefore holds true that "Cow know whe weak fence deh" and so these irregular policemen flack to these weak fences.

There was also the case this week where a youth was brought before the court on two charges: (1) resisting arrest and (2) indecent words. In the absence of a substantial charge, these two minor charges should never be allowed to stand independently in court. The obvious question should be: What arrest was the accused resisting in the first instance? In the obvious absence of a substantial charge, what the accused was actually resisting was the unlawful detention by a policeman and obviously whatever scenario might have occurred was actually instigated by the one attempting, without obvious legal cause, to deprive a citizen of his constitutional right to liberty and the pursuit of happiness.

Channel 7's Jules Vasques Is Opposed To Police Censorship

Dear Mr. Palacio

I write informally to note my disapproval of an increasingly evident tendency to sanitize the police press releases by first, not releasing the names of victims of crimes and now, not releasing the addresses where crimes are committed.

For example, in the recent home invasion, Belize City residents have a right to know if happened in their neighborhood for their own personal and domestic security.

This deliberate non disclosure is contrary both to the mandate of a government elected on a platform of transparency and to the ideals of a democracy established on the bedrock of an informed, alert citizenry.

It is also non productive, because when the accused persons go to court all the names and details are necessarily released because – as is the case in democracies - we have an open court system (by the evidence of this arbitrary abuse of power is suspect, if the police had it their way that too would change – thankfully they don't). I note also that this deliberate non disclosure is

against the Police Media Policy. It is also applied arbitrarily, some names and addresses are released, others are not; I'm not sure who makes those decisions and based on what criteria.

I don't know if the decision is

yours, or if it is taken at a higher level but the press cannot stand idly by and just watch it happen. I will publicize it, oppose it and lobby to have it reversed. I will encourage others to do the same. **Thanks**

Medical Equipment for Countrywide Distribution

MINISTRY OF HEALTH, BELMOPAN, Cayo, Tuesday, September 8, 2009:

The Ministry of Health, through its Health Sector Reform Programme has purchased medical equipment valued at over BZ \$1.6 million to be used in public hospitals countrywide. The equipment includes hospital beds, bassinets, pediatric cribs, delivery tables, equipment, dental fetal monitors, examination tables, incubators, nebulizers and wheelchairs.

According to the Minister of Health, Hon. Pablo Marin, the procurement of this equipment is a direct result of the Ministry's continued efforts to fulfill the health needs of the Belizean people by improving the efficiency, accessibility and quality of health care services.

The supplier of the equipment is Development Relief Corporation B.V. who will also be providing the Ministry of Health personnel with training for the maintenance of the equipment.

The Belize Health Sector

Reform Project (HSRP) is a multi-faceted approach to modernizing the country's healthcare system. The HSRP is a process aimed at introducing substantive changes in the different structures and functions of the sector, with a view to increasing the equity of its benefits, the efficiency in its management, and the effectiveness of its actions; and through this to achieve the

Unemployed Cuban Pleas Guilty To Drug Trafficking As Belizean Co Defendants Joins Him In Jail On Remand

SAN IGNACIO TOWN. Cayo, Monday, September 07, 2009:

Four persons traveling in a small green car were arrested and charged for drug trafficking when police, at the vehicle check point in Red Creek, found two buckets of marijuana inside the trunk of the car.

San Ignacio police informs that it was around 10:45 on the night of Sunday, September 6, when a green, four door, Mazda car with Belize City private license plates BZ-C-00297, with four occupants, pulled up to the Police Check Point in Red Creek, between miles 65 and 66 on the Western Highway. The car was traveling eastbound towards Belmopan from Santa Elena.

The out of town license plates, the late hour of the night and the nervous behavior of at least one of the car's occupants, prompted the police to order them out of the vehicle for a thorough

inspection.

When the trunk of the car was opened, police came upon two plastic buckets containing marijuana. The occupants were advised of the discovery and were all detained and transported to the police head station in San Ignacio and later to the San Ignacio hospital where the buckets were weighed in their presence.

and white bucket which registered 13 pounds while the other one, the red and white bucket, clocked 10 ½ pounds on the scale, for a total haul of 23 ½ pounds of the prohibited substance.

First on the scale was a blue


All four accused were escorted back to the police station where they were formally arrested and charged for two counts of drug

Belizean, cane farmer of a Jasmin Street address in Orange Walk Town and 4) Gian Torres, 19, Belizean, student residing on Sittee River Street also in Orange Walk Town.

On Monday, September 7, all four accused drug traffickers appeared before San Ignacio's new magistrate, Ms. Rachel **Montejo**, where Pasqual Terrero wasted no time in pleading guilty to both charges. He accepted the facts of the case as presented by prosecutor George Gomez. He ordered to forthwith pay a twenty thousand dollars fine, being ten thousand dollars for each count, plus ten dollars cost of court. In default of paying the fine, Terrero would spend three years for each count in jail. The jail time was ordered to run concurrently, for a total

of three years imprisonment on both counts. He was unable to come up with the money and was transported to the Belize Central Prison until either the fine is paid or the three years sentence runs out.

The other accused, Serafina,

Andre and Gian Torres all pleaded not guilty to both charges. Although Pasqual Terrero, in essence "took the rap", charges against the other three co-defendants were maintained by the prosecution and since the combined weight

of the marijuana exceeds the 18.1 pounds as stipulated by the Misuse of Drugs Act, no bail could be offered and all three accused were remanded to the central prison until Tuesday, October 13, for their next appearance in court.

RE: Proprietor "Faya Wata"

I represent Mr. Eric Tobar proprietor of "Faya Wata" night club who has retained me to write this letter on his behalf. Mr. Tobar is in receipt of copies of letters written by one **Ronald** Garrison to various persons including the Liquor Licensing Board San Ignacio Town complaining that "Faya Wata" night club situated on Burns Avenue has been a nuisance (refer copies of letters for ease of reference).

Mr. Eric Tobar said he is the owner of "Faya Wata" night Club.

This club has rented a space from Nazim Juan who is the owner of a building complex situated on Burns Avenue, San Ignacio Town, Cayo District. Mr. Tobar said that at present he has complied with all the legal requirements of the Liquor Licensing Board, The Town

Board, the Central Building Authority and the Environment Department.

Mr. Tobar said the establishment is properly sound proof and strong security has always been maintained. This could be attested to by the Police Department in San Ignacio. Mr. Tobar said the particular time i.e. 15/8/09 which Mr. Garrison was complaining of is a complete falsification. On that day in question no extension was granted since the Town Board was having their own activity at the Oscar Manzanero Complex (this could be verified by the San Ignacio Police).

Mr. Tobar said that a minor was in fact stabbed in Cayo but this incident did not happen inside his night club where there is always a strong security presence and all persons are searched and are not allowed to carry weapon of any kind.

Apart from Mr. Ronald Garrison no other member of the public within the area of the night club has made any complaint. Mr. Garrison does not live on or near Burns Avenue. He live and reside somewhere in the vicinity of the road leading to Benque Viejo.

Mr. Tobar has requested that I copy this letter to all the persons to whom Mr. Garrison has complained so that they are appraised of the true situation and could verify these things for themselves.

It would appear that Mr. Garrison is a lone Caucasian thinking that he can dictate terms and conditions to Belize Police Officials and when he does not get his way try to publicize thing in a negative way.



the police that he was sick in bed since Sunday morning but that he will nevertheless comply with their request.

He said that when he arrived at the station a senior policeman was already there and this policeman immediately began to accuse him of being involved in the robbery at the Chinese Supermarket.

Banner informed that he insisted that he knew nothing about the incident. The senior policeman reportedly instructed a team of subordinate officers to "Take him for a ride up the road". His hands were handcuffed behind his back and he was shoved inside the pan of the police blue D-Max patrol pickup and transported to a feeder road off the Western Highway between San Ignacio and Benque Viejo Town. When the vehicle came to a stop, he was shoved outside the vehicle and landed on the ground thereby sustaining the first injury being a scrape to the left side of the temple.

He was reportedly approached by one of the officers who inquired about the nature of his illness. When he indicated that he was suffering from abdominal pains, the policeman gave him a solid punch in the belly.

All four policemen reportedly sprang into action as they allegedly took turns beating him with their hands and kicking him with their boots. The special constable in particular went into the nearby bushes where he broke a tree branch and began whipping him with it and when it broke he allegedly went for another and continued the beating all this time Banner was rolling on the white marl ground.

During the beating his hands remained cuffed behind his back and one of the policemen allegedly yanked his hand backward and this was when

"Banner" Bernard Anderson, 29, a Santa Elena taxi driver, alleges that he was wrongfully accused, illegally detained and brutally beaten by four policemen attached to the San Ignacio Police Detachment.

Anthony's Supermarket was robbed by two masked, gunmen at around 8:45 pm on Wednesday, September 2 and within half an hour of the incident a team of policemen from the evening shift came banging on the door of Banner's house located in the Trapiche area of Santa Elena Town.

When he answered the banging he was confronted by the police and told that he was wanted for questioning in connection with the robbery at Anthony's Supermarket. He told

he reportedly heard a crack and realized that his shoulder bone was pulled out of place.

After what he said seemed like an eternity, the beating eventually stopped and he was placed back inside the vehicle and returned to the police station.

He alleges that upon arrival his common-law wife and some of her sisters were already gathered at the entrance to the station. Banner said that upon seeing their presence, one of the policemen alighted the vehicle, entered the police station and opened a side door to the cell block through which he was smuggled into the cell block area. He was locked down still with his hands cuffed behind his back and with the metal handcuff scarring his bleeding wrists.

He remained inside the cell in terrible pain and it was not until about two hours later when a corporal who took over the shift rendered assistance by removing the cuff off his hands.

Early the next morning he was escorted to the San Ignacio hospital were the medical officer on duty ordered an x-ray of his shoulder and so he was transferred to the Loma Luz

hospital where the x-ray reportedly showed a displaced shoulder bone. The medical staff on duty advised that he be transported to the Karl Heusner Memorial Hospital in Belize City but he was instead returned to the police station and to the jail cell.

He alleges that his pleas for medical attention was ignored and when the pain became unbearable around midnight on Thursday, he was returned to the hospital where with the assistance of an attendant the doctor was able to snap his shoulder bone back in place.

It was round 12 midnight when the ambulance departed San Ignacio transporting Banner to the Karl Heusner Memorial Hospital with instructions for immediate surgery to remove clot blood for his abdomen. He alleges that upon further examination at the KHMH, the medical staff came to the determination that the clots could be extracted by non-surgical means and thus the treatment began.

He remained all day under police guard at the KHMH and it was shortly after 7:30 on Friday night that the police guard advised him of the message indicating that San Ignacio Police ordered his release and the removal of the guard.

Shortly thereafter he was discharged from the hospital and when he enquired about being transported back to San Ignacio, he was reportedly told that he was free and that he could do as he likes. With the help of relatives he boarded a bus for the journey back to Santa Elena, Cayo from Belize City.

When he reportedly inquired about the return of his car and his cellular phone, he was allegedly advised to wait until







of an Avella Street address in Santa Elena Town.

While the Casildo brothers and Welcome are behind bars, the man hunt continues for a fourth suspect indentified as **Anthony** Roches, Belizean, laborer of a Red Creek address.

It was around 8:45 on the night of Wednesday, September 2, when two, masked armed gunmen entered the Chinese Supermarket and held up the owners of the store, **Edith Chen** and her 56 year old mother.

One of the assailants was armed with what appeared to be a handgun while the other carried what appeared to a shotgun.

The store surveillance camera recorded the incident in 40 seconds from the time the armed gunmen entered the store to the time they departed.

for a total value of \$3,700.

Propoprietor of the Store, Anthony Chen, reportedly saw the gunmen as they entered the store. However, by the time he rushed to the back of the store and returned with his licensed 9 mm pistol, the gunmen had already pulled off the act and reportedly boarded a waiting dark color car that was parked

about 75 yards from the store. The car then sped off towards San Ignacio Town. Chen fired two shots into the air but as the car sped off.

The accused appeared befor San Ignacio's magistrate, Rachel Montejo and were remanded to the Hattieville prison until the next court date on Thursday, October 8, 2009.
