Life Would Have Been Much, Much Worse Under A PUP Government.

Challenges confronting the national economy are by no means minuscule as publicly announced by the Nation's Prime Minister/Minister of Finance, **Hon. Dean Barrow.**

There is an estimated \$M60 deficit in the up-coming budget. This is the current reality. However, we can only imagine what life would have been like if there was not a change of government two years ago.

Prior to the United Democratic Party (UDP) victory at the polls on February 7, 2008, for all intents and purposes, the international financial structure was still intact. It was only subsequent to the UDP victory at the polls, two years ago, that the international financial collapse began.

Belize's finances however, began to feel the strain around midway in the second term of the Musa administration.

We recall that the nation was defaulting on its debt payment. Belize's financial ratings was at the very bottom of the barrel. International Financial Institutions like the World Bank, the Caribbean Development Bank and the Inter-American Development Bank were simply refusing to do any business with the previous administration primarily because of the nation's poor credit ratings. In desperation, the government of the day was forced to scramble for expensive money and so they turned to loan sharks just to keep the national economy from total collapse resulting in the ballooning of the national debt to almost 3 Billions dollar with nothing to show for it as, in most instances, the expensive finance was consumed in recurrent expenditures primarily for salaries and wages.

All of this was taking place while a privileged "accommodated" few dodged paying their rightful share of taxes while others were outright stealing the expensive money.

In those days the financial credibility of that administration was virtually nonexistent. We emerged from that era when, in the face of natural disasters, donor agencies routinely bypassed the elected government of the day and instead channelled assistance to those affected through private institutions.

Life today in Belize is certainly not a bed of roses, but imagine what it would have been like today if the PUP was returned to government. Assistance from international financial institutions evaporated at least 2 1/2 years before the PUP was booted out of office.

The expensive money was getting out of control and like Mark Espat predicted "One of those bullets will eventually strike through the heart of the Belizean economy".

There was a change of government on February 7, 2008. The change, coupled with the hard work and dedication on the part of the new Prime Minister/Minister of Finance, signalled the gradual restoration of fiscal credibility for a collapsing nation as new affordable financing and grants are now beginning to trickle in.

The opposition says: "No Job Noh Deh". The reality is that the pervious administration was heading to the point, like a Caribbean sister nation, of being unable to meet their wage bill. And like the other sister Caribbean nation state having to turn to the dreaded International Monetary Fund for bail out financing

"No Job Deh" the opposition cries. The reality, under a PUP government, would have been far worst as while public officers worked, their pay would have been delayed or even worse they would get no pay at all. This would have been nothing new for the PUP as some public officers still recall those days when

Pumas FC likewise defeated the Green Machine by way of penalty shots and the reigning Sub Champions, Real Benqueño eliminated Benque United by a score of 3 goals to 1.

In the first game of the second round Arenal FC defeated Regaee Boyz by a score of 4 to nil. Falcons FC edged Riverside FC 2-1 and Juventus y Jaguars played to a scoreless draw resulting a victory for Juventus

from penalty shots. Pumas FC scraped to the finals after a tight encounter against Real Benqueño.

In the semi final round, Arenal FC defeated Falcons in penalty shots and in similar fashion Pumas emerged victorious over Juventus.

The marathon ended shortly after 10:30 pm with Arenal FC in first place followed by Jaguars FC in second and Pumas FC rounding of the three top finishers.

Meanwhile in the nearby village of San Jose Succotz, the ceremony began at 11:00 am with Hon. Erwin Contreras delivering uniforms and football to each of the 7 participating teams.

Two Major Constitutional Amendments Passed

Last Friday Belize's House of Representatives passed two major constitutional reforms as follows:

a) The appointment of an Attorney General from the private Lawyers field removing the requirement for that individual to either be an elected member of the House of Representatives or an appointed member of the Senate and

b) To make the Caribbean Court of Justice the final court for all appeals thus effectively replacing the Privy Council in London. With this particular constitutional amendment, Belize now joins Guyana and Barbados as the only three English speaking former British colonies in the Caribbean to move in that direction. Notwithstanding, many other inland states in the Caribbean are speeding up legislation in their respective jurisdictions to do likewise.

These two constitutional amendments were passed into law after the ruling United Democratic Party (UDP) government withdrew a provision that would have allowed Belizeans with dual

citizenships, mainly Belizean Americans, to seek election to the House of Representatives or for appointment to the Senate while retaining dual nationality status.

The proposed dual citizenship amendment was strongly rejected by the opposition People's United Party (*PUP*) and other Belizeans who are disgruntled with Belizean American citizens for leaving their country.

Notwithstanding the PUP's opposition to the proposed amendment, the ruling UDP government has a 25-6 majority of seats in the current House of Representatives.

This supermajority is more than enough for the government to proceed with any amend the Constitution of Belize.

Prior to enacting these amendments, a constitutional reform committee was created in the House of Representatives to conduct consultations throughout the six districts of Belize to hear out the views of the Belizean population.

Most of these community meetings were packed and many Belizeans expressed their views and concerns over these issues.

With the rising murder rate currently in Belize, Belizeans are disgusted with the current system where the Privy Council in London continues to commute the sentences of murderers from the death penalty to life im prison or at times acquittals due to some technicality or another.

The provision to grant Belizeans with dual nationality the right to contest elections to the House of Representative or appointment to the Senate caused heated arguments and debates during the consultation process.

Belizean in the United States were more in support of this legislation than those living in Belize.

The decision to withdraw this provision when the UDP has the majority votes to pass it, was, in my opinion, not a wise one.

The PUP has always been a party that delivers whatever their people want despite the opposition coming from other quarters.

If the UDP had passed that legislation, Belizean Americans

would have consolidated their support for them indefinitely. Now that they have failed to deliver this promise, Belizean Americans might start to think that both the UDP and the PUP are the same when it comes to addressing the concerns of Belizeans living in the United States and elsewhere.

Over the years, Belizean politicians, from both major political parties, have been visiting the United States during election time making lots of promises but have failed in delivering them.

Most Belizeans possess dual citizenships as is spelled out in the Belize constitution. In addition, they have played and still play a vital role in the development of their homeland. However, there has been no program by the governments of Belize that will benefit and encourage Belizeans living abroad to get involved and do some significant things for their country.

In major US cities like New York, Los Angeles, Chicago, Houston, Miami, Detroit, New Orleans and other metropolitan areas where Belizeans reside, they encounter hard times renewing their passports, obtaining Belizean documents and communicating with their diplomatic representatives regularly on matters of major concern and interest. In other words, Belize's diplomatic service in the USA is poor.

The right to vote by proxy from abroad is not even being discussed and it appears as if both political parties are against it despite the fact that this is a constitutional right to which Belizeans living abroad are entitled. I am yet to hear of the current government's position on this issue.

With the passage of this latest constitutional amendment, I expect the PUP to continue opposing the provision that will now legally allow private attorneys to be appointed as Attorney General without being either a member of the House of Representatives or the Senate. The opposition PUP is using the arguments of accountability to the people as the main reason why they are against it and the fear that the current Prime Minister will appoint a close

friend or a relative to that position.

Every political party in Belize is guilty of appointing friends and relatives to public offices in Belize.

In many cases some of those appointed by the PUP, were not even qualified for the posts to which they were appointed. Most appointments were due to loyalty and dedication to their political party.

As for the change to the Caribbean Court of Justice, the PUP was always in support of that change.

Belizeans with dual citizenships will not sit down idly by and drop dead. They will now have to launch an aggressive campaign to bring this issue back to the forefront of Belizean politics.

Another way to achieve their constitutional rights might be to file a case at the Belize Supreme Court on behalf of Belizeans who Possess dual citizenship to force the Belize government to grant them the right to vote by proxy, to become members of the National Assembly as citizens of Belize, to be entitled for land and other benefits that Belize has to offer to all citizens.

The failure to present the 7 Constitutional Amendment Bill for passage with the dual nationality provision is similar to the Democrats in the United States becoming complacent in passing Universal Health Care Coverage to all Americans because of the Republicans obstructionist tactics, when they control a majority in both houses of congress and have a member of their party as the president.

Political science teaches us, that the reason why people give their government power is because they expect them to enforce it and deliver on their promises.

Whenever a government fails to deliver to its people, despite the fact that they possess the means to deliver, the people will become angry and frustrated and remove them from power.





A Policeman, A Soldier, An Electrician, All Facing Criminal Charges On La Isla Bonita, San Pedro

On Sunday, February 21, 2010 about 12:30 am, San Pedro Police visited the Bayside Bar to conduct an investigation into a reported robbery.

Upon arrival the police met **Juan Perez**, 45, a fruit vender of the Corozal District who reported that about half an hour earlier at around 12:00 midnight he was inside his boat named "*Princess Liliani*" along with a helper who is a minor.

Perez informed that they were sleeping when they were suddenly awaken by three men, who identified themselves as Police and BDF officers as they began demanding for "the drugs" to be handed over to them. Perez reportedly told them that he had no drugs.

According to Perez one of the men then began to hit him over the head repeatedly. He was reportedly searched and relieved of a reported \$650.00 dollars in US and Belize currency.

Perez said that he was taken outside of his boat by two of the men whilst the third one searched both the minor and the boat.

Perez reportedly managed to escape from the captors and ran for help whereby the police were alerted.



A Layman's Guide To Climate Change Far More Questions Than Answers

Climate change, and its predicted effects for low-lying underdeveloped countries, creates great angst and uncertainty for ordinary citizens and politicians alike.

They want to know how real it is, how imminent it is, how severe the threats are, and in what forms do they occur.

They question whether enough data have been collected to show irrefutably that we are heading towards an irreversible tipping point with respect to uncontrolled global warming.

They ask if we should hedge our bets and wait, since much of the warming is alleged to be occurring in colder Arctic areas; or should we just play it safe and act. And what should our actions be?

Will these actions have deleterious and negative effects on the country's economy, on development, on everyday lives?

Should the cost of these changes for alleviation be subsidized or financed by the main contributors to global warming?

What should our role be if funds exist, if they do not exist?

What would be ethically and legally required of us under either scenario?

Should the local government provide incentives?

These are just some of the questions that a nation's brain trust must address, and hope in the end, that they have selected wisely and correctly.

Before we continue, some definitions are necessary. While climate change can mean many things, the term is broadly used as a surrogate for global warming: the increased temperature changes because of the greenhouse effect.

Basically, ground reflected infrared radiation heat is trapped in the atmosphere (*like in a glass greenhouse or in an enclosed car*) principally by the so-called greenhouse gases (GHG), water vapor (H₂O), carbon dioxide (CO₂), methane (CH₄), ozone (O₃) and nitrous oxides (NO_x). This action invariably results in higher near-surface land and ocean temperatures.

This is a good thing; it causes the earth to have an average temperature of 59 degrees F (15 C) instead of below freezing.

If that heat had escaped, life on earth would have been impossible!

However, some of these GHG, like CO₂ (organic combustion), CH₄ (cattle burps and rice paddies), have increased beyond its natural levels because of human's activities (anthropogenic GHG).

Carbon dioxide concentration, the principal contributor, has been increasing since the industrial revolution.

In the last 50 years or so, **David Keeling** (1928-2005) at **Mauna Loa**, Hawaii, found a direct correlation between CO_2 concentration and temperature. The CO_2 concentration increased from about 310 parts per million (ppm) to about 380 ppm while the temperature increased 1 to 2 degrees F.

Although other natural warming exists from volcanoes, sunspots, and uncertainties exist because of the role of clouds, most of this new increase is said to have been caused by increased fossil fuel (oil, coal, gas, wood) burning and deforestation and grassland plowing for crops, cattle, and wood.

While oil is still used the most, coal, second in use, is relatively cheap and abundant, but very polluting. It remains a dominant source of electrical energy for the USA, and for growing economies such as India and China, now the largest emitter of CO₂.

The US by far, though, is the largest emitter per capita.

So, is global warming real? Are the scientists and their data reliable?

What do the data show with respect to man-made GHG from a consensus of climate change scientists as exemplified by the Intergovernmental Panel on Climate Change (IPCC)? While contrarian views exist, especially after the East Anglia fiasco in Britain, government officials and ordinary citizens still need to rely on some source of export analysis for direction.

The IPCC, with representation from a majority of countries, and university and government scientists, and with official mandate from the UN and the World Meteorological Organization, presents such analysis. It is their opinion then, that there is a 90% probability that anthropogenic global warming is real, and will get worse.

They contend that the concomitant drop in oxygen concentration as CO₂ increases, means that volcanoes are not the cause, and that only the lower atmosphere is warming and not the upper, as would be happening if solar activities were the cause.

What should governments do? What should the role of the USA and the European Union (EU), China and India, be, with regards to GHG emissions and technology?

Should there be a Cap-and-Trade program where less developed countries can benefit from being less polluting, and from fixing more carbon (sequestration)?

Should the USA and EU share their emerging technologies (*clean coal*) with China and India so that together they can produce better and more efficient "green technologies"?

Should local governments provide businesses and individuals tax incentives for reducing GHG?

How will all this impact local food production and security?

The next pressing questions deserving answers are:

How much time do we have, and how severe are these threats?

Will our lowlands be inundated in the next 5 years from polar and glacial melting and expanded warm oceans waters, our coral reefs gone from bleaching and acidification from increased CO₂, our lands threatened by more storms from earlier warm temperatures off the coast of Africa, our usable waters reduced, our crops scorched, our tourism shattered, our people in disarray?

While a consensus exists that these events are occurring, and that they will get worse based on global warming circulation models, there appears to be no danger in the short term, but a stern warning that we need to change our ways now and reduce our carbon footprints.

We must conserve, reduce, reuse, use incentives to convert to more renewable energy, preserve flora and fauna (diversity), manage chemicals wisely, reforest, revegetate, especially grasses near our waterways, and, yes, stabilize our world's population this century, before we reach that irreversible tipping point!

But what if human global warming is a hoax (less than half in the US believes it's a problem), and just data cherry-picking by scientists to get grants and fame; how uncomfortable would you still be to follow the above prescriptions?

Any person who has a complaint regarding the selling rate charged on US dollar sales may lodge a report to the Central Bank of Belize at 223-6194 with the Manager, International Payments Unit.

The Central Bank of Belize further advised the public that only Authorized Dealers are permitted to engage in the buying and selling of foreign currency. The following entities are Authorized Dealers:

Any unauthorized person or entity who engages in the buying or selling of foreign currency contravenes the Exchange Control Regulations and is liable, upon summary conviction, to a fine not exceeding ten thousand dollars (\$10,000.00) or to imprisonment for a term not exceeding twelve months or to both such fine and imprisonment on a first offence.
