





## Two Thursdays - Two Chinese Businesses Robbed



**Tam's Supermarket on the Bullet Tree Road in San Ignacio SAN IGNACIO TOWN, Cayo, Thursday, April 15, 2010:**

Two Thursdays, two Chinese business establishments, two of them on the Bullet Tree Road in San Ignacio and two of them manned by Chinese women, were robbed.

The first reported incident occurred last Thursday, April 8 when **Liang Shao**, 37, Chinese business woman of a Bullet Tree Road address in San Ignacio Town reported that it was shortly after 9:00 pm that night when two masked male persons of

### It Takes A Village To Raise A Child

The second incident occurred this Thursday, April 15 when **Hong Yan Liu**, 41, Chinese business woman from Tam's Supermarket also on Bullet Tree Road in San Ignacio reported that at around 9:15 am she was robbed by two male masked persons.

Hong Yan Liu informed that she was standing behind the counter when two masked male persons, one dressed in a blue shirt and the other in a black and

red jacket entered her store and demanded money.

One of them proceeded behind the counter and emptied the contents of the cash box into a black bag they brought along.

The robbers reportedly made off with \$600 in cash, \$250 in Smart telephone cards and a carton of Benson & Hedges cigarettes. The incident lasted for less than 2 minutes and was captured on the store's surveillance camera system.

Crimes Investigation Branch personnnel are currently reviewing the tape as the investigation continues.

The Prime Minister and the delegation are scheduled to hold meetings with potential

investors, members of the Belizean community, and the Mayor of Chicago, **Mr. Richard J. Daley**.

During the Prime Minister's absence from the country, Deputy Prime Minister and Minister of Natural Resources and the Environment, the Hon.

Gaspar Vega, will be Acting as Prime Minister.

## Prime Ministerial Delegation In Chicago This Weekend

The Prime Minister of Belize, **Hon. Dean Barrow**, is this weekend leading a delegation on an official visit to the city of Chicago where the delegation will be meeting with city officials, potential investors and concerned Belizeans residing in Chicago, USA.

Since elected to office in February 2008, Prime Minister Barrow has visited two other US cities with a larger concentration of Belizean Americans namely Los Angeles and New York.

On the occasion of the visit to New York City many Belizeans asked questions about; the Belize Guatemalan dispute, prosecuting former ministers of government, crime, gangs, dual citizens rights, proxy voting, land and housing programs, obtaining passports and other documentation, Counselor representation and duties in their respective cities and how Belizeans living in the United States can assist the government in accomplishing their goals and objectives.

I attended the rally that was held at the Manhattan Center in New York City which was packed to capacity and many Belizeans waited in long lines to greet the Prime Minister and Foreign Affairs Minister **Hon. Wilfred Elrington** who also serves as Belize's Attorney General and Minister of Foreign Trade.

In his address to the gathering during the reception Prime Minister Barrow assured the audience that an investigation will be conducted into allegations of illegal acts committed by former ministers of government and as soon as investigations are concluded,

charges would be instituted against those who are found to have broken the law.

The main issue then, had to do with a US\$10 million gifted to the people in Belize by **President Hugo Chavez** of Venezuela for public housing.

# Prime Ministerial Delegation In Chicago This Weekend

This money was later used by the former Prime Minister Said Musa to pay off the debt of a private hospital namely Universal Health Services with the Belize Bank Limited.

Universal Health Services, which has since been renamed Belize Health Partners, is an expensive medical institution in Belize that average Belizean families cannot afford. It therefore caters mostly for the rich people in the country. Several members of the Musa cabinet were against this decision but Musa nonetheless proceeded with using the money to settle this private debt.

Foreign Affairs Minister, Hon. Wilfred Elrington was brief in his remarks. He spent most of his time speaking about government's plans to deal with Guatemala's claim to Belizean land.

Shortly after Prime Minister Barrow's return to Belize from the trip to New York, former Prime Minister Said Musa and his Housing Minister Ralph Fonseca were both indicted on theft charges related to the housing grant from Venezuela.

Even before Musa and Fonseca were arrested, the

Government of Belize was able to successfully secure the return of the Venezuelan money to government's coffers. The money is currently being distributed to provide housing assistance to the poor in every political constituency including those controlled by PUP Representatives.

Also indicted was former Health Minister Jose Coye for some questionable land deal. This was the first time in Belize's history that any former Minister of government was ever indicted for crimes committed while they were in office. Belizeans excitedly await the outcome of all this drama but in the end all three former ministers were acquitted, on technicalities, of all charges.

Belize's Director of Public Prosecution, equivalent to a US District Attorney, expressed an intention of appeal the acquittals of Said Musa and Ralph Fonseca but to date there is no further information on the appeal process. If the appeal is not executed within a specified time, the process will be statutes barred and these men will be free forever and the issue will be dead.

The Foreign Affairs Minister

went full speed ahead in negotiations with the Guatemalans and a simultaneous referendum is to be held in both of countries to give citizens the opportunity to decide if they want the dispute to be heard by the International Court of Justice (ICJ).

While this process is underway, Guatemalans continue to encroach on Belizean's territory at will as if Belize belongs to them. This situation has added more fuel to the fire and increasing tensions along the Belize Guatemalan border.

There was also an attempt to amend Article-7 to the Belize Constitution thereby granting Belizeans with Dual Citizenship the right to run for public office while retaining their Dual Citizenships. This proposed amendment was abruptly withdrawn. Included in the set of amendments was one to change the final court of appeals from the Privy Council in London to the Caribbean Court of Justice (CCJ) and to give the Prime Minister the authority to appoint the Attorney General from the private sector without that individual becoming a member of the Legislative Assembly.

Those amendments sailed easily through the House of Representatives by a party line vote of 25-6. The were later approved by the Senate and signed into law by the Governor General of Belize Sir Colville Young.

Much to the disappointment of the opposition People's United Party, the Privy Council recently ruled that the current government does not need a referendum by the Belizean people to amend the Belize constitution.

The Prime Minister Dean Barrow applauded the court's decision as it now vests him with the authority to return the Dual Citizenship amendment to the House of Representatives and have it passed so that it can benefit Belizean Americans who are desirous of retiring in the land of their birth..

Those of us living overseas, especially in the United States of America, will never forget that it was the People's United Party that was against those of us with Dual Citizenships. They are against giving us the right to run for office in our country of birth because we possess dual citizenships.

The People's United Party has a history of granting amnesty to Guatemalans, Salvadorans, Koreans, Chinese, Taiwanese and others but have no time to address the needs and concerns of native Belizeans. Our last hope therefore rests in the hands of the current government.

The PUP act as if they are angry with us for coming to the United States, to improve our lives, further educate ourselves, join our families, increase our financial reserves and improve our living conditions so that we can help our families in Belize and help to develop our country. After ten years of PUP mismanagement they were booted out of government.

We need to become more proactive in getting involve in our country's affairs because America is not looking like the same country it was when we first arrived. Most Belizeans would prefer to return home if their economic circumstances were better in their homeland and some are thinking about returning home especially since America is going through these economically challenging times.

# Policeman Injured In Bar Brawl

**SAN IGNACIO TOWN, Cayo, Friday, April 16, 2010:**

An off duty policeman is today recovering, on 15 days sick leave, at his home in Benque Viejo Town from stab wounds he received in a bar brawl which occurred during the nighttime hours on Saturday, April 10, 2010.

It was at around 10:45 pm on Saturday, April 10, when police were summoned to the emergency ward at the San Ignacio Community Hospital where they came upon a colleague undergoing emergency medical treatment for stab wounds to the left side of the belly and the upper side of the chest.

**Police Constable # 594 Rogelio Navarette**, currently attached the police sub formation in Benque Viejo town informed that accompanied by his brother, **Abel Navarette**, he was socializing at the Baby Cham Bar on Buena Vista Street in San Ignacio town when his brother became embroiled in an argument with two male persons. PC Navarette informed that he stepped over to find out what was happening. Whilst attempting to find out what was going on, PC Navarette informed that he was attacked by two male

persons whom he said that he was seeing for the first time. One of them reportedly pulled out a knife and inflicted the two stab wounds.

PC Navarette informed that he pulled out the 9 mm police service revolver and fired three shots, all of which missed, at the attackers.

From the San Ignacio Community Hospital, PC Navarette was transported to the Karl Heusner Memorial Hospital in Belize City where he remained or a few days before being released.

Police informed that they are looking for the Landero brothers from the village of Santa Familia who they believe could assist them in the investigation.

The interesting aspect of this particular incident is the presence of an off duty policeman socializing in a bar armed with a loaded police gun.

left merely to extinguish the ashes. At around 5:30 am the incident was brought under control.

Contrary to reports in other sections of the media, Rosalilia Castillo informed that neither the house nor its contents were insured at the time of the incident. She informed that after reconstructing her property in the wake of the December 10, 2005 fire which extensively damaged her property at the same location, she took out an insurance policy but she did not

renew it when it expired on March 31, 2010, being exactly 11 days before this Sunday morning's fire.

In a report to the police,

Rosalilia Castillo estimates the value of the buildings at \$500,000 and the contents at \$36, 895 all for a total loss of \$5036,895.

## **CPBL PRESS RELEASE**

### **FRUIT PRICE SUBMISSIONS**



Citrus Products of Belize Ltd. (CPBL) forwarded to the Citrus Growers Association (CGA) on April 8th, 2010 a revised Fruit Price Submission, for the price to be paid to citrus growers, for oranges delivered to the factories, as per the 2001 Citrus Price Formula ( the Price Formula).

The Price Formula is a long standing agreement that was reached between the CGA and Del Oro Belize Ltd. (now CPBL), on September 14th, 2001. It is used to determine the payment for both oranges and grapefruits delivered by citrus growers to the processing facilities.

The Price Formula provides for the first payment to growers for oranges delivered to be determined by the six-month average future prices for frozen concentrated orange juice (FCOJ) on the New York Board of Trade (NYBOT). The futures market of the NYBOT is a speculative market in which options for FCOJ and other commodities are traded on commodity prices for future delivery periods. The futures market is a volatile market in which prices change daily dependent upon the views that traders hold of the future market prices for these commodities. This volatility is evidenced by the fall in the average six months futures price for FCOJ from US\$1.5363 per p/s on 15<sup>th</sup> March 2010 to US\$1.3558 per p/s on April 6th, 2010 and then on April 8th, 2010 it averaged US\$1.287 per p/s.

Commodities, however, are sold at market prices at the date of sale. This selling price can be lower or higher than future prices dependent on Market trend. Market prices normally follow the trend of the futures market but with a time lag. It is therefore not uncommon for market prices to be between ten to fifteen percent higher or lower than futures prices. This is why the Price Formula provides that subsequent price submissions after the first submission is based upon a combination of actual contracted prices and the six-month average future prices for FCOJ in relation to the uncontracted stock. The Price Formula provides for an automatic price review to take place at any time when the future price for FCOJ changes by more than ten percent.

CGA requested, on March 15th, 2010, a revised Fruit Price Submission for oranges as per the Price Formula, since the futures price for FCOJ was at US\$1.5363 per p/s or 10.23 percent greater than the futures price for FCOJ under the existing price submission sent on December 22nd, 2009 when the price was at US\$1.3955 per p/s. On March 18th, 2010, CPBL forwarded to CGA, the revised price submission for oranges calculated in accordance with the Price Formula. This new fruit price submission reflected a combination of actual Sales contract plus the value of uncontracted stocks of approximately 4.9 millions p/s which was valued using the average six months futures price for FCOJ of US\$1.5363 per p/s. Based upon the Price Formula the new estimated final price for orange fruits was Bz\$1.5227 per p/s, or Bz\$0.0851 per p/s lower than the previous Fruit Price Submission. CPBL advised CGA that although it had the right to deduct Bz\$0.0550 per p/s (i.e. 65% x \$0.0851) from the next payment to growers, it would forego deductions at that time and would wait until the second fruit price submission, due in June 2010, as per the Price Formula Agreement to further assess the situation.

It is important for growers to note that on April 8th, 2010, CPBL submitted to the CGA, a revised fruit price submission in accordance with the Price Formula since the futures price for FCOJ on the NYBOT had fallen beyond the ten percent threshold, warranting a revised Fruit Price Submission. This new Fruit Price Submission showed a further decline in the estimated fruit price of Bz\$0.1316 per p/s. This means that growers have been overpaid by Bz\$0.0855 (i.e. 65% x \$0.1316) per p/s. This should be deducted from the next fruit payment. However, CPBL has, for the second time, offered to forego such deductions and wait until the second submission due in June 2010.

CPBL notes that it is not unusual for the final audited price to growers to be lower than the initial fruit price submission since the final price submission reflects all sales contract and uncontracted carried forward stocks that are valued using the average six months future for FCOJ.

Orange growers may recall that as recent as the crop year 2003-2004, growers were overpaid \$0.057 per p/s as the final price was lower than the price paid to growers using the average six months future price. In this case, CGA agreed with CPBL, as stated in the CGA Minutes of the 37<sup>th</sup> AGM of the CGA held in June 2005 for the overpayment to be treated as an interest free advance to growers, to be deducted from fruit payment due in the next crop year.

It must be noted that the agreement on the Price Formula also provides for the settlement of disputes arising from the implementation of the Formula.

Because of past experiences and the fact that CPBL wishes to pay farmers the best possible price and pay a second and final payment to all growers that CPBL see it prudent to issue this release. Grower's want a second and final payment and CPBL wants also to be able to do this.

Four and a half years ago when I found out that I would be having a baby, I started doing some soul searching. Art was the only avenue that I saw as the perfect language to express what I was going through.

It was an intimate world. A world that reassured, celebrated and defended my identity both new and old. I was manifesting my new self.

I showed some of my art pieces to some close friends and they all encouraged me to look into this hobby as a profession. I was reluctant to do so when I discovered that 90% of artists in Belize are men.

I respect all my colleagues dearly. So this is not to bash any of them. But from what I have seen, the male perspective on art is a lot different.

I came into the art industry from my heart, expressing things that affect me as a woman, mother, lover, sister and many other gender based roles. I often find myself being the voice

of those women who have none or have not yet found theirs. So this isn't just about making money, or making a name for myself, or provoking my 78 year old grandmother with a naked Black Virgin Mary. This is about telling the truth and creating a level of sensitivity towards women that have been used as *"the most expressive art form"*.

My intention is to encourage the countless female artists who are studying nursing, teaching, accounting, while spending countless nights hunched over a piece of paper writing, painting or sketching their hearts out. Do not run away from your true selves. Take a step outside the box and be yourself.

### BTB Launches Paint Beautification Project

The Belize Tourism Board in collaboration with the Ministry of Tourism, Civil Aviation and Culture through its partnership with the Florida Caribbean Cruise Association (FCCA) have embarked on a Belize City Paint Beautification Project.

As part of its destination outreach initiative, the FCCA has donated 225 five-gallon pails of paint that will be used to paint primary buildings in Belize City along the cruise destination route.



A working Committee has been established to manage the identification of buildings that would benefit from the Paint Beautification Project. The Committee comprises of BTB, BTIA, the Belize City Council, the Conscious Youth Development Project (CYDP), Youth for the Future (YFF) and Architect Christy Mastry. The Committee concurred that priority be given to

schools and government buildings.

The structures selected for beautification have been identified as the Housing and Planning building and fence, St. Mary's School fence, the Belize City Council and Thurton Library. The CYDP and the YFF provided the labor to get the job done. The BTB facilitated the organization and logistics in its execution.

Works commenced on March 29th and all buildings will be fully painted by the end of April completing the First Phase of this project. The Second Phase will see more Belize City buildings being painted shortly. The initiative is an active effort on the part of the FCCA and the Belize Tourism Board in collaboration with its partners to improve the appearance of Belize City for our visitors and residents alike.

# Hugo Chávez cries sabotage, while his critics just cry ‘Bananas’

Venezuelan authorities arrested eight Colombians and accuse them of subversive acts

Nation-wide blackouts and rationing have eroded **Hugo Chávez’s** popularity.

It sounded like a **Frederick Forsyth** plot transplanted to South America: Colombian spies in league with the US infiltrated Venezuela to sabotage the electricity supply, sow chaos and topple **President Hugo Chávez**. Venezuelan authorities arrested eight Colombians last week and accused them of subversive acts against the country’s energy infrastructure. They allegedly had photographs of electricity sub-stations, transmission systems and highways.

“*The Colombian government will have to explain this,*” Chávez said during a televised cabinet meeting. “*Some of them had Colombian army ID cards. One of them worked as a medic in the Colombian army, then went to live in Canada, then came to Barinitas. Very strange movements.*”

The arrests – six were detained in the small town of Barinitas and two in the state of Aragua – have

reignited tensions between the Andean neighbours in the run-up to next month’s presidential election in Colombia. President Alvaro Uribe, a US ally who regularly clashes with Venezuela’s socialist leader, responded swiftly: “*The government of Colombia cannot permit violations of human rights against its citizens, whether they live in Colombia or elsewhere.*” A less than convincing claim, given Colombia’s grim record on state-backed death squads.

Chávez also struggled to convince. An energy crisis triggered by drought and under-investment has led to nation-wide blackouts and rationing, crippling the economy and eroding Chávez’s popularity. Last week he extended the electricity emergency for

another 60 days, accusing “*counter-revolutionaries*” of exploiting the crisis by cutting cables, among other tactics. “*Who knows how many power cuts... have been the product of sabotage?*”

Critics and many ordinary Venezuelans scoffed and said the government’s latest claim of a plot seemed something out of Woody Allen’s spoof on tropical despotism, Bananas. According to relatives, five of the detained Colombians are

members of a family that has lived in Venezuela for 17 years and owns an ice-cream factory. Chávez said the factory was a “*façade*”, without elaborating.

He also claims to have thwarted numerous US-backed assassination plots against him. The satirical newspaper Tal Cual reported that the US state department had a clandestine section to train iguanas to sabotage Venezuela’s infrastructure.

# ONE OF TWO GUATEMALAN BANDITS KILLED IN THE PROCESS OF TERRORIZING BELIZEANS

all die. The assailant with the grenade proceeded to demand the conductor's purse. The conductor, **Ricardo Quiroz**, 32, who was seated on the interior hood of the bus engine, reached for the purse which was lodged between the dashboard and the front windshield and handed it to him. He then threw the purse to the one with the gun.

The gunman produced a blue and red nylon bag into which he placed the purse as he walked up to the front of the bus and began pointing the gun at passengers ordering them to put their property into the bag.

Realizing that they were being robbed, some passenger further down the aisle began concealing their property. None of the assailants wore masks.

As the bus was approaching the first street light signaling the entrance into Succotz village, the assailant with the grenade ordered the gunman to hurry. He ordered the driver to open the door. He walked backwards and stood on the bottom step of the bus and this was when a male passenger stood up, rushed towards him and stomped him in the chest. The grenade man fell out of the slow moving bus.

The same male passenger rushed towards the gunman who by this time was in the middle of the bus, he attacked the gunman and threw him to the floor, during the struggle the gunman pulled the trigger of the gun he carried and it snapped at least two or three times. The passenger stomped on his arm resulting in the assailant releasing his grip on the gun. Other passengers joined in the attack on the bandit.

A female passenger was seated in the aisle seat right next to the spot where the scuffle was

taking place. She reportedly hopped over several seats and made her way to the back of the bus. She opened the back door and jumped out landing on the side of the highway. She was later identified as **Lucia Carillo**, 19, Belizean student, from Benque Viejo Town. She was first transported to the San Ignacio Town Hospital and later to the Karl Heusner Memorial Hospital in Belize City. She is currently in critical condition at the Belize Healthcare Partners Hospital in Belize City. She is a 4<sup>th</sup> form student attending Sacred Heart College in San Ignacio. As she prepares for graduation in June, Lucia was reportedly returning to Benque Viejo Town after visiting a friend in San Ignacio.

After the attacker was subdued, the passengers began shouting for the driver to drive the bus directly to the police station in Benque Viejo Town. The driver sped over all the speed bumps on the way to the police station where the injured and bleeding assailant was handed over to police. He was rushed to the San Ignacio Town Hospital where he was officially pronounced dead.

The bloody body, clad in a black T-shirt and blue jeans pants bore many stab wounds to the back.

Police found a Guatemalan birth certificate inside the pants pocket of the deceased in the name of **Wilson Orlando Paz Dominguez**, born in Parcela El Jabin, Santa Lucia Cotzumalguapa in the Guatemalan province of Escuintla.

While the deceased might have been born in the interior of Guatemala, sources close to the investigation informed of the likelihood that he resided in the

bordering Guatemalan Suchitan Barrio which is described as a criminal nest in Melchor De Mencos, Peten, Guatemala.

A post mortem examination conducted by forensic specialist **Dr. Mario Estradabran** on Wednesday, April 14 at the Karl Heusner Memorial Hospital in Belize City certified the "*cause of death as exsanguination, internal and external bleeding as a consequence of multiple stab wounds.*" The body was subsequently handed over to the Department of Human Services and was buried at the Lord Ridge Cemetery in Belize City also on Wednesday, April 14.

A female passenger who was seated next to Lucia Carillo before she jumped out of the moving bus recalls that when the gunman searched her by pushing his hand in her bosom all she could recall was that "*his hand was cold as ice.*" The next thing she recalls is that the gunman was attacked first by a lone passenger and then the girl sitting next to her was gone.

Benque Viejo police informs that every piece of property, including the conductor's purse and the gun, have been recovered as they were all contained in the red and blue nylon bag retrieved from the assailant.

The firearm retrieved from the assailant is a Taurus brand, point 22 caliber, six shooter revolver bearing serial number GG93441 with 3 live rounds of ammunition in the barrel. None of the three bullets had any firing pin indentation, thereby leading the police to assume that either the trigger was not pulled as reported or that the gunman

might have miscalculated the revolution of the barrel and pulled the trigger on three empty chambers.

The recovered property included the conductor's purse containing 788 dollars in cash, 2 cellular telephones, a black wallet, a black plastic bag, a silver plated chain, a bead bracelet, a silver loop earring and 67 dollars in cash.

As they await instructions from the office of the Director of Public Prosecutions, Benque Viejo police are still holding on to the bag of recovered items.

With the possible threat of the presence of a grenade in the area where the bandit was stomped out of the bus, Benque Viejo police merely stood guard in the area until daybreak when, with assistance from the Belize Defense Force the area was thoroughly searched but nothing was found.

This incident has caused major concerns for the senior ranks at the San Ignacio police station especially amidst allegations that two persons, one armed with a grenade and the other with an illegal firearm, were present in the center of San Ignacio Town as they awaited the arrival of the bus. The local senior command informs that, as a preventative measure, officers on patrol will increase searches on suspicious persons in these areas of town.
