SAN IGNACIO TOWN, Cayo District, Friday, July 2, 2010:

San Ignacio police have formally arrested and charged a Santa Elena youth for keeping and firing a gun found behind a house in his neighborhood.

At around 11:50 p.m. on Wednesday, June 30, 2010 just as the evening shift was preparing to wind down their tour of duty for the day, a report was received at the San Ignacio police station regarding the firing of gun shots on Hibiscus Street in Santa Elena Town. The shift commanding Corporal and a team of policemen rushed to the scene where they saw the accused, Jesus De la Fuente, in the company of a female. Police reports that upon seeing the police vehicle De la Fuente reportedly ran behind a house and into the darkness. He reportedly remerged shortly thereafter and was approached by the police.

He was informed of the report received and he denied any involvement with the shots fired. He was detained and searched. Nothing incriminating was found on his person. The yard was likewise searched and again nothing incriminating was

Notwithstanding, De la Fuente was detained and transported to the San Ignacio police station. The following morning, he was taken back to the scene where a search, conducted in his presence, led to the discovery of a small black pistol of unidentifiable brand and serial number was found. The gun, without a magazine, was

found behind the house where De La Fuente had momentarily disappeared the previous night.

were unfolding across the nation, the people of Benque Viejo Town naturally felt short-changed when, between 2001 and 2003, they began to experience the closing down of utility branch offices in their community. ### Santa Elena Man Goes To Jail On Allegations Of Carnally Engaging With A Female Child Two Times

### SAN IGNACIO TOWN, Cayo District, Tuesday, June 29, 2010:

A Santa Elena man was today arrested and charged for two counts of carnal knowledge reportedly committed against the same 13 year old Guatemalan child residing also in Santa Elena Town. The first count was allegedly committed sometime during the month of December 2009 and the second instance allegedly committed on Saturday, June 26, 2010.

Police reports that on Sunday, June 27, 2010, the girl accompanied by her father visited the police station where a formal report was lodged. In a statement to the police, the child informed that at around 11:00 a.m. the previous day, Saturday, June 26, she arrived at the home of an 18 year old female acquaintance on Carillo Puerto Avenue in Santa Elena to assist with house cleaning chores.

The child further alleges that about an hour and a half later, at round 1:30 p.m, a male person, whom she knows as "*Humes*", arrived at the house and shortly thereafter he reportedly gave the 18 year old female a

\$5 bill with instructions to purchase a fry chicken. The child informed that while this person was exiting the house on the errand, she reportedly got up and was about to leave when "Humes" reportedly closed the front door. The child informed that she wanted to leave because about six months earlier, in the month of December 2009, this individual reportedly had sex with her against her will and that more recently, in fact three days earlier, while she was the same house, this same individual reportedly offered her \$50 for sexual favors. On this second encounter the girl reportedly refused, she immediately left the house and returned home.


On this third occasion however, the child informed that after closing the door "Humes" reportedly grabbed her hands, pulled her to a nearby bedroom and proceeded to have sexual intercourse with her against her will. The child further reported that after the forced sexual encounter, "Humes" reportedly placed a cellular telephone on the bed and told her that she could have it and that she should not tell anyone about the encounter and that

if she did, he would kill her and her father.

On Tuesday, June 29, the suspect identified as Timothy Humes, 35, Belizean laborer of a New Area address in Santa Elena Town was formally arrested and charged for the crime of carnal knowledge. He appeared before San Ignacio's Magistrate Anna Rachel Montejo, that same day, where no plea was taken. He was denied bail and remanded to the Hattieville prison and is scheduled to be brought back in court on Tuesday, August 31, 2010.



# Drug/Gang Violence Casts Shadow Over Upcoming Elections In Mexico

Sunday is election day in more than a dozen Mexican states, with voters set to choose governors, state deputies and mayors.

Attention will not just be on the results but on how polling day unfolds given the wave of violence that has marred campaigning in some areas.

Mexico's powerful drug gangs have been blamed for much of the violence, a sign, according to some, of the growing influence of organised crime in the country.

For months, candidates in many of the 14 states holding elections have complained of intimidation by alleged criminal gangs that has forced them to adopt special security measures and limit their campaigning in high-risk areas.

In areas of the country worst-hit by the drugs conflict, which has left some 23,000 people dead since late 2006, political parties admit they have found it hard to find citizens willing to run for office.

One person ready to stand was Rodolfo Torre Cantu of the Institutional Revolutionary Party (PRI), who was favourite

to be elected governor in the north-eastern state of Tamaulipas.

Mr. Torre had spoken about his priority, if elected, to boost security in Tamaulipas, a key battleground between two powerful gangs, the Gulf Cartel and the Zetas, over drug-smuggling routes into the US.

But on 28 June, gunmen ambushed a convoy carrying Mr Torre and his team, shooting him and four of his aides dead.

Mr Torre's murder - the highest-profile political killing in Mexico since the assassination of presidential candidate Luis **Donaldo Colosio** in 1994 - has deepened concerns over how Mexican democracy is suffering at the hands of organised crime. Violence has started to form part of the daily landscape of Mexico Lorenzo Cordoba Electoral expert, UNAM

"There is an escalation in the influence of the drug cartels in Mexican politics," says Lorenzo Cordoba, electoral expert from the National Autonomous University of Mexico (UNAM).

Many see the threats and intimidation of this year's election campaigns as evidence of how Mexico's drug conflict has permeated into the political system.

"Almost all members of my campaign team have received dozens of calls," Xochitl Galvez, a candidate for governor of the state of Hidalgo, told the BBC recently.

The callers "identify themselves as members of organised crime", she added.

The head of the National Action Party (PAN), Cesar Nava, also said recently that many of his party's candidates had received threats which he attributed to the Zetas.

A mayoral candidate for the PAN in Tamaulipas was killed in an attack in May.

The violence has reignited the debate about President Felipe Calderon's decision to take on the cartels and deploy thousands of troops in violent hotspots.

The candidates on the ground have meanwhile learned to take extreme precaution when out trying to win votes.

Take for example the northern state of Chihuahua, where Ciudad Juarez - Mexico's most violent city - is located.

The state's electoral institute was forced to ask for extra protection for candidates who are afraid of campaigning in areas like the valley east of Juarez, a crucial drugs route into neighbouring US territory.

Jorge Abraham Ramirez, the PRI's candidate for state legislator in Ciudad Cuauhtemoc, in central Chihuahua, says that he has taken special security measures on the campaign trail.

"We do not make our daily schedule public, and many times we use decoys. We

announce we are heading for one place and then carry it out it another," he told the BBC.

Alex Lebaron, a fellow candidate in Nuevas Casas Grande, Chihuahua, told the BBC that his team had decided not to hold rallies during the evening and that they kept a low profile when canvassing some areas.

Disruption

Many in Mexico think that local elections are the perfect chance for the drug gangs to flex their muscles - mayors control local police forces and, by being in charge of specific territory, are valuable targets for the cartels' pressure tactics.

Concern is now focused on how violence could disrupt election day and dissuade voters from going to the polls.

The federal authorities say they will deploy extra security forces to make sure the election goes according to plan and that safety for voters can be guaranteed.

#### **Electoral officials sound** optimistic.

"Many said we wouldn't find enough people to man the ballot stations around the state," says Fernando Herrera Martinez, president of the Chihuahua electoral institute. "But we are ready, 100%, to hold the election."

But the violent campaign, electoral export Lorenzo Cordoba believes, shows how Mexicans citizens have become all too used to news of drugrelated crime.

"It's a regrettable scenario, in which the violence has started to form part of the daily landscape of Mexico," he says.

# The Ruling On The Maya Land Case Can Produce Severe Consequences On Belize

The Mayas are the indigenous people of southern Mexico, Belize, Guatemala Honduras and El Salvador numbering about seven million people with cultural differences such as the; Yucatec, Kekchi and Mopan. These differences led to several conflicts and division of land and territories in the region.

Belize is a small country located between Mexico and Guatemala both populated with millions of Maya Indians.

Guatemala has a long history of human rights abuses against these people leading to thousands of Mayas migrating from Guatemala to Belize establishing new settlements even up current times.

While the Mexican government is not as harsh towards these indigenous people, the relationship between these people and the Mexican government is strained especially with those who live in the province of Chiapas.

Centuries ago, the Mayas in Mexico and the Aztecs fought against each other and after the Mayas were defeated many of them fled to Belize adopting Belize as their new homeland.

I am afraid that the recent Supreme Court ruling in Belize will open the flood gates for more Maya Indians to come from Guatemala, El Salvador and Mexico into Belize eventually over populating the country of Belize at the expense of the other Non Maya Belizeans who are still trying to get a small house lot or farm land but are being denied daily.

When the British occupied Belize in 1638 they fought against the Spaniards in several battles which ended with the Battle of St. Georges Caye on the 10<sup>th</sup> day of September 1798. In

the days of colonialism the game was that if you lost the war you lost the land and everything on it hence the reason why colonized countries are experiencing today's challenges.

As a Garifuna, I will urge my people to seriously consider a class action law suit against the Government of St. Vincent & the Grenadines and Great Britain for forcefully occupying and removing our ancestors from our native homeland St. Vincent on the 11<sup>th</sup> March 1797 to other islands and the island of Roatan in Honduras.

Not only were our people forced from their homeland but they were packed on several ships like cargo and dropped off on several other islands along the way unknown to them and separated from their families. Their original names were changed to Spanish names to avoid any trace of their relatives and they carry these label titles up to this day. Hence the reason why Garifuna people today carry surnames like Gonzalez, Nunez, Ramirez, Martinez, Bermudez, Chavez, Gutierrez, Rodriguez, Flores, Garcia and others,

The British encouraged the Garifuna to inhabit southern Belize which at the time was sparsely populated by the Maya Indians. They gave the Garifuna people large parcels of land

which they called "Carib Reserves".

With this recent ruling the Mayas can now question the legality of this action on the part of the British as a test case. If the court rules that the British occupied Belize unlawfully and had no right to grant land to the Garifuna people then the "Carib Reserves" could be given back to the Maya people.

This ruling is taking the country and people of Belize backwards rather than forward and it will benefit those Mayas who were not even born in Belize.

Externally, this ruling plays right into the hands of the Guatemalan government with its long standing territorial dispute with Belize. Guatemala

In exercise of the powers conferred upon it generally by Sections 3, 6, 7 and 22 of the Belize Telecommunications Act, No. 16 of 2002, and Sections 32 and 48 of the Public Utilities Commission Act, Chapter 223 of the Laws of Belize, and all other powers thereunto enabling, the Public Utilities Commission (hereinafter referred to as "the Commission") hereby serves Notice this day, June 30, 2010, to the general public that the Commission intends to make certain amendments to the Belize Telecommunications General Order (Interconnection, Infrastructure Sharing, International Access) No. 1 of 2010, and the Belize Telecommunications Interconnection and Infrastructure Sharing Regulations Order, 2010 that were issued by the Commission on February 12, 2010.

#### Reasons for Intended Amendments:

The Commission intends to make the proposed amendments to provide for the better implementation of the objectives of the Belize Telecommunications Act and for better regulation and control of the telecommunications sector in the public interest.

#### Intended Amendments:

The Commission intends to make amendments to the Orders to the following effect:

- a) To provide that no Licensee shall be allowed unrestricted access to any network or facility for the provision or receipt of international telecommunications services, in order to prevent the provision of telecommunications services in Belize by persons or companies not licensed to provide such services in Belize.
- b) To clarify various sections or provisions in the said Orders which, according to comments received from interested persons, have been a source of confusion or misinterpretation.
- c) To expand and clarify the rate setting methodology or methodologies for the fixing of charges related to interconnection and infrastructure sharing.

Official opening ceremony for the new Emergency Wing of the Western Regional Hospital in Belmopan was held on Monday June 14, 2010.

The Ministry of Health and Belize Natural Energy teamed up with Project C.U.R.E. to ship BZ\$800,000 in medical supplies to Belmopan's Western Regional Hospital.

Project C.U.R.E.'s Philanthro Travel Program visited Belize as part of the initiative whose main patron is the Global Ambassador for Special Olympics and Special Envoy for Women and Children, Mrs. Kim Simplis-Barrow.

The initiative stems from a partnership created between Ministry of Health and Project C.U.R.E. in 2005 to deliver containers of medical supplies and equipment to Belize. Project C.U.R.E. has reached more than 120 countries worldwide.

The New Emergency Wing consist of a "state of the Art" Accident & Emergency Department and two new operating theatres.

Since 2005, Project C.U.R.E. has been working with health partners in Belize and has deliverd an estimated BZ \$9 million in supplies and other medical equipment to hospitals throughout the country.

#### **MOU signed to establish Haemodialysis** units at KHMH and La Loma Luz Hospital

Soon after Cabinet gave approval for the Ministry of Health to enter into an Agreement with the World Organization of Renal Therapies (WORTH) to establish dialysis units, a Memorandum of Understanding was signed on June 3<sup>rd</sup>, 2010 at the Lion's Den in Belize City between WORTH, the Ministry of Health and the Karl Heusner Memorial Hospital and La Loma Luz Adventist Hospital.

The signing of the Memorandum of Understanding will launch a series of historic activities leading up to the establishment of haemodialysis services at the Karl Heusner Memorial Hospital in Belize City and at the La Loma Luz Adventist Hospital in Santa Elena, Cayo.

Through the collaboration of WORTH, a total of eight (8) haemodialysis machines will soon be brought into the country.

A task force has been established to follow through on the establishment of the units at both hospitals. A timeline has been developed to this end with the official opening of the units in September 2010.

### **Senior Steps Program Launched**

The Ministry of Health along with the National Council on Ageing launched its "Senior Steps: Dancing for Health Project" on Tuesday June 1st in Belmopan.

The Senior Steps programme aims to promote active and healthy lifestyles for older persons. It will not only involve dancing, but also educational sessions on nutrition and healthy eating practices, which together will help to improve the quality of life for all participants.

The project hopes to encourage older persons to take better control of and maintain good health.

It will encourage them to understand and apply health information, be self-motivated, have a desire to improve their own health and also actively participate in programs through dancing.

The Program was officially launched in Belmopan City and Corozal where the pilot project will be running simultaneously.

#### **Current Status of Dengue Cases in Belize**

As the rainy season approaches, there is an expected increase in the number of Dengue cases throughout the country.

Current statistical information compiled at the Ministry of Health shows that since January of this year there have been a total of 28 dengue cases confirmed. However, throughout the country a total of 240 persons consulted and were classified as suspect cases, a significant decrease compared to last year when for the same period (January to June) 1,457 suspected cases were recorded.

This year, of these suspect cases 60% correspond to Belize District. The Cayo District accounts for 25%

of the suspected (clinical) cases this year. The other districts have just reported sporadic cases.

In the month of April the Belize District experienced an increase of suspect dengue cases but the weekly number has tapered off.

Of all the suspected clinical cases that attend the public health facilities 70% get tested.

It must also be noted that of the samples tested, 16.5% are reported as positive for dengue.

The public is being requested to make every effort to reduce the breeding sites around the home.



### **BEL Responds to Amandala Editorial on** Illegal Electrical Connections

The June 27, 2010 edition of the Amandala Editorial titled "Profits & People" discusses Belize Electricity Limited (BEL) not doing "business with Kremandala" and the recent electrocution of a Belize City resident. BEL finds it very disappointing that the Publisher of Amandala would use the tragic and unfortunate death of a citizen to try to stir public sentiment against the company, because Amandala is not happy with the medium that BEL uses to advertise.

The tragic electrocution that occurred was seemingly a result of an illegal electrical connection in an unplanned part of Belize City that has no roads or infrastructure.

Illegal connections are an unsafe practice and as this case showed, it can be deadly. The company is very concerned about the safety of the public and repeatedly advises of the dangers. of illegal connections.

Within the past year, BEL has spent over \$5 million on projects to extend power to areas such as the CET Site and Belama Phase IV areas in Belize City. These projects are scheduled for completion by the end of 2010 and in 2011, respectively. BEL continues to work with the Government to extend power to several other communities across the country. However, before BEL can install electrical infrastructure, there must already be roads in a properly surveyed area. The Government of Belize has been doing its part to complete these activities.

It should also be noted that BEL offers a social rate for low income families. BEL is the only utility in Belize that offers such a rate. Over 6,800 customers are benefiting from this lower electricity rate with bills of less than \$11 per month.

In its editorial, Amandala explained and we quote "At Kremandala we have to pay our bills or we will cease to exist. We have to seek profits, so that we can obtain the technology to make us competitive."

Kremandala is right.

No business can survive by losing money. BEL is an essential service, and perhaps even more than Kremandala, the management of BEL has a responsibility to ensure that the company can pay its bills and make a profit to be able to continue to improve its technology and provide an acceptable level of service.

As a responsible company, BEL will continue to discourage illegal connections and encourages Amandala to do the same. BEL will also continue to work with the Government in extending safe power supply to as many communities as possible.

### Remembering The First Graduating Class Of Sacred Heart College, 1964

Let Them Who Have Won the Palm Bear It palmam qui meruit ferrat

SAN IGNACIO TOWN, Cayo District, Thursday, July 1,

Sacred Heart College, with its humble beginnings on Hudson Street in San Ignacio in 1960, is now closing its anniversary celebrations.

Now secure in its present location, it begins its next 50-year cycle at the end of which, it is hoped, it will have made significant and positive contributions towards the economic and social liberation of the human person, instilling and insisting in all those with whom it comes in contact the values of self-help, hard work, fairness and the ever elusive social justice. In this regard, our most sincere best wishes will be part of this important journey.

The year 1964 was most crucial and decisive in the life of Sacred Heart. It was the year when the first class would be graduating after sitting the all-important overseas examinations, at that time the General Certificate of Education (*GCE*).

Four years had gone into the preparation of the first graduating class for the GCE. The results of these examinations, it was confided, would determine whether the school qualified for government assistance - or not. Teachers, especially Belizean, were aware of the challenge. And they did not possess any fancy degrees. They were three in number earning at the most \$110.00 monthly.

One of those three prepared the Fourth Formers in Latin and Spanish, the other did Mathematics and for a short period English History and the third was responsible for English Language, English Literature and ended with the English History course. The Pastor taught the Scripture course, assisted by a Papal Volunteer.

The results rendered by that first Fourth Form gave the school the recognition it needed to earn government's financial assistance. And what a group they were! A small class consisting of great individuals.

Their graduation was held at the now demolished Continental Theatre in San Ignacio, attended

by parents, relatives and other family guests and school invitees. Another significant event in 1964 was that it was the year when our country attained Self Government.

The first graduating class was addressed by Premier George **Price**. Present for the happy occasion were Cayoan Chief Broadcasting Officer Everal Waight and Chief Information Officer Rudy Castillo.

Apart from preparing for graduation, of course, and GCEs, the class of 1964 had taken part in sporting activities, especially football, volleyball and basketball as well as elocution and oratorical contests held at the former Sacred Heart School and the traditional retreats.

At some point in the life of

Catholic high schools in Belize, activities such as elocution and oratorical contests went national. Great and high were the expectations when Sacred Heart travelled to Corozal for one of these and returned noisy and jubilant when the school won the oratorical contest with "Government Is Everybody's Business". Such was life in the early years.

Recognition is deserved by -and owed to- the first graduating class of 1964.

and Mexico will never allow any court in their country to rule like this because that would create havoc in their countries, due to the fact that both places have more Indians than any other race of people.

The Guatemalan soldiers continue to stop native born Maya Indians from establishing villages in their own country as was confirmed by the United **Nations Commission for Human** Rights and that is why they are crossing the border into Belize to establish new villages.

Unlike the difference between Creoles and Garifunas although both are of African descent, the Mayas and Mestizos in Belize see themselves as one people despite the fact that they are from different countries in Central America.

The black population in Belize is dwindling fast because of migration to the United States and the Maya and Mestizo population is growing rapidly as they continue to cross the border.

The government of Belize still have the option to consider allowing Haitians to relocate to Belize as a humanitarian gesture to balance the races but that idea is not even being advanced up by anyone in the media because of fear of being attacked.

The Haitian presence would contribute to the development of Belize in the areas of agriculture and race balance. Belize have vast amount of lands and would receive funding from various international funding agencies for this worthy cause.

In the 1980's Belize made a similar offer to the government of El Salvador which led to the granting of amnesty to thousands of people from El Salvador and many of them eventually become naturalized Belizeans.

I am yet to see a Maya or a Mestizo demonstration against the establishment of unlawful Maya villages in the country of Belize.

If the Mayas do not see borders as differences between the countries in Central America and continue to cross them as they please then the Government of Belize will be disrespected by Guatemala, Mexico and Central American other countries.

With the discovery of oil in Belize recently, this issue has become a major one for the Maya Indians. Their concern is that the drilling for oil will cause serious environmental problems that could lead to the disruption of life in their communities. Also, that the g overnment of Belize will make oil deals against their wishes without consulting them and in the end giving them an unfair profit sharing of the revenues.

People who have purchased private lands from the government of Belize in one of these villages could also be affected by this ruling. If their land tiles are in the areas detailed in these villages, their land tiles may have to be voided and be given land elsewhere. If they insist that they want to retain these lands, then they will have to appeal against this court ruling.

It refreshing to know that the Government of Belize has expressed its intention to appeal this ruling and as such every non-maya and even some of the very same Mayas, who do not agree with this position, should get up and rally behind their

The Government of Belize should take this matter all the way up to the Caribbean Court of Justice if necessary because of the long term repurcussions this judgement will have in the country when it comes to land issues.

If the shoe was on the other foot, how would the Maya feel if, on the basis of this recent ruling they are denied the right to own land anywhere else in any part of Belize except on their traditional lands and that any one of them owning land anywhere should forfeith that land and return to their traditional lands.

I am in favor of the native Belizean Mayas asserting their rights to their ancestral lands but not at the expense of the other Non Maya Belizeans and private owners of land who obtained their properties through legitimate means.

The Belize government must now start the dismantling of all these villages that were established by Guatemalan Mayas in Belize before they start claiming lands on ancestral grounds later. Their immigration status should also be examined and if they cannot produce Belizean birth certificates and other documents they should be sent back to their countries of origin.

A case in point is that new settlement of Guatemalan Maya Indians found to be encroaching 35 miles inside Belizean Western Territory as reported on the front page of the recent Amandala newspaper of June 27, 2010. The Government of Belize should move post haste to dismantle this settlement and send those people back from whence the came.

Government of Belize Professional and Technical Scholarship Awards 2010

The government of Belize (GOB) is offering Professional and Technical Scholarship Awards for the 2010 Academic Year. These scholarships are tenable ONLY at the University of the West Indies, the University of Technology in Jamaica, and the University of Guyana.

#### Limitation of the Awards

The Scholarship award is limited to Bachelor's Degree Program only and is applicable for a maximum of three (3) consecutive academic years of study in so far as students remain in good standing for the duration of the program. Only in exceptional cases will the Ministry of Education consider Post Graduate Programs.

#### Coverage of the Awards

The Scholarship will normally over tuition (including Economic Cost), and allowances for Room and Board, Books, and Incidental Expenses. The quantum of such allowances will be based on recommendations obtained by GOB from respective Universities. Airfare and matriculation will NOT be covered under the scholarship award.

#### Eligibility

- Applicant must be a citizen of Belize
- Applicant must gain acceptance into the respective Faculty of the University at which he/she proposes to attend
- Consideration will primarily be given to those courses of study that are among the following national priorities, which are not listed in order of preference.
- a. Agriculture Economies
- b. Agriculture Marketing/Trade
- c. Chemical/Civil/Electrical/Mechanical Engineering
- d. Human Resource Management
- e. Curriculum Development and Planning
- f. Economics
- g. Geology
- h. Early Childhood Education & Development
- i. Special Education
- j. Counseling (Primary, Secondary School)
- k. Hospital Managment
- l. Finance
- m. Psychiatry
- n. Nursing
- o. Public Administration
- p. Labor and Employment Relations
- q. Transport Technology
- r. Physical Thorapy
- s. Speech Therapy
- t. Petrolenni Geoscience

(Please note that Law and Medicine are not included in the list of National Priorities)

#### Other Conditions of the Scholarship Award

Each scholarship recipient will be required to return to Belize whenever he/she successfully completes his/her course of study and to serve the Government of Belize (or with the permission of the Government of Belize serve in the private sector in his profession or calling) for a period of four years commencing from the date of employment in Belize. Applicants will be required to sign a Bond Agreement with the Government of Belize in this respect.

The scholarship is normally for the duration of the program of studies and requires that the scholarship holder maintain passing grades at the University where he/she is enrolled.

Application Forms can be obtained from the District Education Centers or at the Ministry of Education in Belmopan.

All completed forms must be filled out in duplicate and reach the Ministry of Education in Belmopan no later than July 5, 2010.

### **Mexican Ex-Police Commander Suspected In Michoacan Ambush**

Mexican authorities Wednesday announced the arrest of a key suspect in the attempted assassination of a state security chief whose convoy was attacked with grenades and more than 2,000 rounds of ammunition.

The suspect until recently was a police commander who also worked for the notorious drug cartel known as La Familia, authorities said.

Minerva Bautista Gomez, security chief for the state of Michoacan, survived the April 24 ambush. Two of her bodyguards and two passing motorists were killed.

Ramon Pequeno, head of the anti-narcotics unit of the federal Public Security Ministry, said in a news conference in Mexico City that Miguel Ortiz Miranda, alias "El Tyson," had been arrested Tuesday in Morelia, the capital of Michoacan. Ortiz directed operations in Morelia for the Michoacan-based La Familia, Pequeno said, including attacks

on public officials, kidnappings and extortion.

Pequeno said the suspect also participated in a June 14 ambush outside Zitacuaro that killed at least 10 federal police agents, as well as the 2009 assassination of a senior public security official and decapitation of a state prosecutor.

In one of the most brazen attacks on a public official, Bautista was ambushed as her entourage left a state fair. The assailants used a truck to block a narrow highway passage and opened fire from two sides. Investigators recovered 2,700 spent shells and said 350 high-caliber bullets had hit her heavily armored SUV.

Ortiz told interrogators that the attackers left the scene believing that Bautista was dead.

"Tyson indicated that the attack was in response to changes made within the ministry that went against the interests of La Familia," Pequeno said.

Authorities' contention that Ortiz worked for La Familia while a member of the state security forces illustrates how

traffickers deeply have penetrated regional governments. Bautista told The NY Times in a recent interview that as many as 100 police agents have been interrogated as possible suspects in the attack on her.

Ortiz joined the Michoacan police in 1999 and became commander of a special operations unit before retiring in 2008 after a murder warrant was issued against him, Pequeno said. Ortiz began working for La Familia in 2005, Pequeno said, after accepting a large bribe to release a detained gang member. He provided information to the cartel, alerting it to police movements and offering protection.

La Familia is a ruthless gang dedicated to the trafficking of methamphetamine. The gang has evolved in recent years as its leaders have tried to create a quasi-religious aura around the group. Pequeno said Ortiz described five days of indoctrination when he joined La Familia that included Biblereading, self-help seminars and weapons training.

Ortiz also told authorities that La Familia recently joined forces with the Gulf cartel and other

smaller gangs to fight the paramilitary Zetas. The Zetas were once allied with Gulf traffickers but are now battling them in several parts of Mexico, including the northern border state of Tamaulipas, where presumed drug hit men this week assassinated the leading candidate for governor.

On Wednesday, officials with the Institutional Revolutionary Party in Tamaulipas named the slain candidate's brother, Egidio Torre Cantu, to run in his place in Sunday's election.
