BENJAMIN PETERS AND ALEXANDER EDWARDS MURDERED IN HONDURAS

SANTA ELENA TOWN, Cayo District, Friday, October 1, 2010:

Reports began circulating in Santa Elena Town during the mid morning hours on Tuesday, September 28, about the death, in Honduras, of two of three prime suspects in the March 30, 2010 robbery of the Scotia Bank in the Mennonite Community of Spanish Lookout which also resulted in the shooting death of the bank's security guard.

The report was later confirmed by Honduran press with an article in the La Prensa de Honduras under the heading "Policemen implicated in the death of Belizeans".

Honduran Agua Caliente border station, all three Belizeans were taken to a remote area and

reportedly shot by the police. They were reportedly left to die but one of them miraculously survived.

The survivor's testimony in La Prensa revealed that at around 10 p.m. on Sunday, September 26, they entered Honduras through the Agua Caliente Border Station at the Honduran border with Guatemala. They were reportedly at a bus terminal near the Agua Caliente Customs post where a search by policemen assigned to Customs resulted in the discovery of guns

The First Public Consultation For The Bridge Over The Macal River Linking The Twin Towns

BEDRAN HALL, San Ignacio Resort Hotel, San Ignacio Town, Tuesday, September 28, 2010:

The public consultation on the San Ignacio-Santa Elena by-pass Macal River Crossing was held today in the Bedran Hall at the San Ignacio Hotel Resort.

The event, moderated by **Anthony Mai** from the Department of the Environment, began as scheduled at 6:30 pm on Tuesday, September 29.

Sitting at the head table were **Minister of Works, Hon. Anthony “Boots” Martinez** along with **Chief Executive Officer in the Ministry of Works, Cadet Henderson**; **Senior Engineer Edgar Puga** from one of the three Ministry of Works’ Project Execution Units and **Two Representatives** from the Caribbean Development Bank in their capacity as officials from the principal financing agency.

Approximately 75 persons attended this first public consultation.

Those in attendance included Cayo North Area Representative, **Hon. Salvador Fernandez**; San Ignacio/Santa Elena Mayor, **John Francis August**; Project consultants from **Halcrow Consultancy**, Teachers and students from Sacred Heart College and concerned private citizens and professionals from the twin towns.

The consulting team informed that after careful analysis, the crossing off the Loma Luz Boulevard in Santa Elena town is currently believed to be more

suitable in relation to two other options at the crossing off the end of Carillo Puerto Avenue, Santa Elena.

In arriving at this determination the team cited the following reasons:

a) It makes use of a protected corridor for a future bypass of the two towns

b) It results in lower social impacts when compared with the other two options which draws traffic along narrow, residential streets

c) It removes traffic from the center of the two towns

d) When compared to the other two options, it poses no significant difference in ecological constraints and

d) It produces the best savings in journey time.

The team informed that the project starts at the junction of La Loma Luz Boulevard with the Western Highway in Santa Elena, it follows the entire length of the boulevard and crosses the Macal River about one kilometer downstream from the Hawksworth Bridge. It continues in a southerly direction across open land over the Branch Mouth Road to form a new junction curving south west across an old quarry and the Golden Orange citrus orchard linking up with Joseph Andrews Drive and Benque Viejo Road to rejoin the Western Highway at its junction with Buena Vista Street in San Ignacio Town.

The project will include the strengthening and improvement of the existing highway and

junctions at La Loma Luz Boulevard, Branch Mouth Road, Joseph Andrews Drive and the Benque Viejo Road.

The improvements along the route will include new pedestrian walkways, drainage, culverts, adequate traffic signs, roadway lighting along with the converting overhead electrical and telephone cables going into underground ducts all of which is intended to make the route more attractive and safer for pedestrians and the motoring public.

The high level bridge across the Macal River, according to the consulting team, is primarily designed to relieve congestion in the center of San Ignacio Town and to provide a safe and secure all-weather route for traffic on the Western Highway.

It will also provide a permanent replacement to the low level temporary timber bridge which will be ultimately demolished thereby removing

traffic from Liberty Street and George Price Avenue in Santa Elena while the Hawksworth suspension bridge will be retained and maintained for use by pedestrians and light traffic.

The Ministry of Works informs that no effort will be spared to minimize the impact of the project on property and land owners. The Ministry concedes however that some property will inevitably have to be acquired but when this need arises, the Ministry is committed to guide all affected parties through the process for the appropriate compensation and that all compensations for land and property will be done in strict accordance with Government’s statutory authority and procedure.

The consultation, lasting almost three hours, provided the opportunity for the sharing of comments and suggestions between the consulting team

The team attentively listened and took note of the concerns and comments expressed on various aspects of the project including the movement of traffic; the elevation of the bridge and the roadway as well as the incorporation of suggested roundabouts at crucial junctions along the route.

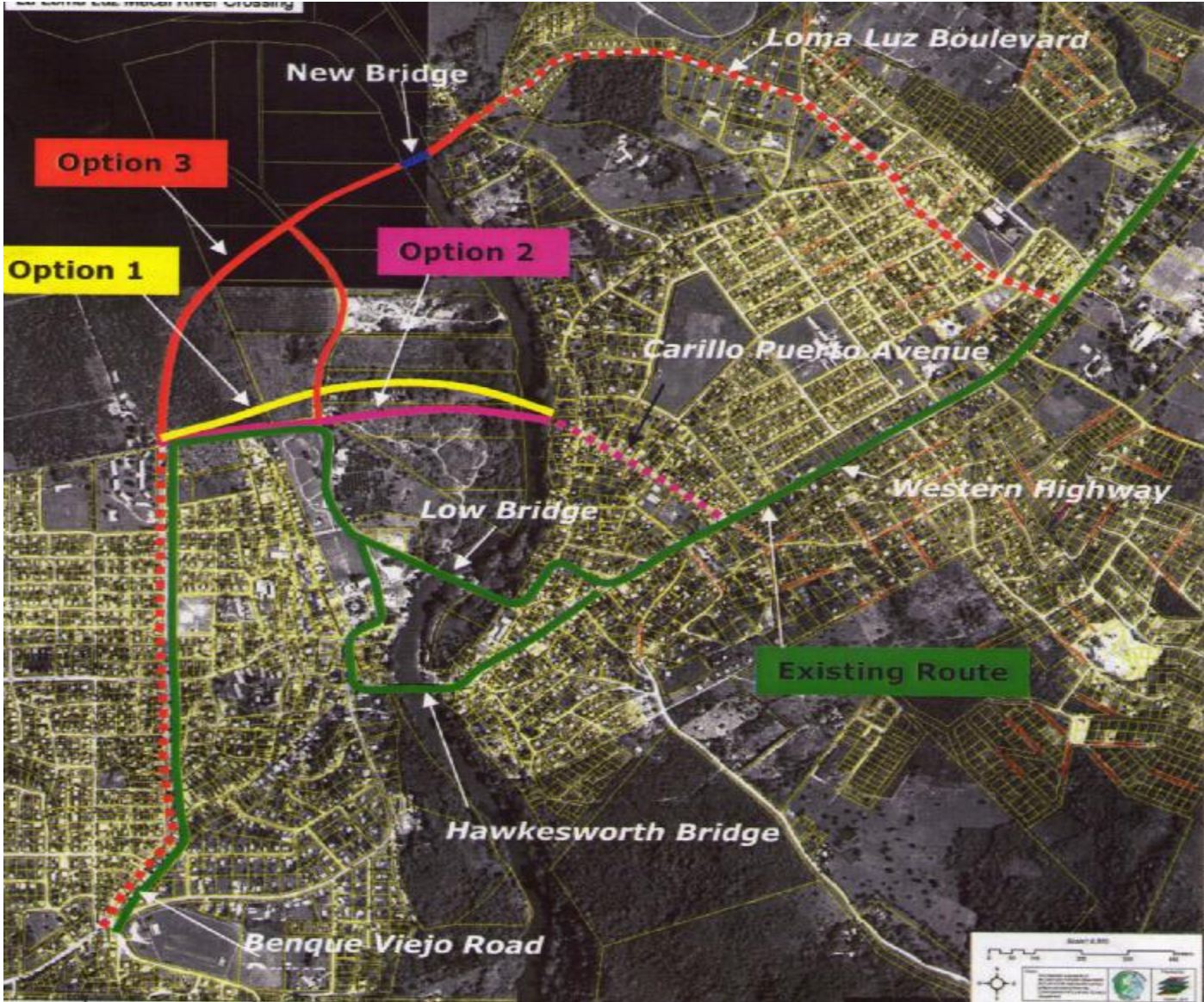
Also brought up during the discussion was the matter of possible inconvenience that could be caused to residents living in the center of Santa Elena Town who will be required to alight buses at the Loma Luz Boulevard and having to walk or pay a taxi for the almost one mile journey into Santa Elena.

Members of the consulting team indicated that they are prepared to attend other public consultations on the project if the need arises.

The construction of the new

bridge, at a cost over 50 million dollars, is slated to commence by the middle of 2011 with the completion date estimated at

around 30 months thereafter. Apart from improving the traffic condition, the project will also be providing much needed employment within the community.

San Ignacio Boy Goes To Big Jail For Attempting To Kill A Santa Elena Man

SANTA ELENA TOWN, Cayo, Monday, September 27, 2010:

A 17 year old boy from San Ignacio Town, on an attempt murder charge, was today remanded to the big jail in Hattieville.

The boy stands accused of attempting to kill a 44 year old man from Santa Elena Town on the night of September 20.

According to San Ignacio Police, the victim, **Leonardo Velasquez, 44**, Belizean laborer of a Trapiche area address in Santa Elena was attacked by the boy and an adult male person in the area of the farmers market in San Ignacio.

The victim was reportedly first hit in the forehead with a stone and when he fell to the ground the attackers stole the mere \$23 he had in the pocket of his pants after which he was cut across the belly and stabbed on the left side of the body below the arm. He was then dragged down the hills and thrown into the Macal River.

The injured man floated under the low timber bridge emerging on the other side where he held on to a handful of shrubs on the river bank for an incredible eight hours (from 8:30 pm to 4:30 am) until the first pedestrian crossing the bridge at

that early hour of the morning heard his faint call for help.

The pedestrian contacted the police and the injured man was removed from the water and transported to the San Ignacio Community Hospital where he was initially treated and later rushed to the Karl Heusner Memorial Hospital in Belize

City where he is recuperating.

Relatives say that the sheer will to survive kept him alive as he remained in the river for eight hours bleeding from the injuries inflicted by the attackers.

While the evidence indicate that two persons were involved in the attack, investigators suspect that this is one of those

classic cases in which a minor, protected by law from the publication of his name and photograph, is taking the full wrap for an adult.

The boy is scheduled to return to court on Thursday, November 11, 2010.

Dangriga Residents Should Rally Against PUP Rally In Their Town

When the People’s United Party (PUP) had their party meeting a couple months ago, the standard bearer for the Stann Creek West constituency **Rodwell Ferguson** moved a motion that Dangriga Town be the venue for the party’s national convention to be held on October 17th this year.

The PUP has a history of totally neglecting the people from the southern part of Belize. The Garifuna people have risen to the top inside the United Democratic Party (UDP) far more than the People’s United Party and the record is there to confirm this fact.

The PUP is so disrespectful to us that right in front of our faces, they took Commerce Bight Pier and gave it away to one of their party supporters **Luke Espat** against the wishes and will of the Garifuna people from Dangriga

Town at no cost. This same man is now seeking a position as an executive member of the PUP

Today, the residents of Dangriga Town cannot go and fish at the pier or unload cargo to make money in order to support their families.

The United Democratic Party is trying to repossess this pier from Luke Espat and return it to the government and people of Belize so that meaningful economic activities can reconvene that will benefit Dangriga residents economically.

After the Garifuna people were brought from their native homeland St. Vincent and forced to live in Roatan Honduras on April the 12th, 1797, they settled along the coastline of Honduras, parts of Nicaragua and Guatemala and in the southern part of Belize.

The British restricted the Garifuna people to the south to avoid them from intermingling with their African brothers and sisters the creoles because they were known warriors.

At that time slavery was still practiced in Belize and they were afraid that the Garifuna people would teach the Creoles their war skills to help them become free people. During this process of institutionalized slavery, they brainwashed the Creoles to think that they were better than the Garifuna people to keep both

racess separate while the Creoles were still slaves. This experience is the main cause for friction and tension between these two African groups in Belize among many of their people up to this day.

From the 1950’s up until Belize became an independent country on September 21, 1981, the People’s United Party was governing the country of Belize. Before that time most Garifuna communities in the south were governed by Non Governmental Organizations with prominent Garifuna leaders from the community at the helm. In Dangriga there was CDS and CAC the two most powerful associations in the town. They both had a huge meeting place to gather and discuss developmental, community development and problem solving techniques. If the British thought that they were making it difficult for the Garifuna people history will prove them wrong. In fact, the southern part of Belize is the richest part of the country in terms of natural resources with various types of soil vegetation for agriculture and a place where you get to enjoy coastal and tropical rainforest life.

Throughout the administration of the People’s United Party, the Garifuna people all had farms and engaged in various types of farming such as; plantain, sugar, banana, citrus, cassava and several other types of crops. Yet, under the leadership of George Cadle Price, they were never given the opportunity to engage in large scale farming like the people in Orange Walk and Corozal Districts with the sugarcane farms. Even up to this day when looking at the industries in the country, the southern part has and is still contributing significantly to the Gross Domestic Product (GDP) of Belize but the return in spending has been less compared to other districts. Belize will never become an industrialized nation unless they do significant development in the southern part of their country with its abundance in natural resources.

The Guatemalans have already conducted their geological survey and this is the reason why

they insist on getting the southern part of Belize if the government of Belize continue to neglect it.

The Garifuna people use to be great warriors but as of lately they are acting like humble children. The Mayas in Belize have organized themselves to seek justice on behalf of their people and they are making significant gains. When will the Garifuna people in the south stand up and say that enough is enough? Land has been taken away that was once Garifuna Reserve Land in the Toledo and Stann Creek Districts, in Barranco Village some Maya Indians from Guatemala have taken away some of their lands and Commerce Bight has been taken away while the National Garifuna Council stand idly by and did nothing. Remember, that we are the only people with black skin that are still indigenous to Belize because of our ethnic makeup. Garifuna people did not come to Central America by choice but were brought by the British against their free will and a great debt is still owed to us.

For these reasons, we can no longer afford to sit on the sidelines any more. I am now calling on my family and friends to protest and boycott this PUP convention to be held in Dangriga Town on October 17, 2010. Unless, the PUP decides to commit themselves to return Commerce Bight Pier to our people in Dangriga Town. In addition, we want to know what is their industrialization plan for the people of the Stann Creek and Toledo Districts for the next five years if they were to be re-elected as the government of Belize. As adults, we are going to refuse the constant practice of people coming into our communities and doling out small change to our people while they give themselves power and enrich their families, cronies and others to rake in millions of dollars on our backs. Sometimes I think people believe that our people are stupid and are not aware of the games that are being played on them. Just remember my people, that the Garifuna people are highly educated, have educated the majority of Belizeans and have a good history of fighting and you don’t want to awake the sleeping giants.

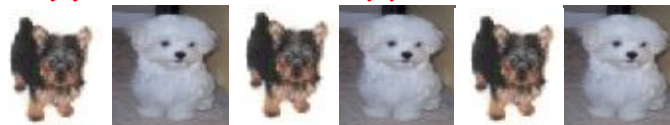

"After a while, to our great surprise, we spotted the pink hippo emerge onto the far bank of the river."

According to the brothers, the hippo is leucitic and not albino as it had some pigmented spots and dark eyes. Leucistic animals

often do not survive in the wild as they are visible to predators and get sunburnt. Hippos however are large enough to fend off rare attackers, while using their sweat as sunscreen.

"It was a young one as it is much smaller than the other hippos and always stayed close to its mother," said Will, who added that it was "*very shy*" and hid behind its mother.

Any Loss Of Life Is Regretted

Dear Editor;

I witnessed the unfortunate accident resulting in the tragic death of young **Kristopher Chuc** from a rather close distance (*I was on the bump closest to the Ferry road*) and caught a glimpse of the rider and his bicycle airborne.

I immediately called the San Ignacio Hospital and the police. I was still on the phone with the police giving them the exact location of the accident when a black pick-up truck coming from the direction of San Ignacio stopped and placed the cyclist on the back with the bike and sped off in the Direction of San Ignacio.

I again called the hospital and as for the emergency ward to be alerted.

On my way to San Ignacio I did see a police vehicle by CP Gas in Santa Elena headed to, I believe the scene of the accident but no ambulance.

I later checked with the hospital about the ambulance and was told that the ambulance 'does not pickup casualties from the road but only makes interhospital transfers!'

This to me if in fact is the case is unacceptable and should be denounced at the highest levels!

As a matter of common sense I am aware that one does not

move a person after such an accident for fear of further endangering the life involved (*I later learnt that my passenger who had gone to the scene across from where I was parked asked them not to move him as the ambulance was on the way and that they could further aggravate his injuries*).

I am appalled though about this policy at the hospital re: use of the ambulance.

I want to ask the **STAR Newspaper** to further investigate this 'policy' and if so then it needs to be amended urgently before any more lives are lost senselessly!

Any loss of life is regretted and I sympathize with the family of young Kris.

Something Does Not Seem Right At Belize Natural Energy Limited

CITY OF BELMOPAN, Cayo District, Thursday, September 30, 2010:

Reports coming out of Belmopan Police indicate that they are investigating a reported theft against a former senior executive of Belize Natural Energy Limited (BNE).

The police informed that BNE's Finance and Accounting Manager, **Jane Longworth** reported to the police that way back over two years ago on September 16, 2008 **Sheila McCaffery** was removed as a BNE Director. However, between the September 30, 2008 and January 2, 2009 (**21 months ago**) McCaffery sed a total of 21 cheques, the property BNE, for the acquisition of goods and services at different business places in Placencia Village,

The report places the unauthorized expenditure at BZ\$19,096. The report further indicate that all 21 cashed cheque were recovered. Police are looking for Sheila McCaffery pending investigation.

GOB condemns actions of Belizean Attorney and former Minister

The Government of Belize registers its strongest condemnation against the actions of a Belizean attorney and former parliamentarian deliberately intended to smear our country's reputation abroad and discourage foreign investment in Belize.

Former PUP Minister and practicing attorney-at-law Godfrey Smith, in a letter dated September 17, 2010, wrote to **Richard Fraser** of the Digicell Group headquartered in Jamaica, warning him and his company against contemplating any investment in Belize Telemedia.

According to Smith, *"Belize, over the past decade has become highly politicized and successive governments have displayed an alarming disregard for sanctity of contracts involving foreign investors."*

Smith cites various examples of this, including agreements entered into and later reneged on or unilaterally cancelled by the last PUP Administration in which he himself served as a

Minister of Government and Attorney General.

Among the examples he cites are Cascal and Belize Water Services Limited, Fortis and Belize Electricity Limited, and Newco and the Belize International Airport.

Smith then goes on to accuse the current administration of refusing to honour consequent international arbitral awards to foreign investors including Newco and the former owners of Belize Telemedia and associated interests, such as BCB Holdings and the Belize Bank. He then points to recent amendments to the Supreme Court of Judicature Act and the appointment of the current Acting Chief Justice as further confirmation of the Belize Government's attempt to

"frustrate existing arbitration proceedings against it".

Smith concludes his letter as follows: *"If indeed you are contemplating doing due diligence on acquiring an interest in BTL, we would be happy to share substantial and detailed information with you on Belize's very disturbing attitude and track record as it relates to foreign investment and international business contracts."*

For a former parliamentarian and practicing attorney, born,

bred and fed in Belize, to so deliberately and calculatingly undertake to undermine the economic interest of his country and people, is outrageously unpatriotic, if not treasonous. The Government of Belize strongly condemns such actions and calls on Mr. Smith to publicly apologize to the people of Belize and to desist from any further actions of the sort, which are clearly motivated and sponsored by some interest other than the national interest.

BENJAMIN PETERS AND ALEXANDER EDWARDS MURDERED IN HONDURAS

in the bags they carried.

According to La Prensa the detainees were identified as **“Benjamín Peters, 25, Alessandro Edward, 30, and a third individual whose identity, for security reasons, is omitted”**.

The surviving Belizean who has been identified as Gabriel Salazar, is turning state witness against the policemen implicated in the murder of **Benjamin Peters**, who is actually 22 years of age and **Alexander Edwards**, informed that after the guns were found in their bags, they were transported to police holding cells where they remained for about 6 hours. At around 3 a.m. on Monday morning they were removed from the cell and told that they were being transferred to the office of the Public Ministry. They were placed in two private vehicles but instead of being taken to Ocotepeque, they were taken much further eventually ending up on the international highway where, in the village of El Sitio, de La Unión, Copán, they were ordered out of the vehicles, shot and left to die.

Peters and Edwards succumbed to the injuries while Salazar miraculously survived and was assisted by villagers who transported him to a hospital where he remains under police and army guard.

While the investigation is suggesting the involvement of a senior officer stationed in Ocotepeque, it has thus far led to the arrest of the following three uniformed policemen also

Henriquez, who police say was driving the small black Geo Prism, 4 door car, at the time of the incident, was subsequently arrested and charged with the standard offences connected with traffic accidents, being:

- Manslaughter by negligence,
- Causing death by careless conduct and
- Drove motor vehicle without due care and attention.

In the absence of a magistrate



Gabriel Salazar miraculously survived

from Ocotepeque: **Nery Torres Torres y Gilberto Lorenzo**, from the Honduran Preventative Police and Police Traffic Officer, **Misael Leiva Bueso**. They are currently detained in Santa Rosa, Copán.

While Benjamin Peters was on the run from Benque Viejo Police in connection with a firearm related incident, Alexander Edwards and Gabriel Salazar were themselves on the run but from San Pedro Police

in connection with the January 30, 2009 triple murder in that eastern municipality. Their names again surfaced in the March 30 robbery of Scotia Bank and the shooting death of the bank's KBG Security Guard, **Steven Lopez**.

While it is reported that Alexander Edwards might have already been buried in Honduras, relatives of Benjamin Peters are working frantically to bring the body for burial in Cayo, Belize.

As this incident in Honduran unfolds, Punta Gorda Police are seriously pondering over the possibility of the trio's (**Peters, Edwards, Salazar**) presence in that southern municipality on the eve of Independence Day (**September 20th**) with intention to rob the Belize Bank in Punta Gorda.

In this incident three persons are said to have crossed the Guatemalan border into Toledo and travelled to Punta Gorda Town

At around 9:30 that Monday morning a Spanish speaking male person engaged the taxi service of Punta Gorda resident **Charles Juarez** for a ride to Bill Usher Beach behind the town cemetery. Upon arrival in the area, two armed male persons emerged from nearby bushes. They attacked Juarez, tied him up and placed him in the back seat of his car.

One of the men then got in the driver's seat and drove the vehicle back into the center of town and made two passes near the Belize Bank but on both occasions a policeman was present in the vicinity. With Juarez still tied up in the back seat of the car, they reportedly drove the car back to the Bill Usher Beach area where they relieved Juarez of his cellular telephone, his cap and ten dollars in cash. They reportedly threatened to kill him before disappearing into nearby bushes. Juarez later freed himself and later reported the incident to the Punta Gorda police.

in San Ignacio Town, the accused, represented by attorney **Elston Kaseke**, appeared in Belmopan's Magistrate court on Monday, September 27 where the three charges were read to him. He was informed that the case will be heard on indictment in the Supreme Court and as such no plea was entertained by the court. He was subsequently released on two signed bails each in the sum of two thousand five hundred dollars and ordered to return to court on Wednesday, November 10, 2010.
