# Fugitive of US Law Captured In San Ignacio

## SAN IGNACIO, Cayo, Friday, January 14, 2011:

He jumped bail and failed to appear in a Texas court on a possession of controlled substance charge and when Belizean law enforcement officers caught up with this fugitive of Texas law he was found in possession of marijuana also an illegal substance in Belize.

He is wanted in Texas under the name **Gregory Forbes**, 53 but when, at around

6:00 pm on Tuesday, January 4, detectives from the San Ignacio police station visited the house he was occupying on Collins Boulevard in San Ignacio town, in addition to the 20 grams of weed, he was also found in possession of a suspected forged US passport with his photograph but under the name **John Paul Govia Jr.** 

He pleaded guilty to the possession of controlled drugs charge and forthwith paid the seven hundred dollar fine imposed by



# Crime And Unemployment Can Cause Many Governments To Change In Belize And The Caribbean

I have always listened to many leaders of the world speaking about what they would like to accomplish for the citizens of their respective countries during their term in office and have very seldom heard any of them committing to providing full time employment to all their citizens. Yet, if the citizens of a country are unemployed they will not be in the position to provide for themselves and their families which will leave the burden on the government.

A caring government should always make full employment its top priority. Any government that does not have this issue on the top of its list is embarking on an impossible journey.

Maybe, if addressing the unemployment situation was of top priority, Belize would probably not be experiencing an escalating in crimes today. I have looked at several studies over the years and it is documented that there is a direct relationship between crime and employment. When a government fails to provide meaningful employment for its citizens, a majority of the

criminals will use that reason as a justification to commit crimes.

The majority of elder Belizeans will readily admit growing up in hard times without the need to engage in criminal activities. This is a true statement to a certain extent primarily because we grew up in different times. This new generation is a lot different from the people who grew up during our time. A majority of these young people are exposed to different things that we were not exposed to when we were growing up and the things that they are currently exposed to is what shape their thoughts and influence their actions. Some of the things as parents and guardians we have control of but a majority of them we lack control over. The common cry in Belize is that this young generation is lazy and they do not want to do anything but beg, sell drugs and steal. There might be some truth to this but time and things have changed in our country, in all the other countries in the Caribbean and the rest of the world.

It is not the responsibility of the private sector to provide full employment to the citizens of a country. That burden lies on the government of a country through a long term plan that gives incentives to private businesses to invest their funds in the economy where they can make profits for themselves and expand their businesses. A person that have money to invest will not spend his or her money until they have evaluated a government's

incentive package. If they come to the conclusion that there is nothing there for them, then they will just sit on the side and hold on to their money until the government comes out with a package that is favorable to them.

Most businesses are attracted to tax incentives, inducements and business loans. In Belize there were several of these given to political parties cronies who were not legitimate business people over the years and the tax payers money went to waste causing DFC to go bankrupt. Some of these individuals still owe the Belizean tax payers and they are not being pursued for the outstanding debts. That same money could have been given to a legitimate business owner who would have provided jobs to many citizens. Giving businesses reasonable tax incentives for hiring people is a wise thing to do. The incentive should be measured and monitored because it will take away from the government's revenue.

The government of Belize came out with a comprehensive plan to combat crime and it was impressive. If this is backed up by a similar plan to deal with unemployment, land reform and lot acquisition it will be difficult for them to lose re-lection. Belizeans are tired of seeing foreigners come into their country be given lots and lands while they are asked to fill out applications wait for years and never hear back anything from the Lands Department. Plus, when they go to Belmopan there is no record that they ever applied for any lot or land while watching the foreigners living in their new homes and forcefully taking lands to do their farming. There is enough land in Belize to give every Belizean citizen living in Belize, the United States and abroad a lot and a farm land so that they can own a part of their country and be proud citizens so what is causing this big delay.

The Ministers of Trade, Industry, Labor, Agriculture, Commerce and Foreign Investment must now get together and formulate a comprehensive package to tackle unemployment in Belize. I have not seen any statistics on what is Belize's unemployment rate but my guess is that it is over 25%. When they brought out the poverty rate recently, it was alarming and this is because of the unemployment situation which has a major impact on most or the citizens' social and economic conditions.

If the government of Belize can get a commitment to establish about three large industrial factories in each district and offer lots and farm lands to a majority of the unemployed residents of Belize City to build a home and do farming elsewhere, the country of Belize would become a more prosperous nation. Belize City is too old and is suffering from serious urban decay and decline. I use to live in Belize City many years ago and it is a different city today. To live in a city just to say you live in a city where you feel unsafe and unsecure is not worth it. In Real Estate a person who has a home is always looking for a peaceful, quiet and enjoyable environment to live.

I still believe that our country of Belize can be a better place than what it is today but for that to happen, we need to get the Belizeans who are; nationalistic, committed, qualified and possess the human resources to be at the helm of our future developmental planning to make it happen. Most of Belize's resources live in the United States and the sooner they tap them, the faster they will have their problems resolved. Before America became a powerful nation in the world, the founding fathers sat down and planned out America's path to world dominance. Who are going to be the Belizean's in the group to sit down and plan out Belize's path?



#### TAX AUDITOR

### The Behaviour of Banks Holdings Ltd (BHL) of Barbados Bad for Belizean Citrus Growers

#### 1. <u>CPBL's resignation from CGA – The real reason</u>

The resignation in 2009 was not based on any direct consideration of benefits to be derived from CGA membership. CPBL documents as far back as 2007 show that a plan was hatched by Henry Canton, William Bowman, Mike Duncker and Ernest Raymond, now owners of Belize Citrus Mutual, a private company, along with BHL, to resign from the CGA and form a new company/association, at the time to be called Citrus Alliance Corporation. The sole aim of the new group was the destruction of the CGA and its 51% majority shareholding of CPBL so that they and BHL could enjoy full control of CPBL.

After the decision of the rogue CPBL Board, controlled by BHL, to resign from the CGA, an undertaking was given to the Hon. Prime Minister of Belize that CPBL would rejoin CGA and would continue to pay its membership fees to the CGA. However, the CPBL Board went on to PASS a resolution not to rejoin CGA but to continue paying the fees. Notwithstanding, commencing the current crop year, Henry Canton, the then CEO of CPBL, supported by BHL, discontinued payment of the fees to the CGA, against the undertaking given to the Hon. Prime Minister and to the Supreme Court of Belize. This is also contrary to the resolution adopted by the Board for the payment of these fees.

#### 2. <u>CGA as Custodian/Guardian of the Belize citrus industry</u>

The CGA in collaboration with the Government of Belize and ORISA, was able to attract \$1,600,000 to jump start the control of Citrus Greening in Belize.

The CGA also provides financing to growers in the millions per year for fertilization and upkeep of groves. Since the aftermath of Hurricane Richard the CGA was able to get a grant of \$350,000 to fund the purchasing of fertilizer for small farmers whose groves were affected by the hurricane. Additionally, the CGA put a proposal to the Development Finance Corporation that resulted in a line of funding of \$4.0 million being made available to all growers in the industry at 9% with two year moratorium and the possibility for refinancing of up to 50%. This line of funding is available to nursery owners who now need to erect screened structures to meet the new guidelines set forth by the Belize Agriculture Health Authority for the certification of citrus nurseries. This is crucial to the continued growth of the industry.

Even more, the CGA has lobbied with the Government of Belize for and got Citrus Greening to be declared a priority area for FAO funding and has provided the technical assistance in making the application for some \$1,000,000 dollars to assist in the control of HLB, including starting diversification into other juice fruits such as passion fruit. This should set the stage for diversifying risk, broadening product lines and increasing the utilization of the processing plants. Additionally, the CGA has been working with a local grant agency to develop a project to attract funding to assist smaller scale citrus nursery operators by providing several community nurseries in different parts of the industry. Belizeans should note that BHL refused to assist growers post-Hurricane Richard.

Sir Allan Fields and Mr. Richard Cozier, of BHL, have stated that CPBL should divest all its citrus groves and have shown little interest in the welfare of citrus growers, particularly the smaller citrus growers. This must be considered very unfortunate as the vast majority of citrus growers are small to medium sized and form the back bone of the citrus industry, provide socio-economic stability for a large sector of the Belizean population.

#### 3. The Performance of CPBL

The issue here is the performance of the Company from the time BHL decided to engage in preventing CGA from appointing its directors and then seeking to change the normal structure of the Board. In his report to BHL shareholders dated December 14<sup>th</sup> 2009, the Managing Director offered the following, "Pricing on citrus concentrates has improved significantly (almost double the low in 2009) and thus contracts and sales going forward will be significantly more profitable. Indeed our expectations are that once the pricing remains at current levels, this operation will be significantly more profitable in 2010". Let's examine the performance a little closer:

We must stress that sales could have been higher in 09/10 as this was the same period in which product was being sold at US\$0.98 per pound solid when the market started at US\$1.18 and peaked at \$US1.63 per pound solid. BHL should note that the despite the low orange crop more solids were sold in 2009 -2010 fiscal, a period of historical robust market prices. Perhaps better scrutiny and governance as practice at home would have yielded a better performance.

To add, at the Annual General Meeting in 2009, William Bowman, co-owner of BCM with Henry Canton, got up and made the following comment regarding the CPBL grove performance of a loss of \$1.6 million, "The average production was mediocre.... He hoped to see some improvement next year as he is aware that this was discussed at the Board level. The Chairman (Mike Duncker) mentioned that the Board is well aware of this fact and has taken the necessary steps to correct the situation."

However, in 2009 the groves lost \$3.8 m and BHL (with the individuals that CGA had removed from the Board but BHL attempted to block their removal) awarded Henry Canton's private company a three-year renewal of its contract to manage CPBL's groves. For the 2009-2010 fiscal period the groves lost another \$3.52 m despite the improvement in fruit prices! BHL mentioned that the crop fell below 4,000,000 boxes. We take it you are referring to oranges because the crop for 2009/2010 was 5,241,182 boxes. As stewards of CPBL you should know that CPBL prepares the national fruit forecast and at the time of the fruit forecast in question BHL was denying the CGA from putting its directors on the CPBL. Furthermore you should know that CPBL 476,000 boxes shortfall in orange production represents approximately 56% of the 850,000 boxes shortfall between the forecasted 4.7 million boxes of orange and the actual 3.85 million boxes. BHL should get the facts straight. They presided over the shortfall!

Under the Citrus Processing and Production Act, there is a Harvest Committee comprised of representatives of the CPBL, CGA and the chaired by the Ministry of Agriculture. The Harvest Committee relies on the national fruit forecast as prepared by CPBL to make a master schedule. The law prescribes for the CGA to then communicate with all growers based on the schedule.

BCM has issued a release telling its members that they do not require a license to deliver fruits and for them to get a schedule from the Fruit Logistics Office of CPBL. CPBL has been breaking the law to accommodate BCM's effort to downplay the legal responsibilities of the CGA to ensure the smooth running of the industry as enshrined in law. Is this kind of illegal behaviour acceptable to BHL?

#### In Closing

BHL seems to be trying hard to absolve its self from any participation in the negotiation of the Investment Agreement, which has been a disaster for citrus growers. This seems tantamount to a case of handling "stolen" goods. BHL says it is not a signatory to the agreement. This is not true. BHL is a signatory to the Investment Agreement. BHL has publicly stated that it has taken on board all the recommendation of the Committee of Five report. CGA is calling on BHL to honour this commitment.

We again invite BHL to work with its partner, the CGA, in this venture. It is imperative that there be a sustainable arrangement, which will be beneficial to the all parties and all the stakeholders who depend on the Belizean citrus industry.

Dear Mr. Irving:

We are in receipt of your letter of November 11th advising of the hurricane damage done to the groves of your members and your appeal for assistance. We also have seen photos of some of the affected areas as well as having direct conversations with some of the growers who sustained damage.

Normally we would have offered whatever assistance was appropriate and affordable however two weeks after Hurricane Richard hit Belize we in Barbados were hit by Hurricame Tomas. All our operating facitliies were impacted to varying degrees and thus our focus has been to remedy damages there. In addition Tomas also inflicted severe damage to the neighbouring island of St. Lucia where residents in most area to the south are still without access to running water some 3 weeks later. We have therefore decided that whatever assistance we can give, after securing our own operations, should go to aid St. Lucia, as a result we cannot at this time offer any help to your growers.

We trust that you will appreciate that the special circumstances of having two hurricanes impact the Western and Eastern Caribbean within the space of two weeks has compromised our capabilities somewhat: nonetheless we wish only the best for your growers and hope that they can rise from this disaster and participate in what we understand should be a good year for citrus.



#### STATEMENT ON THE GULISI SCHOOL PROJECT, DANGRIGA

**Belmopan, Monday, January 10 2011**: In view of concerns raised recently in the media in regards to the contractual procedures regarding the Gulisi School Project, based in Dangriga, the Social Investment Fund wishes to categorically state the following:

- 1. The Social Investment Fund is an organization established by law in 1996 as the main implementing agency of the Government of projects aimed at reducing poverty in Belize. SIF is funded by the Caribbean Development Bank through regular loans to the Government of Belize and through grants through its Basic Needs Trust Fund; the World Bank; the Commonwealth Debt Initiative; the European Union and through local counterpart funding from the Government.
- 2. Established in 1996, SIF has implemented over 498 projects valued at \$68.2 Million dollars in the areas of Water and Sanitation, Health, Education, Economic Infrastructure, Organizational Strengthening, Social Services and Micro-Enterprise Credit. Since February 2008 alone, SIF has implemented 102 major projects countrywide worth \$21.4 Million dollars benefitting over 57,000 Belizeans.
- 3. SIF is committed to working with all communities throughout Belize and to implement projects in **an honest, fair, transparent manner and without fear, favor or ill will**. Our cadre of professional staff and engineers are committed to maintain and preserve the highest standards in both the procurement of goods and services and in the implementation of projects as required by law and our funding agencies.
- 4. All projects being implemented by S.I.F., approved by the SIF Board, that exceed \$200,000 are without exception, subject to national competitive bidding. This means that tenders for the project are advertised in the national newspapers for over three weeks whereby interested contractors are invited to purchase their bidding documents. However, while prospective bidders are afforded the same and equal opportunity on a competitive basis, SIF reserves the right to accept or reject any bid.
- 5. Prior to the tenders' deadline a visit to the project site is organized with prospective bidders to allow them the opportunity to acquaint themselves with the physical nature of the project and all the supporting documents, such as bank statements etc, that need to be submitted along with the tender documents. The site visit for the Gulisi Project was done on the 28th of October 2010.
- 6. On the day of the deadline, a public opening of tender documents is held at the SIF offices where all concerned parties are invited. This is done in public view and in a transparent manner.
- 7. Following the Public Opening of Tenders, an in house Evaluation Committee evaluate all tenders. Factors such as completeness of the bid, meeting the qualification criteria for the contract and lowest evaluated price are used to recommend a bidder.
- 8. Once a prospective contractor has been selected, a request soliciting a "No Objection" is made to the organization financing the project. Once a "No Objection" is secured, all files in regards to the project are then sent to the Contractor General for his perusal and approval of the tendering process. Signing of the contract then follows and the project then begins.
- 9. SIF is committed to providing continuing training to prospective contractors. In this light, a series of training for small contractors was held last year during the month of September, which was also attended by those expressing concern of the Gulisi Project.
- 10. We are also committed to dialogue and to work arduously for the betterment of the poorest for the poor in Belize.

# Haiti: One Year of Mexican Solidarity And Cooperation After The Earthquake

EMBASSY OF THE UNITED **STATES OF** MEXICO, Belmopan, Belize, Thursday, **January 13, 2011:** 

On the ocassion the one year anniversary of the earthquake that devastated Haiti, a release from the Embassy of the United States of Mexico today informed that the Mexican government, through the Foreign Ministry, reaffirms its solidarity with the people of Haiti one year after the January 12, 2010 earthquake that killed approximately 200,000 people and forced 2.3 million, a quarter of the population, from their

It also honors the memory of two Mexican citizens who lost their lives that day and reiterates its condolences to their families.

In response to the earthquake, the Mexican people and government launched an aid program that included sending specialized personnel (rescue workers, doctors, nurses, paramedics and experts in building construction). Navy and the Mexican Social Security Institute (IMSS) doctors treated about four thousand people in one month, and about four thousand buildings were evaluated for damage in Port au Prince in the days after the quake.

Fifteen thousand tons of aid was sent, consisting of food staples, medicine, medical supplies and community kitchens. The kitchens,

from the Mexican Navy and Defense Ministries, served about one million meals in the 11 weeks they were in operation.

Deployment of this aid involved using nine Mexican Air Force planes for 30 flights and five Mexican Navy vessels for 20 trips.

With the generous assistance of Spain and Japan, the Mexican government engaged in triangular aid programs in order to purchase and donate a community kitchen and design and implement earthquake-resistant engineering projects.

It also established a novel public-private partnership novelty between the Mexican Foreign Ministry and civil society organizations (Fomento Social Banamex, Azteca, Jose Cuervo, Televisa, Chrysler, BBVA-Bancomer and United for Them) that led to the Mexico for Haiti Alliance. In February of this year, the Alliance will launch five

education and job-training projects.

Today, because of the serious challenges created by the cholera epidemic, Mexican aid has focused on projects that strengthen health institutions. A Mexican Navy medical team provided its services for 30 days in Saint-Marc, seeing six thousand patients; medical supplies were sent to combat the outbreak of cholera and four pre-fab clinics were donated, the first of which is already under construction in Port-au-Prince.

At the multilateral level, during its term as an elected member of the UN Security Council, Mexico—with other countries encouraged the UN to act decisively to address the emergency caused by the earthquake.

Mexico reaffirms its solidarity with the people and government of Haiti and its commitment to continue contributing to Haiti's development.
