Ten Days Before His Ninth Birthday, Cayo River Claims The Life Of Mohammed Armstrong

SANTA ELENA TOWN, Cayo, Thursday, February 17, 2011:

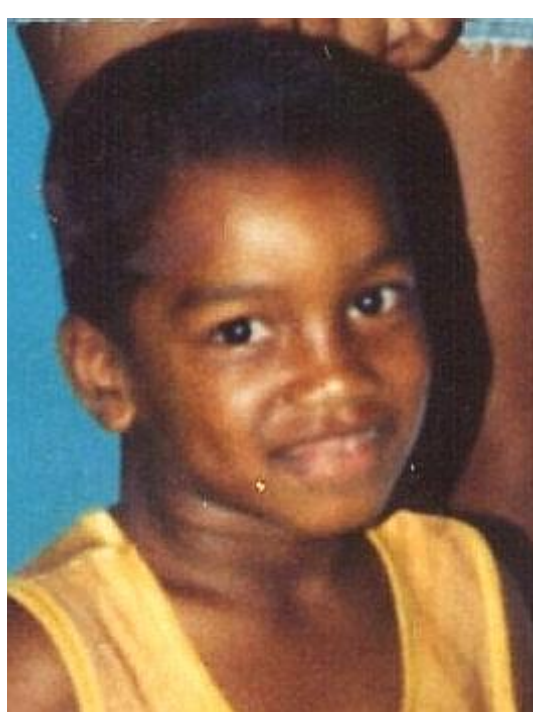
Funeral service was held today in the family yard, Trapiche Area, Santa Elena, Cayo, for eight year old **Mohammed Armstrong**, the victim of a drowning incident in that area where the Macal meets the Mopan to form the Belize Old River near the community of Branch Mouth, Cayo.

San Ignacio Police reports that **David Romero**, Belizean labourer from the Trapiche Area informed that at around 4:30 pm on Monday,

February 14, he was crossing the river from the Branch Mouth community with the deceased holding onto the tail for his T-Shirt. Romero informed that the child lost his hold and went under never to resurface alive again. Romero reportedly returned to the banks of the river seeking assistance but by the time help arrived the child had long disappeared.

A fruitless search in the water began shortly thereafter until around at around 11:30 pm when the Cayo Emergency Response

Team headed by **William Swan**, Director of the Youth Cadet Corp, joined in the search effort and within half an hour the body was retrieved from the water and transported to the Community Hospital in San Ignacio where it was officially pronounced dead by **Dr Gustavo Pacheco**, the medical officer on duty. The body was subsequently placed inside the morgue for the mandatory post mortem examination.

Canadian Tourist Dies From Head Injury And Not Drowning

BELIZE CITY, Thursday, February 17, 2011:

The legally required post mortem examination conducted on the body of Canadian tourist, **Mildred Irene Lines**, certified the cause of death as acute cerebral edima due to head injury.

It was shortly after 12 noon on Wednesday, February 16 when the 83 year old tourist was canoing in the Barton Creek Cave along with fellow Canadian senior citizens **Ian Leckie**, 75 and **Birod Lawrence**, 86 in a 14 feet rented canoe.

The report indicate that upon

reaching an area about a thousand feet inside the Barton Creek Cave, the canoe suddenly capsized resulting in all three occupants falling into the water.

Leckie and Lawrence survived the incident but Lines did not. The apparent lifeless body was later retrieved from the water and rushed to the community hospital in San Ignacio where it was officially pronounced dead.

Police reports that the trio was part of a group of 25 tourists on the expedition headed by fellow

On Wednesday, February, 16, the body was transported to the Karl Huesner Memorial Hospital where the post mortem examination was conducted by Forensic Specialist, **Dr Mario Estradabran**, who, at the conclusion of which, certified the cause of death as asphyxia due to drowning.

Mohameed Armostrong, a former student of Eden Adventist Primary School in Santa Elena, is survived by his mother **Alma Woodye**, Step Father **Nelson Flores**, Father **Ronald Armstrong**.

He is also survived by four brothers: **Ronald Armstrong Jr**, **Tyler Jones**, **Nelson Flores Jr**

and **John Flores** as well as four sisters: **Shameka**, **Shamira** and **Kamesha Armstrong** and **Nazalee Flores**. He is also survived by his paternal grandmother, **Mrs. Gloria Armstorng** as well as several aunts, uncles, cousins, other relatives and many friends.

He was laid to rest inside the nearby Carmen Memorial Cemetery just a stone's throw away from the place he called home.

May his soul rest in eternal peace.

Kylen Facing Double Murder Charges

BELIZE CITY, Wednesday, February 16, 2011:

Derrick Kylen, 23, Belizean, air conditioner technician of #79 Baghdad Street, Belize City was today remanded to the Hattieville central prison after he was formally arrested and charged for two counts of murder, one count of attempted murder, one count of dangerous harm and one count of use of deadly means of harm.

The five charges against Kylen stems from a February 4, shooting incident which claimed the lives of **Ian Martinez**, 34, Belizean mechanic of #44 Gill Street and **Daniel Puerto**, 17, Belizean construction of #1774 Tibruce Street.

Belize City Police reports that it was shortly after 6 o'clock on the evening of Friday, February 4 when the deceased Daniel Puerto and his twin brother Darnell, in the company of other deceased, Ian Martinez, were standing in conversation at the corner of Hibiscus Lane and Tibruce Street, when a brown car drove up, two male persons reportedly jumped out of the car and immediately proceeded to open fire at the trio.

When the shooting subsided Daniel Puerto was left with gunshot wounds to the neck, left

leg, left hand and right side of the back while Ian Martinez was shot in the neck, right side of the rib cage and left shoulder while the more fortunate, **Darnell Puerto** was found with gunshot wounds to both legs and hands.

They were all transported to the Karl Heusner Memorial Hospital where, upon arrival at around 6:15 pm, Daniel Puerto and Ian Martinez were officially pronounced dead by the medical officer on duty while Darnell was admitted in critical condition.

Police continues the search for the second suspect.

Should Heads Of Government Continue To Hand Down Leadership To Their Children?

The three-week demonstration and protests in Egypt that claimed the lives of hundreds was due to the fact that **President Mubarak** wanted to hold on to power in order to pass on his "*throne*" to his son, **Gamal**.

However, the demonstrators held their ground, which forced him to resign, but it cost the Egyptian people a lot -- hundreds of lives, pain and suffering and billions of dollars in damage.

It is not unusual for heads of

government to hand down leadership to their sons or even daughters, but when it comes to bloodshed it is an entirely different matter.

We have seen it in India in the late 1950s and 1960s when **Jawaharlal Nerhu** passed down to his daughter **Indira Gandhi** and she subsequently to her son **Sanjeev**.

It was similar in Pakistan when **President Bhutto** handed over to his daughter **Bonazir Bhutto**, who was also assassinated, and she passed power on to her 19-year-old son **Bilawal Bhutto**.

In North Korea, young **Yang Hyong Sop**, known as **Kim Jong Un**, has been identified to replace his father **Kim Jong II**, who succeeded his father **Kim Sung II**, who was the first leader of the country way back in 1948.

In Kenya, East Africa, 41-year-old **Uhuru Kenyatta** has been handpicked by outgoing President **Daniel Arap Moi** to replace him because Uhuru, who has no political experience, is the son of his mentor, **Jomo Kenyatta**, Kenya's first leader, who Moi succeeded in

1978.

Here in the Caribbean it is not too different. In Jamaica, we saw **Norman Manley** pass over the mantle to his son **Michael**.

Vere C. Bird in Antigua and Barbuda to his son **Lester**.

In Barbados, **Grantley Adams** to his son **Tom**, not to mention in Haiti, dictator **Papa Doc**, despite the fact that he raped the country of hundreds of millions, he "*gave*" the country to **Baby Doc** for him to continue to fleece the nation.

In Guyana, **Forbes Burnham** had five daughters and they were not interested in politics or else he would have placed one of them in a position to take over, but in any event he died at a relatively young of 62.

Cheddi Jagan had a son, but he did not see eye to eye with his father and he was not "*under his father's fold*", hence his widow **Janet** took over, although she was a white American-born woman.

In St Vincent and the Grenadines, **James Mitchell**, who served three and half terms as prime minister did not have a son, and it is said that he changed the country's flag and removed the coat of arm and the breadfruit leaf, and replaced it with three green diamonds, which he said reflected the plural nature of the many islands of St Vincent and the Grenadines.

His critics however say that the three diamonds represented his three daughters. He had only three daughters at the time of the flag change on October 21, 1985.

Apparently his daughters were not interested in politics -- at least at that time -- so he handed over leadership of his New Democratic Party to **Arnhim Eustace**, who lost the government five months later. Now persons close to Sir James said he regretted the move, but nevertheless campaigned for him and New Democratic Party at the

last general elections, when he made a very unfortunate statement that he cannot even trust God, which some critics say costs the NDP a lot of votes and maybe the government.

Now it is said that current St Vincent prime minister, **Ralph Gonsalves**, wants to hand over the mantle to his son, 38-year-old **Camillo**, a lawyer, who is now his country's permanent representative to the United Nations and US Ambassador based in New York.

I do not see a problem with that because I was told that **Camillo**, who is brown skinned, is competent enough to take over. In fact, he is much better than nearly all if not all the ministers in government.

Perhaps I should mention that Ambassador **Gonsalves** has made a name for himself in Washington. He was chosen as co-facilitator with Ambassador **Frank Major** of the Netherlands as facilitators for the preparatory process of the UN Conference of World Financial and Economic Crisis Impact.

He was in the forefront of making demands for more representation in the Security Council for Small Islands Developing State, which in my view is extremely good for a young diplomat.

I do not like to discuss race, especially in politics, but I mentioned that **Camillo** is brown skinned because the race card was touted in the November general elections, when it was said that the country, which comprises mainly blacks, has been run and administered by "*red men*" -- **Mitchell** and **Gonsalves** -- for more than 26 years. In the circumstances I feel that young **Camillo** will be the ideal person to replace his father and to administer the affairs of St Vincent and the Grenadines.

SUCCESS IN YOUR BUSINESS

Follow Up Part II

Last week we looked at how important it is to follow up, especially when you are putting together a little in house competition. This week we are going to look at what you will want to get out of your follow up, and that is information about the effectiveness of your efforts.

When you are putting together a competition within the company, you will need to track the effectiveness of your efforts. So, this will be an invaluable part of your process to making a successful competition.



Gathering information should allow you to see three things when it comes to your competition:

1) Has your competition accomplished your goals as far as enhancing the performance of your staff?

2) Has your competition helped in the development of a team improvement environment with your staff?

3) What needs to be adjusted to make your efforts in these areas more effective?

To acquire the right information on each of the above items, you must have the goals of your competition in front of you in writing, and you must have performance trackers.

Performance trackers are specific, measurable items that will allow you as management to see if you are getting what you want out of your competition. In other words, if it's a sales competition, you will need to see numbers. If it's some other kind of contest, you will need to have traceable items that will make progress easily apparent.

Your follow up will be something

that allows you to get some insight in this area. So, you will need to be **ORGANIZED** in your record keeping. Make it a priority to keep accurate records, especially in this type of endeavour.

The more organized you are with your record keeping, the better handle you will be able to keep on the effectiveness of your competition efforts.

Good record keeping is a paramount necessity for any successful venture, and it is often something that is not properly practiced.

Have a regular consistent scheduled time that you look over the information that you have acquired in your follow up, and log it. Information that is accurate and properly logged, is easy for you to find, and is so much more effective than something that you have perceived as correct but cannot corroborate.

Have a separate log, or computer file, or notebook for the specific items that you are tracking. That will allow you to find the information you are looking for easily, and it will look better to your staff when it comes time to assessing their accomplishments in connection with the goals you have set for them. This is the first step that you will want to have in place to accommodate your follow up. Mental Health Training For Community Nurses Launched

The Ministry of Health, Mental Health Program in collaboration with the Pan American Health Organization, the Mental Health Association, the University of the West Indies and the Mental Health Reform Research Trust of the Royal Free Hospital in London hosted a launching ceremony for a training project in Mental Health for Community nurses today at the University of West Indies Auditorium, Belize City. The overall objective of the project is to strengthen the conditions of mental health services in primary health care by improving the competencies of the community nurses in mental health.

During a BBQ, a friend stumbled and took a little fall - she assured everyone that she was fine. They offered to take her to the hospital. She said that it was nothing serious and that she had just tripped over a brick because of her new shoes.

They got her cleaned up and got her a new plate of food. While she appeared a bit shaken up, **Ingrid** went about enjoying herself the rest of the evening

Ingrid's husband called later telling everyone that his wife had been taken to the hospital. At 6:00 pm Ingrid passed away.

She had suffered a stroke at the BBQ. Had they known how to identify the signs perhaps Ingrid would be with us today. Some don't die. They end up in a helpless, hopeless condition instead.

It will only takes a minute to read the following:

A neurologist says that if he can get to a stroke victim within 3 hours he can totally reverse the effects of a stroke...totally. He said the trick was getting a stroke recognized, diagnosed, and then getting the patient medically cared for within 3 hours, which is tough.

RECOGNIZING A STROKE

Thank God for the sense to remember the '3' steps, S-T-R. Read and Learn!

Sometimes symptoms of a stroke are difficult to identify. The lack of awareness spells disaster. The stroke victim may suffer severe brain damage when people nearby fail to recognize the symptoms of

a stroke.

STROKE

Remember the 1st Three Letters.... S.T.R. Four letters...S.T.R.O.

Now doctors say a bystander can recognize a stroke by asking three simple questions:

S - Ask the individual to **SMILE**.
T - Ask the person to **TALK** and **SPEAK A SIMPLE SENTENCE** (Coherently) - for example **"It is sunny today."**

R - Ask the person to **RAISE BOTH ARMS**.

If the person has trouble with **ANYONE** of these tasks, call emergency number immediately and describe the symptoms to the dispatcher.

New Sign of a Stroke

Stick OUT Your Tongue

Another way to identify a stroke is to ask the person to 'stick' out the tongue.. If the tongue is 'crooked', if it goes to one side or the other, that is also an indication of a stroke.

Some Foreigners Face Serious Hardships In America That Affect The Lives Of Their Loved Ones

Despite the economic problems the United States is currently experiencing it is still the number one country most people in the world are trying to reach because of the opportunities that are still available, technology education, safety net, medical treatment and democratic tolerance.

Yet, many of the people who are dying to come to this country, are not being told that this country is not the country it use to be many years ago and coming to America and leaving your native country

could make a person life worst rather than better.

There are many foreigners living in America, who are not doing good today and want to go back home but due to shame, guilt and the fear of being branded as abandoners and failures continue to live in the United States under deplorable conditions like second and third class citizens.

Many of these people were highly respectable people back in their respective countries but due to the pressure they apply on themselves, stress they suffer from burn out of their bodies take a hold of them and they end up getting hopeless, sick, disable and helpless. Once they reach that stage in their lives, they become dependent on the Departments of Social Welfare to provide them with some form of assistance if they have the proper documentations or finance. If they do not have these two basic ingredients most of the time the burden is left on the shoulders of their families.

When America had many jobs years ago, family members could work two or more jobs to assist them with their needs but today most people are struggling to hold on to their current job much less look for another one that does not exist.

I came to the United States to live exactly thirty-three years ago when **Jimmy Carter** was President of the United States. During those times everything was cheap and many jobs were available. A person could have applied for a Social Security Card by mail, get a Motor Vehicle Identification Card and Drivers License even if he or she was an illegal alien without much questions asked. If they did not like their jobs they could walk off their job and find another one within weeks.

Today in America especially after 911, it is difficult and somewhat impossible for a person to obtain these essential documents in most states. When amnesty was granted to illegal aliens living in the United States by President **Ronald Reagan** many people from Belize, the Caribbean and the rest of the world were eligible to grasp that golden opportunity but failed to take advantage of it due to reasons I still find difficult to grasp. They were given another chance when President **Bill Clinton** signed an Executive Order and still they did nothing to legalize their status in America. Laws have also been changed to restrict people with Permanent Resident status to qualify for certain jobs or do certain things and still they refuse to become naturalized US citizens because of pride in being a citizen from their native countries. Due to the changes made in the United States, citizens who possess Dual Citizenships must now force their countries of natural birth to amend their constitutions which restrict them from having certain rights and privileges to implement a program for them to play an ongoing vital role in their native land.

China is becoming one of the fastest growing economy in the world that is competing with the United States at the international level. Over the years China and many other countries sent their students to the United States to study technology and other educational disciplines at several universities throughout America. Today, these countries have become producing nations rather than consuming nations. There is a relationship between producing and industrial and technological growth for developing nations.

The poorest countries in the world have low production levels and are highly dependent on the producing nations for most of their commodities. Chinese are leaving China because of human rights abuses, to join families in the United States and to invest larger on their capital resources.

Belize, the Caribbean and several developing countries in the world have a lot of untapped natural resources but lack the financial capital, human resources, technology and industries to maximize on them. These countries have the people living abroad and most of them live in the United States of America.

If these countries do not have the money then they will not have extra capital to allocate for their citizens to provide a safety net when they have problems. This is one of the main reason why foreign nationals do not want to go home because they know that there is nothing in place to support them.

The people who were left back home resent most of these citizens who come back home with nothing to give them because their minds are still program to believe that America is the land of milk and honey and these people drank all for themselves and brought nothing back.

Medical treatment is also a major concern of Belizeans and foreign nationals who think about going back home to live permanently.

In Belize and these developing countries like the United States the cost of medical care is becoming more expensive. Most companies in the United States do not cover American citizens for the treatment they receive abroad.

The US Congress should force these insurance companies to pay for the treatment their clients receive abroad if they chose to go and live elsewhere. This would improve the health facilities in these foreign countries and encourage more citizens to return home. Throughout all the Belizean communities in the United States, there is no Belizean association to assist Belizean citizens in their communities when they need help unlike many other countries communities and this is a shame.

Living in a foreign country without having a community based organization makes life difficult. Even the people who were born in America have and depend on these organizations for their survival. Belizeans continue to talk about problems they face rather than find ways to solve them. Part of being a proud citizen of a country is to assist your fellow citizens when they are experiencing difficulties in their lives.

Bureau Of Standard's Statement on Liquefied Petroleum Gas

BELMOPAN, Cayo, February 14, 2011:

The recent revelation surrounding the sale of Liquefied Petroleum Gas (LPG) in the domestic market is underscored by the need for the Bureau to take immediate action to protect the interests and rights of consumers.

As the entity responsible for legal metrology we do not refute these revelations, neither should we be mistakenly viewed as upholding acts of deception that deprive the average Belizean consumer. In an effort to address this issue the Bureau is expeditiously pursuing the following:

In the immediate term the Bureau expects very shortly to pursue measures to provide additional assurance to the consumer as it

relates to purchases of LPG in the domestic market.

In the medium term the Bureau will seek financial support from the Government of Belize to purchase metrology equipment that will assist with monitoring the LPG industry in terms of weights and measures or quantity and quality of LPG mixtures imported.

In addition the Bureau has been able to secure technical assistance from the PTB (Physikalisch-Technische Bundesanstalt) of Germany through its Technical Cooperation arm for Latin America and the Caribbean.The consultancy which is expected to commence in March 2011 will pursue the following objectives:

* Conduct a thorough analysis/assessment of the status - use and needs of standards and application of metrology as appropriate - of the LPG industry in Belize

* Assess product quality and safety

*Evaluate current storage and distribution methods in Belize

* Evaluate and assess suppliers' facilities and infrastructure - plant and equipment

*Seek recommendations for the development of standards applicable to this sector

*Provide guidance on minimum level of investment (capital and technical) necessary of the Bureau for conformity assessment. This includes testing, sampling, inspections, certification and accreditation.

The Bureau acknowledges that this is a serious problem and we are addressing the issue in the quickest and shortest time as resources permit. At the same time, the Bureau reminds the general public that the pursuit to protect consumers cannot be shouldered by one single entity but rather requires active participation by the public and coordination among all relevant regulatory agencies.

Canadian tour manager **Pennie Trip** from Senior Tours out of Montreal in the Canadian Province of Quebec. The group was in the company of local tour guides **Luis Zaiden** and **Cruz Cambranes** from the San Ignacio Resort Hotel.

The report additionally informs that the group was wearing neither life jackets nor helmets.
Today’s post mortem examination was conducted between 1 and 2 pm by forensic specialist **Dr Mario Estradabran** at the Karl Heusner Memorial Hospital in Belize City.
A statement issued by the Belize Tourism Board shortly after of the incident informs that “*The Belize Tourism Board is deeply saddened to learn of the recent death at*

Barton Creek Cave. While the investigation is in its initial stage, the BTB has been made to understand that the tour was led by one of the leading Destination Management Company in the Cayo District. An investigation is currently under-way and we are being updated regularly by the Tourism Police who is also working with other law

enforcement officials. Please know that the BelizeTourism Board takes this unfortunate incident very seriously and will continue to work to understand the situation in an effort to help prevent future incidents of this nature from occurring.”
