Police say that the prompt action by an alert team on mobile patrol successfully averted a robbery in San Ignacio Town.





### Alvaro Aldana Jailed For Gun And Bullets

thoroughly searched but nothing incriminating was found. The police proceeded to search the area resulting in the spotting of a shinny object under a picnic table located a short distance from where Aldana was initially approached.

When the object was retrieved it was found to be a point 380 chrome pistol with black handle bearing serial number CP0 12864. The gun was found fitted with a magazine containing five live rounds of ammunition of the same caliber.

A further search of the area led to the discovery of a black plastic bag found under a grouping of banana trees about five feet from the spot where the gun was found.

When the bag was opened it contained an additional five live rounds of point 380 ammunition. Also recovered from the scene was a black warm cap.

Aldana was instantly detained and escorted to the San Ignacio police station along with the gun, bullets and the warm cap. He was later arrested and formally charged for keeping a firearm without a gun license and for keeping unlicensed ammunition. When asked if he would like to give a statement, he reportedly chose to remain silent.

Aldana spent the remainder of the weekend in police custody. He was taken to court on Monday, July 18, where he pleaded not guilty to both charges.

In light of the gun related offence, Magistrate **Dale Cayetano** proceeded to remand him to jail for ninety days. He will be back in court on Tuesday, October 18, 2011.

**Alvaro Aldana,** 18, of a Delia Street address in San Ignacio Town is no stranger to San Ignacio police.

He is currently on bail in connection with the following five charges: 1) Attempt murder; 2) Three counts of aggravated assault; 3) Keeping unlicensed firearm (a silver and black, 9 mm Sig Sauer brand pistol bearing serial number AE25605); 4) Keeping ammunition without a license (seven 9 mm bullets) and 5) discharging a firearm in public.

The five charges stem from a midmorning, December 2, 2010 incident in which the accused along with one **Kevin** "Midget" **Manzanero**, 26, riding on separate bicycles, were reportedly on a rampage which began at around 10:45 am, when one of them, fired several shots at San Ignacio Town residents **Johan Bermudez**, **Garnet Bermudez** and **Dudley Smith** while they were sitting on the verandah at home.

The next encounter with the pair occurred about 15 minutes later in this incident, San Ignacio resident **Jose Guerra** reported that at around 11:00 am, he was walking on Bullet Tree Road in San Ignacio Town when the men rode up to him and one of them placed a handgun to the left side of his head after which they both rode off.

The duo was eventually halted about 20 minutes later when they arrived, again on separate bicycles, at the 6<sup>th</sup> Street, San Ignacio Town residence of **Anthony Rodriguez** where one of them pulled out a gun and reportedly fired two shots in the air.

The gun reportedly snapped on an attempted third shot this

time at Rodriguez who, with assistance from his brother **Simon Willacy**, administered a beating on them before calling the police.

The gun, the nine bullets and the battered duo were handed over to police.

They were later transported to the San Ignacio Community Hospital and subsequently arrested and formally charged for the five criminal offences for which they are currently on bail.

### **Masked Persons Terrorizing The Community**

FRIDAY, July 22, 2011:

Apart from the headline this week, San Ignacio Police is reporting a significant increase in the number of armed assaults within the community.

#### **INCIDENT #1**

Clarita Zetina, 26, Belizean waitress of a Hillview Area address in Santa Elena, Cayo reported that at about 3:45 pm on Friday, July 15, she was taking a short cut home in an area near the Loma Luz Hospital in Santa Elena when she was attacked by a young male masked person of dark complexion.

Zetina told the police that in the attack, the individual snatched the bag she had slung on her shoulder and that in the ensuing struggle she emerged with abrasions to both hands.

The attacker succeeded in running off with her bag containing \$117 in cash along with her social security card, her voter's registration card and her Atlantic Bank card.

She was also relieved of a gold bracelet valued at \$175.

She was issued with a pair of medical forms via which the injuries was classified, by the attending medical officer, as harm. There has so far been no arrest.

#### **INCIDENT #2**

A 22-year old, US student/ tourist residing in San Ignacio, reported that at about 6:30 pm, also on Friday July 15, 2011, she with four female colleagues, were in the area of the hammock bridge where the Macal meets the Mopan forming the Belize Old River, when they were attacked by a solo, masked, male person of dark complexion who was armed with a machete.

The assailant reportedly threatened them with the machete and ordered them into nearby bushes where he tied their hands and further ordered them to lay on the ground.

He reportedly proceeded to take off the complainant's clothes and unsuccessfully attempted to rape her. He then proceed to sexually assault her with his finger.

She managed to escape but not before she was relieved of a silver color camera valued at \$200.

The assailant also made off

with a \$400 Panasonic camera belonging to one of her colleagues.

The other females managed to untie themselves and escaped. The complainant told the police that although the attacker was masked, she could identify him if ever she comes in contact with him again.

Although she expressly requested court action, an arrest is yet to be made as police informs that they are looking for one suspect while the investigation continues.

#### **INCIDENT #3**

US national, **Jill Hsia**, 19, of an 18th Street address in San Ignacio Town reported that shortly before 9:00 p.m. on Sunday, July 17, she was exercising inside the Victor Galvez Stadium in San Ignacio, along with a fellow US national/roommate, **Kelly Brink**, 21, when they were assaulted by two unmasked male persons of dark complexion whom they saw earlier sitting on the bleachers near the basketball court.

Hsia told the police that one of the attackers held her from behind and robbed of her touch screen iPOD and earphone valued at \$520.


She additionally informed that the attacker also fondled her. The other attacker reportedly held her companion and also searched her but came up with nothing of real value.

In requesting court action she informed that she will certainly be able to positively identify the person who robbed and assaulted her. Again no arrest has been made.

#### **INCIDENT #4**

Louis Krammer, 57, US national/music teacher, residing at #10 Fourth Street, San Ignacio reported that at about 8:00 p.m. also on Sunday July 17, 2011, whilst inside the house he rents, he heard a knock on the front main door. Upon opening the door, two masked male persons of dark complexion rushed into the house one of whom reportedly grabbed him

## Chickenpox (Varicella)

This being the season for Chickenpox - Some basic on the subject should be appropriate

#### What is chickenpox?

Chickenpox (*varicella*) is a common illness that causes an itchy rash and red spots or blisters (pox) all over the body.

It is most common in children, but most people will get chickenpox at some point in their lives if they have not had the chickenpox vaccine. Chickenpox usually isn't serious in healthy children. But it can cause problems for pregnant women, newborns, teens and adults, and people who have immune system problems that make it hard for the body to fight infection.

After you have had chickenpox, you are not likely to get it again. But the virus stays in your body long after you get over the illness. If the virus becomes active again, it can cause a painful <u>viral</u>



infection called shingles.
What causes
chickenpox, and how
is it spread?

Chickenpox is caused by the varicella-zoster virus. It can spread easily. You can get it from an infected person who sneezes, coughs, or shares food or drinks. You can also get it if you touch the fluid from a chickenpox blister.

A person who has chickenpox can spread the virus even before he or she has any symptoms. Chickenpox is most easily spread from 2 to 3 days before the <u>rash</u>appears until all the blisters have crusted over.

You are at risk for chickenpox

if you have never had the illness and have not had the <u>chickenpox</u> <u>vaccine</u>. If someone you live with gets chickenpox, your risk

and threw him to the floor. Whilst pinning him to the floor the assailant reportedly demanded money.

Fearing for his life the complainant reportedly directed them to his wallet, containing US\$4,000 along with BZ\$200.

The robbers also made off with the complainant's black Smart phone valued at \$85 dollars and a plastic bag containing a silver necklace valued at \$50 along with a \$40 brown bead necklace, a \$200 gold ring and two cheques both made out in the name of **Fr. Ed Krammer** each for \$4,650 US dollars (**BZ\$18,600**) for a total of \$27,175.

The complainant informed the police that because of the mask they wore, he would not be able to identify them.

#### **INCIDENT #5**

The fifth reported incident occurred at around high noon on Tuesday, July 19, 2011 in Blackman Eddy Village, Cayo.

It was shortly after the midday hour when San Ignacio police rushed to Society Hall Road where they met **Francisco Penner**, 30, Belizean Mennonite farmer with a swollen left eye and a cut wound to the top of the head.

Penner told the police that at around 12:45, he was on his way home traveling in his horse drawn cart along with his 30 year old wife **Margarita Penner** and their 3 year old son when about half mile into the road he stopped to allow his horse to drink water from a creek.

No sooner had he halted the cart, said Penner, when three masked male persons, of dark complexion, sprang out from roadside bushes. One of them was armed with what appeared to be a shotgun with the barrel sawed off.

The gunman reportedly first struck Penner with the gun in the head and then demanded money.

Penner reportedly pulled out his wallet containing \$120 but instead of handing it to the attacker, he threw it into the roadside bush. Not deterred by Penner's action, the gunmen walked off with a bag containing children clothes.

While Penner was unable to say if the attackers found his wallet, it was not recovered by the police when they searched the area, they did however recover the bag with the clothes. No suspect, no arrest, investigation continues.

tion at a drug store in San Ignacio Town. He was turning off the highway onto Western Street, adjacent to Three Flags Supermarket, when he heard loud bang on the passenger side of his van. The impact shuttered the glass on the front passenger door.

The driver immediately stopped the van and in the process of investigating the incident, he walked behind the vehicle where he saw a male person laying face down on the pavement.

The person was found bleeding from injuries to the forehead. A black mountain bike was also found on the street near the injured man.

Upon closer inspection the driver recognized the person as, **Charlie Trapp**, an acquaintance for over 21 years.

He later learnt that Trapp was riding the bicycle heading in the opposite direction when he crashed into the front passenger side of the van.

Norteño informed that despite Trapp's resistance, he loaded him into the van and rushed him to the community hospital in San Ignacio Town where he was treated for injuries to both sides of the forehead.

At around 8:30 that same night Norteño visited the police station where he reported the accident and a statement was recorded.

He was detained by the police for an overnight and, after serving him with a Notice of Intended Prosecution (*NIP*), Norteño was released the following day.

Similarly, the victim remained under observation at the hospital in San Ignacio for an overnight and was released the following morning.

Three days later, on Thursday, July 14, Trapp began experiencing severe pain and was again rushed to the San Ignacio Community Hospital.

He was later transferred by ambulance to the Karl Heusner Memorial Hospital in Belize City where he remained for two days, on life support until around 5:00 a.m. on Saturday, July 16, when he passed away.

The passing of the victim instantly led police to treat the accident as a traffic fatality and so they visited the scene one week later, on Monday, July 18, to prepare a case file for submission to the office of the Director of Public Prosecutions for legal direction.

The post mortem examination conducted by Forensic Specialist **Dr. Mario Estradabran**, at the Karl Heusner Memorial Hospital in Belize City, on Monday, July 18, 2011, revealed the cause of death as "acute"

lung failure, acute pulmonary edema, bilateral pneumonia, brain thrombosis, head trauma due to road traffic accident."

After perusing the documentary evidence, the office of the Director of Public Prosecutions instructed the police not to proceed with criminal charges against the driver.

A 2:00 p.m. funeral service for **Charles "Charlie" Trapp** was held on Tuesday, July 19, 2011 at the nearby residence of a relative on the Western Highway in Santa Elena Town, after which the procession proceeded to the Carmen Memorial Cemetery also in Santa Elena, Cayo, where he was laid to rest.

### Beto Neal Laid To Rest

After suffering for many years from morbid obesity and associate complications, **Alberto "Beto" Neal** passed away quietly at around 3:00 am on Tuesday, July 19, at his home in Santa Elena, Cayo.

According to his nurse, **Chyna Smith**, the patient, nearing 700 pounds, was bedridden for the last six months of his life and was suffering from hypertension, shortness of breadth and malignant ulcers.

In a television interview after his passing, nurse Smith, on behalf of the family, took the opportunity to express gratitude for assistance rendered by the staff of the Western Regional Hospital in Belmopan, especially sister **Bernadette Rivas** and **Dr. Rene Godoy**.

Nurse Smith also expressed Special Thank You to Ms. Sylvia Godoy the Chairlady of Esperanza Village and to King Jesus Ministries also from Esperanza Village as well as to the nursing staff of the Community Hospital in San Ignacio, especially to sister Sylvia Alvarez.

The 2:00 pm funeral service was held on Thursday, July 21 at the family residence after which the body was laid to rest inside the nearby Carmen Memorial Cemetery in Santa Elena.

Alberto "Beto" Neal is survived by his mother Mrs. Luisa Neal and by his father, Hipolito "Polo" Neal.

He is also survived by four brothers, **Hugo**, **Alfredo**, **Hipolito Jr**, and **Elliott Neal** as well as three sisters, **Margarita**, **Guadalupe** and **Martha** all residing in the United States of America.

He is also survived by his dedicated wife and principal caregiver, Yolanda De La Fuente as well as three sons: Garry, Randy and Roy Neal and one daughter Vanessa Neal. May his soul rest in eternal peace.

is even higher because of the close contact.

## What are the symptoms?

The first symptoms of chickenpox often are a fever, a headache, and a sore throat. You or your child may feel sick, tired, and not very hungry. The chickenpox rash usually appears about 1 or 2 days after the first symptoms start. Some children get the chickenpox rash without having a fever or other early symptoms.

It usually takes 14 to 16 days to get the symptoms of chickenpox after you have been around someone with the virus. This is called the incubation period.

After a chickenpox red spot appears, it usually takes about 1 or 2 days for the spot to go through all its stages. This includes blistering, bursting, drying, and crusting over. New red spots will appear every day for up to 5 to 7 days.

You or your child can go back to work, school, or day care when all blisters have crusted over. This is usually about 10 days after the first symptoms start.

Other illnesses can have symptoms like those of chickenpox. For this reason, you may think you have had chickenpox twice when instead you have had two different infections.

How is chickenpox diagnosed? Your doctor will ask you about your symptoms and will examine you. This usually gives your doctor enough information to find out if you have chickenpox. Healthy children with chickenpox symptoms may not

## British Fireman Shot In Venezuela After Confronting Armed Robbers

Thomas Ossel, 28, who worked for the London Fire Brigade based in Chiswick died instantly after being shot in the face when a gang of thieves forced their way into a guesthouse at a popular resort on Margarita Island, Monday night.

Details of the terrifying attack, in which Mr Ossel's younger brother, Jack, 21 was stabbed in the back but survived, emerged Wednesday. The brothers were traveling in **Venezuela** with a friend, Owen Pearce, 21, who was not hurt during the attack.

The owner of the Posada Casa Rosa said a gang of at least five armed robbers tricked their way into the hotel and then went room to room threatening guests at gunpoint.

"At about 9pm someone rang the doorbell and said they were looking for a room so I opened it," said Peter Eggersdorfer. "A group burst in and I felt a pistol held to my head."

But when the gang tried to rob the three British men they encountered resistance.

"The British people started fighting with them, I couldn't see (what was happening) but

*could hear*," said Mr Eggersdorfer.

I could hear shouting "give me dollars" It was very noisy, lots of action, and then I heard five shots, four in the wall but the last one went into the body of Tom Ossel.

The mother of Mr Pearce described her son's ordeal after speaking to him on the telephone following the attack.

"We've spoken to Owen and both he and Jack are bearing up well," said Meg Hughes-Pearce, 59 from Hereford. "They are very shocked and horrified. They both tried so hard to save Tom but he bled to death."

She confirmed that the robbers opened fire after meeting resistance.

"We don't know exactly how,

but a fight broke out. I think the boys confronted the men because they thought they were going to get shot anyway."

"One of the gunmen opened fire. He had a semi-automatic and bullets were spraying around the room."

"Tom was shot and Jack was stabbed in the back. He's had some stitches but he's left hospital."

"The boys tried to fight back and were throwing furniture at them because that was all they could do. Then the gun jammed and they ran off. They are extremely lucky to be alive."

"Tom was a wonderful boy, a really good guy," she added.

Friends and colleagues paid tribute to Mr Ossel as his father, Ben, flew in to Caracas Wednesday to be with his surviving son.

"We were shocked and saddened to learn of Tom's untimely death," said Ron Dobson, commissioner of the London Fire Brigade. "I know he will be sorely missed by his fellow firefighters."

"Our thoughts are with his family, friends and colleagues at this sad and difficult time."

A tribute page had been set up on Facebook and one friend, Sam Bradley, wrote: "Tom was like a brother to all his mates, male and female. He always seemed to fall on his feet and was surprisingly intelligent."

The **UK Foreign Office** warns of the high risk of violent crimes in Venezuela and that armed muggings and "express kidnappings", opportunistic abductions to extort money from someone, are regular occurrences.



## Belize Should Sign A Defense Pact With Mexico And The United States

Since Belize was granted independence from Great Britain by the Conservative Party under the leadership of Prime Minister Margaret Thatcher on September the 21st 1981, the country is still vulnerable to the historical claim made by Guatemala and its people since 1859. The British landed in Belize in 1638 due to a shipwreck by one of their sailors Peter Wallace on his way to the island of Jamaica. At that time, Spain was given all the territories in the Caribbean and the Americas except the country of Brazil in a treaty signed by Spain and Portugal titled the Treaty of Tordesillas in 1494.

This treaty was witnessed and mediated by a Spanish Catholic Pope Alexander the V1. The British, French and Dutch did not recognize and accept this treaty and decided to wage war against the Spanish for all the territories in the region. The Spanish government later decided to divide the administration of Belize between the Captaincy General of New Spain with its capital in Mexico City and the Captaincy General of Granados which capital was in Guatemala City. The British continued to maintain their settlement in Belize despite opposition from the Spanish crown. Belize was granted colony status in 1862, self government in 1964 and later on independence in 1981. While Belize was developing as a nation state, its neighbors Guatemala and Mexico were doing the same. After Mexico obtained its independence from Spain in 1821, they later signed a treaty with Great Britain in 1893 relinquishing their claim to Belize and establishing permanent borders between the two countries. Guatemala on the other hand, signed a treaty with Great Britain in 1859 to recognize the borders of Belize but later dishonored the treaty due to a clause in the treaty for Great Britain to build a road from Belize to Guatemala but failed to meet their commitment. Since then, Guatemala has been claiming Belize and has threatened to use military force to retake Belize from time to time.

The British Government has been downsizing their forces in Belize since independence and left only a small contingent of forces in the country for military training called British Army Training Support Unit Belize (BATSUB) which ceased most operations in December of 2010. This is happening after the British exploited the country for a total of three hundred and forty-three years. Belize is now left with the burden of trying to resolve a dispute that they did not create which should have been resolved years ago between the British and the Spanish or with the Guatemalans. Belize with its three hundred and thirty-three thousand population and one thousand troops, cannot fight against Guatemala which have about thirty-five thousand active troops and compulsory service that can assemble two million soldiers within months out of the thirteen million inhabitants they possess.

Mexico has not claimed Belize since they signed a treaty with Great Britain years ago and is one of the countries that enjoys good bilateral relations with Belize in all areas. Yet, Mexico has said on several occasions that if Belize was to concede any territory to Guatemala, they would reserve the right to regain the land they ceded in the treaty with Great Britain years ago. Guatemala has not fully recognized the independence of Belize and is still claiming and pressuring Belize to concede some of its territory to them. Guatemala is a huge country compared to Belize and have more than enough land for all its citizen. Still, the native Maya people are not given the opportunity to own their land which was taken away from them by the Spanish Conquistadores back the 1600's. The citizens of Guatemala continue to flee their country into Belize to avoid the military from slaughtering them. Mexico is willing to assist the people and country in anyway and have alerted Belize on several planned Guatemalan military exercises and invasions.

With Belize being the only English speaking country in the Central American region that is of strategic importance to the United States, Belize should also explore the possibility of signing a defense agreement with this country. The United States government is aware of Belize's strategic importance to their country and have assisted Belize with millions of dollars in technical aid. While the British government has been distancing itself from Belize, the American government has been paying keen interest in the affairs of Belize. With drug trafficking, crimes and gangs stepping up in the region, which could possibly lead to the destabilization of governments America has the resources to stop the bleeding.

If the United States does not commit itself to helping Belize and these Central American

nations, the problems will come to America's doorstep. If the Americans were to commit themselves to defend Belize against Guatemalan aggression, there would be some benefits to the American government in the form of economic and natural resources. Some Belizeans might not be in favor of this proposal but the longer this Guatemalan claim remain unresolved, the more it is going to stifle growth and development for our country and people. Guatemala is not going to stop claiming Belize until they realize that they are going up a force that they cannot contend with and that force is the United States of America. The United States government has a good history of living up to their commitments especially when it is in their nation's best interest to do so. Great Britain at one time was the same but now that their resources have been depleted, they are being forced to abandon most of their commitments in the world today. Great Britain also depends on the United States for many financial commitments before they decide on what to do on many oversees ventures.

the village. The report was also relayed to the San Ignacio mobile patrol which at the time was following up a burglary report in San Ignacio Town.

SPU personnel responded rapidly. They arrived on the scene within minutes. Armed with preliminary information, SPU personnel rushed towards San Ignacio Town being the direction reportedly taken by the suspected get-away vehicle which was described as a white, 4 door, Toyota Corolla car. They came upon a car fitting the description parked at the corner of Bullet Tree Road and Unity Street in San Ignacio where they found a group of persons socializing in the yard.

The investigation led to the detention of two persons who were later identified as Belizean domestic, **Jessica Lamb**, 21 and **Khader Habet**, 20, Belizean unemployed residing at the house where the white, 4-door, Toytota Corolla car, with San Ignacio/Santa Elena license plates C01403, was parked.

San Ignacio police visited the scene where **Guo Lian Wu**, 43, Chinese Belizean, owner of the store, reported that he was behind a counter in the store selling boledo when two, slim built, male armed masked persons with blue and white rags covering their nose and mouth, rushed inside the store which at the time was occupied by a

Chinese female employee, **Yiao Yu Luo**, 43, and her 17 year daughter. No customer was inside the store at the time.

Wu informed that one of the robbers pointed a gun at his head while the other pointed a gun at the employee's head as she sat behind another counter where the cash drawer is located.

While holding the gun to the employee's head with one hand, the robber used the other hand to pull open the drawer and emptied it of all the contents and depositing it into a black string knap sack after which they both ran out the store and disappeared into a side street.

Wu informed that while the proceeds from the sale of boledo was under the counter where he sat, it remained untouched. He told police that the robbers made off only with the day's sale amounting to about five hundred dollars.

Seven persons were initially detained during the process of the preliminary investigation of which five were later released.

It is reported that at least one of the detainees is singing like a bird by way of a caution statement.

As the investigation progressed, a third suspect, identified as **Gilberto Castillo**, was later detained.

Going to press on Thursday night, the three suspects still in police custody are, **Jessica Lamb**, 21, the alleged driver of

need to visit a doctor. You may be able to describe your child's symptoms to the doctor over the phone. Then your child won't have to leave the house and risk spreading the virus to others. But it is important to check with your doctor to find out if he or she wants to see your child.

Teenagers, adults, pregnant women, and people with health problems need to see a doctor for chickenpox. This is especially important for pregnant women, since chickenpox during early pregnancy can cause birth defects. Call first to make an appointment and to discuss whether you need to take any steps to avoid spreading the virus when you arrive. For example, office staff may take you straight to an exam room, rather than have you wait in the lobby.

#### How is it treated?

Most healthy children and adults need only home treatment for

chickenpox. Home treatment includes resting and taking medicines to reduce fever and itching. You also can soak in oatmeal baths to help with itching.

People with long-term diseases or other health problems may need more treatment for chickenpox. They may need immunoglobulin treatment (IG) or antiviral medicine. Your doctor can give you these soon after you are exposed to the virus to help you feel better sooner.

## How can you prevent chickenpox?

You can prevent chickenpox by getting the chickenpox vaccine. Doctors recommend two doses of this shot for healthy children 12 months of age and older who have not had chickenpox. Older children and adults who have not had chickenpox and have not yet had the vaccine also need two doses.

If you have been around a person who has the virus and you have not had chickenpox or the vaccine, you still may be able to prevent the illness. Get a shot

of chickenpox antibodies or the vaccine right away.

In rare cases, people who have had the vaccine still get chickenpox. And a few people who have already had chickenpox get it again. If this happens, a milder form of the illness usually occurs, with fewer blisters and symptoms. This is called a breakthrough infection.

Do not expose your child to chickenpox on purpose. Some

parents expose their children to chickenpox because they think it is safer for children to have the illness when they are young. But this isn't a good idea, because even young children can have serious problems from chickenpox.
