A student from San Ignacio Town is today on a five thousand dollar bail for injuring, robbing and sexually assaulting a woman over twice his age. Couple Robbed Near Police Station

SAN IGNACIO TOWN, Cayo District, 14 October 2011:

A man from San Ignacio Town stands accused of pulling off a brazen early morning double robbery within shouting distance from the nearby police station in San Ignacio Town.

Nelina Ayuso, 30, Belizean businesswoman, of a Zericote Street address in San Ignacio Town visited the police station at around 2:20 on the morning of Friday, 14 October and reported that about five minutes earlier she and her common-law husband were robbed by a masked male person.

Ayuso told the police that after closing her business place, **Canta Bar**, on Hudson Street, she and her common-law husband, **Jose Jimenez**, were walking to their separate vehicles for the journey home. Jimenez' car was parked across the street from Trin's Meat Shop while her car was parked in the lot in front of the town hall.

iPod belonging to Avella and a black Motorola cellular telephone belonging to Montejo.

The daylight hours worked to the advantage of the team of policemen responding rapidly to the report resulting in the arrest of Palacio and two alleged co-conspirators.

The investigation revealed that while the robbery was pulled off by Palacio acting solo, the masterminds behind the plan were Police Constable **Holly Vasquez**, then 21, and Belizean Vasquez and Torres as revealed by all three phones the police found in their possessions. In connecting the dots of the text message communications between the trio investigators were able to establish that the crime was initiated by Torres with Vasquez brought in by Vasquez' own text admission as *"the best passport unu got"*

In a statement to police, Palacio, who told the police that he resides at #52 Castle Street in Belize City, informed that he was chilling out in Esperanza village when he allegedly received a call from Vasquez, at around 7 o'clock that Sunday morning, he "told me that he had a move for me". He said that he met his police friend Vasquez, along with Torres, at the double court behind the old hospital in San Ignacio Town. He said that "Vasquez then briefed me carefully about the Gas Station and told me how to do it and get out of the area." He was dropped off at the Gas Station across the street in the white pick-up. "I then went to the Gas Station and I robbed the Gas Station. I called both valued at ninety five dollars along with its contents being nine hundred and fifty dollars in cash, a Victoria Secret lotion valued at twenty dollars and a make-up set valued at one hundred and fifty dollars. Before running off, the assailant also relieved Jimenez of his wallet containing four hundred and eighty dollars in cash.

The investigation later led to the detention and positive identification of **Kevin Manzanero**, 28, Belizean laborer of a Benque Viejo Road, San Ignacio Town address. Manzanero was subsequently arrested and formally charged for robbery.

He appeared in court on Wednesday, 19 October where he pleaded not guilty to the charge.

The prosecution's objection to bail was upheld by **Magistrate Linsbert Willis.** He was remanded to prison and ordered to return to court on Friday, 2 December 2011.

Notwithstanding however, Manzanero is currently out on bail granted by the by the Supreme Court.

Palacio was later arrested and formally charged for three counts of robbery, one count of keeping an unlicensed firearm for the black 941F Jerico brand 9 mm pistol with serial number 153182 found in his possession, and one count of keeping

Realizing that he might not soon be free from jail, Palacio was extremely boisterous in court towards the Magistrate and the Prosecutor when he appeared in San Ignacio's magistrate court on Monday, 17 October. His actions resulted in Magistrate Linsbert Wills, ordering that he be returned to the police holding cell. However, when he appeared in court the following day he was even more boisterous, this time with curse words, towards the Magistrate and the Prosecutor. When he eventually cooled down, he informed that he was changing to a guilty plea. He was consequently sentence to two five-year terms which of course will be swallowed up by the time he is currently spending for other convictions. electrician **Edward Glenford Torres**, then 34.

The first to be found was Palacio, still in possession of the loaded gun, the two stolen telephones and over five hundred dollars in cash. He was found hiding under banana tree leaves, behind a house on Collins Boulevard. The investigation later revealed that the property was connected to Torres.

The investigation further revealed that whilst in hiding, waiting for the get-away ride, Palacio was busy sending and receiving text messages from unlicensed ammunition for the 10 rounds of live hollow point 9 millimeter bullets found in the magazine.

They were all remanded to prison for 10 days. They reappeared in court on 28 October and were all granted bail. After which Palacio returned to Belize City where he was later arrested for attempt murder. He was again offered bail and later arrested for possession of a prohibited firearm when he was found in possession of an AK-47 machine gun for which he is now finally serving several years.

Mr. Golding announced last month that he would resign once the ruling Jamaica Labour Party (JLP) had chosen a new leader - who automatically becomes Prime Minister.

Flores Facing Drug Trafficking Charge

SANTA ELENA TOWN, Cayo, Tuesday, 18 October 2011:

San Ignacio police is this week reporting the arrest of a Santa Elena man reportedly connected to the discovery of almost two pounds of weed near his residence.

Acting upon information received, at team of policemen rushed to the George Price Avenue, Santa Elena Town, residence of **Nelson "Quack" Flores**. The report indicates that upon arrival, a member of the team reportedly saw Flores as he ran behind the house with a black plastic bag in his hand. He was reportedly seen throwing the

bag across a creek. The police caught up with him, detained him and escorted him to the area where the bag landed. When the bag was retrieved and opened it was found to contain suspected marijuana.

Flores was transported to the police station and the content of the bag was weighed in his presence tipping the scale at exactly 900 grams (1.98 pounds). Flores was formally arrested and charged for drug trafficking.

He appeared in the San Ignacio Town courtroom of presiding Magistrate **Linsbert Willis**, on Wednesday, 19 October, where he pleaded not guilty to the charge. He was offered and met bail in the sum of ten thousand dollars and was ordered to return to court on Thursday, 19 January 2012.

Tortilla Vendor Jacked In Santa Familia Village

SANTA FAMILIA VILLAGE, Cayo, Wednesday, 19 October 2011:

A corn tortilla vendor, on a routine evening run in Santa Familia Village, was reportedly jacked of the little cash he carried. **Ezequiel Jimenez**, 38, Belizean tortilla vendor employed by **NL's Corn Tortilla Factory** located on Liberty Street in Santa Elena Town, reported that at about 4:30 this Wednesday evening, he was driving the company's white Toyota pickup truck in Santa Familia Village, on routine evening sales run, when he was robbed by two armed masked men.

Jimenez informed that upon reaching behind the primary school in Santa Familia village on his usual route, having reached the end of the road, he was reversing the vehicle as usual when he was robbed. Jimenez said that he was approached by two male persons, one on either side of the pickup truck. He told the police that the men were both wearing warm caps covering their faces and peeping through holes in their caps. Jimenez alleges that both persons were armed with black handguns. He said that the one on the driver's side pointed the gun at his head while the other assailant positioned himself behind the vehicle. The

Rolson Contina & assailant on his side of the vehicle reportedly ordered him to hand over the black cash purse which was on the seat beside him. He promptly handed over the purse containing one hundred and twelve dollars along with his grey SMART Verizon flip cellular telephone valued at sixty dollars.

Jimenez alleges that after grabbing the purse and the phone,

both assailants disappeared into nearby bushes. He promptly contacted his employers by using the mobile radio with which the vehicle is fitted and reported the incident. He then travelled to the police check point where he reported the matter to the policeman manning the check point.

Jimenez informed that this is the



very first time he has been robbed. No arrest has been made as police investigate the report.

Libya Plans Secret Burial For Muammar Gaddafi

It is believed Colonel Gaddafi and his entourage had been trying to flee Sirte

Libyan authorities are planning a secret burial for ousted leader **Colonel Muammar Gaddafi** following his capture and death, the BBC understands.

However, it appears there may be a delay in his burial, which under Islamic tradition should take place as soon as possible. Oil minister **Ali Tarhouni** told Reuters that Col Gaddafi's body may be kept "*for a few days*".

Nato is expected to declare an end to its Libya campaign in the coming hours.

French President **Nicolas Sarkozy** said the death of Col Gaddafi meant Nato's military intervention in Libya had reached its conclusion.

"Clearly the operation is coming to its end," he told reporters.

Earlier, French Foreign Minister Alain Juppe said the Nato operation would end "subject to a few transitory measures in the week to come".

Authorities now have the dilemma of what to do with the body of Muammar Gaddafi, now in the town of Misrata where it was paraded in the streets on Thursday.

Disagreements appear to have broken out over what should be done with it. Under Islamic law Col Gaddafi should be buried within 24 hours of his death. Interim authorities want a secret burial but no decision has yet been taken on where it should take place - in Misrata, Sirte or out in the Libyan desert. One official told the BBC that fighters from Misrata who captured the fugitive leader don't want to give up control over what happens to his body now. The BBC's Caroline Hawley in Tripoli says the authorities now have to decide how to deal with Col Gaddafi's death and in particular his burial. They have said they will conduct a secret burial and there is some speculation that they might even try to bury him at sea, as al-Qaeda leader Osama

Bin Laden was buried, to prevent any grave being turned into a shrine, she adds

Mr. Tarhouni told Reuters that Col Gaddafi's body - currently in Misrata - was not going to be released for burial immediately. *"I told them to keep it in the freezer for a few days... to make sure that everybody knows he is dead,"* he said.

Asked about the burial arrangements, he said: **"There is no decision yet."**

Reuters also quoted an unnamed official as saying there was disagreement within the **National Transitional Council** (*NTC*) over what to do with the body.

Meanwhile, questions are mounting as to exactly what happened in Col Gaddafi's last moments following his capture. Officials have denied he was executed. There are two videos out there, one showing him alive and one showing him dead and there are four or five different versions of what happened in between those two videos. That obviously raises major concerns. Acting Prime Minister Mahmoud Jibril said Col Gaddafi had been shot in the head in an exchange of fire between Gaddafi loyalists and NTC fighters following his capture in his hometown of Sirte Video footage suggests he was dragged through the streets.

An NTC fighter told the BBC he found the former Libyan leader hiding in a drainage pipe and he had begged him not to shoot.

The fighter showed reporters a golden pistol he said he had taken from Col Gaddafi.

Sayeh told the BBC he doubted that the colonel was deliberately killed, but added: "Even if he was killed intentionally, I think he deserves this."


He added: "If they kill him 1,000 times, I think it will not pay back the Libyans what he has done. We've lost over 70,000 of our best men because of this monster."

On Friday, the UN High Commissioner for Human Rights **Navi Pillay** said there should be a full investigation into the way Col Gaddafi was killed.

Her spokesman **Rupert Colville** told the BBC that Col Gaddafi's death could have been illegal.

that is recognized clearly in international law. On the other hand, it is also very clear under international law that summary executions, extrajudicial killings, are illegal."

UK-based human rights group <u>Amnesty International called</u> for "*a full, independent and impartial inquiry*" into the circumstances of Col Gaddafi's death.

As reports of Col Muammar Gaddafi's death spread thousands of people took to the streets across Libya

Venezuelan President **Hugo Chavez**, an ally and friend of the colonel, called his death deplorable.

"They murdered him," Mr. Chavez told reporters.

However, our correspondents say few Libyans are worried about the manner of their former dictator's humiliating end. They are simply elated that he is gone.

Despite the controversy, celebrations continued late into the night in towns and cities across Libya.

Groups of young men fired guns in the air, and drivers honked their horns in jubilation. US Secretary of State Hillary Clinton, speaking in the Pakistani capital Islamabad, said Col Gaddafi's death marked the start of a new era for the Libyan people. The NTC is expected to formally announce the liberation of the country on Saturday in the eastern town of Benghazi. Nato Secretary-General Anders Fogh Rasmussen said that with the death of Col Gaddafi, an end to the alliance's involvement in the country "has now moved much closer". "After 42 years, Gaddafi's rule of fear has finally come to an end," he said. "I call on

all Libyans to put aside their differences and work together to build a brighter future."

Nato's seven-month campaign of air strikes was carried out under a UN mandate authorizing the use of force to protect civilians in Libya.

Nato has carried out some 26,000 sorties and almost 10,000 strike missions.

Jim Swire: "I think it would have been much better if he could have been kept alive"

Col Gaddafi, who came to power in a coup in 1969, was toppled from power in August. He was making his last stand in Sirte alongside two of his sons, **Mutassim** and **Saif al-Islam**, according to reports.

A body that officials identified as that of Mutassim has been shown on Libyan TV.

There are conflicting reports as to the whereabouts of Saif al-Islam.

On Friday he was reported to be fleeing south towards Niger, according to a senior NTC commander.

Abdul Majid Mlegta told Reuters that Saif al-Islam was believed to be in a convoy of three armoured vehicles trying to escape NTC forces that overran Sirte on Thursday. "We are searching for him. The fighters in the region are on full alert," Mr. Mlegta said. Earlier, acting Justice Minister Mohammad al-Alagi told AP news agency that Saif al-Islam had been captured and taken to hospital with a leg wound. No Leader Of The Opposition In The House Of Representatives

BELIZE CITY, Friday, 21 October 2011:

For the first time in post independence history, Belize's House of Representatives met today with no leader on the opposition side of the floor.

Former Prime Minister, **Rt. Hon. Said Musa**, was initially selected to act as the Opposition Leader for the day, but this was retracted when it became evident that he did not have support from three of the six opposition representatives.

Musa's bid for a day at the helm of the opposition was not supported by former party leader, **Hon. John Briceño**; former interim leader, **Hon. Mark Espat** and Lake Independence area representative, **Hon. Cordel Hyde.**

The opposition People's United Party (**PUP**) has been experiencing leadership challenges for over three years since Said Musa's resignation in 2008.

After serving for twelve years, since replacing the original leader **Rt. Hon. George Price**, in 1996, Musa abruptly resigned the leadership position in the wake of the February 2008 General Elections defeat of his party which served for two consecutive five year terms between 1998 and 2008.

Orange Walk Central's Area Representative and former Deputy Prime Minister under the Musa administration, **John Briceño**, emerged as the new party leader after Musa resigned in 2008.

From its inception the Briceño leadership has been marred with challenges emanating particularly from the so called "old guard" faction the party, represented by Francis Fonseca who contested the leadership convention against Briceño. The challenges continued with repeated requests for Briceño to call a national convention for the election of a party leader as stipulated by the constitution of the People's United Party. A questionable convention was held in late 2010 in the northern village of Patchacan where Briceño was endorsed to serve another two-year term as leader of the PUP.

The pressure further worsened from within as support for Briceño began to further dwindle resulting in the party suffering terrible defeats at the polls in the 2009 municipal elections and the 2010 village council elections.

Briceño's leadership further suffered when a United States Embassy correspondence to Washington emerged via the infamous wikileaks alleging the receipt of a 1.5 million US dollar bribe for the granting of a petroleum exploration license to a foreign company, the proceeds of which, it is allegedly, was used to purchase two cable TV companies in northern Belize.

Much to the surprise of many within the PUP, especially the "old guard" Briceño abruptly resigned on 7 October and the reigns was immediately handed over to his colleague in the "new guard" Hon. Mark Espat one of three deputy leaders of the party.

Given the element of surprise and the potential crisis that was enveloping the party with the sudden resignation of John Briceño, the initial reaction was to show, at the very least, a semblance of unity and so emerged Espat as the interim leader of the PUP. However, given a few days for the reality of the decision to sink in, the old guard remerged, first with the announcement of the untested, Arthur Saldivar, being the only candidate to submit an application for the leadership position. However, just as the application period was coming to a close on 19 October, Espat announced that he was not seeking election as leader of the party With Saldivar alone in the race three other elements from the old guard were announced as candidates for the leadership being the untested candidate in

the person of the party treasurer, **Julius Espat**, and the veteran politician **Michael Espat** from the Toledo East constituency all three of whom hold no nationally elected position in any constituency.

Having bought enough time, the previously defeated Francis Fonseca, after first refusing the position, was eventually *"convinced"* to take on the leadership following the eventual withdrawal of Arthur Saldivar, Julius Espat and Michael Espat. While Fonseca is awaiting

Struggling Wikileaks Stops Publishing Classified Files

MONDAY, 24 October 2011:

Julian Assange says a blockade by US finance companies has cut off 95% of Wikileaks' revenue

The whistle-blowing website Wikileaks is suspending its publication of classified files.

Wikileaks said that it would focus instead on raising funds to ensure its future survival.

The announcement came after what the group called a blockade by US-based finance companies.

This followed its disclosure on the internet of hundreds of thousands of secret US government files and diplomatic cables.

Wikileaks founder Julian Assange said that since last

December an "arbitrary and unlawful financial blockade" had been imposed by Bank of America, Visa, MasterCard, PayPal and Western Union. The attack has destroyed 95% of our revenue," he said. The former computer hacker said the organisation had lost "tens of millions of dollars in lost donations at a time of unprecedented operational costs. A handful of US finance companies cannot be allowed to decide how the whole world votes with its pocket," he added.

Hugo Chavez Is Not Dying Says Venezuelan Doctors

CARACAS, Venezuela, Monday, 24 October 2011:

Doctors treating Venezuelan President **Hugo Chavez** have disputed a claim that he has only two years to live.

The claim was made by **Dr Salvador Navarrete**, who has fled Venezuela, saying he feared for his life.

Dr Navarrete said last week that Mr Chavez had a very aggressive form of cancer.

A member of Mr Chavez's medical team said Dr Navarrete was wrong and had no access to the president's clinical records.

In their first official public comments on the Venezuelan leader's health, three doctors dressed in white coats said

his family," Dr Ramirez said. But the three doctors still did not say what type of cancer the Venezuelan leader has.

<u>'Complete secrecy'</u>

On Thursday, Mr Chavez returned from a medical

"I'm worried that the president and those around him do not know the full magnitude of his illness given it has been handled with complete secrecy," he said.

After the interview was

Mr Assange said Wikileaks must "aggressively fundraise in order to fight back against this blockade and its proponents".

He said the group was taking pre-litigation action against the blockade in Iceland, Denmark, the UK, Brussels, the United States and Australia and had lodged an anti-trust complaint at the European Commission.

Mr Assange is in Britain awaiting a decision by the High Court on the appeal against his extradition to Sweden to face sex assault charges.

After the hearing in July, judges did not give a date for their decision on Mr Assange's bid to overturn a judgment made in February.

He fears extradition to Sweden may lead to him being sent to the United States to face separate charges relating to Wikileaks, for which he could face the death penalty.

The Australian won bail in December and has been staying at Ellingham Hall, a 10-bedroom Norfolk farmhouse owned by Vaughan Smith, director of the Frontline media club.

His bail conditions include wearing an electronic tag and daily appearances at a nearby police station.

Mr Assange describes the allegations as "without basis".



Salvador Navarrete was uninformed and had only had minimal contact with Mr Chavez 10 years ago.

"The president, from the standpoint of cancer, has been diagnosed and treated early. Subject to the appropriate follow-up treatments, the current status is quite satisfactory with an excellent prognosis," one of the doctors, Fidel Ramirez, said in a televised news conference at Venezuela's main military hospital in Caracas.

"Navarrete was not Chavez's physician, or a trusted party, or check-up in Cuba saying he was cured.

Dr Navarrete made the remarks about the Venezuelan leader's health to a Mexican magazine, Milenio, last Monday.

He said in the interview that he had treated Mr Chavez around 10 years ago and had stayed in touch with members of the president's family and medical team.

Dr Navarrete said he had information from the family that the president was suffering from a serious form of cancer - a sarcoma - in his pelvis. published, he said in an open letter published by local media on Friday that police had visited his office, and had searched his files and computers.

He fled Venezuela, along with his family, to an undisclosed location.

The 57-year-old president insists he is well enough to run in the 2012 elections and serve another six-year term.

Mr Chavez travelled to Cuba four months ago for surgery, and has had four cycles of chemotherapy.

Last month, he denied US media reports that he had been

Argentina's Cristina Fernandez celebrates landslide win

BUENOS AIRES, Argentina, Friday, 21 October 2011:

Argentine President Cristina Fernandez de Kirchner has won re-election in a landslide victory, on the back of strong economic growth in the country. Ms Fernandez secured nearly 54% of vote, with her closest challenger, socialist Hermes Binner on just 17%.

Ms Fernandez told jubilant supporters in Buenos Aires' Plaza de Mayo that she wanted to keep Argentina growing.

She also made an emotional reference to her late husband, former president Nestor Kirchner, who died a year ago. "Count on me to continue pursuing the project," she said, watched by supporters on a huge TV screen. "All I want is to keep

who transformed Argentina led us all and gave everything he had and more. Without him, without his valour and courage, it would have been impossible to get to this point."

Ms Fernandez may also regain control of Congress, which she lost in mid-term elections in 2009.

Nearly 30 million voters were choosing who will fill 130 seats in the lower house of Congress, 24 Senate seats and nine governor's offices as well as hundreds of local seats.

The victory marks a dramatic change of fortune for Ms Fernandez, the BBC's Vladimir Hernandez in Buenos Aires says. Ms Fernandez is set to remain the Pink House's resident for the next four years

Political analysts say Ms Fernandez's current popularity is mostly due to the health of the economy, which has boomed thanks to high prices for exports such as soya.

She has also carried out social programmes - such as benefits for three million of the country's poorest children - which have proved extremely popular.

But her critics accuse her of pursuing populist policies, and question whether such programmes can be sustained.

She has also been accused of downplaying the rate of inflation, which is now the second highest in Latin America, behind Venezuela.


