Criminal Charges Building Up Against Alvaro Aldana

SAN IGNACIO TOWN, Cayo, Monday, 24 October 2011:

He is currently out on bail for attempt murder and firearm offences, underage at the time when he is alleged to have committed these crimes, he was legally protected from getting his name and photograph published anywhere. He is now of age and his alleged criminal ways continues as the protective shield has disappeared with his coming of age.

His name is **Alvaro Aldana**. He is back in the news this time around as an 18 year old adult.

Police reports that at around 1:30 am, during the early morning hours of Saturday, 22 October, **Jose Martinez**, 52, Belizean contractor was walking on Flamingo Street towards his house located on the same street, when he was attacked by two unmasked male persons, one of fair and the other of dark complexion.

Martinez said that the attacker of dark complexion hit him in the head with a stick causing a cut wound. He told the police that the area was lighted by street lamps thereby enabling him to identify, by face but not

by name, the attacker of clear complexion who he said lives in the neighborhood.

The victim was taken to the hospital in San Ignacio where the injury was officially certified as wounding.

Police investigation led to the detention, positive identification, arrest and formal charging of **Alvaro Aldana**, 18, Belizean unemployed of a Dalia Street address in San Ignacio Town, for the crime of robbery.

He appeared in court on Monday, 24 October, where he pleaded not guilty to the charge. The prosecution objected to the grating of bail on the grounds that, having now been arrested for another crime, places him in violation of the conditions of the bail for attempt murder and firearms offences which he is

currently on. Notwithstanding, **Magistrate Linsbert Willis** proceeded to offer the accused bail in the sum of \$5,000. He was ordered to return to court on Wednesday, 25 January 2012.

Five Armed Masked Men Invade King Jesus Ministries

This week's home invasion took place at the residence of **Richard "King Jesus" Woolley** in Esperanza Village, Cayo.

Acting upon receipt of a 911 call for assistance, on Saturday, 22 October, police rushed the King Jesus Ministries property in Esperanza village where **Epsy Torres Woolley** reported that at about 8:30 that night, five heavily masked armed men, in dark clothing, stormed into her house and held her up at gunpoint. She was accompanied by her sister **Chana Torres** and

a cousin **Lisa**. All three were individually tied, hands behind their backs, with electrical wire.

The intruders reportedly demanded money and when they were told that there was none in the house they began ransacking the place for about an hour and came up empty handed.

When they finally left, at around 9:30 pm, they drove off in the family's unlicensed, white, Dodge Ram 1500 pickup truck with license plates CY-C-

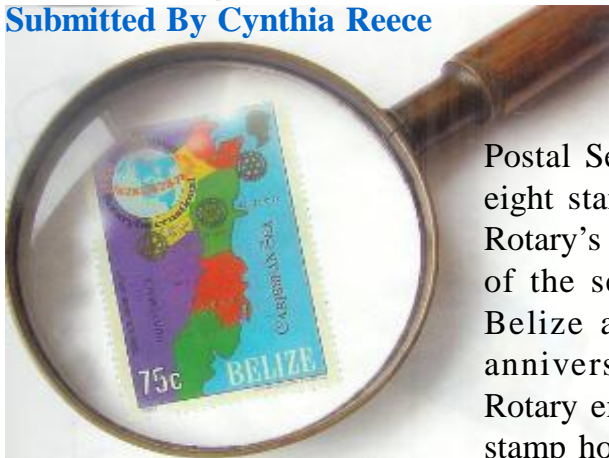

Controvertial 30 Year Old Rotary Stamp Now Worth Big Bucks

The most valuable Rotary stamp was on sale for only two hours in 1981.

In March of that year Premier George Price returned to Belize from meetings in London with a proposed Heads of Agreement in hand.

The Heads of Agreement was supposed to pave the way for Belize's independence from Great Britain later that same year.

The Belizean people were opposed to the Heads of Agreement because they believed that it ceded too much to Guatemala and so began violent protests in Belize City.

In the midst of the political unrest, on 30 March, The Belize Postal Service issued a set of eight stamps to commemorate Rotary's 75th anniversary. One of the sets carried a map of Belize along with Rotary's anniversary logo and three Rotary emblems. The 75 cents stamp however appeared to be ceding the entire Cayo District to Guatemala, due to the similar colors that delineated them.

The Belize Postal Service reacted by immediately withdrawing the entire series and destroying it. However, some were already sold in the two hours that the series was in circulation. The few that were sole "Today, it's worth US\$1,200 each - if any can be found," Emmanuel Serriere says.

The rest of the stamps in the series were reissued in May, 1981, and again in September, this time overprinted with the date of Belize's independence.

The following morning, Sunday, 23 October, police received a report of the presence of an abandoned white pickup truck in the Trapiche area of Santa Elena. A team of policemen rushed to the area where they found the stolen truck with a set of keys in the ignition but with the battery gone. A replacement battery was connected to the vehicle and it was driven to the police station

where it remains.

Several suspects were detained, questioned and released as the investigation continues.

Amazingly, while the police have been successful in making arrests for other crimes, they are yet to make a single arrest in the increasing number of the more serious incidents of home invasions occurring within the community.

Simple Practice During The Flu Season

October marks the start of the flu season and the Ministry of Health has seen a slight increase in flu cases in specific regions around the country since last month.

The Minister of Health, **Hon. Pablo Marin**, on the advise of the Director of Health Services, reminds the public that hand washing is the single most effective measure for preventing the spread of infections including the Influenza H1N1.

While most of us simply rub hands together then rinse, it is important to remember to always include spaces between fingers, thumbs, back of hands and fingernails.

Rinse thoroughly under clean running water then dry hands with a clean hand towel or disposable tissue paper.

If in a public bathroom, use paper towel, be careful not to touch the faucet after hands are washed.

After drying hands, turn the faucet off using the paper towel. If no paper towel is available, drain your hands in the sink and allow your hands to dry by air.

This action should be performed frequently and should be performed by all members of society.

It is important to wash your hands before: preparing food, eating, treating wounds, giving medicine and before touching your face

Also wash your hands after: preparing food; using the toilet; changing a diaper; blowing your nose, coughing or sneezing; attending to a sick person; and handling dirty objects.

A new era in the way teachers teach our children is dawning at Santa Elena Roman Catholic Primary School in Santa Elena Town, Cayo.

Almost 80 Years Later, The Words Of Samuel Alfred Haynes Rings True

He is known as the man who wrote the words to the original National Anthem of Belize and today, over 78 years later the words of **Samuel Alfred Haynes** rings so very true.

The following was compiled three years ago, on 17 August 2008, by **Ambassador Adalbert “Bert” Tucker**.

It is entitled **“Wrong Education: Curse to Social Order, World Peace”**.

Education of the right kind is a blessing to any people but education of the wrong kind is a curse to the social order and world tranquility.

The church and the school are the chief cornerstones of civilization. The first shapes - and the belief in some object of divinity, the second molds the mind to serve the moulders.

The church either saves a man or destroy him for life, education either fits or misfits a

for service.

It has been said that Trade follows the flag. General Smedley D. Butler of the United States Marine in a recent political speech said that American marines are used ostensibly to collect the debts of American bankers and to protect American investments in foreign countries. (He was referring to non-white countries and communities.)

When a foreign nation desires for selfish reasons to

share in the rich potentialities of a backward country, it sends emissaries and agents to court the friendship and confidence of the expectant victim. This done, the “foreign devil” (this is the name given by Asiatics to white exploiters) contracts to finance certain government or private enterprises through loans in return for certain valuable concessions.

These concessions generally cover the mineral, industrial, or agricultural resources of the country, or controlling interests in public utilities ,communications and transportation.

These contracts are drawn up by lawyers versed in the intricacies of international law and are so phrased and timed that the party of the second part, namely the debtor nation is bound to default. At the close of legal formalities the creditor nation religiously fulfills its part of the contract and waits patiently for the inevitable.

In many instances, native officials are bribed to foster legislation favorable to the designs of these foreign devils; and it has been proven

that foreign creditors often dictate through bribes and coercion, the election of public officials in debtor countries and states- this accounts in a large measure for so many puppet governments in most tropical countries.

In this manner foreign nations proceed to establish “spheres of influence” in backward countries and non-white communities.

When marines and battleships are sent to these lands we are told by the State Department of the country involved that they are there to protect the life and property of its nationals. It’s but a clever subterfuge to disguise the real truth...

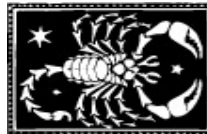

Citrus Growers are advised that the processing of grapefruit only for crop year 2011 - 2012 will begin with the opening of the CCB factory of Citrus Products of Belize Limited (CPBL) on Wednesday, November 2, 2011. Fruits will be received from 7:00 am to 5:00 pm Monday - Friday.

The Final Estimated Price for orange is \$2.2965 per pound solid (pps) or \$13.5508 per box at a yield of 5.9 pound solids per box. Growers will receive an advance of 65% on delivery which is \$1.4929 pps or \$8.8081 per box.

The Final Estimated Price for grapefruit delivered to CPBL is \$2.0180 per pound solid or \$7.8700 per box, at a yield of 3.9 pound solids per box. Growers will receive 65% advance on delivery which is \$1.3117 pps or \$5.1155 per box.

The Estimated Final Price for grapefruit represents an increase of \$0.1216 pps or \$0.4742 per box over the original First Fruit Price Submission received from CPBL. CPBL agreed with CGA that a sales price of US\$2,300 per metric ton for Frozen Concentrate Grapefruit that better reflects current market conditions should be used in the price formula to determine the Estimated Final Price for grapefruit. Growers are informed that CPBL has failed to comply with the provision of the legal binding Arbitration finding that CPBL must submit a sales plan to the CGA before the commencement of the crop. This matter will be referred to the Citrus Control Board.

Growers are reminded that the acceptable maturity ratio for grapefruit is 9:1 brix/acid ratio and for oranges it is 13:1 ratio. Be sure that fruit samples are tested for maturity before harvesting.

Growers who are experiencing losses with oranges are advised that the CGA has forwarded this issue to the attention of the Hon. Minister of Agriculture, Chairman of the Citrus Control Board and the CPBL Board. The CGA has been informed that the cabinet has expressed its concern about growers losing oranges and the Chairman of the Citrus Control Boards has written to CPBL requesting CPBL's cooperation in immediately commencing the processing of oranges. CGA will advise growers when CPBL will start taking oranges.

All Growers are asked to call **Mr. Donaldo Bardalez** at CGA at 522-3511 or 522-3585 Ext 224 for their delivery schedule. Growers must call for their schedule before harvesting. All growers must apply for a producer's license at CGA office before fruits can be delivered for processing.

176 Police Arrested In Honduras As Corruption Purge Continues

Friday, November 4, 2011:

Many in Honduras have lost confidence in the police.

A total of 176 Honduran police officers have been arrested in a purge against corruption and organised crime, the authorities there say.

The security ministry said the officers were suspected of offences including murder, kidnap and drug dealing.

The arrests follow public outcry over the release of four policemen accused of murdering two students.

Earlier this week **President Porfirio Lobo** sacked his top police commanders and deployed troops to combat crime.

“We have to get rid of the rotten apples in the National Police,” Mr Lobo said on

Wednesday.

The Congress has begun debating a new law to reform the police force and tackle corruption.

The officers arrested in the purge on Wednesday belong to the same unit as the officers accused of murdering two students a week ago.

The release of the suspected killers, who have gone into hiding, provoked outrage in Honduras. Four other officers suspected of involvement are still in custody.

There has also been anger over the recent revelation that 300 automatic rifles plus ammunition had been stolen from a police station.

Honduras has been suffering soaring levels of violent crime, which the police have been

unable to contain.

According to a UN report it had the world’s highest murder

rate in 2010, with much of the killing linked to criminal gangs. It is also a major transit route for drug traffickers moving South American cocaine north to Mexico and on to the United States.

Solicitor General's Former Housekeeper Remanded To Prison For Missing Jewelry

Over 11 thousand dollars worth of jewelry went missing from the Cahal Pech, San Ignacio Town residence of Solicitor General **Cheryl Krusen** for which the former housekeeper is in jail.

Police reports that the Solicitor General was out of the country between 27 August and 4 September 2011 and that during her absence the housekeeper was left with the keys to the house.

The selected missing jewelry, went missing from a wooden jewelry box inside the Solicitor General's bedroom. Also

reported missing are two Blackberry cellular telephones and an Apple brand notebook all for a total value of \$11,600.

The housekeeper, **Merlene Hendy**, 51, who was present when the police arrived, was instantly detained and transported to the police station where she denied having any knowledge of the missing items.

During the course of the investigation several persons were interviewed including the housekeeper's 19 year old son who works as a gardener on the property and her 15 year old daughter a student all of whom denied having any knowledge of any of the missing items.

Police reports that the only indication of a possible entry

point into the house was the removal of the screen from a small window in the guest bathroom along with two visible skid marks on the outside wall below the window.

Merlene Hendy was formally arrested and charged for theft. She appeared in the courtroom of **Magistrate Linsbert Willis** on Tuesday, 25 October where she pled not guilty to the single theft charge. She was denied bail and remanded to prison . She is scheduled to reappear in court on Tuesday, 22 November 2011.

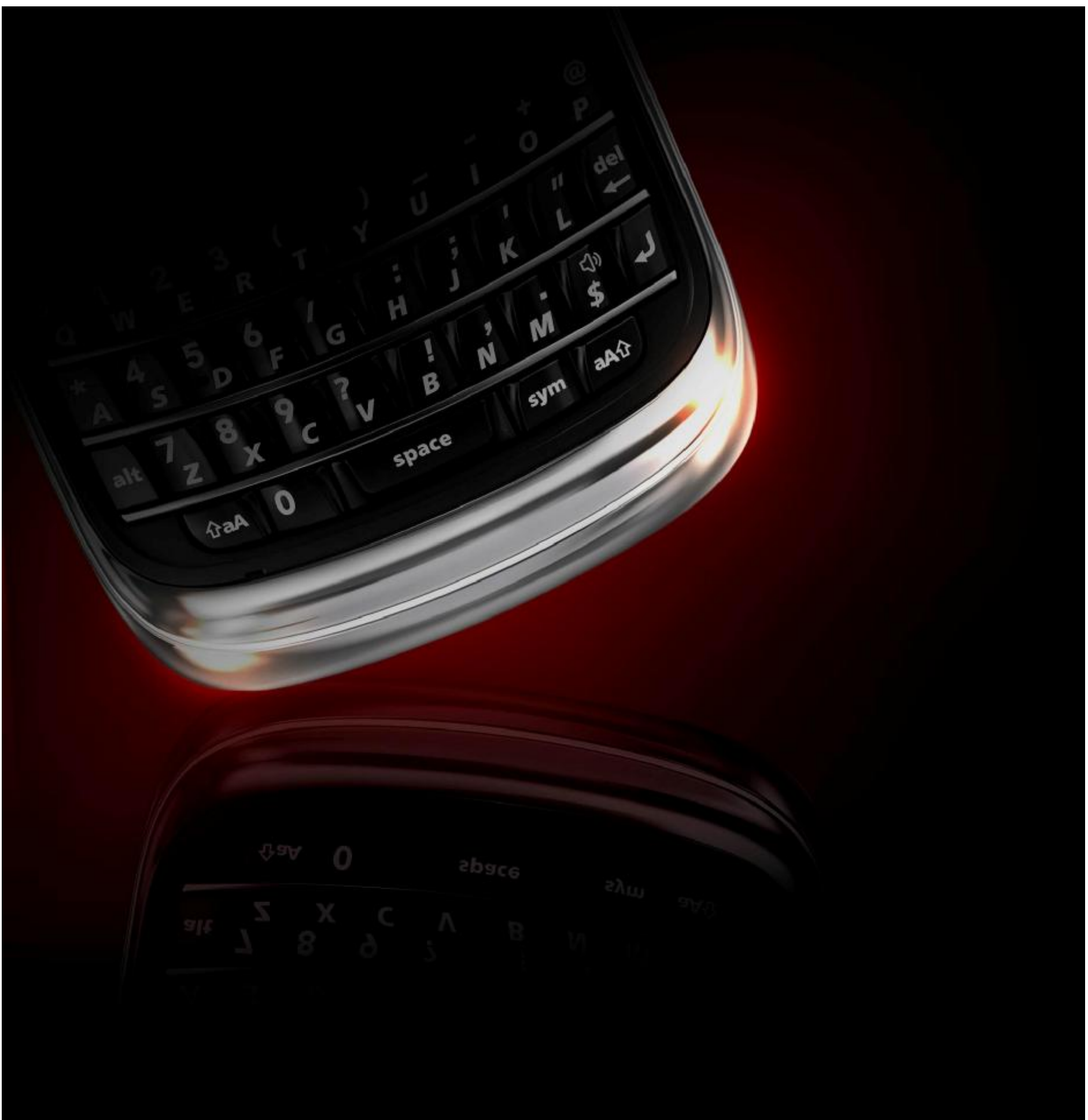
