Jealousy Results In Murder

BULLET TREE FALLS VILLAGE, Cayo, Thursday, December 1, 2011:

Funeral service was held today in Bullet Tree Falls Village for **Domiciano Quixchan**, 45, Belizean Taxi driver, the latest victim of murder in western Belize.

While the initial police press report on the incident informed that Quixchan and his passengers were victims of a robbery turned fatal, subsequent investigations revealed otherwise.

It was shortly after midday on Monday, 28 November when the first telephone report reached the

police station in San Ignacio. The report informed of the presence of the dead body of a

male person on a feeder road in San Antonio Village, Cayo.

A team from the Crimes Investigation Branch was immediately dispatched to the location. The most appropriate route was to travel via Cristo Rey and then onto San Antonio. The police was taking this obvious route when, about a mile into the journey, they received information that the scene was nearer to the village of El Progreso than to San Antonio and so the police turned around on the Cristo Rey Road and headed up the Western Highway towards the village of Georgeville and onto the

Mountain Pine Ridge Road. A few miles into the road, the police spotted a small grey pickup truck heading in the opposite direction towards Georgeville and in the front passenger seat was a male person holding a bloody cloth to the left side of the face. The obviously injured man, identified as **Hernan Manzanero**, told the police that he was along with the taxi driver when they were robbed on the Pine Ridge Road between El Progreso Village and the junction with the San Antonio road. He was instructed to visit the station in San Ignacio to file a report. The police then proceeded to the scene. They

No Foul Play Suspected In Flowers' Death

ORANGE WALK TOWN, Wednesday, 30 November 2011:

The body of **Greg Mykel Alexander Flowers**, 17, University of Belize student, was laid to rest today following 10:00 a.m. funeral services in his home town, Orange Walk.

While relatives are alleging otherwise, San Ignacio police informed that their intensive investigation revealed no evidence of foul play in the drowning death of the student

which occurred at around 4:30 pm on Friday, 25 November in the Mopan River at its intersection with the Macal River forming the Belize Old River near Branch Mouth Community, Cayo.

The investigation revealed that the student, residing with an uncle in Esperanza village during weekdays while attending UB, normally travels to Orange Walk Town on Friday evenings after class, where he

began checking the area between El Progreso Village and the junction into San Antonio as was indicated to them by the injured man but their search was fruitless. They were later directed to visit the post office in San Antonio Village where a person was waiting to direct them to the scene. The police were on their way to the post office when they met another person who took them directly to the scene.

The police first came upon the body of a male person, laying face upwards in the grass off the side of a feeder road. The face was bloody from several cut wounds and the throat was slashed. Police also found a bread knife with an eight inch curved blade, suspected to be the murder weapon, on the ground near the body. The police also found the victim's wallet containing his social security card, bank card and other documents in nearby bushes. The victim's blue Geo Prizm car, bearing Cayo Taxi license plates CY-D-3552, with the engine still running, was found on another feeder road about 400 feet from the body. The car was found with blood on all doors as well as on the hood and on the trunk.

Police began the investigation on the premise that the crime was committed by two unmasked male persons as was reported by Hernan Manzanero. This version did not hold for long however as the information quickly began to reveal otherwise.

As it now stands, the investigation revealed that Manzanero was harboring resentments against Quixchan whom he believed was sexually involved with his 17 year old common-law wife, and so at around 11:30 that Monday morning, Manzanero, accompanied by the 17 year old common-law wife with their 26 day old daughter, boarded Quixchan's taxi for a ride to El Progreso Village located at mile 7 on the Mountain Pine Ridge Road from its Georgeville junction with the Western Highway being the common-law wife's home village. The common-law wife with the infant in her arms sat in

the front passenger seat next to the driver while Manzanero took to the back seat of the car. Quixchan chose to take the route via San Antonio Village because, although a few miles longer, the road was in better condition than the Mountain Pine Ridge Road from Georgeville to El Progreso.

Upon exiting San Antonio Village heading towards the junction with the Mountain Pine Ridge Road, Quixchan was asked to divert into a feeder road and then into another feeder road when Manzanero, seated in the back seat, allegedly pulled out the knife and first raked it across Quixchan's throat. The first cut reportedly was superficial and so they both exited the car with the bleeding Quixchan running around the car trying to escape from Manzanero who was armed with the knife. They reportedly began to tackle resulting in Quixchan gaining possession of the knife which he used to slice Manzanero to the left side of the face. After injuring Manzanero, Quixchan reportedly threw down the knife and told him that he did not want any further problems. Quixchan turned around and began walking away from the scene leaving his car behind. Manzanero reportedly got up, picked up the knife and a stone and began pursuing the bleeding Quixchan. He reportedly struck Quixchan with the stone and as he fell to the ground Manzanero pounced upon him delivering the fatal cut wound to the throat.

Manzanero then fled the scene and caught up with the common-law wife carrying the infant. They visited the nearby home of a pastor in San Antonio Village and after relating the incident about being robbed by two unmasked male persons, they requested and received a ride from the pastor to the home of the common-law wife's parents in El Progreso Village. Upon arriving in El Progreso they boarded the girl's father's vehicle and were travelling to the hospital in San Ignacio when they met the police who instructed them to first visit the police station to make the report where Manzanero was issued with a

pair of medico legal forms and escorted to the San Ignacio Community Hospital. The police escort was later instructed to hold Manzanero under guard as he was emerging as the prime suspect since no one in the area, saw anyone other than Manzanero and the common-law wife, with the infant, fleeing the scene.

The case began to crumble as the common-law wife was interviewed and offered a cautioned statement. Manzanero remained hospitalized under police guard for the two days. He was released on Wednesday, 30 November and was transported to the police station in San Ignacio where he was formally arrested and charged for the murder of Domiciano

Quixchan.

The post mortem examination on the body of Domiciano Quixchan was conducted at the Karl Heusner Memorial Hospital in Belize City between 2:00 and 3:00 p.m. on Wednesday 30 November 2011 by **Dr. Mario Estredebán** who certified the cause of death as traumatic asphyxiation due to slash injury to the neck.

The accused, Hernan Manzanero, 21, Belizean farmer from Bullet Tree Falls Village, appeared before **Magistrate Linsbert Willis** in San Ignacio's magistrate court on Thursday, December 1 where the single murder charge was read to him after which he was remanded to Hattieville Central Prison until Tuesday, 28 February 2012.





The Garifuna People Should Establish An International Language And Arts Institute

Every year after the 19th of November celebrations is gone I sit back and think about what I can recommend as a Garifuna Belizean towards the preservation of my ethnicity and the practice of this rich culture. Since the amount of people who are speaking the language and creating the arts and crafts is declining, there is an urgent need for us to establish an International Language and Arts Institute. The main purpose of this association would be to assemble able and capable men and women together annually to formulate policies to ensure that the language is preserved and be taught in the schools of the following countries; Saint Vincent, Dominica, Honduras, Nicaragua, Guatemala, Belize and the United States in the communities where the Garifuna people live. If the governments of these countries are against approving it, then we must find a way to teach the language ourselves because it is our responsibility to preserve it and not the government. This will include adding new words to the Garifuna language yearly and improving the dictionary and devising a standard curriculum for the language to be taught in schools.

Also, to gather the few Garifuna people who are still alive and honor them for their work over the years in contributing in the areas of; language, arts and crafts. The people who possess these talents are dying and most of our young people are either not interested in learning their trade or do not have the opportunity to learn them in the

communities where they live because the opportunities are not made available to them. One of the criticism you hear a lot among older Garifuna people, is that the younger generation of Garifuna youths are not interested in learning or speaking the language. Our people should realize, that for a language to be learnt faster it must be spoken in the household where the children come from daily. Some of the parents do not want to admit, that they have failed in teaching their language because many of them did not make it their business to make the Garifuna language the predominant language to be spoken in their household while their children were growing up.

Today, in many Garifuna family homes in all the countries where they live, the languages that are spoken the most are; Spanish, English, American and Creole. In many Garifuna communities, the Garifuna people are the minority so for them to survive they have to speak the language of the majority of people and that they can do well and this is why most Garifuna people speak two or more languages. Some Garifuna speak other people's language better than they speak their own native language because more efforts are made to teach those languages in the schools they attend through immersion and

they are being forced to learn those languages. Many of the schools these children attend, do not have any arts and crafts either that teach them about the arts and crafts of the Garifuna, Creole, Maya and other ethnic groups in Belize. In Dangriga we have Benjamin Nicholas, Austin Rodriguez and Pen Cayetano still trying.

The Ministry of Education in Belize should encourage the University of Belize to implement an Ethnic Studies Degree Program that will offer a Bachelors Degree. This program will offer courses about the; Garifuna, Creole, Maya, East Indians, Menonites, Hispanics, British, Chinese and all the other ethnic groups that live in Belize. At the Elementary and Secondary level students will take a course in Multicultural Education to learn and appreciate all the various ethnic and cultural groups in our country. This will help to eradicate racism and build on our country's nationalism. This is the only way Belizeans will be able to learn about each other's culture and appreciate the positives in each other rather than to concentrate on the differences and the things they consider to be negatives based on assumptions and ignorance. Our country is in need of

this program and I cannot understand why it is taking our government so long to implement it.

People do not become nationalistic through dreams, they must be taught. For them to learn this craft, the country must have programs in the schools to give them the tools to answer; Why they are proud to be Belizeans? Racism and segregation will prevail where nationalism is lacking. The United States is a good example of this where African Americans are always willing to put their lives on the line because of nationalism despite the way they are being treated in their country. Likewise, many Garifunas serve bravely in the Belize Police and Defense Forces up to this day. In the war between the countries of Honduras and El Salvador the Garifuna language was used effectively to communicate with the Honduran soldiers and the Salvadorians could not understand the language and this gave Honduras an edge in the war. Once we implement this institute, it should add another hundred years to the life of the Garifuna language. If the Ministry of Education implements the multicultural program in our schools, there will be a major difference in Belizean nationalism for generations to come. Let us preserve the cultures who have contributed to our nation's development to make Belize what it is today.

Henry Canton — Report Card

December 1st 2011

The Committee of Management again calls on the Board of Directors of CPBL and in particular the Banks Holdings Ltd (BHL) Barbados nominated Directors to oversee the affairs of the company and stop the reckless behavior of Henry Canton. CPBL at its December 17th 2010 Extraordinary General Meeting terminated the services of Henry Canton and the BHL directors on the CPBL Board need to respect the decision of the company and stop their unwavering support for Henry Canton.

On Monday November 14th 2011 Henry Canton sent out a press release alleging that Belize Citrus Growers Association Investment Company Ltd (BCGAICL) directors appointed to the CPBL Board refused to sign financing documents for the company. That was untrue. As a matter of fact BCGAICL directors signaled that there was no need for a scheduled Wednesday November 7th 2011 directors' conference call and that the approval could be given via round robin. BCGAICL directors requested that the release be retracted but the BHL directors ignored this request.

On Tuesday November 22nd 2011 Dr. Canton issued a release saying that the signed documents were received and that he would forward same to the attorneys for CPBL and bank so CPBL could access the funds. However, on Monday, November 28th 2011 he was again in the media saying that CPBL received the documents on Wednesday and submitted the documents to the attorneys on Thursday. This not only contradicts his release on Tuesday November 22nd but is blatantly untrue. What he should have informed growers is that he sat on the documents from August 8, 2011 and did not share same with the Board until October 31st 2011 after letters from BCGAICL attorney to CPBL Chief Financial Officer and even then did not provide some relevant and pertinent information. The CGA as the parent entity finds the reckless behavior on the part of Henry Canton unacceptable and calls on the BHL directors to act.

The recent attack by Henry Canton against the CGA's CEO is unfounded and shows a desperate attempt to make this appear as a personal issue. For the record, Mr. Anderson does not send out press releases but it is the CGA that sends out press releases as approved by the Committee of Management. Unlike CPBL where Henry Canton does as he pleases the Office of the CEO of the CGA does not operate in that manner as the Committee of Management of the CGA provides the necessary oversight to ensure the proper governance over growers' business.

The CGA is a membership organization and the CGA as a corporate entity is responsible to keep its members and industry stakeholders informed as to what is happening at CPBL. Gone are the days of hiding information and betraying growers. The CGA takes this opportunity to remind Henry Canton of his report card at CPBL and recommendations, coming out of an independent review of CPBL and which Henry Canton would like to hide, are:

- [CPBL should] Agree on a timetable and process for an orderly leadership change at CPBL to a candidate acceptable to both shareholders
- The company cannot meet its debt obligations under the current financing arrangement. (Note: This is due to Henry Canton's mis-management, like spending over \$1 m on second hand equipment for Feed Mill, which after 3 years has not made a penny of profit.)
- Co-generation business — after three years the cogeneration project remains underutilized and the Company continues to spend significant cash resources on this project. . . .Moreover there are technical problems that have yet to be resolved. (Note: Henry Canton spent \$8m on second hand equipment, which are still not functioning. Equipment that was designed to run on propane was rigged to run on BNE crude with no end of problems.)
- Citrus Price Formula — CPBL's Management on the other hand maintains that the current position is inequitable and that efforts must be made to rectify problems surrounding the distribution of revenues. (Note: Canton betraying growers again by planning to pay them less for their fruits.)
- Capital Investment — capital works projects have also encountered various operational problems which have contributed to the limited success witnessed thus far (Tank Farm is an exception). Broadly, these problems are:
 - o the lack of standardized and rigorous cost benefit analysis for proposed projects;
 - o poor "follow through" on finished projects particularly in relation to marketing and distribution;
 - o the lack of qualified personnel to manage projects and provide technical support

(Note: Through his mismanagement, Henry Canton caused CPBL to squander \$25 million on poorly planned capital investments.)

- Canning Line — the purchase of the canning line in 2007 for US\$350,000 from BHL was financed by internally generated cash. Management believed there may be a market for canned juice sales in Trinidad. However, it appears management has too many projects at this time and other issues to deal with. As such, it is not the time to invest resources on developing a new product line and market. In addition, Tetra Pak and canned juices may share the same target markets. (Note: This is the biggest hoax. Henry Canton fooled citrus growers and the public into believing that BHL, with their marketing expertise in value-added juices, would have brought great benefits to growers and the industry. The opposite has occurred. After five years, the value-added operation (VMC) is performing very poorly. In 2009, lost \$491,237. In 2010, it doubled sales and nearly quadrupled losses to \$1,915,000!)

The CGA is the custodian of its membership's investment in CPBL. The Committee of Management will let growers know the truth about the reasons why CPBL has depleted its cash reserves and was not in a position to pay growers for their fruits being delivered. All growers should understand that to date, except for the Tank Farm for which growers allow CPBL to deduct for local cold storage expenses in the Price Formula, all the value added projects have been incurring losses for some of the reasons as described above.

Henry Canton, this is your report card with the complete unwavering support of the BHL directors on the CPBL Board. The CGA's Committee of Management will ensure that the membership, growers and all stakeholders are continuously updated on these issues as this industry is vital to the success of our national economy. The CGA is the parent entity and will continue its policy of full disclosure and accountability.

'OK' he said, 'I hope I do have

Levi Figueroa Sentenced To Years In Jail Out On Two Hundred Dollars Bail

SAN IGNACIO, Cayo, Thursday, 1 December 2011:

Three weeks ago we reported on the two year sentence handed down to **Levi Figueroa**, 34, by Chief Magistrate **Ann Smith** when he pleaded guilty to a) negligent wounding, b)driving motor vehicle without due care and attention, c) failing to stop and render aid and d) failing to report an accident in connection with the 31 October traffic accident in the village of Georgeville.

In the incident **Orthon Armando Hyde**, 37, Belizean laborer, of a Dalia Street, San

Ignacio Town address was reportedly knocked off his red Lifan brand 125cc motorcycle as he was making his way to San Ignacio.

Nine days later Figueroa walked into the San Ignacio police station and handed in himself. He was detained, formally arrested and charged.

Figueroa was today, December 1 released on an unbelievable \$200 bail after successfully appealing the sentence of the chief magistrate and obtaining an injunction to stay the execution of the two year sentence.

Hugo Chavez Hosts New Regional Summit Excluding The United States of America But Including Cuba

Venezuelan President **Hugo Chavez** is hosting a summit of a new regional bloc that brings together 33 nations of Latin America and the Caribbean.

The general aim of the group, which does not include the US or Canada, is to foster regional ties.

Mr Chavez has described the bloc as a counter to US influence in the region.

The two-day summit is Mr Chavez's first big international event since he was treated for cancer and forced to postpone the original meeting in July.

The summit in the Venezuelan capital, Caracas, will be the inaugural gathering of the Community of Latin American and Caribbean States, known by its Spanish initials, *Celac*.

It will be a further addition to regional groupings that include the Organization of American States (OAS), Unasur, Mercosur, Alba and the Caribbean Community (Caricom).

Unlike the long-established

OAS, Celac does not include the US or Canada.

And unlike the OAS, it will include Cuba, which in 2009 rejected an invitation to rejoin the Washington-based body after a long exclusion.

Mr Chavez has described the summit, with some rhetorical flourish, as *"the most important political event to have happened in our America in 100 years"*.

For the Venezuelan president, Celac forms part of his dream of realizing Latin American unity and also creating a counterweight to Washington.

But for other regional leaders, the aims are less grand though no less important, correspondents say.

These include examining the region's response to the global financial crisis, promoting economic development and discussing joint efforts to tackle drug-trafficking.

And Celac's birth does not herald the demise of the OAS, analysts say.

"[The OAS] has clearly defined purposes and principles to

guide it. Its procedures are in place. And it has a budget -

most of which comes from the US and Canada," Peter Hakim, president emeritus of the Inter-American Dialogue think tank, told the AFP news agency.

The inaugural summit was due six months ago but was postponed because Mr Chavez was recovering from surgery to remove a cancerous growth.

The talks on Friday and Saturday will be watched for indications of Mr Chavez's current health.

The Venezuelan president has said he is completely recovered after four rounds of chemotherapy.

He is expected to run in next October's presidential election for another six-year term.



No Foul Play Suspected In Flowers' Death

resides with his grandfather. On this occasion however, instead of following the routine, he accompanied three other male friends to the banks of the river.

They reportedly took off their shirts as they entered the water. They were in the water for a while when suddenly the deceased, not known to be a good swimmer, reportedly jumped into a deep part of the river. He immediately went under. Sensing that he was in trouble, his fellow students reportedly tried to assist but soon realized that they were endangering their lives and so they abandoned the effort as they began shouting for assistance. Some villagers rushed to the area and attempted a fruitless effort to assist. The search was suspended as darkness set in and the following day it continued but the effort was reportedly hampered due to the almost 30 feet depth of the river and the murky condition of the water in the area where the deceased went under.

Again after sunset on Saturday the search was suspended resuming on Sunday morning until the body eventually emerged to the surface on its own in almost the exact spot where it went under almost two days earlier.

The deceased was found still clad only in the brown short pants he wore when he went under.

While it is alleged that the police took almost an hour to arrive on the scene after the body was placed on land, it is reported that a detective constable who lives in the area was around since early Sunday morning and that he remained in the area until the body was found and placed on the bank of the river. He reportedly relayed the information to the police. Being a weekend with Scenes of Crime personnel on standby duties and not readily available at the station, it took the police a while to assembled the team. Police informed however that they were on the scene within the hour.

The body was transported to the community hospital in San Ignacio where upon arrival, at around 3:00 pm, it was officially pronounced dead by **Dr. David Pacheco**, the medical officer on duty at the time.

The legally required post mortem examination was conducted between 11:00 am and 12:00 noon on Wednesday, 30 November, at the hospital in San Ignacio, by **Dr. Armando Betancourt** who certified the cause of death as asphyxia due to drowning.
