**SAN IGNACIO, Thursday, 19 January 2012:**

While doing the rounds today, we came upon **Eustace Hendy**, best known within the community as **Jack Budd**, who had an experience he was eager to share with **STAR** readers.

Apart from asking for a little hands out, Jack Budd earns a living by washing cars in the Savannah area during the daytime hours and as a block watchman, for business places in the same area, during nighttime hours.

Jack Budd alleges that he was in his quarters cooking a meal when, at around 8:00 pm on Wednesday, 18 January, he left the food on the fire and was on his way to the corner store to get some ingredients to add to the

meal. He alleges that he was walking to the store and smoking a broken cigarette when he was approached by the police on

patrol. The police allegedly demanded to know what he was smoking. Although it was allegedly established that he was indeed smoking tobacco and not marijuana, he was nevertheless detained and taken to the police station. Whilst at the police

station he reportedly managed to get a friend to visit his quarters and to extinguish the fire under the meal he was cooking. He further alleges that although he begged to be released because of his responsibility as a night watchman coupled with the fact that he committed no crime, he was locked away and was not released until at around 9:00 am on the following day without any charge. He said that he walked out of the Police station and then rushed to his quarters where he found the charred remains of what should have been his supper the previous night.

Jack Budd alleges that a few hours after his release, it was brought to his attention that the music box inside a club in the area, where he normally watches at nighttime, was broken into and that all the coins were missing.

In an effort to confirm his allegation, we visited the night club, where a female employee confirmed that the music box was indeed broken into and that the coin container was emptied. The employee however, could not say when the burglary was actually committed.

# Change, Move Out or Go To Jail - New Sheriff In Town

She arrived in early January 2011 and after serving the community for one year, Superintendent of Police **Mrs. Louise Willis** bid farewell to San Ignacio police on Monday, 9 January thereby giving way for the arrival of a new sheriff in town.

The new Police Officer Commanding the Cayo (Police) District is **Senior Superintendent of Police Alvan Gentle Jr.**, 50. He comes to Cayo equipped with both police and military command training and management experience.

Although he was born in Belize City, Alvan was only four years of age when his parents relocated to Esperanza Village, Cayo where Alvan was raised and currently resides. He is a class of 78 graduate of San Ignacio's Sacred Heart College.

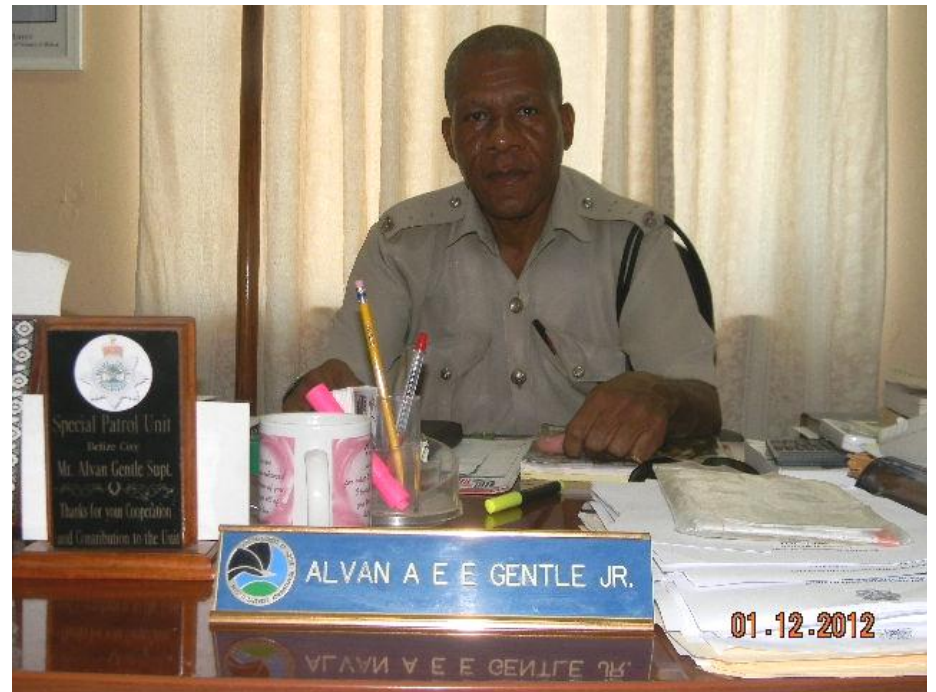
Alvan Gentle Jr. first joined the Belize Police Force over 30 years ago in 1981. His first stint with the police lasted six years. As a young constable he was first posted to Patrol Branch in Belize City and later transferred to San Ignacio after which he was posted as a Police Immigration Officer

in Corozal during that era before the formation of the Immigration Department when immigration duties were performed by the police.

In 1987 he shifted career sliding into the Belize Defence Force as a Cadet Officer. He served as a lieutenant in the army up to the end of 1991 and on 13 January 1992 he re-enlisted into the police force as an Inspector of Police to take command of the of Tactical Services Unit (TSU) which was a paramilitary arm of the police stationed at the Police Training Academy in Belmopan.

The subsequent amalgamation of the TSU and the Serious Crimes Squad (SCS) gave birth to the Dragon Unit of which Gentle served as Commanding Officer. He remained with the Dragon Unit until 1998 when he was transferred to San Ignacio as second in command of San Ignacio Police. He spent a year in San Ignacio before moving back to the Belmopan compound of the Police Training Academy to command the Anti Drug Unit (ADU) which was formed to replace the Dragon Unit.

He served as Commander ADU

for three years between, 2000 and 2003, when he was transferred to Belize City where he served under the current Acting Commissioner of Police David Henderson as second in command of Eastern Division's Patrol Branch.

His other tours of duty, in chronological order includes Officer Commanding (OC) Benque Viejo Police Sub-Formation – Back to the ADU – OC Stann Creek (Police) District, OC Belmopan Sub-Formation and now as of Tuesday, 10

January as OC Cayo (Police) District with responsibility for Benque Viejo and Belmopan Sub-Formations.

In a brief interview with the **STAR Newspaper**, Sr. Supt. Gentle informed that he intends to continue building on the foundation laid by his immediate predecessor Supt. Louise Willis and other commanders before her. He said that he will be working closely with the business community as well as with every individual, association

## A Police Formation Marred With Allegations Of Irregular Behavior

**SANIGNACIO, Cayo, Thursday, 19 January 2012:**

While he is new in town, **Sr. Supt. Alvan Gentle** is taking command of a formation marred with allegations of misconduct some of which include the abuse of police vehicles for which we understand that, much to the dislike to the habitual abusers, he has already laid down a strict policy.

There are also allegations of policemen routinely acting as judge, jury and executioner such as the allegation of the policeman who came upon a male resident with a small package of un-custom goods and instead of arresting and charging that individual, this policeman allegedly confiscated the goods, demanded and received \$100 in cash from the individual and then allegedly proceeded to retained

possession of both the goods and the cash while allegedly threatening to plant something on the individual if this incident should ever come to light.

There are also allegations of an increasing number of incidents involving missing prisoners property especially cash, jewelry and cellular telephones while most of the victims are either too happy to be released or might have been intoxicated when detained to even recall where their money, jewelry or phones went.

There is also the allegation by a pawnshop owner who was brutally attacked inside a night club by an off duty policeman moon shining as a security guard for which the businessman has retained the services of an

attorney to file suit against the policeman and the department.

Then there is the case, with documentary evident in the form of text transcripts, implicating a policeman colluding with a notorious criminal in the robbery of two gas station attendants which, after many months, is yet to come to its natural conclusion.

Then as recent as today there is the allegation by Cayo

Businessman **Carlos Javier Popper** of the detention and brutal treatment of his son who, apart from allegedly being beaten by a team of policemen, was brought almost to the point of suffocation when his entire head was placed and held inside a plastic bag.

As with all things, time will be the true revealer of the effectiveness of the community's new police Commanding Officer.

### Ms. Patricia Is Still Out Her \$500 And Despite Ample Evidence, The Police Seems To Care Less

The case of the Dangriga Scotia ATM theft is why I Patricia Dunlap Jacob am still writing.

I am still concerned there has been no arrest or money refunded to my account.

I question why there has been no reporting from any policeman in Hopkins or Dangriga is such a clear cut case.

When I make calls to ask about the case most of the time I am put on hold and then find I have been hung up on. This makes me believe that the police just do not care as to hang up is not proper procedure.

I am the victim of a crime and do not believe I am being treated as such but more like an inconvenience.

I am the victim here. I am that unfortunate person who suffers from a clear adverse circumstance of being stolen from. I am a person who was swindled and robbed! I should be treated with respect and shown some concern for the situation that is still pending.

The thief can clearly be identified on the video clip from the bank security camers. I have a copy of the video clip. I bought it from the Scotia Bank in Dangriga . It shows the man using my ATM card at the exact time \$500 was withdrawn from my account.

It should be part of police training their daily routine when answering the phone as an officer's job is to help victims not hassle them. Being polite is one issue, being professional as well as helpful is another!

Please help me, the victim in this unsolved mystery or will I ever see justice in Belize with the help of our Police who are to serve us the victims.



# Bullet Tree Man Busted With Weed

San Ignacio's resident Magistrate **Nardia Morgan** ordered a Belizean man from Bullet Tree Falls Village to forthwith pay half of a ten thousand dollar fine after he pled guilty to a drug trafficking charge.

At around 6:30 on the morning of Thursday, 12 January 2012 a team of police officers, armed with a warrant to search for drugs, visited the Bullet Tree

Village residence of Belizean laborer, **Miguel Mendez**.

Upon arrival the team encountered a male person, who identified himself as Mendez, standing on a front porch. He was informed of the mission and asked if he had anything to declare. He reportedly pointed to a black plastic bag on the porch next to him which he described as his "*personal smoke*". The

bag was found to contain suspected marijuana. The only persons in the house at the time of the search were Miguel Mendez and the 17 year old live-in female partner. They were both informed of the offence committed and placed under arrest. Further search of the house revealed nothing incriminating. A search of the yard led to the discovery of

a larger parcel containing suspected marijuana.

Mendez and the 17 year old female were transported to the San Ignacio Police station where the contents of both parcels were weighed in their presence with the smaller one weighing in at 34 grams while the larger one tipped the scale at 226 grams. They were subsequently arrested and charged with possession of a controlled drug in relation to the 34 grams and drug trafficking for the 226 grams.

They appeared in court later that day where Miguel Mendez pled guilty to both charges while the charges against the female were withdrawn. In accepting the guilty plea, Magistrate Morgan imposed the mandatory ten thousand dollar fine requesting for half of it to be paid forthwith and for the balance to be paid by 30 May 2012 in default three years in jail. Mendez was unable to come up with the instant five thousand dollars fine and was transported to jail.



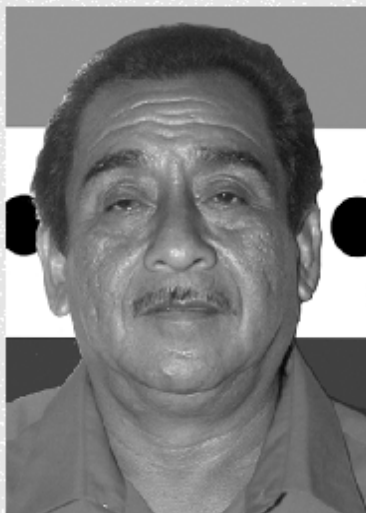

pots are ever the alike. And lo and behold you will take home a unique piece of art work that you created. The PUC is required to issue an Initial Decision on the submission by January 23, 2012.

The licensee or an interested party representing users of at least 10% of the water supplied in the preceding year may submit written comments on the Initial Decision within 15 days.

Where there is no objection to the Initial Decision the PUC shall adopt it as its Final Decision.

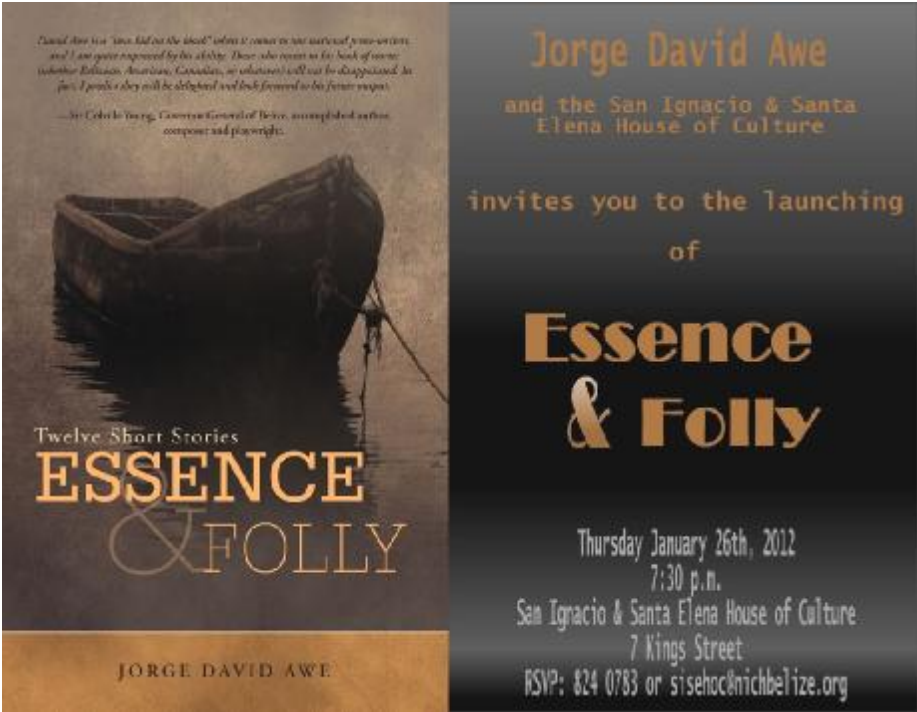


# Jorge David Awe To Launch New Book

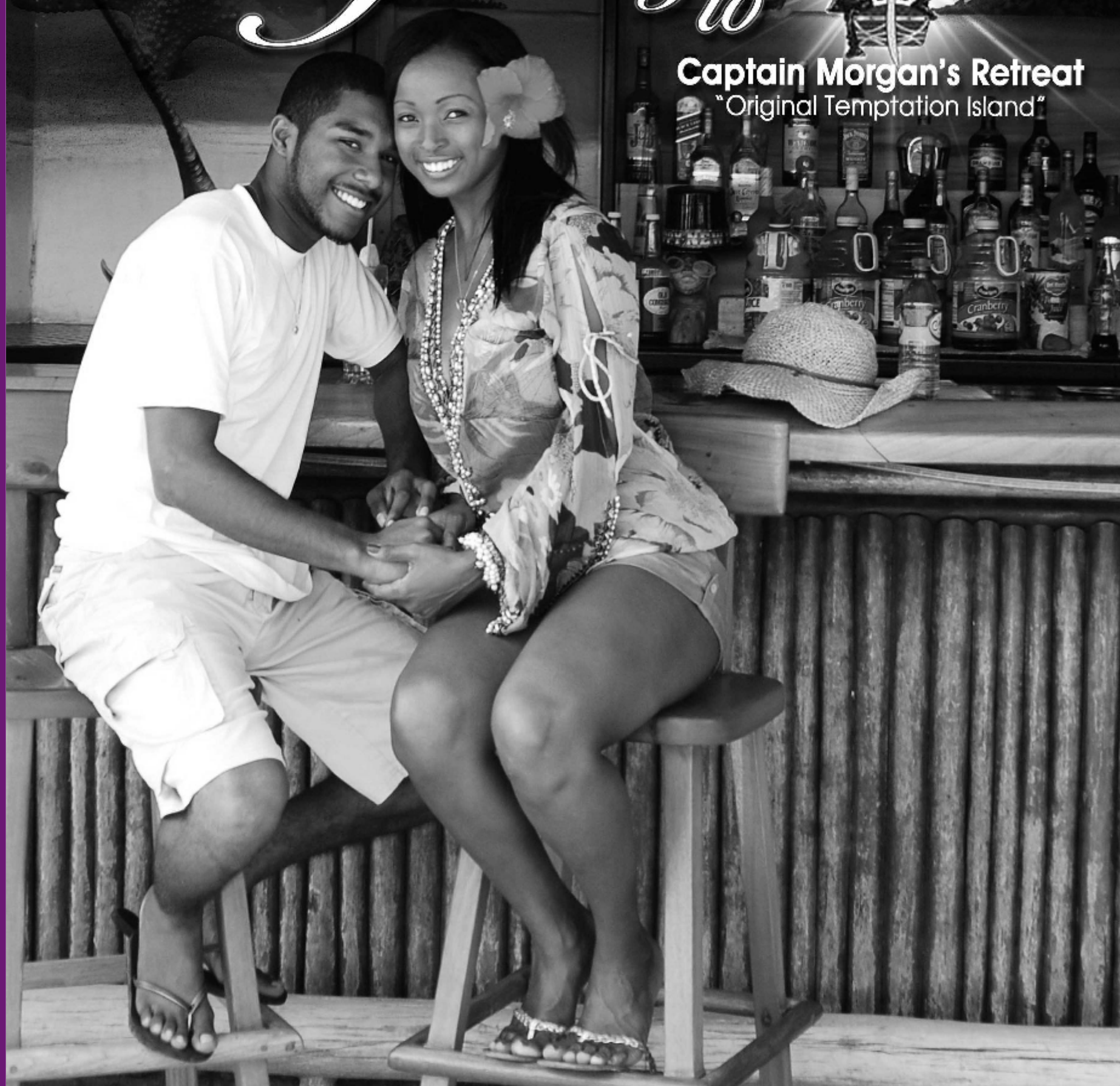
