PC Francis Aldana Criminally Charged

SANIGNACIO TOWN, Cayo, Wednesday, 2nd May, 2012:

Was this policeman drunk on duty? Did he view himself as judge, jury and executioner? What prompted him, as he admitted to a commanding officer, to *“Knock the young man”* because of what the boy was accused to have done.

Does this case show that some policemen are in dire need of anger management training?

Even in primary schools, corporal punishment has been

outlawed. What therefore gives the police the right to corporally punish a child in his care?

Police Constable #11 Francis Aldana today finds himself on the hot seat as he stands criminally charged for allegedly causing harm to a 15 year old minor who, on Tuesday, May 1, was brought to the station by a brother and a sister for allegedly misbehaving at home.

The case is being handled

personally by **Inspector Reymundo Reyes** in his current capacity as officer commanding the formation.

It is alleged that when the boy was brought into the station he was handed over to the accused who was assigned diarist duties.

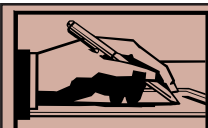

Editorial



End The Nuisance - Not Rocket Science

The term “*Broken Window Theory*” comes up all too often in police lingo, “*we must take action against small offences as they will eventually lead to more serious crimes*” says the police.

Noise pollution is an offence contrary to the laws of Belize. The people living on the entire length of Joseph Andrews Drive in San Ignacio Town, especially those living in the area of that section sloping down to the Sacred Heart College compound, have for many, many years been complaining about the ear piercing noise produced by truck drivers who are in the habit of applying the jake brakes of the trucks they drive just simply for the heck of it. They have zero consideration especially for the just born babies and elderly folks living along that corridor. This condition also applies to the multitude of residents living on the Western Highway in Santa Elena, Red Creek, Esperanza and areas beyond.

Experienced truck drivers say that there is absolutely no need for these irresponsible truck drivers to be causing this unnecessary disturbance which they do at any hour of the early morning, noon or night.

Now, the question is, why is the police not doing anything to put an end to this irresponsible behavior? Why is our elected town council, with its own traffic section, not doing anything to stop this terrible disturbance?

Every one of these truck drivers know that they cannot and will never pull off this kind of crap anywhere beyond our borders.

It does not require rocket science to halt this behavior in its tracks. All it takes is for someone to mount the necessary operations against those offending drivers.

How can we halt the noise pollution? The majority of these drivers do not own the trucks they drive. They work for a boss.

The boss makes money when the wheels of his truck are rolling. Any delay in moving from point A to point B is a charge on the truck owner. A truck owner would not normally retain the services of an **irresponsible** driver who delays operations. Irresponsible – that’s just what these heartless, noise making drivers are and so the authorities must expose their irresponsible behavior.

How can these irresponsible drivers be exposed? We first start by canvassing residents along the corridor, with a view of identifying those areas of frequent infraction. When the policeman is on idle patrol, he parks the mobile in a nearby off road ready to rush out on hearing the offending sound. The driver is detained, the truck is taken out of commission (**wheels stop rolling – money stop making**) for the entire duration while the driver is processed and criminally charged. His boss senses the delay and if it persists that driver will inevitably lose that job. No one wants to lose their job – The word will rapidly spread around – They will halt the irresponsible behavior – the community will be spared of this nuisance – and life, along the corridor, will be much more pleasant.

Issuing these offenders with traffic tickets is not cutting it. It takes 10 to 15 minutes to write up a traffic ticket. This is time that they can make up by applying more speed on the road as they endeavor to erase the delay in time so as to minimize the chance of their employers catching up on to them. The speeding to make up lost time further lends for the possibility of these irresponsible individuals causing traffic accidents and possible loss of life along the way. On the flip side, processing them through the courts takes a few hours and this is lost time that will be harder for them to conceal from their employers.

PC Francis Aldana Criminally Charged

At about 5:30 pm on Wednesday, May 2, the boy accompanied by his mother visited the police station in San Ignacio where they officially lodged a report requesting court action against PC #11 Francis Aldana.

The report alleged that when the child was brought into the station on Tuesday, May 1 he was handed over to PC Aldana who was working diarist duties at the time. It is alleged that the accused policeman was taking note of the child’s particulars as is required prior to detaining him. Aldana reportedly asked the boy: “*You da bad bway then?*” According to the report, when the child answered “*No Sir*” he was reportedly asked to repeat his response and after he did, it is alleged that the accused policeman stood up from behind the desk and punched him in the stomach which, according to the boy, caused him pain.

In his statement to police, the child alleges that after punching him in the stomach, the policeman escorted him to a holding cell where he instructed him to take off his shoes after which he was again attacked by the policeman who, this time, stomped him on the left leg causing him severe pain.

The child alleges that the final attack came just as he was being placed inside the cell at which point, he alleges that the same policeman punched him to the left side of his face before shoving him into the cell

In corroboration of the boy’s story, and upon being examined by the police, the child was observed with a swelling in the

area of the left rib cage and complaining of pain to the left side of his face. He was issued with a pair of medico-legal forms and escorted to the San Ignacio Hospital where the medical officer on duty, **Dr. David Pacheco**, certified the injuries as harm.

The report indicates that upon being questioned, the accused policeman reportedly admitted that he “*did knock the young man but it was because I got anger when I heard that he pulled knife at his mother*”.

Upon this admission Aldana was, on Thursday, May 3, immediately cautioned, formally arrested and accordingly charged for causing harm to the boy. He was slated to appear in court shortly after being formally charged today, however, there was no magistrate in court on Thursday afternoon. Aldana was consequently freed on a \$500 police signed bail and ordered to return to court at 9:00 am the following day, Friday, May 4, 2012.

After his appearance in court the report will be forwarded to police headquarters in Belmopan where it will be decided if this policeman will be allowed to continue performing duties as per usual or if he will be placed on interdiction and relieved from all police duties until the case is brought to a final conclusion.

What on earth was going through this policeman’s mind. Of all persons he knows that every movement at the front desk and in the cell block area is recorded specifically to protect citizens against these kinds of abuses. He obviously was of the impression that this one was not going to come back to bite him.

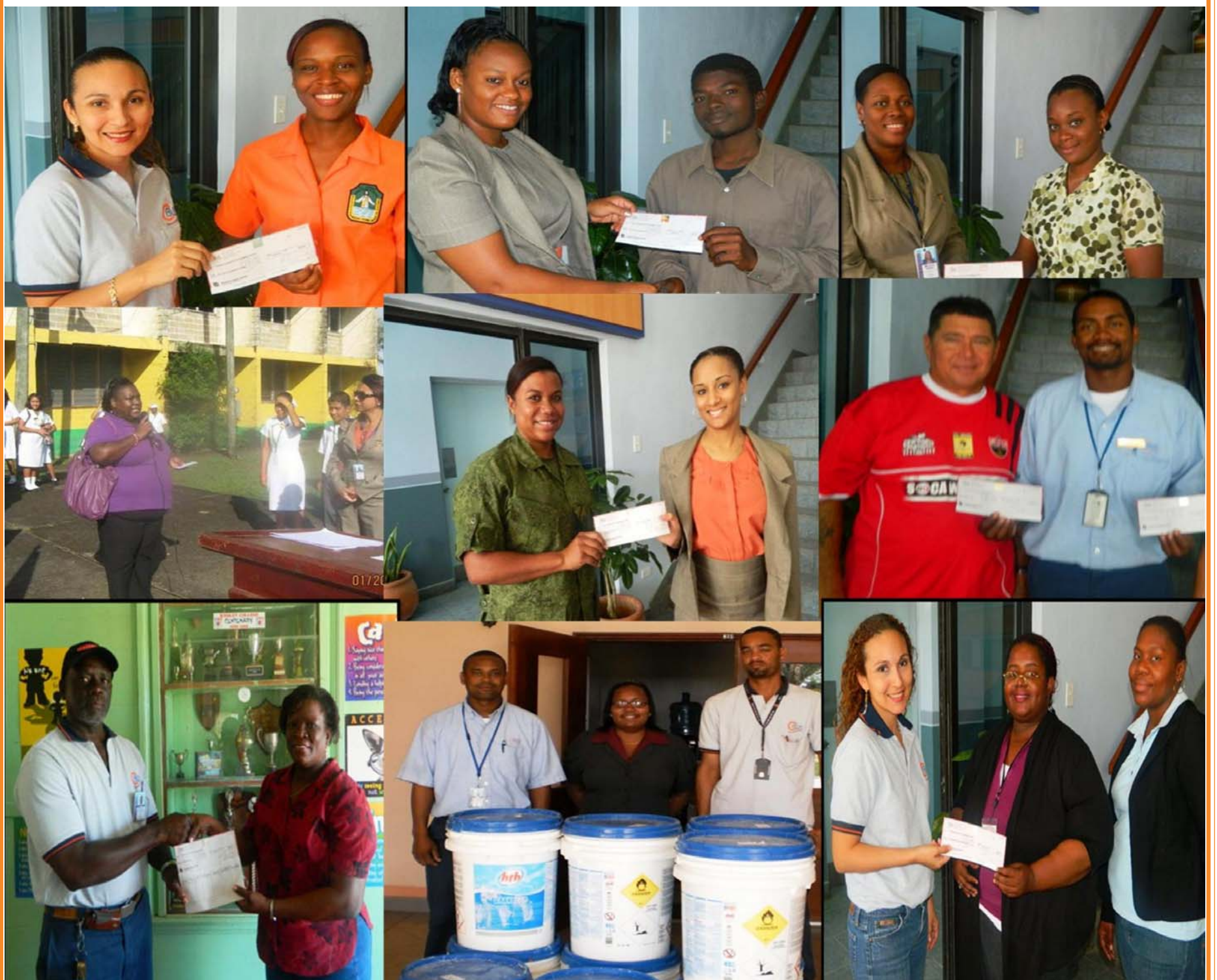

Dead Bodies Stacking Up In The Morgues

SAN IGNACIO TOWN, Cayo, Wednesday, May 2, 2012:

No less than fifteen is the number of dead bodies in morgues across the country awaiting the legally required post mortem examination, as the nation is without the services of the only forensic specialist in the country.

Dr. Mario Estradabran, Police Forensic Specialist today confirmed that the 2-year contract he held with the government expired on February 1, 2012, and that he is still in negotiations with the Ministry of National Security aimed at arriving at mutually agreeable terms for a contract renewal.

A source within the Police Department informed that although the contract expired over three months ago, Dr. Estradabran would still perform the service on an individual basis when requested. However, as of last week he has totally discontinued providing the service as he awaits word from the ministry on the new contract.

The last post mortem he is said to have conducted was last week on the body of Taylor Street gang leader, Arthur Young.

A reliable source informed that when the last contract expired at the end of January 2012, the ministry reportedly sent him a contract, under the same terms and conditions as well as salary, as the previous one. He reportedly refused the offer and instead submitted one with changes in terms, conditions and of course with a sizable salary increase.

His submission was reportedly rejected by the ministry prompting the commencement of negotiation for mutually acceptable new arrangements.

While in the past **Dr. Hugh Sanchez** who is employed by the Ministry of Health at the Karl Heusner Memorial Hospital in

Belize City, would pitch in to assist, he is not a Forensic Specialist but rather a Clinical Pathologist.

Given the demand for the service and the scarcity of immediate specialist replacement, a compromise with Dr. Estradabran is expected sooner rather than later as the number of dead bodies continue to increase in morgues across the country. The situation is

further aggravated by the need to determine cause of death and as the laying loved ones to their final resting place should supersede other considerations.

Furthermore, the longer a body is kept in the morgue, the more expensive it gets for relatives as morgue fees increase with every passing day.

The morgue fee, for example at the Karl Heusner Memorial Hospital is twenty five dollars per

day for the first three days that is of course if the patient passed away whilst undergoing treatment at the hospital. The fee increases to fifty dollars per day after the first three days. In those cases where a dead body is brought into the morgue then the fee is a straight fifty dollars per day from day one. In terms of the other districts, the morgue fee is a standard twenty five dollars per day across the board.

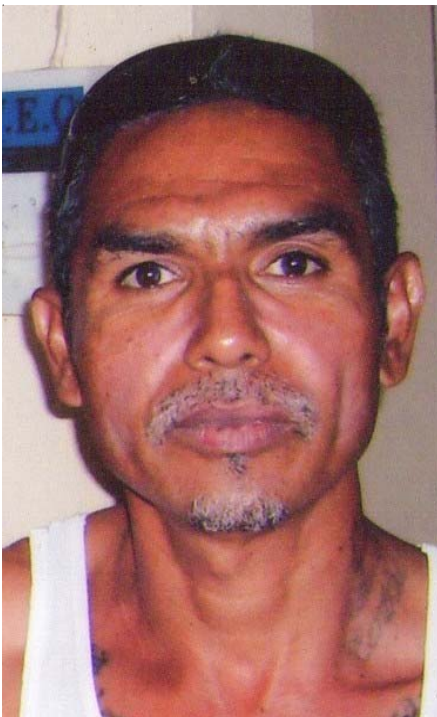
Santa Elena Man Found Dead At Home

SAN IGNACIO TOWN, Cayo, Thursday, May 3, 2012:

Although they were initially suspecting foul play, the family of a man found dead inside the house he rented in Santa Elena Town has agreed to accept the clinical cause of death as certified by the attending medical professional.

It was shortly after 7 o'clock on the morning of Saturday, April 28 when **Ismael August**, with intent to visit his brother Fedi, arrived at room #15, Sansores' apartments in the Santa Cruz area of Santa Elena Town. Upon arrival he found the front door open. He stepped inside where he saw the motionless body of his younger brother, face downward, on the floor.

He immediately contacted the police. A team of policemen arrived shortly thereafter. The police confirmed the presence of the motionless body of a male Hispanic person, face downwards, on the floor inside

apartment #15. He was wearing a blue t-shirt, black jeans pants, black socks and a small blue knapsack.

Police say that upon turning over the body, they observed what appeared as bruises to the face and clotted blood down the side of the mouth settling in the neck area.

The body was identified to the police by the brother **Ismael August**, 54, as being that of his 48 year old, unemployed, Belizean brother, **Fedi Nicascio August** whom he said had only one week earlier moved into the apartment. The body was removed from the scene and transported to the community hospital in San Ignacio where it was officially pronounced dead by **Dr. Maria Goncalvez**, the medical officer on duty at the time.

Police described August as an individual known to have had a

drinking problem which they believed, and was confirmed on Wednesday, May 2 by the medical examiner, **Dr. Misael Ramirez** who certified the cause of death as *'Hypo-volemic shock, perforated gastric ulcer, chronic alcoholism.'*

The police investigation revealed that the deceased was undergoing medical treatment for a chronic alcoholism condition and that the last time he was released from the Karl Heusner Memorial Hospital was on

Monday, April 13. While the approximate date of death was certified as the same Saturday when the body was found, close relatives say that he was last seen alive during the evening hours on Thursday, April 26. A 10:00 am funeral service on Thursday, May 2, was held for **Fedi Nicascio August** at his mother's house in San Ignacio Town. The funeral procession ended at the St. Rita Cemetery in San Ignacio Town where he was laid to rest. May his soul rest in peace.

Two Journalists Killed In Mexico

MEXICO, Thursday, May 3, 2012:

Two missing Mexican journalists have been found dead in the eastern state of Veracruz has sparked protest marches in Veracruz

The dismembered remains of photojournalists **Gabriel Huge** and **Guillermo Luna** had been dumped in bags in a canal along with two other bodies.

Their deaths come days after another reporter was killed in Veracruz.

Mexico is one of the world’s most dangerous countries for journalists, with many killings blamed on drugs gangs.

Gabriel Huge and Guillermo Luna were reported missing on Wednesday after they did not return from an assignment.

Their bodies were found in the port of Veracruz in Boca del Rio municipality.



Prosecutors said both showed signs of torture and blamed organized crime for the killings.

Mr Huge - who worked for the newspaper Notiver - had recently returned to Veracruz after leaving the state following the murder of two colleagues last year.

Mr Luna - who was his nephew - worked for the photo agency Veracruznews.

Also discovered were the bodies Mr Luna’s girlfriend, **Irasema Becerra**, and former photojournalist **Esteban Rodriguez**. The bodies were found on International Press Freedom Day.

Last weekend another journalist in Veracruz - Regina Martinez of the national news magazine Proceso - was found killed in her home in the city of Xalapa.

A total of seven journalists have been killed in Veracruz since the beginning of 2011.

The state has been the scene of a bloody battle for control of drug-trafficking routes between two of Mexico’s most powerful gangs - the Zetas and the Gulf Cartel.

To mark its 30th Anniversary the Central Bank of Belize will be launching a commemorative circulation \$20 Belize currency note and \$1 coin on Monday 30 April 2012.

The front upper left hand corner of the note includes a depiction of the majestic Jabiru Stork in flight. The Jabiru Stork (shown in a standing position) was selected to be the symbol of the Central Bank of Belize in 1982 due to the impressive size, dignity and strength of its appearance as these characteristics are retained and enhanced when the bird is in full flight. Directly below the Jabiru Stork is the commemorative text "30th Anniversary Central Bank of Belize". The new dollar coin also includes a depiction of the flying Jabiru on one side.

The back of the currency note and the reverse side of the coin depicts the Central Bank of Belize headquarters which was opened for operations in 1998. One of Belize's architectural landmarks, the building was constructed on the theme of functional simplicity to provide a focal point and suitable setting for the institution that bears primary responsibility for oversight of Belize's financial system.

The Commemorative \$20 banknote and \$1 coin are legal tender which will circulate alongside the existing \$20 banknote and \$1 coin. The existing \$20 banknote depicts the Jaguar in the front and the animals of Belize in the back. The public is advised that all security features incorporated in Belize's currency notes remain unchanged.

The Central Bank of Belize will be distributing posters to financial institutions, the government departments, statutory bodies, business enterprises, schools, libraries, police stations and other target groups. Posters will also be made available to those who visit the Central Bank of Belize.

The Government of the Republic of Cuba, under the Belize/Cuba Government Scholarship Programme, is once again awarding scholarships to the Government of Belize for the Academic Year 2012- 2013. Qualifying Belizean Students would pursue a medical degree.

Tenure of Scholarships

The Scholarship is normally for the duration of the programme of studies and requires the scholarship holder to maintain above average passing grades at the aforementioned University. The scholarships become tenable in August 2012.

Eligibility

Applicants must:

- 1) Be a citizen of Belize
- 2) Must be between the ages of 18 and 25
- 3) Complete a Scholarship Application Form (in triplicate) which can be obtained at the Ministry of Education in Belmopan or District Education offices in the six districts.
- 4) Present certified copies of Associates Degree, be a sixth form graduate with a background in the sciences as well as transcript from Junior College.
These documents are to be authenticated by the Ministry of Education, the Ministry of Foreign Affairs and Foreign Trade, and the Embassy of Cuba in Belize City.
- 5) Present a recent (not older than 6 months) Medical Certificate indicating good health, including the results of an HIV/AIDS test and a Pregnancy Test.
- 6) Present an updated police record.
- 7) Provide CXC and/or other equivalency examination results.
- 8) Provide 3 recent passport size photographs

The Ministry of Education, has established a Selection Committee, which includes representatives of the Cuban Embassy in Belize, Ministry of Health and the Ministry of Foreign Affairs and Foreign Trade. The process of selection will include a programme of orientation for the successful applicants.

Completed application forms and other documents MUST be submitted to the attention of the Director of Tertiary and Post Secondary Education Services in the Ministry of Education no later than June 10, 2012. It is anticipated that selected applicants will be invited for an interview.

informed that the police was looking for arms, ammunition and drugs. The police say that when asked if they had anything to declare, they both said no. Notwithstanding their declaration an “on the spot” search was conducted. The couple was instructed to accompany the police in every aspect of the search of the vehicle.

The police alleged that just as they were moving to search the back of the car, the female approached Inspector Reyes and reportedly offered to pay him two thousand dollars to let them continue their merry way. Reyes reportedly ignored the offer and when the trunk was popped there, in clear view for all to see, stood a brown “*Distribuidores De Saco El Quetzal*” plastic sack, obviously too large to conceal in the trunk of a small car. The female instantly broke down and began crying.

Police suspect that the brand of the plastic sack could very well indicate that the weed came from across the border in Guatemala where the word “Quetzal” (the name of Guatemala’s national bird) is a common brand name.

The driver and the female companion were detained and escorted to the police station in San Ignacio where they were identified as Richard Smith,

32, Belizean Security Guard of #6744 Raccoon Street Extension being the other side of Central American Boulevard in Belize City, straight down from the biggest police station in the nation. The female was identified as Sandra Thompson, 27, Belizean residing in the St. Martin De Porres, Lake Independence area of Belize City.

In addition to the marijuana, police also took possession of cash amounting to 1,707 Belize dollars being 831 dollars found in the driver’s possession along with 182 Belize dollars and 347 US dollars (694 Belize dollars) in the female’s possession. They were informed that the cash, under suspicion of being the proceeds

of drug activities, would be kept as evidence in the case. In the absence of a scale to accurately weigh the weed, police escorted the couple and the weed to the San Ignacio Community Hospital where, in their presence, it was placed on the scale with the needle moving to a flat 33 pounds or 14,969 grams.

Richard Smith and **Sandra Thompson** were jointly arrested and charged for drug trafficking. They appeared in court on Wednesday, May 2, where the single joint charge was read to them by **Magistrate Linsbert Willis**. They both pled not guilty to the charge.

Magistrate Willis informed that in matters of this nature he could not grant bail. Despite the pleas of the female and her mother for the granting of bail citing that she has a breast feeding infant at home, Magistrate Willis reiterated his inability to offer bail. He proceeded to remand both accused persons to prison until Monday, August 6, 2012. It was at this point that the female began to cry loudly in court to the point where she passed out and fell to the floor like a log. She was removed from the court and rushed to the community hospital in San Ignacio.
