

Caretella And Pagett Freed Of Murder Charge

After a 12-member jury was empanelled, the trial began in earnest with Crown Counsel **Ms. Sheiniza Smith** prosecuting on behalf of the office of the Director of Public Prosecutions.

Pagett was represented by Senior Counsel **Ellis Arnold** while Senior Counsel **Simeon Sampson** appeared on behalf of Caretella.

Among the witnesses testifying for the prosecution was **Rafael Martinez** who told the court that Caretella and Pagett visited him at home on the day of the murder where they planned to rob a gas station. He said that they encountered Waight and decided to rob him instead. He told the court that they boarded Waight's taxi and that one of them pulled out a gun, placed it to Waight's head and ordered him to drive to a feeder road in the Linda Vista area of Santa Elena where he was relieved of his wallet and cash. Waight allegedly attempted to run away but was shot in the back of the head after which he fell to the ground.

In his defence Pagett told the court that he could not have committed the crime because at the material time he was working inside a local meat shop. For his part, Caretella told the court that he was working with his father in Santa Elena.

After hearing Martinez' testimony both defence attorneys submitted that Martinez was given immunity for his testimony and that his testimony could not be trusted as he was simply saving his skin.

The crown proceeded to call three more witnesses but despite its best effort, the prosecution appeared unable to convince the jury, beyond a reasonable doubt, of the guilt of the accused William Pagett and Thomas Caretella.

The jury retired after listening to closing submissions presented by the prosecution and the defence and after deliberating for about three and a half hours, the jury returned with a not guilty verdict after which Justice Gonzalez ordered Caretella and Pagett to walk free.

Improved Water Services Coming Soon

SAN IGNACIO, Cayo, Wednesday, June 13, 2012:

The uninterrupted supply of water to consumers in the community, a long standing and repeated request by **Mayor John August**, will soon become a reality in the twin towns of San Ignacio and Santa Elena as well as for residents in Esperanza Village, all connected to the municipal water system.

The Belize Water Services Limited (**BWS**) will begin the construction of a generator house and the acquisition of a new generator to keep the system running in the event of power failures.

The Belize Water Services Limited is gearing up for the implementation of a multi-million dollar investment earmarked for the upgrading of the water supply system in the west.

The project, to be undertaken in three phases, includes, in the first phase, the construction of the generator house and the acquisition of a new generator for a combined price tag of one hundred and seventy thousand dollars.

The second phase will bring to reality the construction of a half million gallon concrete water storage tank at a cost of 1.2 million dollars. This new tank will drastically increase the current storage capability of 90 thousand gallons at the treatment plant and the 80 thousand tank located on top of the hill in the Cahal Pech area.

The third phase of the project will result in a 1.3 million dollar investment in a total upgrade of

the water treatment plant.

The works will be undertaken on the site of the present water treatment plant located next to the fire station in San Ignacio.

BWS is eager to begin the project as the technical team is convinced that the current water treatment facility is rapidly approaching the point of becoming inadequate for the increasing demands for the delivery of quality water services to consumers in the area.

A major hindrance in the implementation of the project was ownership of the property between the fire station on the BWS compound which is being settled as the research shows that the strip of land was marked for a street access that was never opened as it would come to a dangerous end on the slope to the Macal river.

In supporting the project, which apart from creating employment during the construction phase and bringing to reality his request for uninterrupted water supply, **Mayor John August** accompanied by the Chairman of the Belize Water Services, **Alberto August** and the District BWS Manager, **Ron Cunningham** today visited the site where the project was explained to him.

In commending BWS for other expansion projects undertaking in the twin towns, Mayor August expressed his full support for the project as BWS continues delivering quality and cost effective water services to consumers in all its service areas.

OCEANA HOST FAMILIARIZATION TOUR FOR MEDIA

BELIZE CITY, Sunday, June 10, 2012:

As part of its campaign to highlight the importance of Belize's fragile marine ecosystem, Oceana In Belize invited the media from across Belize to join them, along with actress **Kathlene "Kate" Walsh**, on a familiarization tour of the Blue Hole and Half Moon Caye Natural Monument.

Kate Walsh is an American actress in film and on television. She is most known for her role as **Dr. Addison Montgomery** on the ABC drama series **Grey's Anatomy and Private Practice**. Off the set Kate says that she is more than a person made famous by the various characters that she plays in the movies and on television. She sees herself as a citizen of the world engaged in conservation.

Escorted by Oceana's Vice President **Audrey Matura Shephard**, Kate made her grand appearance on the pier for a quick meet and greet with the assembled media after which she was whisked away for the helicopter ride to the island while the press and Matura Shephard took the three-hour boat ride from Belize City to Half Moon Caye.

The trip afforded those in attendance a first hand demonstration of the importance of the barrier reef to the coastlines of Belize. As the boat left the safety of the inner waters of the barrier reef, the height, length and intensity of the waves increased thereby effortlessly tossing the boat at will on the waters.

While the boat manoeuvred over massive waves, Matura Shephard seized the opportunity to explain the importance of the reef which she said served as a

protection against the blunt force of the waves that would otherwise erode Belize's coastline. She explained that she is fighting every single day to assist in the preservation of Belize's barrier reef, marine life and the entire marine eco-system.

On Half Moon Caye the group was afforded the opportunity for a close up view of the Belize Audubon Society's haven for the Red-footed Booby birds. For its part, the Management and Staff of BAS took the opportunity to showcase the wonderful work undertaken to ensure the survival of the birds and other marine life that call Lighthouse Reef Atoll their home.

Kate Walsh landed on the island, by Astrum helicopter at 1:30 pm. She boarded a boat with the media for a snorkelling expedition to the Blue Hole.

The Blue Hole is an amazing national jewel set in a ring of corals, measuring 1,000 feet across and 412 feet deep. This ocean-floor sinkhole is a world renowned dive attraction for thrill seekers from across the globe.

Lighthouse Reef Atoll plays a major role in tourism attracting thousands of visitors each year.

After snorkelling the Blue Hole for about half an hour, Kate and the media headed back to Half Moon Caye for the interview segment of the expedition.

In her presentation Kate reiterated the importance of the barrier reef not only to the marine life that call it home but also to the very survival of Belize. She said that the barrier reef acts as a fence keeping out the bad people from entering our yards in this case; she said that the waves are like the bad people who if left unchecked will destroy Belize's coastline. Kate said that she considers herself blessed to have had to opportunity get an aerial and sub subsurface view of Belize's magnificent barrier reef. She said that it would be just wonderful if every single Belizean could get a chance to behold the barrier reef from in the air and from under the sea in order to appreciate that it is something worth fighting for. She also informed that apart from its natural beauty, the sea provides a means of livelihood for over a billion people.

In responding to a question about given the opportunity to say something to the Prime Minister

of Belize, what would she say, Kate said **"I would say, thank you for having me in your country. It is a gorgeous country, so pristine and such a jewel. I just want it to be intact for everyone to enjoy and visit not only for tourist but also for the people of Belize to be able to enjoy it and**

protect it."

The educational and enjoyable maritime expedition was organized and funded by Oceana In Belize. Apart from expressing gratitude to Oceana in Belize, the group also says thank you to the management and staff of the Belize Audubon Society showcasing their bird and other wildlife protection efforts on Lighthouse Reef Atoll.

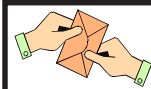

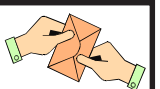

Gomez Remanded To Prison On Carnal Knowledge Charges

SANIGANCIO, Cayo, Monday, June 11, 2012:

After evading police for seventeen days, a Salvadoran laborer was today remanded to prison on three counts of carnal knowledge allegedly committed against a 14 year old Belizean girl from Santa Elena, Cayo.

San Ignacio police informed that on Tuesday, May 22, 2012,

the father accompanied by the alleged victim visited the station where the initial report was lodged indicating that the accused carnally knew the child on three occasions being January 19, January 24 and February 3, 2012.

In her statement to the police the child provided a detailed account of the three occasions on which the accused allegedly carnally knew her all of which allegedly occurred in the house where she lives.

The police immediately began the search for the accused. During the course of the investigation the police was informed that the accused had departed Belize for his home country, El Salvador. Notwith-

standing this information, the search continued for the accused. It ended on Friday, June 8 when he was found at his place of business on the Western Highway in Santa Elena. The accused was immediately detained and

escorted to the police station in San Ignacio where he was informed of the report made against him.

At the station he was positively identified as **Dennis Gomez, 22**, Salvadoran laborer of a Western Highway address in Santa Elena. He appeared in the San Ignacio courtroom of Magistrate **Narda Morgan**, on Monday, June 11, where he pled not guilty to all three carnal knowledge charges.

In concurring with the prosecution's objection to the granting of bail, Magistrate Morgan proceeded to remanded the accused to prison for the full 90 days. He will therefore be reappearing in court on Wednesday, September 12, 2012.

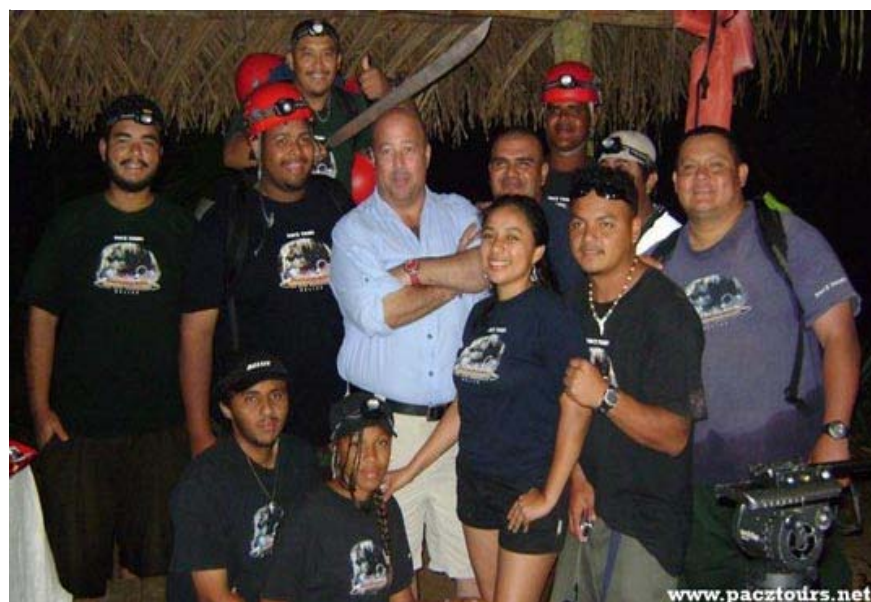

Farewell to a Belizean Child



Jasmine Lowe, 13

Dear Jasmine,

Like so many Belizeans right now I am still so sad, confused and angry that one more young life has been taken from us, that one more precious smile is gone, that one more family has been devastated by the senseless violence that continues to rip our country apart.

Everything you did, from helping grow food on your family farm and brightening the San Ignacio markets with your smile when you sold it, to your participation with the Scouts, your church and your community, it all seemed to benefit Belize.

You showed so much promise that everyone who knew you would surely say, "*Jasmine represents the future of Belize*".

And today, through my sorrow and anger, I realised that you still can represent the future of Belize, that even in death you can make a difference.

And that's why I am writing this Jasmine, to put a promise into words that I'm going to start working to make sure you are a part of our future. Instead of just being snuffed out, your life can become a light to illuminate a path for all of us and guide us out of the darkness that is enveloping Belize right now.

If this sounds crazy I just ask you to hear me out. This is the promise I make to you, your family, your friends and your fellow Belizeans, and I am asking them to join me.

I am much older then you were when you were taken from us, Jasmine, and I have seen a great many things happen in Belize over the years.

I remember a Belize when money was scarce, but we were rich in so many other ways. Our

streets and our children were safe. Old people were respected and treated with courtesy and kindness. You never passed anyone without a smile and a greeting, even just a simple nod and a friendly "*yes, mon.*"

There was no TV, but that was all right – we made our own entertainment, and every street and every village had their own stars, someone who could sing, play guitar or drums, tell stories or just make you laugh. I miss that laughter so much.

When I was younger I left Belize to work, and I tell you couldn't wait to come home. That's when I first realised that we had something all the money in the world couldn't buy – we had

ourselves. We had each other and this beautiful little country we worked so hard to make our own.

I remember we were proud of Belize. It felt good to say, "*I'm from Belize,*" because back then, when people thought of Belize, they thought of a beautiful peaceful little country. When the tourists first started to come I remember them telling us how lucky were, how friendly Belizeans were, how our little country was a sparkling Jewel. And we knew it was true. There was no better place in the world to live.

Now look at us Jasmine. Innocent people are being gunned down in the street, stray bullets are killing children in their bed,

and young boys are murdering to get membership in gangs where there is no future but more death, jail, and misery. Always having to act tough, never a smile, full of crack-fuelled courage that's just a cover for the constant fear.

And like a disease their fear and paranoia has spread through the community. Everyone seems to be locking themselves inside these days Jasmine, staring into a box, too afraid to go outside and be with real people, with their neighbours, listening to music and each other's stories, feeling like a part of a community, a neighbourhood.

How did we become so afraid, not of some foreign invader, but of each other? I tell you Jasmine, sometimes I wake up in the morning and think this is a bad dream.

But now I believe this is a nightmare that we have the power to change. Your death made something click inside me. I'm sick of being ashamed of my country, of being afraid in my own town, and now I know that the only cure for this shame is to do something.

And this is why you can still be part of our future, Jasmine. For me your murder was the last straw, and you inspired me to start doing something to help change things. And if you did this to me, you can do it to a lot more of us. That would be the most beautiful tribute we can pay you. **"Yes man, things changed after Jasmine Lowe's murder."**

So that is the promise I make to you today. I am going to start doing something and I am going to ask all Belizeans to join me. I am asking every pastor and church member, Scout leader, community leaders, organisations, clubs and everywhere where people meet to start getting together ideas for a very important day, the 15th of September, Jasmine Lowe Day.

I pray that after that day, people will talk about the two Belizes - Belize Before Jasmine, and Belize After Jasmine.

Before Jasmine we felt powerless. Crime was out of control, the gangs were running the streets, and people were too afraid to do anything about it. Just keep quiet and mind your own business. Don't make yourself a target. Just get by, there's nothing you can do about it.

Then came Belize After Jasmine

After Jasmine we had people power. If over a hundred people could brave the jungle at night, cross the river, walk through the water, forget their fears so that they could join together to hold candles to light up the dark night and bury you with love and respect, that proved we are still a people who care. By joining together to comfort the family by telling them that they are not alone, that showed that we are still a community, that we still have a heart.

You did that Jasmine. You brought people out of the comfort of their homes on a dark and wet night to show that they care, to express their love and

humanity.

And if over a hundred people can suddenly heed the call and come together on a dark night, why can't a hundred thousand people come together to stop the madness? Why can't all of us join together to rise up and demand a better Belize?

I know that there are many more good people in Belize than bad. I know most Belizeans love their families, work hard and look out for each other. I still see it every day. I still love my country.

But good people hardly get noticed. It seems like you've got to commit a crime to get on the news these days, and even there the competition is fierce.

But what if the good majority demands to get noticed? What if, After Jasmine, we show some real People Power? If we show our numbers we will get noticed, we will make the news, and people will have to take notice.

Every church, NGO, Scout group and any organisation can join in. Even your old Karate club Jasmine. If every group in every village came together, we would be united in demanding that our politicians show the same will we are showing and do something.

And we won't let them tell us there's nothing to be done, Jasmine. No, that's when we remember you and all the other victims and say, Guess What? There's a lot that can be done. We can see Special Constables on the street. We can see the Police Cadets program expanded, we can organise the boy scouts, girl scouts, church groups, and everyone who wants into neighbourhood watch and other programs.

The thing is, we're at crisis point in Belize, and that calls for extraordinary action. And the best way to get the world's attention is by joining together People Power has changed governments and systems around the world, and if we show we are united, something will get done here.

September 15 2012 will mark 100 days since the terrible day when we buried Jasmine. What a tribute if on that day people all across Belize wore a coloured ribbon and organised to gather in the Macal River Park and all

across Belize to celebrate her life and show how many of us are willing to come out to demand that things change, that our children have a future, that our streets are safe again and that laughter returns to Belize.

September 15 gives us time to meet with each other, to send letters to the editor about what we are thinking and to our elected officials asking them what the government plans to do. Jasmine, imagine if we all rise up with one strong voice saying this madness has to stop! We will get noticed.

At least we have a chance, and we go to bed at night knowing that we did something. If we do nothing, the horror will only get worse.

Sure, some people are just going to shake their heads and say that it will never happen, that the situation is too far gone, that Belizeans organise, and that After Jasmine is an impossible dream.

Even your father is too young to remember Jasmine, but in our fight for independence, we had huge rallies and demonstrations. You think they just handed us our independence, no we had to fight for it, and we had to show that enough Belizeans wanted it, and wanted it badly, that the tide had turned on colonialism.

Now we must demand independence from fear and violence, rape and murder, and with enough of us, we can turn the

tide on crime this time. And it's only right we do it before the September celebrations, when we celebrate how we first came together as a nation. Now we need to demonstrate how to survive as a nation.

Do you think it's impossible, Jasmine? Do you remember that two thousand years ago another innocent was murdered; someone else died a terrible death. That time it was a man and that man's life and his death inspired something that changed the entire world. That something was hope. That something was a message that said, **"We don't have to live this way anymore. We are better than this"**.

You know what happened after that, Jasmine.

This week I am going to start. And if people read this and talk about it with their friends, teachers, pastors, MPs and any and everyone who will listen, maybe, just maybe your brief, bright spark will ignite a blaze, something that will burn though our complacency, our hopelessness, our despair and surrender to what can only be described as evil.

That could happen, Jasmine, and you will have contributed to our future, your life will have made a difference, and while we must live with the sorrow that can never have you back, at least we can take comfort that we kept your spirit alive and with you achieved something miraculous.

The New Three-Classroom Building

made the initial approach to the trust for funding. Thank you Stacey for the major role you played in bringing this project to reality.

We are today inaugurating your three classroom building measuring 25 by 90 feet, constructed at a cost over 267 thousand dollars. Construction began on December 5 of last year and was fully completed 6 months later, on June 6.

I take this opportunity to express sincere appreciation to the contractor **Mr. Richard Tzul** and his crew for constructing a fine building.

Mr. Tzul, from the very first day he broke ground here, has always insisted that he was going to construct a building the likes of which all of us would be proud. This structure that we are about to inaugurate today is indeed a testament of his firm commitment.

Now I know that you are not here to listen to any long drawn out speech. You want us to hand over your new school building to you and you want us to get out of here as quickly as possible so that you can begin to enjoy your new building.

But before we go, I would like to ask you for just a little more of your time to give you a brief summary of what the Belize Natural Energy Charitable Trust is all about.

The Trust is a bold and solid partnership between the Government of Belize and the Belize Natural Energy Limited.

The Trust is governed by a legal instrument known as the Trust Deed. It was signed on February 25, 2008, a mere 18 days after the first United Democratic Party Government

was elected to office.

The Deed which gave birth to the Trust, was signed by **Prime Minister Dean Barrow**, on behalf of the Government of Belize and by **Dr. Gilbert Canton** in his capacity as the Chief Executive of the Belize Natural Energy Limited on behalf of the oil company.

The Trust comprises of six members – three representing the Government of Belize and three representing the Belize Natural Energy Limited.

A new Board of Trustees is appointed every two years thereby triggering the rotation of the chairmanship between the two partners, being the Government of Belize and the Belize Natural Energy Limited.

The new Board of Trustees, just this week reappointed to serve another two-year term, include: **Chairman Daniel Gutierrez**, **Mrs. Melanie Escalante** and **Mr. Kevin Herrera**, all representing the Belize Natural

Energy Limited while the Government appointed representatives include the outgoing Chairman **Orlando Burns** from Orange Walk Town, **Principal Ismael Requena** and myself.

The Trust is funded by way of 1% of the gross revenue received from the exportation of crude oil, which, at the current rate of production, averages around 1.6 million dollars annually which is paid into the Trust fund by way of quarterly instalments.

It therefore goes without saying that, the more crude oil Belize produces and exports, the more money goes into the Trust Funds.

With more money going into the Trust Fund it automatically translates into the availability of more funds to invest in the core educational and social environmental projects.

In other words, if Belize was producing and exporting ten times the amount of oil we are currently exporting, there would have been a greater probability that we would have today been inaugurating, not a 267 thousand dollar three classroom building, but rather a 2.67 million dollar thirty classroom building for you.

Notwithstanding this reality, there are still a few among us who are insisting that we should not explore for more oil.

I end by asking all you, as well as those with children and relatives attending this school, to please take good care of your school building.

The engineers: **Mr. Rabby**, **Mr. Polanco** and **Mr. Tzul**, assures us that this building will be around for many, many years to come.

We ask you again to take care of it and in doing so, you are ensuring that it will remain in service for future generations of Belizean leaders as the Trust continues to do its part in unlocking the potentials of Belizeans countrywide.
