Pineda In Critical Condition At KHMH

SAN IGNACIO, Cayo, Sunday, February 10, 2013;

A Honduran man today is in a coma on life support at the Karl Heusner Memorial Hospital in Belize City.

The incident which landed the man in the hospital is reported to have occurred inside Las Ninfas de Mariana Bar, located at #23 Back Street in San Ignacio which is operated by the victim’s estranged common law wife from whom he has been separated for about two months.

When police arrived on the scene at around 2:00 am on Sunday, February 10, 2013, they first came upon a male person of Hispanic descent sitting on the ground in the

yard. His face was swollen and blood was coming from the nose and mouth. He was identified as **Jose Santos Pineda** the estranged common law husband of the bar operator, **Mariana Galvez**.

Further into the premises the police came upon a male Hispanic youth standing outside the establishment with a cut wound to the left side of the back and a small cut wound to the left side of the face. He was identified as **Israel Betancourt Perez**, 19, Guatemalan laborer residing in Santa Familia Village. He was in the company of **Victor Perez**, 38, Belizean heavy duty equipment

Another Man Is On Life Support At The KHMH

SANIGNACIO, Cayo, Thursday, February 14, 2013:

Another man from San Ignacio, suffering from a blow to the back of the head with a blunt instrument, is on life support at the Karl Heusner Memorial Hospital in Belize City.

It was around 2:00 am on Sunday, February 10, 2013 when the police was summoned to the emergency unit of the San Ignacio Community Hospital where they encountered a male Hispanic person, with an injury to the head, undergoing emergency medical treatment.

A male youth who was present at the hospital identified the patient as

One incident, two exact opposite pronouncements. A vehicle, admittedly the personal property of the Cayo North PUP elected Area Representative **Joseph Mahmud** was photographed with the front driver's side wheel, on top of a 17 year old boy.

The politician confirms that he is the owner of the vehicle but that he was neither in the vehicle nor on the scene of the incident. operator also residing in Santa Familia Village. The police also found the bar owner, **Mariana Galvez** who was complaining of pain to the back after being allegedly knocked to the floor by the estranged common law husband who is reported to have attacked her and attempted to rip off her clothing.

All three persons were transported first to the station and later to the community hospital in San Ignacio where they were examined. **Mariana Galvez'** injury was classified as harm while **Israel Perez;** injury was classified as wounding. The patient with the most severe injury, **Jose Santos Pineda**, was prepped and rushed, by ambulance, to the Karl Heusner Memorial in Belize City where he is currently listed in a critical condition and on life support inside the Intensive Care Unit.

In a statement to the police the estranged common law wife **Mariana Galvez**, 33, Guatemalan businesswoman of a San Ignacio Town address informed that it was shortly after 2:00 am when a customer walked into the bar and requested to buy a beer.

Galvez informed that while serving the customer, the estranged common law husband, **Jose Santos Pineda**, reportedly walked into the establishment, and that while the customer was sitting at the counter, Pineda grabbed a beer bottle and threw it at the customer hitting him in the head. He took another bottle, broke it and, with

the stub, reported inflicted a cut wound across the back of the customer.

Galvez further told the police that upon seeing the commotion she attempted to run out of the bar but was allegedly intercepted by Pineda who grabbed her by the hair and threw her to the floor. She further alleges that apart from attempting to rip off her clothes including her underwear, he pulled out a knife which he tried to use to cut her tongue. She reportedly bit him on the hand.

The customer, later identified as **Victor Perez**, 38, Belizean laborer of a Santa Elena address reportedly came to Galvez' assistance and when the police arrived they found Pineda unconscious on the floor.

In contradicting the sequence of events as related by the complainant, the victim's sister told the police that her brother was at the Piache Bar in San Ignacio performing his usual DJ duties. At closing time he was allegedly kidnapped, at knife point, by a man, placed him inside a waiting vehicle and was taken over to Mariana Bar where he proceeded to beat him unconscious in front of the estranged common law wife who she alleged had paid the kidnapper to kill her brother.

The sister told the police that her brother fathered an infant child with the complainant and that the union has been a violent one eventually resulting in severing of the relationship about two months ago and the issuance of a restraining order prohibiting her brother from any

Jamaica In Crisis Debt-Swap Plan

Jamaica has announced plans for its second debt swap in three years in the face of a *"serious economic crisis"*.

Prime Minister **Portia Simpson Miller** is taking measures to reduce its debt, which currently stands at 140% of gross domestic product (GDP), one of the highest ratios in the world.

"If this debt is not reduced, Jamaica faces a dismal future," she said.

The move is aimed at satisfying conditions demanded in a deal with the International Monetary Fund.

About 55% of government spending goes towards paying the nation's debt, while 25% goes on wages. That leaves just 20% for everything else - including education, security and health.

'Significant sacrifices'

In a televised address, Ms Simpson Miller, who belongs to the People's National Party (PNP), said a national debt exchange would be launched.

The administration will offer a swap of higher-interest debt for lower-cost debt and will require *"significant sacrifices"* from financial institutions and domestic bond holders.

The move follows an earlier debt restructuring in 2010 under the

previous Jamaica Labour Party (JLP) government.

Since many bondholders already took a hit in 2010, Finance Minister **Peter Phillips** acknowledged that they were likely to be disappointed, but urged them to accept the offer.

He said it should reduce the country's debt-to-GDP ratio by 8.5% a year until 2020.

Tourism downturn

Jamaica has been negotiating a loan with the IMF for the past year. As part of the agreement, the country must

reduce debt, as well as the government wage bill.

This implies *"significant austerity in the public sector"* according to **Laurence Allan**, Latin American and Caribbean analyst at IHS Global Insight.

He says that *"Simpson Miller faces a massive challenge"* in getting the reforms through and that many *"poor and ordinary Jamaicans view Jamaican elites as those who caused the debt problem and, conversely, who have suffered the least from its consequences"*.

But he adds that *"no Jamaican*

government in recent memory has enjoyed such favourable domestic political conditions".

Jamaica is one of a number of Caribbean countries struggling with a growing debt burden amid falling tourism revenues.

Much of the region depends on tourists from Europe and the US for its income, but the global financial crisis has cut visitor numbers severely.

Last year, Belize, another member of the Caricom regional trade bloc, came close to defaulting on a \$550m *"superbond"* that represents half its public debt.

But in December, Prime Minister **Dean Barrow** said that bondholders had agreed *"in principle"* to a restructuring deal.

Do You Have A Favorite Child? You Should Read This

It is perhaps motherhood's dirtiest little secret: Favoring one child over another.

Favoritism is usually not intentional and can happen for a variety of reasons. Maybe one kid is the most well-behaved in the brood, especially talented, has an inexplicable bond with a parent. And often times the opposite can be true: If one child has behavioral problems, he can become the favorite because he requires extra attention.

And while moms may objectively realize that favoritism isn't ethical or even a conscious act, a new study published on Tuesday in the February issue of the journal Child Development shows that showing more love to one kid harms more than just the *"naughty one"*—it damages the entire family unit, causing increased mental health problems in children such as aggression, attention, and emotional problems.

The study included 400 Canadian families with up to four kids each whose average age ranged from



2-to-5-years old. Due to the fathers' conflicting schedules, only mothers were assessed for certain *"risk factors"* such as education and income level, mental stability, whether they were single parents, and had suffered any past mental or physical abuse. Then, researchers assessed how much the mothers displayed favoritism which they called *"differential parenting"*—giving positive feedback to one child and negative feedback to another—by both observing mother-children interaction and asking the moms questions such as, *"How often do*

you and your child talk or have fun together?" and *"How often do you get angry with your child?"*

"We found that moms with more risk factors tend to favor one of their children the most," says lead study author **Jenny Jenkins, Ph.D.**, a professor in the department of Applied Psychology and Human Development at the University of Toronto. And while a favored child may experience momentarily satisfaction, the overall home environment becomes hostile and aggressive, especially between siblings. *"That was the most surprising part,"* she says.

The study didn't observe why some kids are favored over others but according to Jenkins, when a family doesn't have much support or resources, it's harder for parents to treat their kids equally. *"In general, parents really try their best to be fair to their children. The problem is, outside stress can affect how parents react at home. And of course there are just some*

kids who are more troublesome or harder to connect with than others," she says.

"Kids are very perceptive to how they're treated in comparison to the rest of the family," says Jenkins. *"Many older ones are able to understand why one sibling may need more attention at any given time but it's still important for moms to be as transparent as possible when doling out punishments or spending extra time with one child so no one feels left out."*

If you find yourself getting angry with one child, try to tap into your feelings by asking yourself: Are you upset because of what your kid did or which kid did it?

And finally, as frustrating as those *"It's not fair!"* tantrums are, listen to them. *"Often times, your child is telling you that he feels unloved,"* says Jenkins. *"Hear those tantrums and learn from them."*

Learn These Basic CPR Steps

CALL 911 FIRST!Check the scene for immediate danger. Make sure you are not putting yourself in harm's way by administering CPR to someone unconscious. Is there a fire? Is the person lying on a roadway? Do whatever is necessary to move yourself and the other person to safety.

Assess the victim's consciousness. Gently tap his or her shoulder and ask **"Are you OK?"** in a loud, clear voice. If he or she responds, CPR is not required. Instead, undertake basic first aid and take measures to prevent or treat shock, and assess whether you need to contact emergency services.

If the victim does not respond, continue with the following steps.

Call 911, give the dispatcher your location, and notify him or her that you are going to perform CPR. If you are alone, get off the phone and start compressions after that. If you have someone else with you, have him or her stay on the line while you do CPR on the victim.

Do not check for a pulse. If you are not a trained medical professional, odds are you will spend too much valuable time looking for a pulse when you should be doing compressions.

Check for breathing. Put your ear close to the victim's nose and mouth, and listen for slight breathing. If the victim is coughing or breathing normally, do not perform CPR. Doing so could cause the heart to stop beating.


Place the victim on his or her back. Make sure he or she is lying as flat as possible - this will prevent injury while you are doing chest compressions.

Perform 30 chest compressions. Press down with both hands directly over the breastbone to perform a compression, which helps the heart beat. Chest compressions are more critical for correcting abnormal heart rhythms (ventricular fibrillation or pulseless ventricular tachycardia). Do the compressions in a relatively fast rhythm. Some agencies recommend doing compressions to the beat of the chorus of "Stayin' Alive," a 1970s disco hit, or at roughly 103 beats per minute.

Make sure the airway is open.

Place your hand on the victim's forehead and two fingers on their chin and tilt the head back to open the airway. If you suspect a neck injury, pull the jaw forward rather than lifting the chin. If jaw thrust fails to open the airway, do a careful head tilt and chin lift. If there are no signs of life, place a breathing barrier (if available) over the victim's mouth.

Give two rescue breaths (optional). The American Heart Association no longer considers rescue breaths necessary for CPR, as the chest compressions are more important. You can give them if you choose to, though.

Continue CPR until someone takes over for you, emergency personnel arrive, you are too exhausted to continue, an AED is available for immediate use, or signs of life return.

Chicago Names Joaquin Guzman Public Enemy No. 1

The city of Chicago has named its first public enemy number one since **Al Capone** - a drug cartel leader who lives in a mountain hideaway in western Mexico.


Joaquin Guzman is the leader of the powerful Sinaloa cartel, which is suspected by federal agents supplying the bulk of narcotics sold in Chicago.

The Chicago Crime Commission has named other public enemies, but the 1930s gangster was the only prior number one.

The US has offered a \$5m (£3.2m) reward for Guzman's capture.

He has been indicted on federal trafficking charges and US officials want him extradited if he is ever captured, said on Thursday.

Federal officials agree that Guzman should be considered a Chicago crime boss, despite his removed

location.

"*Guzman is the new Al Capone of Chicago*," Jack Riley, the top Chicago official from the US Drug Enforcement Administration (DEA), said at the news conference.

Capone based his bootlegging and

other criminal enterprises in Chicago when it was illegal to make or sell alcohol in the US. He gained notoriety for the so-called St Valentine's Day Massacre, which left seven rivals dead.

But **Jack Riley** says that Guzman,

whose nickname El Chapo means "*shorty*" in Spanish, is more ruthless than the legendary gangster.

"*If I was to put those two guys in a ring, El Chapo would eat [Capone] alive*," he told the Associated Press, while pointing to pictures in his office of the criminal kingpins.

Mr Riley says Chicago is both a destination for drugs from Guzman's cartel and a distribution hub for the rest of the US.

While cartels are rarely directly linked to crime in the city, the DEA agent said drug trafficking is an underlying cause of territorial battles between street gangs that are blamed for rising homicide rates.

Forbes magazine has estimated Guzman's fortune at about \$1bn.

"*Not since the Chicago Crime Commission's first public enemy number one has any criminal deserved this title more than Joaquin Guzman*," JR Davis, president of the non-governmental Chicago Crime Commission,

He is known as the "*blade runner*" because of the prosthetic blades he races in. He was born without a fibula in both legs and had his legs amputated below the knee before his first birthday.

Police were called to his home in the a gated compound on the outskirts of South Africa's administrative capital in the early hours of Thursday morning.

They found paramedics treating a 29-year-old woman with four gunshot wounds to the head and upper body. She died at the scene, and officers recovered a 9mm pistol.

Early reports suggested Mr Pistorius might have mistaken his girlfriend for an intruder.

Police say neighbours heard noises around the time of the shooting, they had been called to investigate incidents of a domestic nature at the same house in the past.

Hours later, after being questioned by police, Mr Pistorius left a police station accompanied by officers, his face mostly covered by the hood of a grey jacket.

His court hearing was originally scheduled for Thursday afternoon but had been postponed until Friday to give forensic investigators time to carry out their work, said Medupe Simasiku, a spokesman for the prosecution.

Mr Pistorius's father, Henke, declined to comment but said: "*We all pray for guidance and strength for Oscar and the lady's parents.*"

Miss Steenkamp's publicist confirmed to the BBC that the 29-year-old model had died.

'Day of love'

In her last Twitter messages, Miss Steenkamp had spoken about her excitement about Valentine's Day.

The 26-year-old is due to appear in court on Friday.

Pistorius made history in London last year when he became the first double-amputee track athlete to compete in the Olympic Games.

Six Arrested Over Rape Of Spanish Tourists In Acapulco

Bolivia: Morales Criticises Chile Over Sea And Soldiers

Bolivia's President **Evo Morales** has renewed his calls for the release of three soldiers arrested in Chile.

The soldiers were arrested in January after crossing the Chilean border carrying an assault rifle.

In a speech marking the 134th anniversary of the war in which his country lost access to the Pacific Ocean, Mr Morales called the men *"great defenders of the sea"*.

It was the first time in decades that a Bolivian leader celebrated the event.

Chile says the men were detained after entering the country illegally, while Bolivia argues they were following car smugglers as part of an army operation.

Bolivia said it would appeal to an international court if Chile did not release the soldiers.

'Open wound'

Mr Morales accused Chile of making *"political decisions"* rather than ones based on law.

"As we claim our sea issue, Chile wants revenge [for it]. Our soldiers are great heroes of the sea and we will never abandon them," said the Bolivian leader.

Landlocked Bolivia has a

long-standing claim over sea access lost after the Pacific War, which started with the Chilean invasion of what used to be the Bolivian port of Antofagasta on 14 February, 1879.

For years, Mr Morales has been calling the border issue an *"open wound"*.

The current borders were set by a treaty signed in 1904, after Chile won the war.

Bolivia broke off diplomatic relations with Chile over the territo-

rial dispute in 1978.

In 2011, Mr Morales said Chile had failed to respond to a deadline he had set for progress in negotiations.

Chilean President **Sebastian Pinera** rejects Bolivia's assertions.

Mr Morales traditionally uses Bolivia's annual Day of the Sea, commemoration of its defeat by Chile in the 19th Century war on 23 March, to talk about sea access.

This was the first time in decades that a Bolivian leader also used the

anniversary of the invasion to claim the lost territory.

Chile is involved in a similar dispute over maritime boundaries with Peru, which also lost territory in the War of the Pacific.

In 2010, Peru signed a deal allowing Bolivia to build its own port on Peru's Pacific coast.

The demand for the return of its lost coastline is the subject of powerful national sentiment in Bolivia.

The landlocked Andean nation maintains a small navy, and schoolchildren are taught that regaining access to the sea is a patriotic duty.

Pope Benedict Hints He Will Retire Into Seclusion

The outgoing head of the Roman Catholic Church, **Pope Benedict XVI**, has hinted he will withdraw into seclusion after stepping down at the end of this month.

"Even if I am withdrawing into prayer, I will always be close to all of you... even if I remain hidden to the world," he told a meeting of Roman priests.

The pontiff, 85, shocked the world's biggest Christian Church on Monday when he announced his resignation.

He cited his advanced age as the reason for resigning.

The Pope appears to be planning a complete retreat from the public eye, the BBC's Alan Johnston reports from the Vatican.

However, he is expected to spend his retirement in a monastery at the Vatican and his relationship with his successor as pope is bound to be an endless source of speculation, our correspondent adds.

A new pope is expected to be elected by cardinals before Easter, which falls on 31 March this year.

'Certainly a surprise'
Pope Benedict made his remarks at the Vatican in what amounted to a farewell address to hundreds of priests who serve in the Diocese of Rome, our correspondent says.

He appealed to the spirit of the reformist Second Vatican Council of the 1960s.

"We must work for the realisation of the real council and for a real renewal of the Church," he said.

Speaking earlier, some of the unnamed priests gave their reaction to the pontiff's decision to resign.

"People are divided, some say that he was right in doing so, since he did not feel able to continue any longer, others on the contrary feel dejected," said one.

"As for me, I am grieved and I hope and I pray for Benedict XVI, hoping that the Church again finds strength."

"It was certainly a surprise for everybody," said another.

"Maybe in this moment we cannot easily understand it since

all of us are feeling shocked but it is a sign that our pontiff wanted to act for the good of the Church.

his father, **Pedro Choc**, a taxi operator. The 16 year old boy told the police that, after the close of the Blue Angeles Night Club, his father was on a job transporting three male persons to Bella Vista Street just off Bullet Tree Road also in San Ignacio.
