
SAN IGNACIO TOWN, Cavo, Wednesday, March 13, 2013:

Preparations are being made for the burial of two young men who were reportedly shot by police as they fled the scene of a robbery in San Ignacio shortly after 12 noon on Tuesday, March 12, 2013.

San Ignacio police reported receiving an emergency call via the 911 line of a robbery in progress at Roses Chinese Restaurant & Store located between miles 67 and 68 on the George Price Highway on the western outskirts of San Ignacio town.

It is reported that a team of policemen rushed to the scene where in the area they came upon two male persons, one of whom was seen with a blue rag concealing his face while the other wore a black stocking over his face and toting a sawed-off shot gun.

Police reportedly identified themselves and ordered the men to stop when the masked man armed

with the shot gun allegedly swung around and fired a single shot in the direction of the officers. It is reported that the police returned fire resulting in the shooting of both individuals.

The injured men were rushed to the Community Hospital in San Ignacio where, on arrival, they were officially pronounced dead. They were

subsequently identified to the police by family members, as Belizean laborers, **Rony Garcia**, 22, residing at the corner Dalia and Flamingo Street and Jose Garcia, 18 of a 5th street address both in San Ignacio

The bodies were transported to the Karl Heusner Memorial Hospital in Belize City, on Thursday, March 14, for the legally required post mortem examination.

Police reportedly recovered, from the scene, \$342.85 in various denominations inside a black knapsack along with eight packs of cigarettes, twelve Phillies cigars, a blue flip phone and a black Kyocera flip phone. Police also retrieved a 16 gauge cartridge from the front pocket of one of the dead men. All items found at the scene have been positively identified as those stolen from Roses Restaurant & Store.

In a subsequent statement to the police, Ming Feng Chen, 30, Chinese businessman and owner of

Cayo's Oscar Quiroz Is The Cyclist To Watch On Holy Saturday



Oscar Quiroz Flanked By His Many Awards and Medals SAN IGNACIO TOWN, Cayo, August last year, Quiroz has Thursday, March 14, 2013: competed in the Vuelta Del Provenir,

Oscar Quiroz, the junior cyclist who has recently graduated into the major leagues will be the cyclist to watch in the March 30, Annual Holy Saturday Cross Country Cycling Classic.

The rising young cycling star who participated in the Smart Belmopan Cycling Classic on March 10, shocked the crowd when he captured the top prize in the junior league category by crossing the finish line one minute and forty seconds ahead of the second place finisher.

Quiroz has dominated the junior league since exploding onto the scene back in March 2010 when he competed in the Junior Cross Country Cycling Classic placing 9th in this prestigious race, an excellent feat by any standards for a first time rider.

Since his debut in March of 2010, **Oscar Quiroz** has gradually increased his placement in every race and is now the cyclist to beat in the junior cycling competitions.

On the international scene, in

August last year, Quiroz has competed in the Vuelta Del Provenir, a three day race in Guatemala City. He has also competed in the Caribbean Junior Championship I ndividual Time Trials, bringing back silver with a mere three seconds from capturing the gold medal.

As he continues to train hard in preparation for the Annual Holy Saturday Cross Country Cycling Classic Quiroz is now participating as a senior rider. He is confident that the over thirty hours of intense training he puts in each week will pay off as he competes with Belize's top cyclists as well as with international riders who will be participating in the race.

In an interview with the **STAR Newspaper**, Quiroz informed that he intends to "fly" through the twin towns of Santa Elena and San Ignacio to the cheers of the proud residents propelling him on the return journey to the finish line in Belize City.

We take this opportunity to wish Oscar all the very best of luck in his bid to be crowned the 2013 Cross Country Cycling Champion of Belize.

Roses Restaurant & Store informed that it was shortly after 12 noon on Tuesday, March 12, when a male person wearing a black stocking over his face rushed into the store and placed a sawed off shotgun to the side of his head, demanded money and ordered him to the floor. Chen additionally informed that the assailant took the female cashier's cellular telephone. He said that a second unarmed male person, with a blue rag covering his face, and a black knapsack on his back, also entered the store and jumped over the counter, opened the wooden cash drawer, grabbed and loaded the cash into the bag he carried. He also grabbed an assortment of cigarettes. Chen further informed that after taking the cash and the cigarettes, the man exited the store through a side door and entered the restaurant where he robbed the waitress of her cellular telephone before dashing out of the building and running across the George Price Highway.

A member of the family informed that they each received a gunshot wound to the back of the head while Ronny Garcia is said to have received an additional shot to the back which existed the chest. A relative of Jose Garcia informed that Jose has been living in Progresso Village, Corozal since August of last year and that he was in San Ignacio since Friday, March 8, 2013.



Pope Francis Warns Church Could Become 'Compassionate NGO'

Pope Francis has warned the Catholic Church would become "*a compassionate NGO*" without spiritual renewal.

In a Sistine Chapel Mass with cardinals on his first day as Church leader, the pontiff said: "If we do not confess to Christ, what would we be?

"We would end up a compassionate NGO. What would happen would be like when children make sand castles and then it all falls down."

Francis is the first Latin American - and the first Jesuit - Pope.

The BBC's David Willey, in Rome, says the 76-year-old has already been swift to stamp his style on the papacy.

Pope Francis is regarded as a doctrinal conservative, but he is also seen as a potential force for reform of the Vatican bureaucracy, analysts say.

On Wednesday night, Pope Francis endeared himself to the crowds in St Peter's Square - and underlined his reputation for humility - when he asked them to bless him before blessing them in return from the balcony of the basilica.

The Vatican's account of his first hours in the top job on Thursday also emphasised Pope Francis's humility, describing how he shunned a special car and security detail provided to

take him to the Vatican, travelling instead on a bus with the other cardinals.

Following his first outing as pope to the Rome basilica on Thursday, Francis went back to the clergy house in a city centre side street where he had been staying ahead of the conclave that elected him on Wednesday.

"He packed his bags and then he went to pay the bill for his room so as to set a good example," said Vatican spokesman Father Federico Lombardi.

He also broke tradition by remaining standing to receive cardinals' acts of homage after his election, instead of sitting in the papal throne, Father Lombardi said. over 80 who did not take part in the conclave.

On Saturday he will meet the world's media at a special papal audience, an opportunity perhaps to set out some of his global vision, says the BBC's James Robbins in Rome.

A visit to his predecessor **Benedict XVI** at his retreat at Castel Gandolfo outside Rome is also planned, but will not take place in the next couple of days, Father Lombardi said.

The visit to Benedict is important, correspondents say, as the existence of a living retired pope has prompted fears of a possible rival power.

Francis will be installed officially in an inauguration Mass on Tuesday 19 March, the Vatican added.

Early HIV Drugs 'Functionally Cure About One In Ten'

Rapid treatment after HIV infection may be enough to "functionally cure" about a 10th of those diagnosed early, say researchers in France.


They have been analysing 14 people who stopped therapy, but have since shown no signs of the virus resurging.

It follows reports of a baby girl being effectively cured after very early treatment in the US.

However, most people infected with HIV do not find out until the virus has fully infiltrated the body.

The group of patients, known as the Visconti cohort, all started treatment within 10 weeks of being infected.

They stuck to a course of antiretroviral drugs for three years, on average, but then stopped.

The drugs keep the virus only in check, they cannot eradicate it from its hiding places inside the immune system.

Normally, when the drugs stop, the virus bounces back.

This has not happened in the Visconti patients. Some have been able to control HIV levels for a decade.

Dr Asier Saez-Cirion, from the Institute Pasteur in Paris, said: "Most individuals who follow the same treatment will not control the infection, but there are a few of them who will."

He said 5-15% of patients may be functionally cured, meaning they no longer needed drugs, by attacking the

virus soon after infection.

"They still have HIV, it is not eradication of HIV, it is a kind of remission of the infection."

Their latest study, in the journal PLoS Pathogens, analysed what happened to the immune system of the patients.

Early treatment may limit the number of unassailable HIV hideouts that are formed. However, the researchers said it was "unclear" why only some patients were functionally cured.

Dr Andrew Freedman, a reader in infectious diseases at Cardiff University School of Medicine, said the findings were "certainly interesting".

"The presumption is that they've started treatment very early and the virus hasn't spread to so many of the long-term reservoirs and that's why it works.

"Whether they'll control it forever, or whether it'll be for a number of years and subsequently they will progress and the virus will reappear, we don't know."

However, he cautioned that many patients would be diagnosed much later than in this study.

China Confirms Li Keqiang As Premier

China's leaders have named **Li Keqiang** premier, placing him at the helm of the world's second-largest economy.

Mr Li, who already holds the number two spot in the Communist Party, takes over from **Wen Jiabao**.

Mr Li was elected for a five-year term but, like his predecessor, would be expected to spend a decade in office

On Thursday, **Xi Jinping** was confirmed by legislators as the new president, completing the transition of power from **Hu Jintao**.

Li Keqiang's widely-signalled elevation was confirmed by 3,000 legislators at the National People's Congress, the annual parliament session, in Beijing, by 2,940 votes of 2,949 cast.

As premier, he will oversee a large portfolio of domestic affairs, managing economic challenges, environmental woes and China's urbanisation drive.

The appointments seal the shift from one generation of leaders to the next. A raft of vice-premiers and state councillors will be named on Saturday, before the NPC closes on Sunday.

Mr Li, 57, who is seen as close to outgoing leader **Hu Jintao**, speaks fluent English and has a PhD in

economics.

He has called for a more streamlined government, eliminating some ministries while boosting the size of others.

The son of a local official in Anhui province, he became China's youngest provincial governor when he was tasked to run Henan.

But his time there was marked by a scandal involving the spread of HIV through contaminated blood.

Mr Li is expected to end the NPC with a press conference on Sunday, given by **Wen Jiabao** for the past decade.

On Thursday, Xi Jinping's move was approved by 2,952 votes to one, with three abstentions.

Hours later, US President **Barack Obama** called both to congratulate him and raise concerns over ongoing issues, including cyber hacking and North Korea.

"Both leaders agreed on the value of regular high-level engagement to expand co-operation and co-ordination," a White House statement said.

Mr Obama is sending both Treasury Secretary **Jacob Lew** and Secretary of State **John Kerry** to Beijing in coming days, in an apparent bid to reach out to the new administration.

In an editorial, state-run Global Times said Mr Xi and his colleagues needed to show powerful leadership to unite society.

"China cannot stop developing or fighting corruption. Social unity is the key to how China can stand against complex international affairs," it said.

Brazil Outrage Over Sao Paulo Cyclist's Lost Arm

A road collision in Brazil has caused outrage after police said a motorist drove off with a cyclist's severed arm attached to his vehicle.

The driver, who later turned himself in, told Sao Paulo police that he had dumped the limb in a stream.

The arm has not been recovered but doctors believe it could have been reattached, police told local media.

The cyclist - a window-cleaner on his way to work - is said to be in a stable condition in hospital.

The accident that saw the cyclist's arm torn off took place on Sunday morning on Avenida Paulista, one of Sao Paulo's busiest streets.

'Difficult to find'

The authorities say the driver, a 22year old student, will be charged with attempted murder and driving while under the influence of alcohol. However, they haven't yet decided how to charge him for the disposal of the arm.

The student says the arm fell into the car after the collision.

The motorist's lawyer, Cassio Paoletti, has told BBC Brasil he denies the attempted murder accusation and that his client did not stop for fear of the reactions of witnesses.

"If he had stayed, they would have killed the boy. For instance,



the police station was surrounded by hundreds of people who verbally abused and threw cans at my client's father, who's a 60-year-old man," Mr Paoletti said,

adding he would press for serious bodily harm charges.

A policeman told the BBC the case was still under investigation, but the driver had admitted to throwing the

arm into the stream.

"It has dirty, murky waters, so it might be difficult to find it," he said, adding that the man was being questioned about the details.

Police say the motorist was on his way back from a night out when his car hit the window-cleaner.

After the accident, he reportedly drove a friend home and discarded the arm, before turning himself in.

A number of cyclists gathered outside the police district where the driver was being questioned to


