San Ignacio police is this week reporting the interception of a cargo of over one hundred pounds of western weed suspected to have been destined for eastern streets.

## Police Investigates Police Traffic Accident

## SAN IGNACIO TOWN, Cayo, Tuesday, April 9, 2013:

A four year old boy, the victim of a road traffic accident involving a police vehicle, was today rushed to the Community Hospital in San Ignacio.

It was shortly after 7:00 pm on Tuesday, April 9, 2013 when police driver/Special Constable **Domingo Kan**, 46, was driving a black police Hilux with Belmopan license plates B-0145 on Bullet Tree Road heading to the San Ignacio Community on official police duties.

In a report to the police, Kan informed that as he was driving on Bullet Tree Road he observed a child dashing across the road in the pathway of the vehicle he was driving.

Kan informed that despite his best efforts to avoid the accident; the child collided into the back right end of the Hilux resulting in the child falling backwards on the road.

The child, who was accompanied by the father, was immediately placed in the police vehicle which continued enroute to the community hospital. The male child, with injuries to the head and abrasions to both feet was rushed into the emergency area where he was treated and later released.

The matter is under investigation by traffic personnel of the San Ignacio Police station.

its act together, the car carrying the weed had already slipped pass San Ignacio from Benque Viejo heading full speed ahead in an easterly direction.

After getting its act together a team of policemen in the police vehicle set chase eastward on the George Price Highway dashing through Santa Elena Town, Red Creek, Esperanza, Central Farm and by the time they entered Georgeville, they spotted the small black car heading in the opposite direction of the setting sun.

The police eventually caught up with the black Toyota sedan with Benque Viejo taxi license plates D-00378. The driver and a single male passenger were ordered out of the car where a search resulted in the discovery, inside the trunk, of two Guatemalan "Quetzal" brand red sacks, in "maka-pal (knapsack)" style completed with straps that goes over the shoulders and across the forehead to ease carrying. Both sacks were found ram jam with weed.

The two occupants of the taxi car were immediately detained and along with the weed and the car, they were transported to the police head station in San Ignacio where the driver was identified as Belizean, **Domingo Vega**, 37, of Lomas Del Rodeo area in Benque Viejo Town. The passenger was identified as Carlos Meda, 32, Guatemalan farmer residing on the Guatemalan side of Arenal Village along the Belize's western border with Guatemala.

The weed was weighed in the presence of both Vega and Meda where they confirmed the weight at 107 and <sup>3</sup>/<sub>4</sub> pounds (48,578 grams).

Faced with a joint (no pun intended) drug trafficking charge, Vega and Meda appeared in the San Ignacio Town courtroom of Magistrate Narda Morgan on Friday, April 5, 2013, where they both pled not guilty to the charge. Magistrate ordered that they be remanded to the big jail. The next court date comes up 45 days later, on Thursday, June 20, 2013.

## **Mendez Pleas Guilty To Criminal Charges**

## BENQUE VIEJO TOWN, Cayo, Thursday, April 5, 2013:

The court appearance of a Benque Viejo Town pharmacist was fast tracked this Thursday morning when the presiding Magistrate, Attorney **Linsbert Willis**, was advised by the defense of the intention of the accused to change from a not guilty to a guilty plea.

Cesar Mendez, brother of PUP Orange Walk East area representative, Marco Tulio Mendez, was criminally charged back in June of last year with three counts of aggravated assault of an indecent nature committed against a 12 year old female minor.

Since the arrest last year, Mendez has consistently maintained a not guilty plea. The next appearance in court was set for Thursday, April 25 as court cases are currently heard only on Thursdays in Benque Viejo Town.

The matter was brought up in court last Thursday, April 5, being three weeks earlier than scheduled, at the request of the accused through the attorney, **Richard** "Dickie" **Bradley**, where the accused pled guilty to two of the three charges of aggravated assault of an indecent nature committed against a 12 year old female minor. Athird similar charge was dismissed allegedly due lack of evidence.

In accepting the guilty plea, Senior Magistrate Linsbert Willis proceeded to impose a two hundred and fifty dollar fine on each of the two counts against Mendez for a total fine of five hundred dollars. Mendez was afforded 87 days, up to June 30, to pay the fine. In default of payment the admitted wrongdoer will spend three consecutive months in jail on each count for a total of six months

imprisonment.

The charges against Mendez spanned several months during which it is alleged that he had three encounters with the 12 year old girl. The facebook relationship between Mendez and the girl reportedly climaxed when an alert relative reportedly came upon what they described as "nasty" messages allegedly sent by Mendez to the child.

In the wake of last Thrusday's outcome of the case it is alleged that the child's family is outraged at what they are calling "a slap on the wrist" for Mendez. The outcome of the case has likewise caused quite a stir in the close knit Benque Viejo community so much so that the Director of Public Prosecutions, Mrs. Vidal has ordered the police prosecutor in Benque Viejo to submit a full report on the matter. We were reliably informed that the report has already been submitted to DPP Vidal.

## **Uncle Accused Of Molesting Nieces**

## BENQUE VIEJO TOWN, Cayo, Thursday, April 4, 2013:

An uncle was today remanded to prison as he stands accused of sexually assaulting two of his nieces.

A mother, accompanied by two daughters, visited the police station in Benque Viejo Town where the two minors, in statements to the police informed that the uncle had sexual relations with one and touched the other inappropriately.

A medical examination conducted last Friday, April 5, confirmed that the thirteen year old girl was indeed carnally known. She told the police that her uncle, **Alejandro Martinez** had sexual intercourse with her, against her will, on two separate occasions the last such encounter

## Mexico Government Says Drug-Related Murders Down By 14%

Mexico's government says there have been fewer drug-related murders in Mexico since President **Enrique Pena Nieto** came to power on 1
December 2012.

It said the number of drug-related killings between December and April had fallen by 14% compared to the same period a year earlier.

Mr Pena Nieto says the fight against crime is one of his main priorities.

Shortly after coming into office he announced the creation of a new police force.

#### 'Early days'

Government spokesman **Eduardo Sanchez** said 4,249 people had been killed by organised crime gangs between 1 December 2012 and 1 April 2013, a fall of 14% compared to the same four months a year earlier.

The government of former president Felipe Calderon stopped releasing figures of drug-related violence in September 2011, but Interior Minister Miguel Angel Osorio Chong said the federal government had continued to keep a tally.

"The idea is to be transparent about the figures and our methodology, so that organisations, academics, experts and the press can evaluate them for themselves," Mr Osorio said at a news conference.

Mr Osorio said kidnappings had dropped by 25% in the last four months compared to the months of August to November 2012, but he warned that it was "too early to assume victorious attitudes" in the fight against organised crime.

## Us Blacklists Honduran 'Drug Lord' Chepe Handal

The United States Treasury has frozen any assets held in the US by the alleged leader of a Honduran drug-trafficking organisation.

The US Treasury accused **Jose Miguel Handal Perez**, known as "Chepe Handal", of smuggling cocaine from Colombia and Venezuela to Mexican drug cartels.

Mr Handal and his family have been banned from doing any business with US citizens and companies.

He has denied the accusations.

"They fell on me like a bucket of water. We are trying to clarify the situation, as we do not know where they originate," he told the AFP news agency.

His wife, **Ena Elizabeth Hernandez Amaya**, and his father, **Jose Miguel Handal Larach**, have also been blacklisted by the US Treasury.

They were listed under the US Foreign Narcotics Kingpin Designation Act.

"Chepe Handal plays a critical role in the transportation and distribution of drug shipments between South America and the Sinaloa Cartel and Los Zetas," Office of Foreign Assets Control Director Adam Szubin said in a statement.

Much of the cocaine produced in

South America is now smuggled through Central America before it reaches Mexico and consumers in the LIS

Mr Handal, 38, is running for Congress in November's general elections for the Liberal United Front (FUL Toro).

"I have decided to enter politics for the first time because Honduras is facing one of the worst crises of its history," says Mr Handal in his website.

He blames the crises on the "lack of conscience and social awareness" of established politicians in the impoverished Central American nation.

The Handal family owns several companies in the Honduran city of San Pedro Sula, near the border with Guatemala.

"Handal invests in and coordinates the receipt of drug-laden aircraft departing from Apure, Venezuela into Honduras via clandestine airstrips," says the US Treasury statement.

"He also facilities the movement of these drug shipments out of Honduras by land to Guatemala, where members of Los Zetas and the Sinaloa Cartel take possession."

Mr Handal was charged with drug dealing in Florida in 2011, the US Government says.

The leader of the Sinaloa Cartel, **Joaquin "Shorty" Guzman Loera** is Mexico's top drug dealer and America's most wanted man.

Guzman and many of his relatives also have their assets in the US frozen by the Treasury.

The three sacks were transported to the police station in Benque Viejo Town where the combined weight was recorded at 120 pounds being 13 pounds more than the 107 pounds seized earlier by San Ignacio police.



#### Tens Of Thousands At Us Immigration Reform Rallies

Tens of thousands of demonstrators have rallied across the US in a mass call for citizenship for millions of undocumented immigrants.

The co-ordinated protests were designed to press Congress to act as senators negotiate an immigration reform bill.

In Washington DC cheering crowds gathered outside the Capitol, and more than 1,000 demonstrated in Atlanta.

Lawmakers are expected soon to unveil a bill that would grant a path to legal status for undocumented immigrants.

The push for immigration reform follows an election in which Hispanic voters overwhelmingly supported President Barack Obama and Democratic candidates

Most of the estimated 11 million undocumented immigrants in the US are Hispanic, and members of the Republican Party have acknowledged they must support some kind of immigration deal if they hope to win more Hispanic votes, analysts say.

#### 'Jobless Americans'

On Wednesday, gatherings entitled Rally for Citizenship were held in New York, Washington DC, San Francisco, Atlanta and dozens of other places.

The demonstrators included farm



labourers, domestic workers, union leaders and immigration activists.

"We won't win immigration reform just coming to Washington," said Ben Monterroso, of the Service Employees International Union. "We need to walk the streets all over the country."

Organisers in Washington DC said about 400 coaches brought people into the US capital for the rally in favour of immigration reform.

Democratic lawmakers, including New Jersey Democratic Senator **Bob Menendez** and Illinois Congressman **Luis Gutierrez**, spoke while Latino musicians **Olga Tanon** and **La Santa Cecilia** performed.

In the halls of the US Senate, a bipartisan group of senators is close to a deal on legislation that would require tough border security measures to be in place before undocumented immigrants could gain legal status.

It would also enable tens of thousands of legal immigrants to come to the US under a guest worker programme.

Groups favouring stricter immigration laws say the reforms under consideration would exacerbate financial problems for state and local governments and would lead to higher levels of illegal immigration.

#### Bill expected soon

"There ought to be a rally for the 20 million Americans who can't find a full-time job," Roy Beck, president of Numbers USA, said in a statement on Wednesday.

The bill is expected to be unveiled

within days and it could proceed to a vote before the Memorial Day holiday weekend at the end of May.

The US has not undertaken a major push to reform the immigration system since 2007, when a bipartisan bill failed in the Senate.

In 2010, Congress debated but did not approve the Dream Act, which would have given legal status to some young immigrants who came to the US as children.

In June, President Barack Obama unveiled a programme to allow young undocumented workers who immigrated as children to apply for two-year, renewable visas. He has expressed optimism that an immigration bill could be passed in the first half of 2013.
