Benque In Over Two Y irst Murder In

BENQUE VIEJO TOWN, Cayo, Wednesday, August 07, 2013:

Three days after his brutal death, relatives of Pedro Antonio Vasquez are today making final funeral preparations to lay his body to rest in Benque Viejo Town.

An arrest is yet to be made as Benque Viejo police say that they are following several leads in what they say is the first murder in the jurisdiction in over two years.

The call of the presence a dead body in the municipality was received by Benque Viejo police at around 5:00 am on Sunday, August 4, 2013. Police rushed to the scene where they came upon the still bleeding motionless body, still with a pulse, of a male Hispanic person face downwards in a pool of blood adjacent to the gas station on Churchill Street.

The man was rushed to the community hospital in San Ignacio where, on arrival, he was officially pronounced dead by the doctor on

Police reports that the deceased, later identified by a relative as Pedro

Antonio Vasquez, was observed with several injuries to the left and right side of the forehead consistent blows inflicted with a blunt object. He was also found with a large stab wound to the face.

A post mortem examination conducted on Monday, August 5, 2013, certified the cause of death as brain hemorrhage and suffocation as a result of the flow of blood into the air passage.

Police further reports that the deceased was also the victim of a beating several months ago and that the accused is still before the court. Police say however that the investigation has not been able to make a connection between both incidents.

The family is yet to obtain an official death certificate as they are grappling to come up with documentary identity of the decease despite him having been positively identified by a relative for the purposes of the post mortem examination.

As the investigation continues Benque Viejo police is seeking the assistance of the public in solving the murder of Pedro Antonio Vasquez.



Venezuela Top Court Rejects Capriles' Election Appeal

Venezuela's highest court has rejected an appeal by opposition leader **Henrique Capriles** against April's contested presidential election result.

The Supreme Court of Justice described the appeal as **"inadmissible"**.

After the ruling Mr Capriles tweeted that there was a "lack of justice" in Venezuela.

Nicolas Maduro, Hugo Chavez's handpicked successor, won the election by less than 1.5 percentage points - about 200,000 votes.

The opposition alleged that the vote had been marred by fraud.

In June the Venezuelan National Electoral Commission (CNE) confirmed President Maduro's victory in an audit on millions of votes, but Mr Capriles denounced the audit as "a fake".

In her ruling on Wednesday, Justice **Gladys Gutierrez** said the opposition had not not offered

"sufficient proof" to back up their allegations.

The 10-point appeal had been lodged by Mr Capriles, the opposition coalition and several citizens.

On Tuesday, Mr Capriles criticised the court's delay in making a ruling and said that he would take the case to "international bodies".

April's election was called after the death of President Chavez on 5 March following a long battle against cancer.

Youths from six communities in Belize travelled to El Salvador over this past weekend (2 - 5 August) to attend a Bahá'í Youth Conference. 
selling of prayer wall plaques, and doing odd jobs.

light of justice may shed its radiance upon the whole world."

Among the topics discussed are the unique characteristics that distinguish the period of youth, the importance of fostering an environment of encouragement, and the contribution youth can make for the betterment of society. Readers Write



Dear Editor:

I carefully read Scott Stirm's insulting reply to my letter appearing in your Sunday, July 21, 2013 edition.

Stirm attempts to insult me personally by saying that I am a homosexual. I am, and I have no more of an apology for that than I do for being right-handed, bald, or having blue eyes. He attempts to insult me by stating that I am married to a man. I was, indeed, legally married to **Thomas J. Brady**, M.D. five years ago, after having made a life together for the prior 33 years. Our marriage is legal under the laws of California and the United States Government. I have no apology for my married status. It offers us the legal protections, health care rights, tax benefits, financial obligations to one another, and the protection of our estate that traditionally married couples have without asking for it. We have no issue with our marriage not being recognized by various churches, synagogues, and mosques (although it is by some); ours is a civil marriage, not holy matrimony governed by the church. And Stirm attempts to insult me and my home town of San Francisco (the city where the United Nations got its start) by calling it the "epitome of debauchery" and ascribing to me excitement

over a fringe festival I never attend.

I have offered Pastor Stirm several opportunities to get to know me as a person through dialogue and correspondence, but he refused any communication with me other than that which would convert me to his cause because he only has "the time for someone who is asking questions and wanting to change." He would prefer to hold onto his straw man image of me in favor of the person I am. While I have been subjected to much worse treatment in my own country, such treatment occurred in the 1970s when the Dominionist agenda was first being pushed in the U.S., the same agenda Pastor Stirm is, using in his word, "weaseling" into Belizean society. Fortunately, U.S. citizens of all faiths soon saw both the mendacity and the danger of that movement, and it has been losing adherents consistently since that time. That U.S. failure is why this hidden agenda is now being sold overseas in places like the Caribbean, Africa, and Latin America.

The danger here is not directly from **Scott Stirm**, who I believe is quite sincere in his beliefs of what is right and necessary for Belize. The danger lurks in the Dominionist agenda that informs his beliefs and

actions.

Dominionism, also known as "Seven Mountains" or "Seven Pillars" theology, or Christian Reconstructionism, seeks to establish control and domination by a particular fundamentalist Christianity over seven broad areas of society: (1) media, (2) arts and entertainment, (3) business, (4) education, (5) government, (6) family life, and (7) religion in all the nations. It is not that Pastor Stirm seeks to lead people to a Christian path that is dangerous; it is that he sees his particular path as the only way of being a "true" Christian. I have found that when one person or one group thinks that they possess the only truth in the world, danger and violence too often follow. Think of Jim Jones in Guyana, David Koresh in Stirm's Waco Texas, Fred Phelps and his Westboro Baptist Church, or even the Spanish Inquisition. People get hurt in these environments. People get killed.

But even that picture is not what gives me fear for Belize. Back in the 1970s in San Francisco (and at the beginnings of the Dominionist movement in the U.S.) the situation was similar to that today in Belize. The LGBT community were openly advocating for justice and equality before the law, and the anti-homosexual religious community openly resisted with the exact same slanders and libels currently used by Scott

Stirm and the other Belize Action leaders: they're after our kids, they will ruin the country, they can't reproduce so must recruit, they are the camel's nose under the tent of moral decay, they are sick deviants, and so on and so on. The city was divided into warring camps of for and against.

Then something terrible happened. Dan White, who was a county supervisor, resigned his office, decrying the moral and cultural decline of his city. One day, in a fit of anger and with a loaded revolver in his pocket, he crawled through an open window in city hall to avoid the metal detector. He proceeded up to the office of Mayor George Moscone, and emptied the gun into Moscone's head and chest. Then he reloaded his gun and walked into the office of Supervisor Harvey Milk, the first gay public official in San Francisco, and proceeded to assassinate him as well. With a **"friendly"** prosecution by the district attorney, White was convicted of voluntary manslaughter rather than premeditated first degree murder and sentenced to a seven year prison term. The day that sentence was announced was followed by a night of rioting.

The first was by a hurt and outraged LGBT community, who stormed city hall screaming "he got away with



The Situation In Trinidad Could Lead To Change In Electing Prime Minister

Most of the countries that were former British colonies have a government that is similar to the one in Great Britain. In this type of government the Prime Minister is the Head of State and they have a Bicameral Legislative Body. The Prime Minister is the Leader of his or her political party who is elected to serve in the House of Parliament to represent his or her constituency. The Leader of the party that wins his or her seat and the majority of seats in the House of Parliament, automatically becomes the Prime Minister of the country. However, if the Leader of the party loses his or her seat, then he or she cannot serve as the Prime Minister of the country. The elected members of the party can then choose from among themselves their leader to become the Prime Minister.

In Great Britain the Queen or King acts as the Titular Head of State and as such he or she swears in the newly elected Prime Minister. In most of the other former British colonies that role is being performed by the Governor General of the country who represents the Queen or King of England.

Trinidad and Guyana are the only two former British colonies in the Caribbean and Latin America that declared themselves Republics. They both have a President but the functions of that office is different in both countries. In Trinidad the President duties is similar to that of a Governor General in all the other Caribbean countries but in Guyana the President is the Head of State and is elected by all the people through a direct vote.

In most countries Party Leaders are elected through party conventions except in the United States where they have no Party Leaders and the President is elected through a series of State Primary elections and then nominated at a Party Convention by Delegates from their political party. The candidate that gets the most Delegate votes at the Convention becomes the nominee of the party to run for President. The Leader of a party is the chief spokesperson for their political party and he or she remains as the leader until he or she resigns or is removed from the party leadership due to some vote or wrongdoing.

The advantage of having a Party Leader is that there is a person ready to become Prime Minister to represent a political party at anytime. Why? Because in most of these countries Constitution, there is a "Vote Of No Confidence Clause". If any elected member of Parliament comes to the conclusion that the person who holds the office of Prime Minister is not serving in the best interest of the country, he or she can table a Vote of No Confidence Resolution before the House of Representatives or Parliament against the Prime Minister. This is something that can occur in Trinidad today. In fact I am almost certain that there are members of the Trinidadian Parliament who are contemplating on doing that now. They are just waiting to see who else is going to leave or asking themselves; Where do I stand with all this chaos and confusion that I am involved in now?

Having a Direct Vote to elect a Prime Minister or a President has its advantages and disadvantages. The advantage is that anybody will be able to run and the best person who wins becomes the country's Prime Minister or President. Another advantage is that if the candidate comes from an ethnic group that makes up the majority of the population, he or she increases his or her chances of becoming Prime Minister or President. The disadvantage is that the person who wins the Prime Minister or President might not have the support of the members of the House of Representatives and Parliament. This could have happened in the United States when Ross Perot ran for President as a member of the newly formed Reform Party against Bill Clinton and George Bush Sr. in 1992.

Political Scientists are divided on which one of these two model of selecting a Prime Minister and President works better. In Guyana, most of the people are East Indians and they will have a difficult time electing a Black President unless the East Indians like him or her. The racial tension between these two groups remain tense up to this day

and they do not trust each other which makes it difficult for racial healing. The Presidency of Forbes Burnham remains in the minds of the older East Indians and until that generation die out things will change. Trinidad have more East Indians than Blacks but the political relationship between the two ethnic groups is not that bad.

In Belize where I am from we have a Black Prime Minister by the name of **Dean Barrow** for the first time in our country's history serving his second term despite the fact that we have more people of Mestizo origin. If Belize was to amend its Constitution to have a Direct Vote for the office of Prime Minister, I do not think we would have a Black Prime Minister. When this Prime Minister leaves office, there will be many who will contest for the leadership of the party and with money playing a major role in Belize's politics today, I cannot predict the outcome of the new scenario. The two main political parties must now begin to ask what the Belizean people think of them both. People are becoming impatient with them and are beginning to look for an alternative party. Luckily for the two major political parties in Belize, the VIP and the PNP have not organized themselves nationally to be looked upon as a real alternative to pose a threat to PUP and UDP yet.

Mayan Sculpture Discovered In Guatemalan Pyramid

Archaeologists working in a Mayan pyramid in Guatemala have discovered an "extraordinary" stucco sculpture depicting gods and Mayan leaders.

The frieze, which is eight metres long and two metres wide (26ft by six feet), shows three figures decorated with quetzal feathers and jade sitting atop the head of a mountain spirit.

It was found at the pre-Columbian archaeological site of Holmul.

Site director Francisco **Estrada-Belli** called it it a once-in-a lifetime find.

Snake Lords v Tikal

The frieze was found below a 20m-high (65ft) pyramid which was built over it in the 8th Century.


"The preservation is wonderful because it was very carefully packed with dirt before they started building over it," Mr Estrada-Belli said.

The sculpture is believed to depict the crowning of a new Mayan leader in about AD590.

It also bears an inscription made up of 30 glyphs, which was deciphered by Harvard University expert **Alex Tokovinine.**

The inscription says that the carving was commissioned by the ruler of a nearby city-state, Ajwosaj ChanK'inich.

The archaeologists say the frieze and its inscription shed light on a classical period of Maya rule in which two rival kingdoms, Tikal and the Snake Lords, fought for control of the



The figures are richly decorated with quetzal feathers and jade

region.

Mr Tokovinine says the inscription suggests that Ajwosaj, who was a vassal of the Snake Lords, came to the site to re-establish the local political and religious order after

Holmul, which had supported the Tikal kingdom, had switched sides.

murder" while breaking every ground floor window the building, overturning and burning several police cars, and attacking the police with rocks and bottles. The second was later that night when several hundred police marched on the gay neighborhood in a phalanx with their billy clubs at the ready. They surrounded the two blocks of the neighborhood so that no one could get away, and started beating people over the head. Several people were seriously injured. Then they broke all the shop windows and went into one gay bar and restaurant and tore it to pieces.

That was the turning point. All of the various communities of San Francisco—LGBT, people of faith, Asian, African-American, Hispanic, non-believers—seemed to ask themselves, "Is this the kind of community, of city, of society that we want to live in, that we want for ourselves and our children?"

And all residents started to leave their particular ideological corners and talk to one another and ask how we could find a way to accommodate all the citizens of San Francisco, not just those we agree with.

I fear for Belize because I see it heading in the same direction I saw in San Francisco. I fear that people will not wake up to the real danger, not of LGBT and their mythical agenda, but of tragedy and violence fomented by people who think they know the only right way for other people to live.

It took the assassination of Reverend **Martin Luther King** to awaken American to the danger of vile injustice of Jim Crow laws in the south. It took the bombing of Birmingham's 16th Street Baptist Church and the death of four little black girls to awaken Alabama to the danger of the injustice of a completely segregated society. And it took the assassination of Moscone and Milk and the subsequent riots to change us in San Francisco. What will it take for the citizens of Belize, who have a long and well established tradition of "live and let live," to wake up to the danger of the discord and strife used by Dominionists like Scott Stirm to advance their control over how all Belizeans must believe and live? - Asa DeMatteo -

Malaria vaccine shows early promise in clinical trials

A malaria vaccine has shown promising results in early stage clinical trials, according to researchers.

Researchers found the vaccine, which is being developed in the US, protected 12 out of 15 patients from the disease, when given in high doses.

The method is unusual because it involves injecting live but weakened malaria-causing parasites directly into patients to trigger immunity.

The research is published in the journal Science.

Lead author Dr Robert Seder, from the Vaccine Research Center at the National Institutes of Health, in Maryland, said: "We were excited and thrilled by the result, but it is important that we repeat it, extend it and do it in larger numbers."

Many bites

It has been known for several decades that exposure to mosquitoes treated with radiation can protect against malaria.

However, studies have shown that

it takes more than 1,000 bites from the insects over time to build up a high level of immunity, making it an impractical method of widespread protection.

Instead, a US biotech company called Sanaria has taken lab-grown mosquitoes, irradiated them and then extracted the malaria-causing parasite (Plasmodium falciparum), all under sterile conditions.

These living but weakened parasites are then counted and placed in vials, where they can then be injected directly into a patient's bloodstream. This vaccine candidate is called PfSPZ.

To carry out the Phase-1 clinical trial, the researchers looked at a group of 57 volunteers, none of whom had had malaria before.

Of these, 40 received different doses of the vaccine, while 17 did not. They were then all exposed to the malaria-carrying mosquitoes.

The researchers found that for the participants not given any vaccine, and those given low doses, almost all became infected with malaria.

However for the small group given the highest dosage, only three of the 15 patients became infected after exposure to malaria.

Dr Robert Seder said: "Based on the history, we knew dose was important because you needed 1,000 mosquito bites to get protection - this validates that.

"It allows us in future studies to increase the dose and alter the schedule of the vaccine to further optimise it. The next critical questions will be whether the vaccine is durable over a long period of time and can the vaccine protect against other strains of malaria."

He added that the fact that the vaccine had to be injected into the bloodstream rather than into or under the skin made delivery more difficult.

Commenting on the research, Dr Ashley Birkett, from the Path Malaria Vaccine Initiative, said: "They are clearly very early stage trials in small numbers of volunteers, but without question we are extremely encouraged by the results."

He added that most current vaccine candidates targeted parts of the P.

falciparum parasite rather than the whole organism.

"This approach induces a broad response against a lot of different targets on the parasite," he said.

There are currently about 20 malaria vaccine candidates in clinical trials.

The most advanced is called RTS,S/AS01, which has been developed by the pharmaceutical company GlaxoSmithKline, and is in a Phase-3 clinical trial involving 15,000 children in Africa.

According to the latest figures from the World Health Organization, there were an estimated 219 million cases of malaria in 2010 and an estimated 660,000 deaths.





Colombia coca area down by 25% - ZIN

The area of land planted with coca - the raw ingredient for cocaine - in Colombia has fallen by 25%, a UN report has said.

The land under coca cultivation is now about a third of that in 2001, says the UN Office on Drugs and Crime (UNODC).

While coca areas fell nationwide, they rose in three provinces plagued by rebels and drug gangs.

Colombia is one the world's top three cocaine producers and has made the war on drugs one of its main priorities.

Prevention v eradication

The annual report by the UN's Integrated Illicit Crops Monitoring System says that the land planted with coca bushes has dropped from 64,000 hectares in 2011 to 48,000 hectares in 2012, the lowest figure since monitoring started in Colombia more than a decade ago.

The report confirms preliminary figures quoted to the BBC by the Colombian Defence Minister in June.

Analysts say the fall in coca production suggests illegal groups which have so far financed themselves through drug trafficking may increasingly be moving into illegal gold and emerald mining, both of which have been increasing in Colombia.

The groups take advantage of the

fact that, unlike coca or cocaine, gold and emeralds are legal to transport and sell

Mine field

But the head of Colombia's counternarcotics police, Gen **Luis Alberto Perez**, told the BBC that the UN figures showed that their strategy to focus on the worst-affected areas had worked.

He said that even though the police had eradicated less coca than in previous years, the force had increased its presence in those regions where most of the coca was grown, preventing people from planting coca bushes in the first place.

He also praised the government's social programmes, which aim to

convince farmers to switch from growing coca to legal crops.

The UNODC report, which uses satellite imagery to map areas planted with coca, says that there was an increase in coca plantations in three provinces: Norte de Santander, Choco and Caqueta.

According to Gen Perez, police activity in these three provinces was hampered by left-wing Farc rebels and drug gangs.

The general says an increased use of landmines by these groups means that eradication workers cannot pull out the plants by hand without the risk of stepping on a mine.

The border regions have the highest density of coca plants, with the

southern town of Tumaco again topping the list.

Gen Perez says a ban on aerial eradication - using planes to spray herbicides on coca plants - in a 10km-wide (6-mile wide) strip next to the border has made this area a magnet for drug growers.

Colombia agreed to the exclusion zone after Ecuador brought a complaint against its neighbour at the International Court of Justice in 2008 saying its territory was being poisoned by the spraying.

According to UN figures released earlier this week, coca growing also decreased in Bolivia.

The UNODC said coca cultivation had dropped by 7% between 2011 and 2012 to 25,300 hectares.

Bolivia is, along with Colombia and Peru, among the world's top three producers of cocaine.

The figures for Peru are expected to be released over the next weeks.

Honduras Drug Gang Shootout Leaves 17 Dead

Seventeen people have been killed in a clash between rival drug gangs in Honduras, chief prosecutor **Roberto Ramirez** has said.

The shootout happened in La Mosquitia, a remote region on Honduras' Atlantic coast.

The area is the main transit route for cocaine being transported from South America to the United States. Honduras has the highest homicide rate in the world, much of it blamed on gang violence and drug traffickers

Mr Ramirez said that one of those killed was a gang leader from neighbouring Nicaragua - Victor Centeno, known as "El Muco".

Earlier, Honduran Deputy Defence Minister **Carlos Funez** said the body of the drug lord had been taken across the border by members of his gang.

Navy and army personnel have been despatched to the area to investigate the incident.

Mr Funez attributed the clash to a "turf war" between rival criminal organisations.

Nicaraguan and Honduran gangs

to a wealth of evidence.

"A cocoa-based treatment would likely be very popular, but it's too soon to draw any conclusions about its effects.

"One drawback of this study is the lack of a control group for comparison, and we can't tell whether the results would have been different if the participants drank no cocoa at all."

But he added: "Poor vascular health is a known risk factor for dementia, and understanding more about the links between vascular problems and declining brain health could help the search for new treatments and preventions."

Cocoa 'might prevent memory decline'

Drinking cocoa every day may help older people keep their brains healthy, research suggests.

A study of 60 elderly people with no dementia found two cups of cocoa a day improved blood flow to the brain in those who had problems to start with.

Those participants whose blood flow improved also did better on memory tests at the end of the study, the journal Neurology reported.

Experts said more research was needed before conclusions could be drawn.

It is not the first time cocoa has been linked with vascular health and researchers believe that this is in part due to it being rich in flavanols, which are thought to have an important role.

In the latest study, researchers asked 60 people with an average age of 73 to drink two cups of cocoa a day - one group given high-flavanol cocoa and another a low-flavanol cocoa - and consume no other chocolate.

Blood flow

Ultrasound tests at the start of the study showed 17 of them had impaired blood flow to the brain.



There was no difference between those who drank flavanol-rich cocoa and those who had flavanol-poor cocoa.

But whichever drink they were given, 88% of those with impaired blood flow at the start of the study saw improvements in blood flow and some cognitive tests, compared with 37% of people whose blood flow was normal at the beginning of the study.

MRI scans in 24 participants found that people with impaired blood flow were also more likely to have tiny areas of brain damage.

"We're learning more about blood flow in the brain and its effect on thinking skills," said study author Dr Farzaneh Sorond a neurologist at Harvard Medical School.

"As different areas of the brain

need more energy to complete their tasks, they also need greater blood flow. This relationship, called neurovascular coupling, may play an important role in diseases such as Alzheimer's."

The researchers said the lack of difference between the flavanol-rich and flavanol-poor cocoa could be because another component of the drink was having an effect or because only small amounts were needed.

Dr Simon Ridley, head of research at Alzheimer's Research UK, said this was a small study but that it added
