

# SANIGNACIO TOWN, Cayo, and transported to the police

Wednesday, July 30, 2014:

A man caught carrying a washing machine on his shoulder in the early hours of the morning on Monday, July 28, was arrested, charged and denied bail.

Police on mobile patrol shortly after 3:00 am on Monday, July 28, in the Bradley's Bank area of Santa Elena town reportedly came upon a male person of Hispanic decent carrying a washing machine on his shoulder. When questioned he was unable to provide a reasonable response for his action. He was detained and transported to the police station in San Ignacio along with the PL Laundromat brand, 6 kilo washing machine. The detainee was identified as **Armando Novelo**, 24, Belizean mason residing in the Hill View Area of Santa Elena Town.

The detainee was still in police custody when at around 5:00 am on Tuesday, July 29, **Christine Codd**, Belizean housewife residing in Bradley's Bank, visited the police station and reported that her washing machine was missing from its usual spot on the verandah of her house. The machine held by the

Novelo appeared before magistrate **Herbert Panton**, in San Ignacio magistrate's court on Wednesday, July 30 where, before pleading not guilty to the theft charge, said to magistrate Panton, "*I neva thief it, I buy it*". He was advised to leave all statements for the trial. Magistrate Panton concurred with the prosecutor's request for the denial of bail. Novelo was consequently remanded to prison with the next court date set for, Wednesday, September 3, 2014.

If there is any truth in the most recent allegation, against the PUP Standard Bearer in the Belize Rural North constituency regarding impropriety involving large sums of missing money from a client, then the accused might just be in for very rough times ahead.

While we sit on opposite sides of the political divide, for the sake of his sanity, his political aspirations and indeed his entire well being, we wish him no ill. The allegations against him however are extremely serious in nature given that, in months just past, he portrayed himself as the vanguard for all that is right. Even more serious is that at one juncture in his life he was aspiring to become the leader of the political party to which he belongs, an aspiration that, who knows, he might still be harboring in the back deep recesses of his mind.

The complainant in this matter would be venturing into dangerous territory in the advancement of false charges against this individual. The revelations of the sequence of events however presents diametrically opposite versions of what **s Telling The Truth?** actually transpired; hence it can be safe to draw the assumption that one party is telling the truth while the other is not being truthful. The interview with the accused, aired on Channel 7's Thursday evening newscast, seems to have come across as, if not an outright display of arrogance, bordering very close thereto.

The unfolding of this matter will be very interesting to follow. One thing is for certain however: It has opened an inter party wound, cutting at the very core of the opposition, a deep, deep wound that will never soon heal. Given that the allegation seems to have all the elements required for the levying of a theft charge against the accused. Furthermore, given that it directly and individually implicates one who is seeking an elected position on his party's ticket for the next general election, the silence on the part of the leader of the opposition is deafening. Is this how leaders act? Do they simply wait in the wings hoping that matters of this serious nature just "blow away like a lee breeze?"





### **Ebola: Global Experts Begin Emergency Talks At WHO**

Global health experts at the World Health Organization (WHO) are meeting to discuss new measures to tackle the Ebola outbreak.

The meeting is expected to last two days and will decide whether to declare a global health emergency.

On Wednesday, a man suspected to have contracted Ebola died in Saudi Arabia. If confirmed, this will be the first Ebola-related death outside of Africa.

The virus has killed nearly 900 people since February in West Africa.

The outbreak began in February in Guinea, and has since spread to Liberia, Sierra Leone and Nigeria.

On Wednesday a nurse became the second person to die from

five other cases of Ebola were being treated in isolation in Lagos, sub-Saharan Africa's largest city.

It comes as leading infectious disease experts have called for experimental treatments to be offered more widely.

Two US aid workers who contracted Ebola in Liberia appear to be improving after receiving an unapproved medicine ahead of their evacuation back to the US.

But it is not clear if the ZMapp drug, which has only been tested on monkeys, can be credited with their improvement.

Prof Peter Piot, who codiscovered Ebola in 1976, Prof David Heymann, the head of the Centre on Global Health Security, and Wellcome Trust director **Prof Jeremy Farrar** said there were several drugs and vaccines being studied for

possible use against Ebola.

"African governments should be allowed to make informed decisions about whether or not to use these products - for example to protect and treat healthcare workers who run especially high risks of *infection*," they wrote in a joint statement.

The WHO, "the only body with the necessary

international authority" to allow such experimental treatments, "must take on this greater leadership role", they said.

The meeting of the WHO's emergency committee in Geneva is focusing solely on how to respond to the Ebola outbreak.

Three-year-old Elle arched her arm and pointed her fingers. "You're frozen, Gaga!"

I stopped in place, one arm behind me, the other in the air. She giggled, then quickly unfroze me.

If you are in the vicinity of anyone under the age of 6, you're familiar with the movie, Frozen. In it, two sisters struggle in their relationship with each other and in finding acceptance.

At one point Elsa, the older sister, sings these words:

Let it go. Those are words I sensed God speaking to me years ago.

Let go of the past that you cannot undo.





### Facebook Sued By 25,000 Members

A data privacy campaigner has signed up 25,000 people to a "class action lawsuit" being taken against Facebook.

Max Schrems alleges that the way the social network monitors its members' activity on and off the site puts it in breach of EU laws.

As part of the claim, he also alleges that the company co-operated with Prism, a US surveillance scheme.

Facebook has previously denied knowing about Prism before it was mentioned in leaked US government documents.

The company has, however, acknowledged complying with national security requests from US government agencies.

Facebook has not commented on the wider case being brought against it.

The BBC understands it does not plan to respond until it has been served the relevant papers.

### **Facebook search**

Mr Schrems asked Facebook users based outside the US and Canada who wished to take part in the case to sign up via an app.



The case is targeted against the company's Irish subsidiary, which is responsible for all accounts belonging to users outside of North America. It has been filed with the Commercial Court for Vienna, the 26 year old's home city.

Among the allegations are that Facebook broke EU privacy laws by introducing:

Graph Search - a facility allowing users to find out about other members' activities on the social network

External website tracking monitoring members through the Like buttons embedded into third-party webpages

**Big data analysis** - the ability to gain insights into Facebook members' by data-crunching the billions of interactions people have with the site every year

#### Model case

Mr Schrems is demanding 500 euros (**\$667, £396**) in damages for each of the first 25,000 people who signed up to the case. While the Austrian legal

system does not make provision for US-style class actions, Mr Schrems is working round this by getting the other participants to transfer their financial claims to him, which is permitted.

If he wins he intends to share the money after delivering a 20% cut to a German firm that is funding the case.

While the promised payout might have helped him attract support, Mr Schrems says the money is a side-issue.

Instead, he explains, the dispute with Facebook is intended to be a "model case" that sets a precedent addressing the wider problem of tech firm developing products that comply with US laws, but are not adapted for other countries' rules.

"It is not an epic fight with Facebook but more of a general question of where we are going and if we respect our fundamental rights in Europe," he told the BBC.

"Right now I have the feeling that we love to point the finger at the US in Europe, and say they are not respecting our privacy. But the reality is that we don't really do anything

# Chikungunya

Chikungunya is an infection caused by the Chikungunya virus. It causes an illness with an acute febrile phase lasting two to five days, followed by a longer period of joint pains in the extremities; this pain may persist for years in some cases.

The disease is transmitted similarly to dengue fever. It is transmitted to humans by virus-carrying Aedes mosquitoes. Specifically, there are two species of mosquitoes, A. albopictus and A. aegypti, that are extrinsic hosts (vectors) of chikungunya virus. The strain of chikungunya spreading to the US from the Caribbean is most easily spread by A. aegypti. There is concern that this strain of chikungunya could mutate to make the A. albopictus vector more efficient. If this mutation were to occur, chikungunya would be more of a public health concern to the US. The A. albopictus or "Asian Tiger" mosquito is more widespread in the US and is more aggressive than the A. aegypti. It is known that monkeys, apes, and rodents act as a reservoir for the virus. Having rodents as a viral reservoir for chikungunya differs from that of dengue which has only humans and nonhuman primates as hosts.

#### Signs and symptoms

The incubation period of chikungunya disease ranges from one to twelve days, typically two to three. The majority of those infected will develop symptoms. Symptoms include a fever up to 40 °C (104 °F), a petechial or maculopapular rash of the trunk and occasionally the limbs, and arthralgia or arthritis affecting multiple joints.

Other nonspecific symptoms can include headache, nausea, vomiting, conjunctivitis, slight photophobia and partial loss of taste. Ocular inflammation from chikungunya may present as iridocyclitis. Retinal lesions may also occur. Pedal edema (**swelling of legs**) is observed in many people, the cause of which remains obscure as it is not related to any cardiovascular, renal or hepatic abnormalities.

Typically, the fever lasts for two days and then ends abruptly. However, other symptoms-namely joint pain, intense headache, insomnia and an extreme degree of prostration—last for a variable period; usually for about five to seven days. People have complained of joint pains for much longer time periods; some as long as two years, depending on their age. Recovery from the disease varies by age. Younger people recover within 5 to 15 days; middle-aged people recover in 1 to 2.5 months. Recovery is longer for the elderly. The severity of the disease as well as its duration is less in younger people and pregnant women. In pregnant women, no untoward effects are

noticed after the infection. **Prevention** 

The most effective means of prevention are protection against contact with the disease-carrying mosquitoes and mosquito control. These include using insect repellents with substances such as DEET (N,N-diethyl-metatoluamide; also known as N, N' - diethyl - 3 methylbenzamide or NNDB), icaridin (also known as picaridin and KBR3023), PMD (p-menthane-3,8-diol,a substance derived from the lemon eucalyptus tree), or IR3535. Wearing bite-proof long sleeves and trousers also offers protection.

In addition, garments can be treated with pyrethroids, a class

of insecticides that often has repellent properties. Vaporized pyrethroids (for example in mosquito coils) are also insect repellents. Securing screens on windows and doors will help to keep mosquitoes out of the house. In the case of the dayactive Aedes aegypti and Aedes albopictus, however, this will have only a limited effect, since many contacts between the mosquitoes and humans occur outside.

#### Treatment

Currently there is no specific treatment. Attempts to relieve the symptoms include the use of NSAIDs such as naproxen, paracetamol (acetaminophen) and fluids. Aspirin is not recommended.

## Protecting The Chiquibul

SAN IGNACIO TOWN, Cayo, Thursday, August 7, 2014:

Friends of Conservation and Development (**FCD**), a non-profit organization charged with the responsibility to protect the Chiquibul Reserve in the Mountain Pine Area of the Cayo District, today held closing ceremonies for European Union's ECP-FLEGT project 2013-2014 at the Rumors Resort on the western outskirts of San Ignacio Town.

During the ceremony **Rafael Manzanero**, FCD's Executive Director and his team received special commendation for the wonderful work they do in the national reserve.

In his presentation Manzanero informed that the major challenges confronting FCD in the Chiquibul are illegal logging, the illegal panning for gold and the extraction of the exotic Xate plant. Manzanero additionally informed of the complexities involved, given that Guatemalans residing in neighboring communities are major offenders who operate primarily during nighttime hours thereby posing extreme difficulties for enforcement as the FCD lacks the capacity to conduct patrols after sunset.

In terms of staffing the FCD currently operates with a manager and eight rangers. In further strengthening its enforcement capabilities, Manzanero informed of the planned creation of a Joint Enforcement Unit comprising elements from the Belize Defence Force, the Belize Police Department and of course FCD Rangers. Notwithstanding current challenges the FCD continues to protect the reserve whilst instituting mechanisms to reduce the loss of biodiversity in the area under its charge.

### Venezuela To Close Colombia Border Each Night

Venezuela says it will close its border with Colombia at night from Monday, to try to stop large-scale smuggling of petrol and food.

The government says that tonnes of goods - produced in Venezuela and heavily subsidised - are sold in Colombia at much higher prices.

The shortage of many staples in Venezuela's western border area this year led to anti-government protests.

The border closure was agreed with the Colombian government.

President Nicolas Maduro discussed the measures with his Colombian counterpart, Juan Manuel Santos, at a summit on 1 August.

The 2,200km-long (*1,360 miles*) border will be closed between 22:00 local time and 05:00 every night.

"That amount of food is enough to feed 700,000 people for a month," he added.

Mr Maduro's left-wing government subsidises petrol and many food staples, such as milk, rice and pasta, which are sold at controlled prices.

But it says that up to 40% of the goods produced in Venezuela end up on the other side of the border.

Dissatisfaction with the shortage of many staples, as well as rampant crime and high inflation, led thousands of people in the western Venezuelan states of Tachira and Merida to take to the streets in January.

The protests quickly spread to the rest of Venezuela, which faced similar problems.

In order to enhance its capacity the FCD plans to undertake the following:

a) The creation of a joint enforcement task force to better patrol the area,

b) the upgrading of key posts in order to recruit qualified staff c) the search for additional funding to cover recurrent operational costs such as vehicle, vehicle maintenance, fuel, supplies, equipment and salaries, and

d) legal training and legislative change in order to increase the rate of convictions.

Recent successes of the FCD in the execution of its duties include the arrest and successful conviction of several offenders, all Guatemalans, on charges ranging from illegal entry, illegal logging and the illegal possession of arms and ammunition. The FCD has also confiscated one hundred and sixteen fitches which were later burnt due to the inability to transport them out of the reserve given the terrain and road conditions to Caracol and Las Quevas. They have also taken possession of six horses abandoned by those engaged in illegal activities as they flee subsequent arrests.

With Guatemalans as primary offenders. FCD the is aggressively seeking the consolidation of bi-national collaboration and the development of strategies with Guatemalan authorities to address incidents of incursions into the national territory of Belize as well as to minimize the detention and possible incarceration of Guatemalans.

Manzanero informed that the Chiquibul Forest Reserve comprises 7.7 percent of Belize's land mass. It comprises plush forests with an abundance of flora and fauna and a wide array of exotic woods.

Manzanero additionally informed of the recording of 439 illegally logged cedar and mahogany trees with a combined value of almost 10 million US dollars (4.2M in cedar and almost 5.2 M in mahogany).

Given this statistics, the questions being asked are: How much do you value the Chiquibul? What is it worth to you? Do you think we can stop illegal activities especially logging in the reserve? Who is brave enough to work and protect what is ours?

# USB 'Critically Flawed' After Bug Discovery, Researchers Say

Cyber-security experts have dramatically called into question the safety and security of using USB to connect devices to computers.

Berlin-based researchers **Karsten Nohl** and **Jakob Lell** demonstrated how any USB device could be used to infect a computer without the user's knowledge.

The duo said there is no practical way to defend against the vulnerability.

The body responsible for the USB standard said manufacturers could build in extra security.

But Mr Nohl and Mr Lell said the technology was "critically flawed".

It is not uncommon for USB sticks to be used as a way of getting viruses and other malicious code onto target computers.

Most famously, the Stuxnet attack on Iranian nuclear centrifuges was believed to have been caused by an infected USB stick.

However, this latest research demonstrated a new level of threat where a USB device that appears completely empty can still contain malware, even when formatted.

The vulnerability can be used to hide attacks in any kind of USBconnected device - such as a smartphone.

"It may not be the end of the world today," Mr Nohl told journalists, "but it will affect us, a little bit, every day, for the next 10 years".

"Basically, you can never trust anything anymore after plugging in a USB stick."

USB - which stands for Universal Serial Bus - has become the standard method of connecting devices to computers due to its small size, speed and ability to charge devices.

USB memory sticks quickly replaced floppy disks as a simple way to share large files between two computers.

The connector is popular due to the fact that it makes it easy to plug in and install a wide variety of devices. Devices that use USB contain a small chip that ''*tells*'' the computer exactly what it is, be it a phone, tablet or any other piece of hardware.

It is this function that has been exposed by the threat.

In one demo, shown off at the Black Hat hackers conference in Las Vegas, a standard USB drive was inserted into a normal computer.

Malicious code implanted on the stick tricked the machine into

thinking a keyboard had been plugged in.

After just a few moments, the *''keyboard''* began typing in commands-and instructed the computer to download a malicious program from the internet.

Another demo, shown in detail to the BBC, involved a Samsung smartphone.

When plugged in to charge, the phone would trick the computer into thinking it was in fact a network card. It meant when the user accessed the internet, their browsing was secretly hijacked.

Mr Nohl demonstrated to the BBC how they were able to create a fake copy of PayPal's website, and steal user log-in details as a result.

Unlike other similar attacks, where simply looking at the web address can give away a scam website, there were no visible clues that a user was under threat.

The same demo could have been carried out on any website, Mr Nohl stressed.

**Mike McLaughlin**, a security researcher from First Base Technologies, said the threat should be taken seriously.

**"USB is ubiquitous across all** 

devices," he told the BBC.

"It comes down to the same old saying - don't plug things in that you don't trust.

"Any business should always have policies in place regarding USB devices and USB drives. Businesses should stop using them if needed."

The group responsible for the USB standard, the USB Working Party, refused to comment on the seriousness of the flaw.

But in more general terms, it said: "The USB specifications support additional capabilities for security, but original equipment manufacturers (OEMs) decide whether or not to implement these capabilities in their products.

"Greater capabilities of any product likely results in higher prices, and consumers choose on a daily basis what they are willing to pay to receive certain benefits.

"If consumer demand for USB products with additional capabilities for security grows, we would expect OEMs to meet that demand."

Mr Nohl said the only protection he could advise was to simply be ultra-cautious when allowing USB devices to be connected to your machines.

*"Our approach to using USB will have to change,"* he told the BBC.



## **Attorney Authur Makes Money Allegations Agianst Melonie**

### **Risk to reputation**

This is not the first action Mr Schrems has taken against the social network.

In 2011 he forced the firm to reveal all the information it was holding on him.

When he discovered the 1,222 pages of information included details he thought he had deleted or had not consented to being shared, he lodged a complaint with the Irish data protection commissioner. The case has since been referred to the European Court of Justice, but has already resulted in the firm restricting its use of facial recognition software and making it easier for members to find out more about the data held on them. One of the UK's leading data protection lawyers, who is not involved in the case, suggested the latest action could deliver a landmark ruling.

"The current climate of data protection enforcement in the EU in the courts and by the data protection regulators, coupled with an increasing awareness by consumers of their rights means that this case could well run its course in the Court in Vienna and achieve a result for Max Schrems and Facebook users," said Robert Bond, a

Mr Schrems has limited the number of people involved in the case to 25,000 because each participant's submissions must be vetted.

### US Deputy Assistant Secretary of State Visits Belize

### BELMOPAN, Cayo, Thursday, August 7, 2014:

The Embassy of the United States of America in Belize today informed of the visit of US Deputy Assistant Secretary of State for the Bureau of International Narcotics and Law Enforcement Affairs (INL).

The release informed that on Monday, August 4, 2014, the embassy hosted Luis Arreaga, Deputy Assistant Secretary of State for the Bureau of International Narcotics and Law Enforcement Affairs (INL) who spent two days in Belize, visiting key locations in Belize City on the first day and travelling to western towns of San Ignacio and Benque Viejo on the second day prior to crossing the border into

detailed plans and efforts to identify, isolate and treat cases. It could involve imposing travel

restrictions on affected areas. A WHO spokesman said: "We can't speculate in advance what the committee members are going to decide in advance."

Meanwhile, the World Bank is allocating \$200m (£120m) in emergency assistance for countries battling to contain Ebola.

It is the world's deadliest outbreak to date and has centred on Guinea, Liberia and Sierra Leone. Eight people are currently in quarantine in Nigeria, Africa's most populous country, and two have died there.

The Saudi man died after showing Ebola symptoms when he returned from a business trip to Sierra Leone, the Saudi health ministry said.

He died in an isolation ward at a hospital in Jeddah, it added.

Officials in Liberia said a Spanish priest and two Spanish nuns had been infected in the capital, Monrovia.

The Spanish government said it would send a plane to repatriate recovery \* Fruit bats are considered to its citizens. be virus' natural host British Airways has temporarily

suspended flights to and from Liberia and Sierra Leone until 31 August because of the health crisis, the airline said in a statement. It follows a similar suspension by two regional airlines last week.

The virus spreads by contact with infected blood and bodily fluids. The current outbreak is killing between 50% and 60% of people infected.

There is no cure or vaccine for Ebola - but patients have a better chance of survival if they receive early treatment.

Ebola has initial flu-like symptoms that can lead to external haemorrhaging from areas like eyes and gums, and internal bleeding which can lead to organ failure.

\* Symptoms include high fever, bleeding and central nervous system damage

\* Fatality rate can reach 90% but the current outbreak is about 55%

\* Incubation period is two to 21 days

\* There is no vaccine or cure

\* Supportive care such as rehydrating patients who have diarrhoea and vomiting can help Guatemala in continuance of the tour.

On arrival the US official was greeted on the airside of Phillip S.W. Goldson International Airport by staff of the embassy after which he was ushered into the main terminal building where he was afforded the opportunity to observe immigration and customs equipment funded by the US government, in operation.

From the airport he was transported to Belize City, where he was afforded a short tour of "gang areas" and then on to St. John's Vianney Primary School where the Gang Resistance Education and Training (GREAT) program was in full session. This afforded the US official the opportunity to visit each classroom where he interacted with instructors and students engaged in the program. The two week summer program, funded by CARSI (Central America Regional Security Initiative), involves lengthy educational experience, encompassing classroom instructions, athletics, art expression and two field trips. It seeks to educate young Belizeans about the dangers of gang association and gang violence.

Hitting the ground running, the US official was whisked from St. John's Vianney to the Queen Street Police Station where he was afforded an upfront view of improved methods being implemented by the police to electronically log arrests and other crime information using the Crime Information Management System (CIMS) a project also funded by CARSI. At the Queen Street police precinct the US official was hosted by the Officer Commanding Eastern (Police) Division, Assistant Commissioner of Police, Dezerie **Phillips** and other high ranking police officers who highlighted improvements resulting from CARSI funded projects particularly in the areas of technology, scenes of crime processing, forensics and ballistics analysis. On the second day of the visit the Deputy Assistant Secretary of State visited the Ministry of National Security at the Curl Thompson building in Belmopan where he was met by National Security Chief Executive Officer, Retired Colonel of the Belize Defence Force, George Lovell. From Belmopan he was transported further west to San Ignacio where he met the senior




**Deputy Assistant Secretary,** Luis Arreaga command as well as members of the Cayo Neighborhood Watch Association and People's Coalition.

Heading even deeper west he was afforded the opportunity to see the Mobile Interdiction Team (MIT) in action at a check point on the George Price Highway leading into Benque Viejo Town. Prior to departing Belize for Guatemala, the US official met with Customs, Immigration, and Border Management Agency officials at the Western Border Station in Benque Viejo Town.

The embassy release informs that the government of the United States of America, through CARSI, is engaged in assisting Central American governments in their efforts to combat violent crimes while simultaneously improving citizen security.

CARSI programs, says the release, enable Central American governments to weaken the influence and violence of gangs, organized crime, and narcotics. The United States of America, through CARSI, is committed to implementing sustainable, high-impact programs in law enforcement training and professionalization, anti-gang activities, equipping police and other security forces, sharing information within the region for the investigation and disruption of criminal activities, and assisting in the interdiction of narcotics, firearms, bulk cash, and smuggling. The release ends by informing that the government of the United States of America through INL aims to continue funding gang prevention programs using CARSI as the vehicle to supply up-to-date training and equipment to the police in the effort to prevent violent crime and the distribution of narcotics thereby enhancing citizens' security and the rule of law.
