
FILM MAKER FOUND DEAD IN SELENA VILLAGE

SELENA VILLAGE, Cayo, **January 4, 2016:**

Who would want to kill **Matthiew** Klinck? That is the question at the center of police investigation after the 37-year-old Canadian film maker was found dead at his place of residence on the outskirts of Spanish Lookout Community. He had been staying at the remote area in Selena Village since May of 2014.

Klinck's friends went to visit him around 8:30 on Monday night and were taken to the house by the caretaker of the estate, Edwin Paz.

Paz said that when they approached the house, "the door was open and the truck was open". They continued towards the house and found the lifeless body of Klicnk. Paz immediately called police to the location. Police arrived at approximately 8:40 p.m. According to police reports, the house was ransacked and some 15 feet away was the body of Mathew Klinck in its initial stage of decomposition and had what appeared to be a stab wound to the left side of the neck. He was



dressed in a blue jeans pants and a beige T-Shirt. A medical examiner has determined that he was stabbed about 14 times,

mostly to the torso and neck. The cause of death was recorded as "hypovolemic shock due to internal and external hemorrhage due to multiple stab wounds".

Police have not determined a motive as yet. Though the house was ransacked, the caretaker says as far as he has seen nothing was stolen. Paz said the last time he saw Klinck was on Saturday, January 2, sometime between 3:00 and 4:00 p.m. when he "stopped by, said hi and he drove in -that's how he normally did it". Klinck doesn't have any known enemies, according to friends. He has been living and producing films in Belize for the past five years. He is remmebered locally for the feature film "Curse of Xtabai" which was shot entirely in Creole. In 2014, he started working with other Belizeans to

Cable Wire Kills Man On Iguana Creek Road

December 22, 2015:

Eddy Alberto Sanchez, 29, of Buena Vista Village has died as a result of injuries sustained during a motorcycle accident two weeks ago.

On December 22, Sanchez was driving his grey Meilun 125 motor cycle in the outskirts of Spanish Lookout off the Iguana Creek Road and upon reaching the entrance of Belize Concrete Limited he collided into a cable wire used for the barrier of the compound which was across the road. He sustained severe head and body injuries and was rushed to the Western Regional Hospital in a critical condition.

Doctors at the hospital did what


SPANISH LOOKOUT, Cayo, they could to stabilize and prepare him for transport to the tal in Belize City.

> Doctors at the nation's final referral hospital executed multiple operations to save Sanchez's life.

Unfortunately, the injuries were too severe for him to recover. Sanchez died on Monday afternoon December 28, at 2:00 p.m.

Police issued a release with details of the incident on December 30. There has been no word on whether or not Belize Concrete Limited is being looked at as a responsible party for Sanchez's accident.

Investigation into this incedent continues.



Huge Heist In Ontario Village

ONTARIO VILLAGE, Cayo, December 28, 2015:

Thieves in Ontario Village raided the farm of 58-year-old American **Charles Davison** and made off with almost \$10,000 worth of goods. Davison is a livestock exporter and importer who went home to the United States for the Christmas holiday.

He returned on Monday,



December 28, and noticed that several items were missing from his farm. The missing items include one horse cart valued at \$1,000, a Mahogany table valued at \$400, a red

95 feet Andrews metal tower valued at \$1,700, two black meter radio valued at \$300, two meter antennas valued at \$600 and buggies valued at \$5,500. The total value of the items unaccounted for thus far is \$9,500.

The theft is being investigated by Belmopan and San Ignacio Police. These are the type of incidents that can only be prevented by strong neighbourhood watch practices.

Police had advised residents to inform their neighbours when they plan to leave their homes unattended for an extended period of time. This would allow one to be thy neighbour's keeper and hopefully such activities would be discovered, reported and stopped.



Major Crimes Down In Cayo

SAN IGNACIO TOWN, Cayo, January 6, 2016:

The Belize Police Department has released its national crime statistical report for 2015 and it shows that major crimes has decreased by 23 percent in the San Ignacio Formation.

In 2014 there were 226 crimes to obtain people's property. Those included 91 burglaries, 16 robberies and 119 thefts. In 2015 there were only 66 burglaries, 28 robberies and 82 thefts. That is a total of 176 crimes to obtain people's property. That is a decrease of 22.1 percent.

There were 25 violent crimes against the person in 2014. Those are 7 carnal knowledge, 13 murders and 5 rapes. In 2015 there 17 violent crimes



Superintendent Andrew Ramirez against the person. Those are 7 carnal knowledge, 5 murders and 5

rapes. This is a decrease of 32 percent in violent crimes against the person.

In total, there were 251 major crimes in the San Ignacio Formation in 2014 and only 193 in 2015. This is a decrease of 23.1 percent.

Mayor Earl Trapp recently wrote a letter to Superintendent Andrew Ramirez, Officer in Charge of the San Ignacio Police, saying, "The tremendous response from our residents is indeed overwhelming to have noted the vigilant patrol of officers across hot spots and busy routes throughout the municipality of San Ignacio and Santa Elena. It is no doubt that business owners and residents felt

secure and the very minimal occurrences proved your strategy to be a complete success in law enforcement."

Beware Of Fake Cheques

A Belize Bank account for **House** of Salvation, located at #3 Cahal Pech Road in San Ignacio, has been closed for two years now but that did not stop two dishonest individuals from making purchases using the company's cheque book.

The Credit Manager for

Caribbean Tires in Spanish Lookout reported to San Ignacio Police that on Tuesday, December 29, she received a Belize Bank cheque by mail in the name of House of Salvation in the sum of \$5,103. This cheque was payment for the purchase of six tires picked up by two men at the depot on December 10. The tires

cost \$850.50 each. The Credit manager checked with Belize Bank and was told that the House of Salvation's account has been closed for two years. She was also told that the signatures on the cheque does not match the ones they have on the file. It was then that a Caribbean Tires representative called police to report

the matter.

Police are looking for two men in connection to this act of dishonesty. Upon their arrest, they are expected to be charged with obtaining property by deception.

Police are also warning businesses to be on the lookout for cheques from the House of Salvation. It is not yet known how many such cheques are out.

Things Look Bright For Cayo In 2016

The year 2016 will be another great year for the twin towns of San Ignacio and Santa Elena as there are numerous projects set for completion in this calendar year.

The first project to be inaugurated is the brand new, fully staffed Santa Elena Health Center. This will be a first class medical center that will bring healthcare services closer to residents who currently have to pay taxi fare to go all the way to the new San Ignacio Hospital on Bullet Tree road.

2016 will also see the completion of the new San Ignacio-Santa Elena

Bypass. The new bridge will be a state of the art structure that will stretch across the Macal River. It is being funded by the Government of Belize and the Caribbean Development Bank at a cost of \$19,961,575.16. Simultaneously, road works will continue between Santa Elena and San Antonio Village as well as from Georgeville to the junction with San Antonio Village. These sections of road will be fully paved and completion is expected in 2016.

Perhaps the most welcomed project of 2016 is the upgrading of the

George Price Highway from Belmopan to the Benque Border. The Inter-American Development Bank and the European Union have approved BZ\$ 65 million in new financing for a project to rehabilitate and maintain a key stretch of the George Price Highway. Under the project, a stretch of 19.4 miles between Belmopan and Santa Elena will be rehabilitated; including the Roaring Creek Bridge which will be replaced with a higher and wider new bridge. According to a release from the IDB, "The Government of Belize has placed this project high on its list of priorities in the transport infrastructure sector."

The release goes on to read: "The goal is to improve road connectivity within Belize's main districts and with Central America by decreasing travel times and costs as well as increasing resiliency to the effects of climate change, which is of significant importance since the section to be reh abilitated is also an important hurricane evacuation route for the coastal population in the Belize District. The project will also support the routine and periodic maintenance of the rehabilitated infrastructure and will help to reduce road accidents and fatalities."

While these projects are in the pipeline, one project that is ready for inauguration is the new boulevard



between the roundabout at Loma Luz and Salazar St. This beautiful stretch of road will be officially inuagurated very shortly. Hon. Rene Montero and Hon. Omar Figueroa continues to lobby tirelessly for more projects in the Cayo area.

Can Belize Feed Itself? A Matter Of National Security

Food security is defined as existing "when all people at all times have access to sufficient, safe, nutritious food to maintain a healthy and active life". This will become one of the greatest challenges in the world as we face the effects of climate change, according to the Food and Agriculture Organization of the United Nations (Climate change and food security, 2008). In Belize, according to the Belize National Food and Agriculture Policy (2015-2030), decreasing food security has been identified as one of the main threats to the well-being of Belizean people.

There are three ways in which we can transform our food production systems to make them stronger in the face of these challenges.

The first one is to ensure long term productivity of our agricultural systems. To be able to grow, a plant needs nutrients and water, which are found in the soil. For this reason, soil health and protection are key elements for the long term productivity of agricultural systems.

To be healthy, soils need organic matter and the micro-organisms that process it into nutrients, so that plants can absorb them through their roots. Once we harvest a certain crop, soil needs to be replenished with organic matter for it to be able to provide another harvest. This can be done through organic or artificial methods. If we use artificial methods, adding industrial fertilizers, and combine it with the usual application of herbicides and other chemicals, we are killing the micro-organisms necessary for healthy soil. That is what frequently happens in large scale agriculture, which are huge plantations of one single species (corn, African oil palm, sugar cane, bananas or citrus).But also, in small scale agriculture, when we burn vegetation in order to plant a cropwe areburning the same organic matter and micro-organisms that will be needed for long term productivity. There are many organic ways of replenishing the soils' nutrients, for example planting crops in between rows of leguminous trees that can be pruned every year, such as the species Inga edulis, locally known as bri-bri, which has

had success in Honduras (growing corn, bananas, pineapples and cocoa yam, among many other crops) and is being tested as we speak in the Toledo district, providing farmers with healthy, productive, stable soils (even on slopes) and plenty of fire wood as a results of the pruning.

Another way of enhancing food security is by making our agricultural production resilient to climate change effects. In Belize, these changes will bringmore and longer drought periods and higher temperatures, as well as more frequent intense flooding. We need agricultural systems that are able to store water in the soil to resist dry conditions. Good news! This can be done through tree roots. . So, we need trees in our farms. This is known as agro-forestry andin many areas of Belize, cacao and coffee based agro-forestry are already providing farmers with cash-crops they can sell in fast growing valuable markets. Among these cash crops there are fruit trees and other plants that can provide food for local sale, as a gift to our children, they can even produce valuable timber trees. These crops can also be combined with small livestock rearing that can provide food for families and for local sale.. This kind of farming helps retain water in the soil, keep moisture and coolness in the airand help in the creation of rain clouds. In the same way, through their roots, they help hold the soil and sediments in cases of heavy rain, reducing the amount of nutrientsbeing washed into the sea, killingcoral reefs and its dependant fishing and tourism industries. This type of farming is much healthier than traditional methods such as slash and burn milpa, cattle ranching and large scale agriculture, which can't store water, damage soils, and **increase** the amount of sediments that go into our rivers and coral reefs.

Finally, we can **source our food** from local farmers. Belize has been blessed with very good conditions for sustainable agriculture that can provide us with fresh products at low prices, from either agroforestry systems or organic, compost based vegetable gardens. Access to markets of locally produced food and agricultural products value chains can be improved to make them more accessible to the public, and give a chance for the development of small, locally owned, agriculturally based businesses. By increasing the amount of healthy food in the market, we can also tackle another of the big challenges that we find in Belize, the one of increased cases of obediabetes, hypertension and sity, disease. These heart conditions can be fatal and are often related to unbalanced diets based heavilyon imported, processed food and soft-drinks, lacking more fruits and vegetables.

The Belizean government has developed, and is in the process of approving a new National Food and Agriculture Policy (2015-2030). All these aspects are mentioned in it, but we know from past experience (National Land *Use Policy approved in 2010*), that there is a long stretch between policy approval and real actions on the ground. The policy also calls (in its draft) for an increase of the contribution of the food and agricultural sector to GDP fromcurrent 13% to 20%. That is a huge increase. Let's make sure that it is based on sustainable, climate change resilient agriculture, and not at the cost of clearing more precious forests for unsustainable and vulnerable developments that will only bring short term benefits for a very few and great environmental damage for all.

In the rapidly changing environment that we will find ourselves during the coming years, we have a chance to leave a great inheritance for our children. One of a healthy, plentiful Belize that can provide food for all its people.
